Prove allegations on CAA, Shah dares Rahul

It only confers citizenship: Minister

Rahul equates NRC, NPR with demonetisation

Both tax the poor, says Cong. leader

Former Congress president Rahul Gandhi on Friday equated the National Register of Citizens (NRC) and the National Population Register (NPR) with the demonetisation of November 2016. He said both the exercises taxed the poor and if the NRC was implemented across India, the poor would suffer the most as they would have to pay bribes to correct any mistakes made during the enumeration.

"Whether NPR or NRC, it is a tax on the poor people of the country. You understand demonetisation. It was a tax on poor people.

Go to banks and give your money but do not withdraw money from your account. Entire money went to the pocket of 15-20 rich people. This [NPR or NRC] is the same thing," he told reporters at Raipur airport.

Army respects rights of adversaries: Rawat

Its rights cell will have policemen to redress complaints

Army chief Gen. Bipin Rawat on Friday asserted that the Indian armed forces have the utmost respect for human rights and pointed out that the Human Rights Cell in the Army headquarters was being upgraded to the level of a Directorate.

His comments come a day after he said students leading crowds to carry out arson and violence is not leadership, in an apparent reference to the protests across the country against the Citizenship (Amendment) Act (CAA).

"The armed forces not only ensure protection of human rights of our own people but also of adversaries and deal with the prisoners of war as per the Geneva Conventions," he said, while speaking on 'Preserving Human Rights in times of War and Prisoners of War', at the National Human Rights Commission.

The human rights cell, created in 1993, was being upgraded as a Directorate, which would be headed by an Additional Director General of the rank of a Major General. It would also have police personnel to address complaints and facilitate related enquiries, he stated.

Women inducted

Gen. Rawat said a new initiative was undertaken in October last by recruiting woman jawans in the Military Police force. The Army took along police personnel in search operations, keeping in view the concerns of women during such operations. "The Army has now decided to deploy lady jawans of its Military Police

No politics in what Army chief said, says V.K. Singh

The Modi government came to the defence of Army chief General Bipin Rawat on Friday after he drew flak from several quarters for his remarks criticising those leading protests and guiding students to carry out arson and violence.

Speaking to ANI, Union Minister and former Army chief Gen. V.K. Singh (retd.) defended Gen. Rawat's comments and asked the Opposition not to politicise everything. There was nothing political in asking students to maintain peace while protesting, he said.

"In our great country, the Opposition can turn anything into a controversy. Ideal would have been to see the statement in the context in which Army chief has said a particular thing. Ask him what he meant. I don't see any politics in it. If I tell students 'don't unnecessarily damage property', is it politics? Search your heart and ask this question," Gen. Singh said.

The Opposition had alleged that the Army chief's comments were political in nature and that he should desist from indulging in politics.

Peaceful protests held in city amid tight security

Over 300 detained at U.P. Bhawan

Peaceful protests against the Citizenship (Amendment) Act were held here on Friday amid heavy deployment of security personnel.

Demonstrations were staged outside Jama Masjid in Old Delhi, Jor Bagh, Uttar Pradesh Bhawan and Seelampur after Friday prayers. At U.P. Bhawan, around 357 protesters, including 75 women, were detained for defying prohibitory orders.

Protesters at Jor Bagh started their march towards the Prime Minister's house but were stopped by the police near the Jor Bagh metro station. They staged a protest at the site for an hour and later dispersed.

In Old Delhi, the protesters gathered outside gate number 1 of Jama Masjid and raised slogans. Former Congress MLA Shoaib Iqbal and party leader Alka Lamba were among the leaders who

took part in the protest. Speaking from a raised platform outside the mosque, Mr. Iqbal and Ms. Lamba demanded that the Central government should call a joint session of Parliament and withdraw the CAA and also tell people that the National Register of Citizens will not be implemented across the

The protesters, many of them not associated with any political party, said their agitation will continue till the government scraps the new citizenship law and promises not to implement the NRC. At Jamia Millia Islamia, students observed a daylong hunger strike against alleged police brutality during their protests. The students demanded an impartial judicial inquiry into the deaths during the anti-CAA protests across the nation, release of

Posters, drones keep fearful locals indoors in Firozabad

Incidents of December 20 leave residents apprehensive

Renowned for its colourful glass bangles, Firozabad saw only red on December 20. It's been a week since six people were shot dead here, but posters, drones, and heavy police deployment have scared residents into staying indoors.

An eerie calm prevailed on the Rasulpur bypass where protests against the Citizenship (Amendment) Act had spilled on to from the Mohammedgunj market on December 20.

On Friday, most shops on both sides of the road and along interior streets in residential areas remained shut amid heavy police and paramilitary deployment.

The policemen wore antiriot gear with helmets and held batons in their hands as they made sure there was no assembly before or after Jumme ki Namaz (Friday prayers).

At every road junction along prominent streets, posters were seen every few metres displaying pictures of those who authorities allege threw stones during the protest on December 20. "Identify them and tell the police," read the message in Hindi.

"These are the people who are behind the violence that took place in Firozabad on December 20. These radicals committed arson, caused damage to public

property and harmed people. Identity them and help the police. You just have to call. Fulfil your duty as a responsible citizen. Your identity will be kept confidential," said the poster accompanied by a collage of 10 photos. There were at least three posters at each location.


Locals said they were afraid of getting picked up by the police or being stopped to be asked "unnecessary" questions and of the drones hovering over their houses taking pictures and videos.

Big chase

Raeesa Begum, 36, a resident of Rehmat Nagar, said her four daughters and three minor sons run back inside the house as soon as they see a police car. "Bas yahi dar laga rehta hai ki police ghar ke andar na aa jaaye, hamare bacchon ko le jaaye (we are scared that the police shouldn't enter our house and take our children)." She added that she had instructed the boys not to leave the house. "What if they look similar to someone who is in those posters and the police take them for interrogation," she said. Salma (53), another resi-

dent of Rehmat Nagar, said she saw a drone hovering over her residence on December 25 evening. "Now they are taking pictures of us drying clothes also. What if they take pictures of our children in these cameras and post them too," she asked.

Friday prayers in Baghiya was marked by announcements on loud speakers from a mosque urging people to either return to work or their homes so as to ensure peace in the locality.

Jama Masjid observes peaceful protest

Cong. leaders head stir; will continue agitation till govt. strikes down CAA: demonstrators

Hundreds of people gathered outside Jama Masjid in Old Delhi to protest against the Citizen (Amendment) Act (CAA) and National Register of Citizens (NRC) on

With placards reading -"India against CAA NRC" "Withdraw CAA" and "We Demand Equality" - the protest amid police presence was peaceful.

Former Congress MLA Shoaib Iqbal and Congress leader Alka Lamba were among those who headed the protest, though many of the protesters were people who came for namaz at the

The protestors said they will continue the agitation as long as the government does not strike down the CAA and promise to not implement the NRC. Mr. Iqbal and Ms. Lambademanded that the Centre should call a joint session of the Parliament and take back CAA, and also tell people that NRC will not be

implemented.

Wearing a hijab before entering the platform, Ms. Lamba said: "Since the Prime Minister said in Jharkhand that protesters can be identified by their clothes, people like me have started to change their clothes. Now identify who is a Hindu and who is a Muslim."

A 25-year-old protester, Irshad Ahmad, who works at a shop, had come to the mosque to offer prayer when he came to know about the stir. "We are protesting so that our voices are heard."

A senior citizen, Fahim Aktar, who gives tuitions for a living said: "Now that Babri Masjid issue is over and we Muslims have accepted that verdict, the BJP is looking for something else to divide people." Mohammad Suhail, 29, who had come from Laxmi Nagar with a handmade poster that reads - India against CAA NRC – said: "Modiji has accepted refugees from six religions, then why not Muslims? We had also fought for independence." Mr. Suhail said he had to come to Jama Masjid to protest as the police did not allow him to the same in Laxmi Nagar. When asked

whether the protest is dying down at Jama Masjid, 24year-old DU student Mohammad Numan, said: "Police's violence is very high. In Banaras, people were dragged out of their houses and beaten."

"Those who failed in Class X and XII are now telling university students that they are being misled," he added.

The protesters said compared to last Friday when there was a call for protest and people had shut their shops in Old Delhi, this time, the stir was "weaker".

Meanwhile, 40-year-old Kurshid Ahmed, selling caps and prayer beads said: "The number of tourists has fallen by at least 70% since the protests began and the business is also affected.

Over 300 detained for protesting outside U.P. Bhawan against CAA

DCP says stir conducted in violation of Section 144, detainees released by 5 p.m.

Over 350 people were detained on Friday after they staged a demonstration outside Uttar Pradesh Bhawan here over alleged police atrocities against those protesting the Citizenship (Amendment) Act (CAA) and the proposed pan-India National Register of Citizens

Deputy Commissioner of Police (New Delhi) Eish Singhal said the protest was held in violation of Section 144 of the CrPC imposed in the area.

"The protesters did not have permission and were asked not to protest but they refused to follow the directions issued by the police...357 protesters, including 75 women, were taken to Mandir Marg and Connaught Place police stations. All of them were released by 5 p.m," he said.

The officer said on Thursday, Badre Alam, the leader of the protesters, was told by the police to take proper permission to hold a protest at U.P. Bhawan or conduct the same at Jantar Mantar. "But he did not pay any heed to the advice of the police," the DCP added.

The police said they had deployed adequate security personnel in and around U.P.

"Most of the roads leading to the Bhawan were barricaded. The police and paramilitary personnel were deployed to stop any protesters marching towards U.P. Bhawan," said an officer.

Around 150 people marching towards U.P. Bhawan were detained at Kautilya Marg roundabout. All of them were taken to Mandir Marg police station in buses, the police said. There was also a water

A court here allowed the police on Friday to carry out a bone ossification test to ascertain the age of an accused, arrested in connection with a violent protest at Seemapuri against the Citizenship (Amendment) Act and National Register of Citizens, claiming juvenility.

Metropolitan Magistrate Gita passed the directions after the police submitted that

the accused did not have any valid age proof and it needs to conduct the test. The court directed the Medical Superintendent of GTB hospital to conduct the test on December 28 and asked the police to submit the report by December 30.

Bone ossification test

"In the opinion of the court, the ossification test of accused is necessary as no document as mentioned in the Juvenile Justice (Care and ments submitted by the protection of children) Act, 2015, is produced on behalf of the accused. And in the ment, bone ossification test is last resort by which age of accused can be determined," the court said. The court was hearing a plea, filed through advocates Zakir Raza and Monis Rais, claiming that the

ople-centric schemes. Previous governments have not done it, and we do not care about whether they will do it in the future, but we will make sure that we continue to work for the welfare of the people," he

The Chief Minister said that AAP would make its manifesto for the Assembly elections based on consultations with people through town hall meetings.

"We discussed cleanliness on Thursday, and now we are discussing traffic congestion. We will continue to discuss and add an issue each day to ensure that all important points are covered in our manifesto, which is to be released around January 15-20, 2020," he said. The Delhi Assembly polls are likely to be held in February.

List of roads

Talking about traffic congestion, Mr. Kejriwal said that the government has designated a consultant to create a list of locations in Delhi where there are daily traffic jams.

"The designated consultant will provide us with a report within 9-10 months on how to solve the problem of traffic congestion in these locations," he said.

The Chief Minister added that they will then start working on resolving congestion issues on each road mentioned in the list.

"Just as we have worked on addressing issues in the fields of education, health, power, water, sewer, and drainage, etc., in the last five years, we will work on resolving traffic congestion issues in the next five years," said Mr. Kejriwal.

He added that currently 93% of Delhi receives tap water. "Our next step is to provide 24-hour water supply to the people of Delhi,"

Big businesses have a problem with street vendors, says CM

Kejriwal says vendors should not be seen as encroachers

Chief Minister Arvind Kejriwal met with members of the Town Vending Committees (TVCs) on Friday and urged them to facilitate a survey to resolve the issue of displacement of street vendors by authorities.

He also announced that the Delhi government would bear the cost of the survey, which is to be conducted by the municipal corporations.

"I hope that the vendors will not have to face any obstacles after the survey... industrialists and big businesses have a problem with street vendors and small-scale businesses. They have a problem with parallel businesses as they stand to lose. I promise that I will not let injustice against you [street vendors] prevail" he said.

Source of employment

"I believe the government must ensure employment to

Congress picks apart AAP govt. report card

The Delhi Congress on Friday released a 'post-mortem report' on the '10-point report card' by the AAP government and termed it a "bundle of lies"

DPCC chief Subhash Chopra said that the reality of the Arvind Kejriwal-led government is that "it provides only dirty drinking water and polluted air to the people of Delhi". He added that the AAP government has been promoting itself with "misleading ad campaigns" and "lies", and that Mr. Kejriwal has woken up to the reality of the welfare of the people only in the last three months of his government's tenure.

"AAP, which came to power on the issue of Lokpal and Swaraj, is now running away from both issues and the Lokayukt, which was established by the then Congress government, has been made ineffective," said Mr. Chopra.

The party further claimed that the AAP government had not spent 42% of its budget on health and that the "inflated health budget remained only on paper".

Former MP Sandeep Dikshit said that Mr. Kejriwal had promised to set up 1,000 Mohalla Clinics, but established only 189 clinics out of which 100 are not functional. He added that the clinics were opened after shutting down 500 government dispensaries.

KVs outperformed Delhi govt. schools: think-tank

Report based on 1,000 RTI replies

A report by the BJP-linked think-tank, Public Policv Research Centre (PPRC), has claimed that Central government schools outperformed Delhi government schools in 2019.

The report, released on Friday, was compiled over three months based on around 1,000 Right to Information replies by the Aam Aadmi Party government.

Govt. rejects findings The report claimed that

Class 10 pass percentage in Delhi government schools came down from 95.81% in 2015 to 71.58% in 2019; pass percentage of Kendriya Vidyalayas during the same period improved 99.59% to 99.79%.

The Delhi government has dismissed the report stating that it was "unfair" to compare its schools with Centre-run Kendriva Vidvalayas, which admit students through entrance tests.

"Over 1.6 lakh Delhi government school students sat for Class 10 Board exam in 2019; the number in Kendriya Vidyalayas of Delhi was around 7,800," said a government official.

PPRC director and BJP MP Vinay Sahasrabuddhe alleged that the Delhi government "indulged in propaganda" and published full-page advertisements but did "nothing" on the ground.

'Only State to not submit proposal under Pradhan Mantri Awas Yojana'

Delhi residents have not gotten any benefit from the Centre's urban housing scheme due to the ego of a Chief Minister who does not want to implement a scheme in the name of the Prime Minister, Housing and Urban Affairs Minister Hardeep Singh Puri said on Friday.

Delhi is the only State which has not submitted any proposal under the urban section of the Pradhan Mantri Awas Yojana (PMAY), a flagship central scheme promising housing for all by 2022. Earlier this week, Delhi Chief Minister Arvind Kejriwal launched the Mukhya Mantri Awas Yojana for residents of the city's slum clusters and promised to provide them with *pucca* houses.

"He has prioritised his ego and the name of a scheme. and he has sacrificed the scheme for his ego... If deve-

lopment is going to be based on the nomenclature of a scheme, then you are depriving your own citizens," said Mr. Puri.

Queries to the Delhi government about the State's failure to implement the central scheme, and Mr. Puri's allegations, were not answered.

Mr. Puri claimed that the AAP-led Delhi government's decision to put on hold for more than a year a survey for in-situ slum rehabilitation under the PMAY was a classic example of "a political fourth vertical, which is a credit-linked scheme whereby individuals directly apply for interest subvention on their housing loans without any State involvement. Also, PMAY has completed more than 50,000 homes in the city which were sanctioned under the earlier central scheme, the Jawaharlal Nehru National Urban Renewal Mission, with proposals coming from the previous Congress government in

In total, the PMAY has crossed the one crore milestone in terms of houses sanctioned nationwide, as against a validated demand of 1.12 crore. However, only 32 lakh houses have actually been completed so far, with another 28 lakh having reached the grounding stage. The Centre expects to sanction the entire target next year and complete construction by 2022.

8-year-old girl raped, killed in Nuh

Teen apprehended for assaulting toddler in a separate case

An eight-year-old girl was allegedly raped and murdered and a toddler was sexually assaulted in separate cases in Nuh in the past 24 hours, the police said on Friday.

A 14-year-old has been apprehended in connection with the assault on the toddler.

The eight-year-old girl from a village in Nuh district, had taken her goats for grazing in the forest with her friends on Thursday when she went missing. Her parents found her body on Friday morning and informed the police.

"When she did not return home in the evening with her friends, the family along with the villagers searched for her till late at night. They resumed the search at daybreak on Friday and found her body," said Superintendent of Police, Nuh, Sangeeta Kalia.

The body had injuries suggesting rape, said Ms.

Kalia. A case of murder under the Indian Penal Code and rape under the Prevention of Children from Sexual Offences Act has been registered in this connection. The post-mortem was conducted by a medical board of Nalhar Medical College.

The body was found at an isolated spot inside the forest, she said, adding: "Even if the girl had screamed for help no one would have heard her."

She was strangled to death with her dupatta, the officer said. The suspect was spotted with the deceased's goat by some villagers. "Five teams have been constituted to investigate the case. The suspect is in his early 20s," said Ms. Kalia.

Minimum plummets to 4.2°C, lowest this season

Met forecasts further dip in mercury

It was the coldest night of the season on Friday with the minimum temperature settling at 4.2 degrees Celsius in the Capital with the Met department forecasting that it may slip further in the next few days.

According to the bulletin issued by the Met department, a fresh western disturbance is very likely to affect the western Himalayan region from December 30 night onwards and under its influence, Jammu and Kashmir, Himachal Pradesh and Uttarakhand are very likely to experience light or moderate scattered to fairly widespread precipitation between December 31 and Ja-3 with intensity on January 2.

Under its influence, light/moderate isolated to scattered rain/thundershower is also very likely over Punjab, Haryana, Chandigarh and Delhi during the same period.

The Met said that due to these prevailing meteorological conditions, cold day to severe cold day conditions will continue in Delhi till December 29.

Court allows man to recover ₹24 lakh loan from friend

Cheque issued by borrower was rejected by the bank

A Delhi court has allowed a man to recover ₹24.20 lakh loan from his friend with 6% interest for the period his recovery suit was pending. The plaintiff used to lend

money to his friend as he required it for running his chit fund business. According to the complaint, the lender had lent this amount to the borrower between September 2008 and January 2009. The plaintiff would lend

money and the borrower would issue promissory notes to guarantee repayment. At the time of the repayment, the defendant would issue cheques in his favour and take back the promissory notes.

For this loan amount, the



borrower had also issued a cheque in his favour. But when the plaintiff deposited it for encashment in his bank, it was rejected with the comment that the account of the issuer of the cheque did not have sufficient money to make the payment.

Thereafter, he served a legal notice on him but he did not bother to return the money. Then, he filed a recovery

In his defence, the defen-

dant submitted that the cheque the plaintiff presented to the back was actually a stolen one.

But Additional Sessions Judge Brijesh Kumar Garg dismissed his defence, saying that though he lodged a complaint regarding the loss of the cheque, he failed to inform about it to his bank.

"The defendant has failed to produce on record any written information or instructions issued by him to his banker for stopping the payment of the missing cheques. The defendant has failed to give any such intimation or instruction to his banker till 23.02.2009 or thereafter, when the cheque was returned by his banker for insufficiency of funds," Mr. Garg said allowing the suit.

Court acquits Delhi Police SI and constable in corruption case

Probe officers fail to recover money allegedly taken as bribe

A Delhi court has acquitted a Delhi Police sub-inspector (SI) and a constable in a corruption case as the Central Bureau of Investigation probe officers failed to recover the money allegedly taken as bribe despite laying a trap at the police station where they were posted at that time.

According to the prosecution, the SI had demanded and obtained the money as bribe through the constable at the police station. The constable was arrested and interrogated in police custody for two days, but the bribe money could not be recovered.

The prosecution failed to show that there was any conspiracy on the part of the accused persons for commission of aforesaid offences and that the accused persons had caused

of facts and circumstances, I conclude that the prosecution has failed to prove beyond reasonable doubt that there has been demand of bribe on the part of accused Deepak Vashist and acceptance of bribe money through co-accused

Dharam Pal," Additional Sessions Judge Arvind Kumar said while acquitting the two policemen.

"Admittedly tainted amount has not been recovered. The prosecution failed to show that there was any conspiracy on the part of accused persons for commission of aforesaid offences and that accused persons had caused disappearance of evidence of offence," the Judge further

"Pondering over the ongoing discussion, I am of the considered opinion that prosecution has failed to bring home guilt of accused persons beyond reasonable doubt. Accordingly, I hereby acquit them of all the charges," Mr. Kumar

NGT seeks report on clearance to thermal plant

Plea challenges environmental nod

Following a plea challenging the validity of an environmental clearance granted to a thermal power plant in Bulandshahr, the National Green Tribunal (NGT) has directed the Central Pollution Control Board (CPCB) and Indian Institute of Technology (IIT) Delhi to collect relevant data and furnish a

A Bench headed by NGT chief Justice Adarsh Kumar Goel was hearing a plea moved by NGO Social Action for Forest and Environment (SAFE), which also sought directions to collect ambient air quality for the winter months this season.

While passing its order, the Bench said, "Let the joint committee of the CPCB and IIT-Delhi collect the da-



ta and furnish the same by February 19. The State [Uttar Pradesh] pollution control board may provide requisite logistics to the committee for the purpose."

Earlier, following a report furnished by an expert appraisal committee, the NGT had said, "A proper verified information has to be looked into..." and had directed the Ministry of Environment, Forests and Climate Change to furnish an affidavit.

Rushdie's ancestral house valued at ₹130 crore

There is a dispute over sale of the house between Rushdies and ex-Cong. leader

Salman Rushdie's ancestral house in Civil Lines here, which the globally renowned writer's father had agreed to sell to a Congress leader in 1970 but the deal was stalled due to a dispute between the two sides, has been valued at ₹130 crore by the Delhi High Court.

The dispute had gone all the way to the Supreme Court, which on December 3, 2012, ruled in favour of former Congress leader Bhiku Ram Jain's side, di-



recting the Rushdies to hand over the house to the Jains for the market price as on date of the order.

The apex court, however, left it to the Delhi High Court to determine the market value of the The High Court has now

determined the market value of the property, as on December 3, 2012, to be ₹130 crore, since the Rushdies said they had a buyer to purchase the house at

Justice Rajiv Sahai Endlaw said, however, that if the Jains are unable to purchase at that price, the Rushdies will have to sell the house for ₹130 crore within six months to some other buyer.

Further, if the Rushdies are unable to sell it for minimum ₹130 crore within the given time, 60 days from then, the Jains would be entitled to purchase the property for ₹75 crore which was the circle rate prevailing on December 4, 2012, the High Court said. It said that if the Jains

cannot purchase the property for ₹75 crore, the Rushdies would stand relieved of the agreement entered into by both sides in 1970 with regard to the

Plea challenges environmental clearance granted to solid waste management unit

'Maintain vigil on operation of Gurugram plant'

Following a petition challenging the environmental clearance (EC) granted to an integrated solid waste management unit in Gurugram, the National Green Tribunal has directed the Haryana State Pollution Control Board to maintain vigil on the operation of the plant, while permitting the clearance granted.

Power sector gets a boost in Rajasthan

Mahadayi river dispute: if need be, will go against Union ministry, says Sawant

CM says the case is pending before Supreme Court, people need not be worried

Goa Chief Minister Pramod Sawant on Friday said his government, "if required", would go against the Union Ministry of Environment, Forest and Climate Change in the Mahadayi river issue.

The belligerence comes after the Union ministry on December 24 wrote to Karnataka stating environment clearance (EC) was not required for its Kalsa-Bhanduri drinking water project on the river.

Goa and Karnataka are embroiled in a dispute on sharing of the Mahadayi water, and the former has been opposing the Kalsa-Bhanduri project.

Speaking to reporters after a cabinet meeting in Porovorim, Mr. Sawant said. "The case regarding the Mahadayi river water diversion is pending before the Supreme Court. I would like to categorically state that Goans need not be worried. If required, we will also go against the Union Ministry of Environment, Forest and Climate Change."

High-level meeting

Mr. Sawant has called a highlevel meeting later in the day to chalk out the future course of action. "The Goa government will also write to Prime Minister Narendra Modi seeking his intervention."

The CM hit back at Leader of Opposition Digambar Kamat for suggesting a one-day session of the Goa Assembly, and said "those who allowed the (Mahadayi) water to be diverted have no moral ground to tell government how to act on the issue".

The CM said, during Mr. Kamat's tenure as chief minister (2007-2012), Karnataka managed to divert the river water, but the latter "did

ASI to restore wood-silver casket of Goa's patron saint

The wood and silver casket containing relics of Goa's patron saint Francis Xavier will undergo restoration in 2020 at the hands of Aurangabadbased science branch of the Archaeological Survey of India (ASI) and the work requires immense precision, a senior official said on Friday.

In 1622, the Catholic Church canonised Francis, and his body was placed in a silver casket and kept in the Chapel of St. Francis of Borgia at Bom Jesus Church in 1624. A new casket was made in 1637 by Goan silversmiths.

"We have got approval for the restoration of Saint Francis Xavier's casket in Goa. Some formalities (of the approval) are remaining but we expect the work to start in the new year," deputy superintending archaeological chemist of Maharashtra and Goa, Mishra, told PTI.

"The work is very delicate. The wooden part and the silver plates will have to be treated separately. Minute examination of the casket has to be carried out. The 32 plates which are nailed to the wooden casket need to be removed very carefully," he said. He said it has to be checked if the casket has a termite problem, adding the velvet cloth inside is also tattered.

Mr. Mishra said an ASI team of five to six persons will be part of the restoration work but more experts will be pencilled in if required.

No plan to set up detention centre: Kerala

Chief Minister's Office says the move was initiated by the previous government in 2012

The Kerala government has decided to stop all proceedings related to the setting up of a Foreigners' Detention Centre in view of the "present circumstances." It also maintained that the move to set up the centre "was initiated in 2012 during the term of the previous government."

Responding to a report that appeared in these columns on Friday, a communication issued by the Chief Minister's Office said no files related to the project were seen by the Ministers. The campaign that the State was planning to set up a detention centre was baseless and it had not taken any such decision as reported. A false campaign was being undertaken by some quarters in this regard, it said.

The Centre had asked all State governments in August 2012 to set up detention centres for housing foreigners who had illegally entered the country, or those who overstayed after the expiry of passport and visa documents. It was meant for those who were to be deported to their homeland after completing their punishment here. The Centre wanted the States to draw up proposals in this regard, the communication said.

Following the letter, the Home Department convened a meeting on November 4, 2015. The Social Welfare Department entrusted with the task of setting up the centres immediately outside the police department and jail premises.

On February 29, 2016, the Director of Social Justice was asked to submit a recommendation for setting up the detention centre and a managing committee, consisting of the district social justice officer and a District Police Superintendent, was given the responsibility. The Social Justice wing of

the Secretariat sought information on the likely number of inmates from the Director of Social Justice and from the State Crimes Record Bureau. However, the SCRB did not give any information. The Centre had been sending reminders to the State departments regarding the letter that was issued, it said.

VIIAYAWADA The Andhra Pradesh Cabinet on Friday decided to tread cautiously on the proposal for three capitals for the State, by resolving to constitute a high-power committee to examine both the recommendations of a team of experts led by retired IAS officer G.N. Rao and the findings of Boston Consulting Group (BCG), expected to submit its report in the first week of January 2020, and pick the best of

The members of the committee have not been announced yet.

The government did not make the much-anticipated declaration of Amaravati, Visakhapatnam and Kurnool as Legislative, Executive and Judicial capital cities.

The three-capital move Venkataramaiah. had been vehemently op posed by farmers who had parted with about 33,000 acres under the pooling scheme, and the Opposition parties, mainly the Telugu Desam Party and the Bharatiya Janata Party, which insisted that decentralisation of development (not administration) was the need of the hour.

"Chief Minister Y.S. Jagan Mohan Reddy did not want to make a hasty announcement because he is aware of the concerns raised by farmers in Amaravati and he is committed to doing justice to them and also elicit the opinion of all other stakeholders before going ahead with a particular plan," said Information and Public Relations and Transport (I&PR)

On alleged "insider trading" in Amaravati, Mr. Venkataramaiah said the Cabinet decided to hand over the investigation to the Lokayukta, CBI or the CB-CID after taking legal advice.

He said a Cabinet subcommittee found evidence of the large-scale purchase of lands by elected representatives, individuals close to the former Chief Minister N. Chandrababu Naidu, some companies in which he (Mr. Naidu) owned shares and several benami transactions a few months before Amaravati was declared as the capital in December 2014.

Details of those who resorted to insider trading and dared the government to institute an inquiry would eventually come out, he

Winged visitors flock to Pulicat, with birdwatchers in tow

District authorities plan to conduct annual flamingo festival in first week of January

NELLORE The annual flamingo festival in Nellore district is round the corner with the winged visitors arriving in large numbers on their annual sojourn.

District authorities, who are planning to conduct the festival in the first week of January, say they expect the number of birds to be much higher than usual thanks to copious rains this year.

More than 40,000 flamingos can be seen in action at the lake, said Sullurpeta Divisional Forest Officer M. Hima Sailaja who is overseeing arrangements for the Flamingo Festival from January 3 to 5. "Birds like Black-tailed godwit and Kentish plover, which are rare visitors, have also arrived at the lake this time," Ms. Sailaja said.

A variety of aquatic and terrestrial birds, including painted storks, large and little egrets, grey pelicans, grey herons, and water birds like northern pintails, blackwinged stilts, northern shovellers, common teal, seagulls, terns, sandpipers, and common coots have come in large numbers this time. The lake supports a rich biodiversity and high biomass of fishes, prawns, crustaceans, coelenterates and planktons. "About 75 bird species vi-

sit the sanctuary, of which 30 bird species are migratory. The other feeding migrants that can be spotted are pelicans, painted storks, open-billed storks, grey herons, cormorants, white ibises, spoonbills, egrets, reef herons, and spotbilled ducks," Ms. Sailaja said in a conversation with The Hin-Four venues – Sullurpeta,

B.V. Palem, Atakanithippa and Nelapattu – have been selected for holding various cultural programmes and stepping up awareness on the brackish water ecosystem during the festival as the winged visitors make merry in the 600 sq km area covering the mandals of Tada, Sullurpet, Doravarisatram, Chittamur and Vakadu. The department has arranged for binoculars for nature lovers to view the birds. Educative films on snakes and birds will also be screened as part of the festival, she added.

"She was a great teacher so long as you respected her. She would talk to you - little sounds, indications, et al. and she appreciated a thoughtful response," Sqn Ldr (retd.) Anshuman Manikar fondly recalls his experience of flying the MiG-27 swing-wing fighter jet. He was at the Jodhpur Air Force station on Friday for the ceremony of de-induction of the last squadron of the aircraft with the Indian Air Force (IAF).

This also means that the IAF's combat strength has now fallen to 28 fighter squadrons, way below the authorised strength of 42.

Sqn Ldr Manikar said his best recollection of the fighter jet was low-level, highspeed runs over range, "optimum mix of fun and watchfulness and a complete adrenaline rush."

"Not a drawback really, but fighter trips were so much better, ergonomicswise. But that was a small cost to pay, given the diverse variants she serviced," he told The Hindu.

End of an era

At the 'winding down' ceremony, the aircraft from the No. 29 Squadron (SCOR-PIOS), the only unit in the IAF operating the MiG-27 Upgrades, flew for the last time, marking the end of the variable sweep (Swing Wing) era of the IAF.

To commemorate the historic occasion, the squadron flew in a five aircraft 'Arrowhead' formation, flanked by the Sukhoi 30 aircraft.

The No. 29 Squadron was raised on March 10, 1958 at the Air Force Station Halwara with 'Ouragan' (Toofani)

"The squadron is now slated to be number-plated on March 31, 2020, with December 27, 2019 being its last flying day, thereby making the swing wing fleet a part of the IAFs glorious past," the IAF

"MiG 27 swing-wing fighter aircraft has been the backbone of the ground attack fleet of the IAF for the past four decades," the Air Force said in a statement.

The fleet earned its glory in the historic Kargil conflict, when it delivered rockets and bombs with accuracy on enemy positions, it added

From 1985 onwards, the IAF has flown about 165 MiG-27 fighters, licence-manufactured by the Hindustan Aeronautics Limited.

This marks the end of another Russian MiG series in the Indian inventory. All the other MiG-variants, such as MiG-23 BN & MiG-23 MF and the pure MiG 27 have already been retired from the IAF. The upgraded MiG-21 Bisons and MiG-29s now remain in service of which the MiG-21s are scheduled to be phased out very soon.

The IAF will continue to operate three squadrons of the upgraded MiG-29UPG for sometime, while it is also negotiating for another squadron from Russia.

The Navy operates two squadrons of the MiG-29K/ KUB off its aircraft carriers.

Negatives of 'lost' 1985 Somali epic found at NFAI

'The Somali Dervish' is a masterpiece by Said Salah Ahmed and was last seen in 1985

In an event of great import to the preservation of African cinematic heritage, the negatives of an epic Somali film thought to have been lost were "discovered" in the vaults of the Pune-based National Film Archive of India (NFAI).

The Somali Dervish, a four-hour-long 1985 masterpiece by eminent Somali poet, playwright and filmmaker Said Salah Ahmed, chronicles the revolutionary Somali Dervish movement under the leadership of the legendary anti-colonial fighter Mohamed Abdullah Has-

Hassan is revered as the 'Father of Somali National-

ism' and known by the sobriquet 'Mad Mullah'.

The India connect It chronicles Hassan's twodecade struggle against British colonialism in the late

19th and early 20th centuries

till his death in 1920.

Shooting of the 280-minute film (also known as The Somalia Dervishes) began in 1983 and was completed in 1985. It was produced by an Indian company.

In fact, the film is believed to be the only feature-length narrative motion picture pro-

duced in the country as Somalia's cinematic heritage was buried under the ravages of a bitter civil war, which commenced in the 1980s.

"The importance of the 'discovery' of this film in the NFAI vaults is hard to overstate, given that there is precious little information on Somali film heritage," said Prakash Magdum, Director, NFAI, speaking to The

Mr. Ahmed, who moved to the United States as the Somali Civil War raged across his country in the 1980s, had last seen the film in 1985 in Abu Dhabi, after which it was considered "lost".

Subsequently, he made a string of inquiries in film archives across the globe, in-

cluding the Washingtonbased Library of Congress and film vaults in Paris.

Director delighted

Mr. Ahmed was speechless on learning that the NFAI did have the negatives.

"It is like finding your own child back after so many years," said the 74-year-old Mr. Ahmed, following his visit to the NFAI on Thursday, where Mr. Magdum, along with Ujwal Nirgudkar, consultant, NFAI, handed the reels to him.

Another Somali film, an hour-long documentary titled A future for Somalia (1978), too, was found in the NFAI vaults during the search for *The* Somali

Fuel to the fire

The burden of proof must not be on the people to prove their citizenship

The Union Cabinet announcement on Tuesday that the National Population Register (NPR) would be updated across the country, barring Assam, at an expense of over ₹3,941.35 crore, would have been considered a routine administrative measure but for the myriad concerns among the public about the government's intentions. The announcement on the NPR came amid continuing protests against the recent Citizenship (Amendment) Act (CAA), 2019, in many parts of the country and lingering uncertainty regarding the National Register of Indian Citizens (NRIC), on which senior government functionaries have given conflicting statements. Prime Minister Narendra Modi said on Sunday that the NRIC had not been discussed in the government, but that did not mean that it would not be taken up. His assurance that no Indian of any religion will be adversely affected by the controversial CAA rings hollow, when the government has not cleared the air in unambiguous terms that it has no plans for an elaborate plan to tabulate citizens. The NRC, as it was rolled out in Assam, puts the burden of proof on citizens to establish that they are indeed citizens. The undocumented and the poor will bear the brunt of this approach. The proposed format for enumerating the NPR only exacerbates this concern and adds a third axis to the ongoing confusion and turmoil. It is correct that the NPR is not about citizenship but only about residency. However, when additional questions such as "place of birth of father and mother", etc are being proposed for the forthcoming exercise, the concern that this may be a prelude to the NRIC is logical.

Instead of coming clean and reassuring the public on its plans, the ruling Bharatiya Janata Party (BJP) has sought to muddle the debate further by pointing out that the Congress-led United Progressive Alliance (UPA) had prepared the NPR in 2010. It is nobody's argument that the state should not enumerate the population or collect data on the people – which are all essential for providing good governance. Never in the past, including when a part of India broke away as Pakistan on the basis of religion, did the prospects of a religious test for citizenship appear even remotely in this country. In 2014, the BJP election manifesto explicitly stated that India was a natural homeland for "persecuted Hindus", and Mr. Modi made the now-familiar, and extremely problematic, distinction between "infiltrators" and "refugees". With the passage of the CAA, and the announcement of the NRIC, there is enough factual basis for doubting the government's claim that the NPR has nothing to do with the NRIC. In the current climate of panic among a significant section of the country's poor and the Muslim minorities, the government, at the highest levels must speak up to bolster their confidence in India's constitutional democracy. Equivocation, and polarising grandstanding on the CAA, the NRIC, and now the NPR, may yield political dividends for the government but at a very high cost to the nation. This is the time to douse the fire, not add fuel to it.

Decisive shift

The Chief of Defence Staff could finally bring about unison among the armed forces

The government has acted with reasonable alacrity to create the post of the Chief of Defence Staff (CDS), who will head the Department of Military Affairs (DMA). It was only four months ago, on August 15, that the Prime Minister stressed the importance of creating this post, whereas two Defence Ministers came and went after Manohar Parrikar promised that this move was very much on the government's agenda. To be fair, the delay has been more a result of fears in the minds of the three services – the Indian Army, Indian Navy and Indian Air Force – of how such a development could impact on the role and functioning of the three arms of the armed forces, in terms of curtailing or inflating their importance. There must have been a parallel thought in the bureaucracy how such a shift would affect them too. This move will install the CDS, in the rank of a four star general, as Secretary, DMA.

There is no doubt that the job of the CDS will be exceedingly challenging, a task which is easier set than done. The job calls for total transformation of traditional military mindset. The CDS has to restructure the military commands into appropriate theatre or joint commands for which a critical prerequisite is 'jointness' – a term that envisions the various arms of the armed forces working in unison towards a goal. This is a very tall order, considering India's experience. Since Independence, the armed forces have been working separately, with no concept of jointness. The only jointness that comes into play effectively is when officers of the various services go to courses in, say, Wellington, at the Defence Services Staff College, or at the National Defence College, Delhi. All that will have to change, and change quickly, for a variety of reasons, not least the security environment in the region, with the Americans preparing to move out of Afghanistan and the restiveness consequent to the dilution of Article 370. According to the cabinet release, the new incumbent will have three years to achieve this. It flows from this urgency therefore that the name of the next CDS will have to be soon announced. It is also necessary that the first incumbent is given a term of three years so as to be able to carry the ambitious vision laid out in the cabinet note through to its conclusion. The job is strategic, requires personal supervision, and cannot be left unfinished for the successor to finish. Given the challenges and the limited time-frame within which to accomplish it, allowances will have to be made for attendant hiccups.

In CAA narrative, finding the judiciary's lost voice

This is a watershed moment for the judiciary not to falter and for judges to undo the wrongs of the past

The recent enactment of the amendments to the Citizenship Act have left many, and certainly myself, very disturbed. The legislation itself is undoubtedly problematic and is compounded by the linkages with the National Register of Citizens (NRC). I was a part of a People's Tribunal on the deployment of the NRC in Assam, and we found that even though it was conducted under the aegis of the court, it was a disastrous exercise with terrifying consequences.

The protests that have followed the Citizenship (Amendment) Act (CAA), 2019, were not surprising, but the manner in which the protesters were treated certainly is. The reaction of the law and order machinery to what were essentially student-led peaceful protests has led to incidents of violence and loss of property across the country, which is terribly unfortunate. This is a reflection of the times we live in and signals that the youth in our country have to spend the next significant amount of time battling a leadership that comes across, at once, as communal and authoritarian.

Subdued judiciary

At such times, empathy is but a natural reaction, particularly from a generation that has lived through and seen the worst of the authoritarian regime that was the Emergency. In this context, what I personally feel worse about is that the voice of the judiciary in this narrative is either almost entirely absent or has been overwhelmed by a strong executive.

The CAA is touted as a "fasttrack" means of granting citizenship by naturalisation to what it identifies as persecuted minorities (Hindus, Sikhs, Buddhists, Jains, Parsis and Christians) from three neighbouring countries (Afghanistan, Bangladesh and Pakistan). Those belonging to these communities from these countries will not, as per the law, be regarded as "illegal immigrants".

Restrictive definition

Since the Bill was proposed, and after it was eventually enacted, we have seen multiple perspectives emerge that offer frameworks of different kinds to explain the legislation and the politics surrounding it. The primary, and arguably, the most important view is that the legislation is unconstitutional. It is so for many reasons, not least that it is arbitrary and violates the right to equality before the law enshrined in Article 14 of the Indian Constitution. It deliberately marginalises Muslims as a minority community, and uses religious identity as the basis for granting citizenship. In doing so, it erodes the spirit of the Constitution. There is no legislative basis for singling out persecution of religious minorities as the basis for granting Indian citizenship, just as there is no logic in restricting "fast track" naturalisation to persons from three countries alone. Surely, persecution of any kind ought to be the sole criterion for granting citizenship to immigrants. Restricting the definition of persecution in this manner erodes the premise on the basis of which the republic of India was constructed, and ignores the historical realities of the freedom struggle (founded on principles of equality and diversity) which brought us Independence.

Alternative perspectives exist too, on the opposite side of the

the CAA is not harmful at all and is intended merely to offer amnesty and a speedy route for legitimate migration. Arguably, this narrative – that the CAA is not harmful –is a more important issue than the question of constitutionality, for it tries to sweep under the carpet the grand design that this legislation forms a small part of.

Of a religious nationalism What is the grand design, you may well ask. On the face of it, the implications of the CAA is to isolate individuals who identify as belonging to the Muslim community. If you restrict the understanding of the law, as the government would have it, to applying it only to immigrants, then this law automatically makes Muslim immigrants second class priorities when they are on Indian soil, even though they may have made the long trek to India for the same reasons (poverty, political persecution, etc.) that drove their Hindu or Christian neighbours out. If you expand the understanding of this law, as the government has overtly done (by linking the NRC to the CAA), it has implications of making all Muslims in India second class citizens. In doing so, this law and policy subverts and even destroys fundamental constitutional principles of secularism, fraternity, humanity.

The roots of this lie in the ideolspectrum, fuelling a narrative that ogy of cultural and religious na-

tionalism propagated by Hindutva icons, i.e., Vinayak Damodar Savarkar and his ilk, with Savarkar propounding that the ideal was the "Hindu Rashtra (state), Hindu Jati (race) and Hindu Sanskriti (culture)". In the form of religious nationalism, this ideology envisages a nation under Hindu rule, a Hindu rashtra in Akhand Bharat (a United India), premised on the belief that only Hindus can claim the territory of British India as the land of their ancestry, i.e. pitrubhumi, and the land of their religion, i.e. the punyabhumi. In this context, Muslims and Christians are viewed as foreigners who are not indigenous to the territory of India, and whose religion originated in a separate holy land.

My personal background links up with this narrative in more ways than many would imagine. My maternal grandfather was the president of the Hindu Mahasabha in the 1940s, and the first writings that I was ever exposed to in my school days were Savarkar's works. Writing in 1938, when Hitler was on the rise, Savarkar justified Hitler's policies towards the Jews and driving them away from the motherland. He said, "A nation is formed by a majority living therein. What did the Jews do in Germany? They being in minority were driven out from Germany." While absorbing what I read as a child, and admiring (even now) his poetry, I was also always questioning the Mahasabha as an institution, attempting to understand what prompted their actions. Even in those times, I was especially struck by Savarkar's obsession with Fascist dictators of the times. notably Hitler and Mussolini.

The ideological positions on marginalisation, majoritarianism, and constitutionality taken by the Hindu Mahasabha and its successors have been consistent, but in their consistency, they have also

revealed flaws in holding on to an imaginary idea of a Hindu rashtra, and disengaging from the reality of a culturally, linguistically, and religiously diverse, modern India.

Because the CAA is immoral, a people's movement is inevitable and necessary, for otherwise the fundamental principles on which the constitutional idea of India rests will be destroyed for something that can render deep wounds

A turning point

In the wake of the CAA protests, the Chief Justice of India reportedly said that if people/protesters wanted to "take to the streets", then they need not approach the courts. Some could read this statement as a sort of warning that good behaviour was a prerequisite for obtaining justice. In any event, in a democracy, protest and a recourse to the judiciary are options that are legitimately available to the people. Indeed, to dissent or protest is the lifeline of a democracv. But, what is the judiciary supposed to do when society as a whole is protesting? In such a scenario, as is playing out now, there is no clear line that can be drawn between declaring protesters as good or bad.

Historically, Indian courts have had a chequered history in tackling circumstances where they are the final arbiter. Especially when faced with a powerful executive, courts have tended to falter, the Emergency being a case in point. This is a watershed moment for this generation of judges to undo the wrongs done by their predecessors 40 years ago to the people of India. We eagerly await these reparations.

How not to counter economic stagnation

The government has to garner resources and give a boost to the economy by increasing its investments



he Centre and the States are so short of resources that their fiscal deficit is burgeoning. The Prime Minister, at a function of the Associated Chambers of Commerce and Industry of India recently, was optimistic but the Reserve Bank of India (RBI) Governor was less positive, admitting that the country's economic problems are also structural. The government has argued that its structural reforms would pay dividends in the long run. Whether or not that happens, action is needed now. So, what should the govern-

Impact on tax revenues

It has to give lead to the economy since the private sector, in its reaction to the slowdown, has lost confidence and is investing less, which is only aggravating the economic crisis. An RBI report suggests that business confidence, consumer confidence and capacity utilisation are down. So, there is no escaping the fact that the government has to garner resources and give a boost to the economy by increasing its investments. But the slowdown has adversely im- & pacted growth of tax revenues.

The government calculated tax revenues on the assumption of a 12% nominal growth. But, it has been around 9%, both last and this year. So, in 2018-19, tax revenue was short by about ₹1.5 lakh crore. But this was not reflected in the ing rates. Mercifully, that did not planning for the 2019-20 Budget. Therefore, given that the base for taxes cannot fill the resource gap. calculating tax revenue this year The States have also been comwas wrong and the rate of growth is incorrect, the revenue shortfall for the Centre will be even larger than last year - around ₹2 lakh

The States get 42% of this revenue so they will get ₹84,000 crore less. Further, the concessions in corporate taxation of ₹1.45 lakh crore will also mean ₹58,000 crore less revenue for the States. While the Centre has obtained ₹1.76 lakh crore from the RBI's reserves, no such succour is available to the States. The Centre will also get the proceeds of disinvestment but that is not shared with the States. In brief, the States will have a larger shortfall in resources than the Centre. So, what can they

The Goods and Services Tax (GST) Council met on December 18, where it was expected to help raise more indirect taxes by rais-



occur. So, revenue from indirect plaining that they are not getting the funds that are due to them from the Centre. The Centre has partly responded to this by transferring more, but that raises its

The Centre is required to give the States: their share of Integrated Goods and Services Tax (IGST) and compensate them if the revenue growth of State Goods and Services Tax is less than 14%. This last is to come from the cess collected on sin goods and luxury goods. One of the big contributors to GST has been the auto sector, but with sales falling over the last 10 months collections have declined. The Centre is apparently holding back the States' share of IGST and arguing that the cess collection is inadequate to compensate the States for their shortfall.

The dilemma is that if the GST rates are increased, prices would rise and demand would further slump, further aggravating the slowdown and shortfall in revenues. One of the suggestions has been to raise the 5% slab to 6% or 10%. It has also been suggested that taxes on petro goods and liquor for human consumption are under the purview of the States, and they can raise tax rates on these items. But these will be inflationary moves and demand would fall.

The problem is compounded by the shortfall in direct tax collections. This is both the result of corporate tax concessions and the slowing economy. Income-tax rates cannot be raised now since that would be seen as inequitable - rich corporates will pay a lower tax rate than the middle classes, who pay income-tax.

Effect of I-T reduction

There is pressure to reduce income-tax rates to boost demand in the economy. But a cut in incometax rates will largely benefit less than 2% of the citizens who pay a significant amount of income-tax. They are well-to-do and unlikely to increase consumption. Similarly, the cut in corporate tax rates will not boost demand since neither investment nor consumption will rise. Investment will rise only when capacity utilisation improves. Much store is being laid at the doors of multi-national corporations relocating their factories from China to India but this will be too small to arrest the current declining trend in investment in In-

Unorganised sector missed

The problem has been that government has been in denial and delayed action till after the Budget in July 2019. Even then it catered to the corporate sector slowdown and not where the problem originated from: the unorganised sector. The concessions to the corporate sector have narrowed the fiscal space available without raising demand.

If the unorganised sector is separately accounted for, the economy is in a recession – it is not just a slowdown as official data based only on the organised sector indicates. The fiscal deficit at all levels of government is already high so a policy decision is needed on how much more it can be. If the fiscal deficit is allowed to rise further, extra resources can be used to boost incomes in the unorganised sectors through greater public investments. In the 150th year of Gandhiji, his talisman, "last person first" is the need of the hour.

A divided State's capital conundrum

After 5 years of planning on using 33,000 acres of pooled land for an unfinished mega capital, Andhra Pradesh is now exploring newer options. **Appaji Reddem** recounts the promises and realities of Amaravati, and the impact the new government's three-capital proposal has had on the region's farmers

The Andhra Pradesh (A.P.) government's three-capital proposal has stirred a hornet's nest and rattled the 25,000-odd farmers who parted with their land, totalling more than 33,000 acres, for a world-class 'Amara-

Speaking on December 16, the last day of the Legislative Assembly's winter session, Chief Minister Y.S. Jagan Mohan Reddy said the idea of one flamboyant capital with nine cities, as mooted by his predecessor N. Chandrababu Naidu, was not financially viable and the State could instead have three capitals, which could enable decentralised development. "Visakhapatnam may be the executive capital; Amaravati the legislative capital; and we may have High Court in Kurnool," he said, adding that a mega capital would require an investment of over ₹1 lakh crore which neither the State nor the Central government could afford. "The past (Telugu Desam Party) government spent ₹5,800 crore in five years. The money was sourced through Central funding, Amaravati Bonds and other sources and we are paying a ₹7,000-crore annual interest on that," he claimed.

In the last 10 days, many villages in Amaravati have witnessed protests and rallies by farmers over the government's suggestion to shift the Secretariat and High Court out of Amaravati. On the other hand, the atmosphere in the districts of North-Coastal Andhra and Rayalaseema has been one of jubilation, as the people there feel that they are finally getting their due.

The present insecurities of the Amaravati farmers have their roots in certain unkept promises of the previous government. Owing to multiple issues, the Telugu Desam Party (TDP) government's 'capital efforts' did not progress beyond building temporary structures of the Assembly, the Secretariat, the High Court and permanent residential apartments for bureaucrats and other government staff. Further, the TDP's humiliating loss to Reddy's YSR Congress Party in the 2019 Assembly elections left the farmers high and dry.

Five years since they parted with the lands after being promised the heaven, the farmers now stare at uncertainty. What was once touted to be a worldclass capital city now presents a disappointing picture.

What went wrong?

Multiple factors have contributed to Amaravati's slow growth. One, the Naidu government went against the Sivaramakrishnan Committee's Report. Two, it picked multiple partners for planning and made frequent changes to the plans. Three, there was a delay in the World Bank loan process. And, four, firms from Singapore did not show enough interest in the 'Start-up Area' project two-and-a-half years after they signed a Memorandum of Understanding (MoU) with the government.

Following the bifurcation in 2014, the A.P. government pooled in over 33,000 acres of land from farmers in 29 villages

of the Amaravati region, promising a world-class mega capital. It was planned that Amaravati would have nine other 'cities', including a 'knowledge city' a 'government city' and a 'justice city'. The exercise was initiated to develop the region and pass on the benefits to the farmers.

Unkept promises

Farmers were promised a variety of benefits, including rent of up to ₹50,000 per acre for 10 years; jobs for family members; reimbursement of children's education fees; residential and commercial plots; all major infrastructure facilities like roads, power-lines and drains; and free health cards. However, most farmers complain that the promises were not kept.

Sudharani Boyapati, a farmer from the Krishnayapalem village, regrets not following her instincts while giving away her one-acre land for a capital. While most farmers of her village were willing to part with their land, Boyapati made news by strongly resisting the land-pooling exercise. Though she ultimately had to yield to pressure from the police, revenue and peer groups, she remained sceptical of the government's development promises. Speaking to The Hindu, tears in her eyes, she says: "Today, I feel like crying out loud to my heart's content for my past mistakes. The day I gave away my land was the saddest day of my life. The doubts I raised five years ago have come true today. The undeveloped plots that government gave in return for our land are less valuable compared to the price of our fertile agricultural land."

Prior to the pooling exercise, Boyapati was cultivating four acres of land, including three acres of leased land, making an income of up to ₹1.5 lakh, which she says was three times the lease amount paid by the government. "I wanted to send my daughter for civil services coaching but had to marry her off as the rent paid by the government was nowhere near the income from our fertile land. The promised reimbursement of fees was not given for my son, who is pursuing engineering," she says. The Capital Region Development Authority (CRDA), which undertook the land-pooling exercise, promised farmers that the area would become another Singapore, the farmers' plots appreciate multiple times and there will be a lot of improvement in quality of life, she says.

Financial difficulties are only one of the several problems faced by Pandu (named changed), a farmer at the Nelapadu village where the temporary High Court building came up. Due to lack of physical activity following the landpooling exercise, many farmers began

suffering from lifestyle diseases, he says. "My father was administered a stent in the heart last year. I'm becoming lazy as well. Earlier, agriculture had

He adds: "We are also struggling to fend for our children's school fees. This was not the case earlier. The land-pooling exercise has caused us a lot of mental turmoil as there has been no development here."

On the other side are farmers from the Undavalli, Penumaka and Nidamarru villages, where land is considered more fertile, who did not want to part with their land. While some farmers demanded more compensation, the others simply did not want to lose their primary source of income.

Penumaka-based farmer K.S. Reddy was one of the farmers who refused to give away their land and, as a result, were made to suffer the state's highhandedness. "Our names were erased from revenue records. We were pressured by the police and revenue personnel. Ultimately, we approached the High Court and got a stay order," he says. Koti Reddy, who belongs to the same village, says the government did not fulfil its promises. "The demand for land has now decreased. On top of all these, freeze on cultivation in the 34,000 acres is a disappointing sight for all farmers," he says.

The TDP government was also accused of major manipulations while conducting the land-pooling exercise. It was alleged that political leaders and people close to the government bought land at cheaper prices much before the announcement of Amaravati as the location of the capital. The present government is planning a probe into such accusations of insider trading. Speaking about the issue in the Assembly, Finance Minister B. Rajendranath Reddy said, "People close to Mr. Chandrababu Naidu, other Ministers and their relatives bought over 4,000 acres much before the announcement of Amaravati. These people came from different parts of the State and bought the land. It is some kind of insider trading worth

"What transpired in A.P. was that decisions were taken according to the whims and fancies of a few influential persons ruling the State. There was no consultation with the other political parties. The people of the other regions were kept in the dark. The voices of nose wno opposed the capital city being located in Guntur-Krishna region were gagged or ignored," wrote I.Y.R Krishna Rao, former A.P. Chief Secretary, in his book Whose Capital Amaravathi? back in 2018.

'Not another Hyderabad'

Following A.P.'s bifurcation in 2014, the Union Home Ministry constituted a committee to study the alternatives for a new State capital. The committee, headed by former Urban Development Secretary K.C. Sivaramakrishnan, recommended one major administrative city and several other cities focused on investment, technology and industry. Most importantly, the committee warned the government against building a capital in the Vijayawada-Guntur-Tenali-Mangalagiri (VGTM) region. It stated that the fertile land in the region was essential to ensure food security and agriculture. It instead recommended Donakonda, where ample government land was available, as a suitable location for a new capital.

In contrast to the wishes of the TDP government, which wanted a humongous and world-class capital city, the committee wanted a smaller one to avoid concentration of development and wealth. "The committee is strongly of the view that locating several governmental offices within the VGTM area is both unfeasible for financial reasons and undesirable for decentralised development. It will significantly add to the "honey pot" character, similar to Hyderabad, which in turn will detract from the potential and growth prospects of other centres in Andhra. It is questionable whether the existing government offices in particular commissionerates, directorates etc. however numerous they are, will be able to facilitate or generate economic development or employment by themselves."

The committee further added that it did not consider a single large capital city a feasible option available to A.P. The concentration in Hyderabad of the legislature, the courts and the executive had happened over several years and was a major bone of contention in the bifurcation process, it said.

The committee also spoke of the possible environmental impact of densifying the urban area in the vG1M region. It said there should be least possible dislocation to existing agriculture systems as the districts of Krishna, Guntur and West Godavari comprise some of the best agricultural lands in the country. Also, Guntur and Krishna districts are among the State's most populated areas "Any attempt to convert agricultural land into non-agricultural use will seriously displace this workforce, rendering [it] unemployed; loss of valuable agricultural land and disappearance of small holdings [will] benefit only... the real estate operators," the committee stated.

Further, the committee also made a specific mention of the high water table in the region and the related vulnerabilities. Quoting the reports of the Geological Survey of India (GSI), it stated that the high water table and vulnerable soil types may together lead to severe problems. "Any invitation to government offices and institutions to locate within the VGTM urban area may lead to a construction boom and haphazard development which may, however, seriously strain the existing infrastructure and aggravate the vulnerability of the area," the report pointed out.

Suggesting a decentralised development across the State, the committee indicated that Vizag region in Uttarandhra; the Rayalaseema Arc comprising Kurnool, Anantapur, Tirupathi, Kadapa and Chittoor; and the 'Kalahasti-Nadikudi spine' could be considered for distributed development. Expansion of all existing cities was also another option, said the committee.

Naidu's greenfield capital vision

However, ignoring the committee's suggestions, the TDP government went ahead with its plan to build a huge greenfield capital. As the exercise of land pooling progressed, a grand ceremony was arranged for laying the foundation of the proposed capital. Prime Minister Narendra Modi, on October 22, 2015, laid the foundation stone for the Amaravati capital city, in the presence of several other dignitaries, including Japan State Minister of Economy, Trade and Industry Yosuke Takagi.

On the same day, Singapore's Minister for Trade and Industry S. Eswaran offered the city-state's support. Japanese Minister Takagi and Chief Minister Naidu signed an MoU. rector General of the Japan Bank for International Cooperation, also signed an MoU with the AP government for facilitating foreign investments in the new capital and region. Later, in 2017, following the Swiss Challenge method, the Ascendas-Singbridge Pvt Ltd and Semb corp Development Ltd signed an MoU with the A.P. government's Amaravati Development Corporation to construct the start-up area in about 1,691 acres in the core capital region, abutting the riverbanks of Krishna in Amaravati. Further, a special purpose vehicle was floated for the development of a startup area in which the Singapore consortium was expected to invest about ₹306 crore for a 58%-equity partnership with the ADP.

The State government also sent around 125 farmers, out of the total 25,000, to Singapore to give them some exposure on dealing in real estate and other sectors. The idea was to train farmers for multiple business opportunities. The farmers were also explained in detail how Singapore, which was once a colony of fishing communities, emerged as an economic city.

It also took an inordinately long time of three years for the past government to conceptualise designs for the capital. The government involved multiple firms – like Foster and Partners, a British Architecture firm; Japanese design firm Maki and Associates; the Singapore-government owned Surbana Jurong; and China's Guizhou International Investment Corporation. In addition, the government also involved film directors S.S. Rajamouli and Boyapati Srinu add value to the designs. However, ultimately, there was no official announcement by the government on whether any one design had been finalised.

More than five years since the bifurcation, all structures built in Amaravati - like the secretariat complex, State legislature and the High Court complexremain temporary. The failure of the Amaravati vision was possibly one of the factors that contributed to TDP's massive loss in the Assembly election.

The YSRCP government decided to entrust two panels with the task of providing proposals on a new capital. The report by one of them, the G.N. Rao Committee, which gave the three-capital idea, is currently being analysed by a high-level committee consisting of Ministers and top officials. The second committee, having officials from the Boston Consulting Group, will submit its report in the first week of January.

A final call on the three-capital proposal will be taken only after these two reports are studied.

Prove allegations on CAA, Shah dares Rahul

"I want to tell every citizen of the country that in this Act there's no provision to take away the citizenship of anyone, not even minorities. The Act aims to give citizenship to minorities who have come from Pakistan, Afghanistan and Bangladesh and not snatch it [citizenship]," he said.

"You [the Congress] please do not mislead people. Don't try to destroy the country's peace. If you have the facts, then present them before people," he said.

It was Mahatma Gandhi's desire that after Partition, all non-Muslims who did not

wish to live in Pakistan should be allowed to come to India. In 1950, Prime Minister Jawaharlal Nehru entered into an agreement with his Pakistan counterpart, Liaqat Ali – known as the Jawahar-Liaquat accord - in which both agreed to protect the rights of minorities in both countries.

People had fled these countries to escape religious persecution and seek refuge in India. Through the CAA, citizenship was being given to them and it would not be snatched away from anyone in the country, Mr. Shah said.

Rahul equates NRC, NPR with demonetisation

He also attacked the government for the economic slowdown. The rate of growth had declined from nine % to nearly four % as per the changed technique to assessing the GDP. "But if we measure the growth rate through the old method, then it will just be 2.50 %. Poor people are asking that after robbing them of their entire money, what have got [in return]," ne

Prime Minister Narendra Modi had failed to understand the crisis the country was going through with the ongoing violent protests, crime against women and 45-year high unemployment rates, he said. "He is merely wasting the time of the country. Apparently, he is not able to understand what

happened and how it hap-

"The money of poor people and farmers have been snatched after demonetisation. Ten to 15 people of the country had benefited with ₹3.50 lakh crore...Nobody is buying anything and factories are getting shut. It's simple economics. It seems the Prime Minister is not able to understand it," he said.

Celebrating tribes

Earlier, speaking at the inaugural function of the three-day 'National Tribal Dance Festival, 2019' in Raipur, Mr. Gandhi said farmers and tribal people were the major drivers of the economy, and unless the marginalised and different religions were heeded and unity weaved around diversity, the economic crisis would continue and no jobs

"Without taking everyone along, the economy can't be revived. Every thought and voice must be included in the running of governments, and the Chhattisgarh government is doing precisely that. It has exemplified unity in diversity," Mr. Gandhi said.

The three-day festival will see performances from 1.800 dancers from across India and six nations.

Chhattisgarh Chief Minis ter Bhupesh Bhagel said the State, which had 32% tribal population, had many unique traditions and cultures. "It's our duty to protect their cultures and we have done that. On the one hand, we have won the confidence of farmers and on the other, we have successfully won the hearts of tribal people,"

"In the past few days, there has been widespread protests in colleges, universities and prominent institutions across the country against the government's decision to implement the National Register of Citizens and the CAA. Faced by this massive backlash, the Prime Minister and the Home Minister have indulged in characteristic doublespeak, and are now attempting to covertly undertake the exercise through the National Population Register," Mr. Venugopal said.

He accused the police in BJP-ruled States such as Uttar Pradesh of attacking protesters.

"There were cases of deaths due to police firing at many places. The government has put itself in a bind on these issues with the PM. the Home Minister and the Defence Minister making contradictory statements on different occasions. The CAA proposes to violate the guarantees of Article 14, in contravention of the Constitution of India," he said, adding that the NPR was only a way to implement the

Rahul is 'liar of the year', says BJP

Javadekar picks on his NPR comment

The BJP said here on Friday that Congress leader Rahul Gandhi should be awarded the title of "liar of the year" for his claim that the National Population Register (NPR) was a "tax" on the poor.

Accusing the Congress of trying to fan instability in the country, Information and Broadcasting Minister Prakash Javadekar said the people were with the government on the new citizenship law and NPR.

"The NPR does not involve any monetary transaction and its data is used to identify the poor so that government welfare schemes could reach the targeted people," the BIP leader said at a press conference at the party headquarters, adding that a similar exercise had been undertaken in 2010 as well. "It's the Congress's old game of allowing illegal immigration into the country for political profit. Their own leader Kirip Chaliha had said that former Assam Chief Minister Hiteshwar Saikia had fostered illegal immigration to build vote banks," Mr. Javadekar said.

He called out Chief Ministers Pinarayi Vijayan of Kerala and Mamata Banerjee of West Bengal for issuing notifications to suspend work

Compulsory renewal of OCI cards goes

No need for a certain age group to do so on renewal of their passports

The Union Home Ministry has relaxed the provisions for Overseas Citizens of India (OCI) card holders that made it compulsory for those aged above 50 and below 20 to renew their cards on renewal of their passports.

Several OCI card holders were not able to travel to India due to this and many were stopped by airlines and immigration authorities at various airports due to the mismatch.

According to a recent Home Ministry order, an OCI card holder is required to reregister each time a new passport is issued till 20 years of age and once after 50 years of age but re-issuance of OCI registration is not mandatory each time a

new passport is issued between the ages of 21 and 50.

"In order to facilitate OCI card holders, this requirement has been relaxed till 30th June 2020 as per MHA instructions dated December 17. The OCI cardholder should carry existing OCI card along with Old and New passport," the Ministry spokesperson tweeted.

OCI cardholders are given

benefits on a par with non-Resident Indians in financial, economic and educational fields, except in the acquisition of agricultural or planta-

tion properties.

OCI cardholders are given free multiple entry and multi-purpose life-long visa to visit India and are also exempted from reporting to police authorities for any length of stay in India.

Techies write to govt. against citizenship law

In an open letter, several Indian-origin engineers, researchers, analysts, and designers working with global companies such as Google and Facebook have condemned the Citizenship (Amendment) Act.

The letter, issued "in solidarity with the Indian democracy", was posted through the "TechAgainst-Fascism" handle medium.com.

It called upon technology leaders like Sundar Pichai (Alphabet), Satya Nadella (Microsoft), Mark Zuckerberg (Facebook), Jack Dorsey (Twitter), Dara Khosrowshahi (Uber), Mukesh Ambani (Jio), Gopal Vittal (Bharti Airtel), Kalyan Krishnamurthy (Flipkart) and Shantanu Narayen (Adobe) to take a stance and publicly denounce the "fascist acts by the Indian government". "We call upon the leaders

to use technology as a force for good, to refuse to share user details with the government, refuse to shut off the Internet at the government's whim, provide tools for citizen mobilization, and ensure that content moderation is not skewing pro-government," it said.

The Citizenship Amendment Act, combined with the National Register for Citizens, is a deeply anti-Muslim scheme that will create statelessness and global disparity for Muslims, growing worse with India's economic decline and climate change, said the letter.

The signatories opined that the Act was political and electoral towards building a "Hindu Rashtra". Many signatories remained anonymous "in the face of recent retaliation from tech companies against protesting employees... and from the Indian government on family and loved ones..."

Personal queries directly linked to establishing citizenship: SC

It said this in 2005 order on a plea by present Assam CM

Questions about a person's place and date of birth, his parents' names and their place of birth are meant to ascertain citizenship, the Supreme Court has held.

The court, in a 2005 judgment on a writ petition filed by present Assam Chief Minister Sarbananda Sonowal, has clearly held that these personal questions are directly associated with "establishing citizenship".

"In order to establish one's citizenship, normally he may be required to give evidence of (i) his date of birth (ii) place of birth (iii) name of his parents (iv) their place of birth and citizenship," the judgment, authored by Justice G.P. Mathur for a three-judge Bench of the court, on July 12, 2005 held. Moreover, the court explained that these facts figured specially in the conestablishing citizenship because they "would necessarily be within the personal knowledge of the person concerned and not of the authorities of the



State". In case of doubts about a person's citizenship, the burden of proving that these facts were true was on the person concerned.

The government has so far denied any link between the National Population Register (NPR), which is to establish usual residency, and the National Register of Citizens (NRC), meant to establish citizenship. In fact, the NPR takes into account foreign citizens too. However, if the NPR form of 2020 carries these personal questions highlighted in the judgment, apprehensions raised in the public mind that the NPR is a stepping stone for a nationwide NRC become

justified. The 2005 judgment came zenship (Registration of Citizens and Issue of National Identity Cards) Rules of 2003 was notified in December 2003. The Rules clearly linked the NPR and the NRC. Rule 4(3) of the Citizenship Rules states that personal details collected for the 'Population Register' would be used in the preparation of the National Register of Indian Citizens. The Citizenship Rules de-

fine 'Population Register' as a "register containing details of persons usually residing in a village or rural area or town or ward or demarcated area [demarcated by the Registrar General of Citizen Registration] within a ward in a town or urban area". Rule 4(3) mandates that for "preparation and inclusion in the Local Register of Indian Citizens, the particulars collected of every family and individual in the Population Register shall be verified and scrutinised by the Local Registrar, who may be assisted by one or more persons as specified by the Registrar

General of Citizen Registra-

tion".

Income Tax officials pursuing Ambani money trail overseas

'Notice served on the family over hidden foreign assets'

The Income Tax Department has said that it 'exchanged' information regarding "members of the Mukesh Ambani family" over alleged "undisclosed foreign income and assets" in a quarterly meet this month at Ukraine, with seven countries India has pacts with.

Under the Double Tax Avoidance Agreements and Anti-Money Laundering and Countering the Financing of Terrorism pacts, the tax department can expect a response within 90 days from its counterparts in seven countries - Switzerland, St. Lucia, Mauritius, Luxembourg, the U.S., the U.K. and Belgium.

I-T Department officials said even if the response shared under the common reporting system agreed upon by countries as part of the recently signed Automatic Exchange of Information (AEOI) pact, it may take a long time before a 'Letter Rogatory' (LR) could be initiated by the department to

approach authorities in old tax havens.

"We have rarely received a response from these same seven countries in less than 90 days as prescribed, and agreed upon under the two pacts. It will take a long time for us to move ahead in this particular case," said an official, referring to the overseas accounts linked to the Ambani family.

The department reportedly served a notice on March 28, 2019 to the Ambani family under the provisions of the Black Money (Undisclosed Foreign Income and Assets) and Imposition of Tax Act of 2015, regarding holdings in the Capital Investment Trust. E-mailed queries to Mu-

kesh Ambani's flagship firm

Reliance Industries on the issue, didn't elicit a response till the time of going to press. A RIL source told The Hindu, "The company has not received any letter." A media report had

claimed the notice also included names of the three children of Ambani.

The report had claimed the Ambanis had failed to disclose details and holdings in the Cayman Islands-based Infrastructure Company Limited, of which they were also "ultimate beneficiaries."

The Swiss Leaks, in 2015, had named 1,195 Indian accounts, including 14 holdings connected to Capital Investment Trust, found connected to 628 Indians who had accounts in HSBC Private Bank, including the Ambanis.

The collective worth of these accounts was estimated to be ₹25,000 crore in 2006-07.

"The idea is to demolish the misinformation campaign being carried out by some political parties on the new citizenship law, the NRC and the National Population Register," a source said. "The situation is delicate and a dialogue is therefore important," he

'CAA is a glimpse of things to come'

Friday prayers peaceful in U.P.

Internet services were suspended in 21 districts and security was tightened

Amid suspension of Internet services in 21 districts and tight security, Friday prayers concluded "safely" across Uttar Pradesh, a week after several cities and towns witnessed arson and vandalism during protests against the Citizenship (Amendment) Act, the police said.

The number of persons arrested across the State since December 10 in connection with the violence touched 1,246, with another 5,558 persons held in preventive custody, the police said. More than 370 cases have been registered.

Objectionable posts

The police have also arrested 125 persons and registered 95 FIRs for "objectionable posts, rumours, messages and videos" posted on the social media. Action has also been taken in respect of 20,950 posts on the social media, including 10,380 on Twitter and 10,389 on Face-

book, the police headquarters said in a statement.

So far, the police have admitted to 19 deaths during the protests.

In Lucknow, the famous Teele Wali Masiid held prayers peacefully, amid a heavy presence of police and Rapid Action Force personnel outside its gates. After 'namaz' concluded, people

trickled out of the gate and headed home, instead of gathering outside the gate.

Director-General of Police O.P. Singh said the State was peaceful for the fourth day running and law and order was maintained, but there was a strategic deployment of forces at sensitive places which witnessed violence

He said Internet services were temporarily suspended in 21 districts, including the State capital, to prevent "fake news circulating or rumours flying around".

Several well-known activists in Lucknow and Varanasi, including retired IPS officer S.R. Darapuri and senior advocate Mohammad Shoaib, have been arrested.

'No NPR updation in Bengal'

Won't allow any detention centre in State till I am alive: Mamata

Continuing with her opposition to the Citizenship (Amendment) Act, West Bengal Chief Minister Mamata Banerjee on Friday said she would not allow detention centres to be set up in the State.

Ms. Banerjee also said that her government will not allow updation of the National Population Register (NPR).

"They are saying that there will be detention camps. We are in government here in Bengal. As long as I am alive, there will be no detention centre in the State," Ms. Banerjee said while participating in an event in North 24 Parganas district.

Giving an assurance that the people who came to India during Partition or during the 1971 war of liberation of Bangladesh are all citizens, the Chief Minister said nobody will have to leave West Bengal or the country.

'NPR process changed' Speaking on the issue of

NPR, Ms. Banerjee said earlier she had agreed to the exercise. "Later, I came to know that they have changed the entire process. Anything for which the people have to suffer, neither I, nor my government will do it," she said. She, however, did not elaborate on what changes have been brought in the NPR exercise. A communication by the Home and Hill Affairs Department of West Bengal government on December 16, 2019 stated that it has "stayed all activities regarding the preparation/updation of NPR".

Earlier in the day, Ms. Banerjee released a poem on social media composed by her against the CAA and the National Regidster of Citizens. The poem in Bengali titled 'Adhikar (right)', is critical of the current state of affairs in the country.

"Ami to e deshtake chini na/ Ami to eikhane janmaini/ Ami jonmechi Bharatbarshe/ Bibhed korte sikhi ni (I do not know this land, I was not born here. I was born in India, I never learnt how to divide)," the poem states.

12 killed in Kazakhstan plane crash

Nearly 100 people were on board the aircraft that came down soon after take-off and slammed into a house

Twelve people were killed and dozens injured when a plane with nearly 100 passengers and crew on board crashed soon after take-off in Kazakhstan on Friday.

The Bek Air Fokker 100 got into trouble shortly after departing from Almaty, the Central Asian country's commercial centre, on a predawn flight to the capital Nur-Sultan.

It lost altitude during takeoff and broke through a concrete fence before hitting a two-storey building, Kazakhstan's Civil Aviation Committee said. It was not immediately clear what caused the crash.

"The plane tilted to the left, then to the right, then it started shaking while still trying to gain altitude," said businessman Aslan Nazaralivev, who survived the crash. Investigators found marks on the

runway. "Before crashing, the aircraft touched the runway with its tail twice, the gear was retracted," Deputy

Sklyar told reporters. "A commission ... will establish whether this was pilot error or technical issues. The runway was condition."

A survivor told a news website that she heard a "terrifving sound" before the plane started losing altitude. "The plane was flying at a tilt. Everything was like in a movie: screaming, shouting, people crying," she said.

Authorities initially put the death toll at 15 or more but later revised the figure to 12. They said 49 people were in hospitals, some of them in a serious condition.

'Breach of rules' The plane had been carrying 93 passengers and five crew, and the Interior Ministry said the captain was among

those killed. The Ministry said it was investigating a possible breach of flight operation and safety rules, a standard legal procedure. Kazakhstan's aviation committee said it was suspending all flights by carrier

"Those responsible will face tough punishment in accordance with the law," Kazakh President Kassym-Jo-Tokayev tweeted, expressing condolences to the victims and their families. He also ordered an audit of all Kazakh airlines.

Mr. Tokayev declared December 28 a national day of mourning and appointed Prime Minister Askar Mamin to head a commission to investigate the crash.

Israel's Netanyahu sweeps party poll

Vows to win March general election

Embattled Israeli Prime Minister Benjamin Netanyahu told supporters on Friday he would win a March general election after scoring a landslide victory in the leadership primary of his rightwing Likud party.

Israel's longest-serving premier, who faces a corruption indictment as well as a third general election in 12 months, was expected to beat rival Gideon Saar in the leadership primary.

But the convincing margin of victory – by 72.5% to 27.5% – strengthens his position in the party he has dominated for 20 years. Around 57,000 Likud members voted on Thursday - a little less than 50% of those

"Now is the time to unite and bring a tremendous victory for the Likud and the right in the election," Mr. Netanyahu told a press conference.

"Most of the people support the right and support me to lead the government."

In what appeared to be a general election campaign speech, Mr. Netanyahu did not mention the defeated Saar once.

He thanked U.S. President Donald Trump, a close ally, for his support for Israel and said a Likud victory in the next election would bring more achievements."

Likud and the centrist Blue and White party were deadlocked after elections in both April and September, with neither able to command a parliamentary majority under Israel's sysof proportional representation.

Last month, Israel's Attorney General indicted the

prime minister for fraud, bribery and breach of trust over a series of corruption allegations he denies.

Blue and White leader Benny Gantz also used Friday's primary result as a rallying call for the general election.

He said Mr. Netanyahu's victory showed Likud members had "elected a leader facing three indictments. who is seeking to unravel the rule of law and secure personal immunity".

"These elections demand that we place a mirror in front of 'the Netanyahu party' and make the choice for unity, dignity and internal reconciliation."

Third shot

Ofer Zalzberg, Israel analyst with the International Crisis Group think tank, said the result kickstarted the election campaign.

"Netanyahu is going for a third shot, hoping the next election will prove more successful," he said.

"This strengthens his position within the right wing who saw he is still able to achieve victories but it fundamentally doesn't change the arithmetic for the next election."

IS claims it executed 11 Christians in Nigeria

'The killings were in reprisal for the death of former chief Abu Bakr al-Baghdadi and his spokesman'

Jihadists aligned to the Islamic State group have released a video claiming to show the execution of 11 Christians in restive northeast Nigeria.

The footage posted online late on Thursday by the ISlinked propaganda arm Amag showed 11 blindfolded men being shot and stabbed by jihadists from the Islamic State West African Province (ISWAP) at an undisclosed location. "This is a message to Christians all over the world," said a masked man in the one-minute video.

He claimed the killings were in reprisal for the death of IS chief Abu Bakr al-Baghdadi and his spokesman.

IS leader Baghdadi committed suicide in October to avoid capture during a U.S. special forces raid on his hideout in northwest Syria.

In recent months, ISWAP has intensified its attacks on Christians, security personnel and aid staff, setting up roadblocks on highways and conducting searches.

+ 'Climate change caused 15 disasters this year'

Calamities cost \$1 bn each, says a charity

At least 15 natural disasters linked to climate change this year caused damage of over \$1 billion each and seven of them cost at least \$10 billion, British charity Christian Aid said on Friday.

This year is set to be the second hottest year in history and each of the disasters in the report has a link with climate change, Christian Aid said. "From Southern Africa to North America and from Australia and Asia to Europe, floods, storms and fires brought chaos and destruction," it said.

Assembling its report from official figures, estimates by NGOs and aid bo-

dies, scientific studies and media reports, the charity said the disasters displaced millions and caused wides pread deaths. These included the floods that ravaged north India, typhoon Lekima in China, Hurricane Dorian in the U.S., floods in China, floods in the Midwest and southern U.S., typhoon Hagibis in Japan and the Ca-

tliest tragedy at \$25 billion. The charity said the majority of deaths were caused by just two events, in India and southern Africa, which called it "a reflection of how the world's poorest people pay the heaviest price for the consequences of climate



Moreover, it is shown that learning is a continuous process, and the wise person directs what he has learnt to ultimately reach God and get freed from samsara.

'Credit growth + may plunge to 58-year low'

As the GDP growth has plunged to an over six-year low of 4.5% in the second quarter of the ongoing fiscal, credit expansion may plummet to a six-decade low of 6.5-7% in FY20, says a report. Credit growth was a high 13.3% in the previous fiscal, says rating agency ICRA in a report.

This could well be the lowest credit growth in 58 years. The figure stood at a low 5.4% in FY62, according to RBI's annual credit

growth data. Till end-November, credit growth had been at under 8%. "Factors such as muted economic growth, lower working capital requirements and risk-aversion among lenders will compress the incremental credit growth in FY20," the report said.

Investment advisers must do client risk profiling: SEBI

To strengthen the conduct of investment advisers, Securities and Exchange Board of India (SEBI) on Friday asked them to do proper risk profiling of clients and obtain their consent on the same before providing any advice to such investors.

The capital markets regulator also restrained investment advisers from providing free trial for any product and service.

The measures, aimed at further strengthening the conduct of investment advisers while providing investment advice and to protect the interests of investors seeking their advice, will come into effect from January 1, 2020, SEBI said in a circular.

Gross NPAs may rise to 9.9% by next Sept., says RBI report

Reviving twin engines of consumption and investment remains the key challenge, according to Governor Shaktikanta Das

The gross non-performing asset (GNPA) ratio of banks may increase to 9.9% by September 2020 from 9.3% in September 2019, according to an RBI report.

"Stress tests indicate that under the baseline scenario, the GNPA ratios of banks may increase to 9.9% by September 2020 due to change in macroeconomic scenario, marginal increase in slippages and the denominator effect of declining credit growth," the RBI said in its Financial Stability Report. The baseline scenario assumed the continuation of the current economic situation in the future.

The report said state-run banks' GNPA ratios may increase to 13.2% by Septem-

ber 2020 from 12.7% in September 2019, whereas for private banks it may climb to 4.2% from 3.9%, under the stress scenario. Foreign banks' gross bad loans may increase to 3.1% from 2.9% in September 2019.

The report said banks' net non-performing

(NNPA) ratio declined in September 2019 to 3.7%.

The aggregate provision coverage ratio (PCR) of all banks rose to 61.5% in September 2019 from 60.5% in March 2019. "Following the recapitalisation of state-run banks by the government, [all] banks' capital to riskweighted assets ratio (CRAR) improved to 15.1% in September 2019 from 14.3% in March 2019," the report said.

The state-run banks' CRAR improved to 13.5% from 12.2% during the same period. Bank-wise distribution of asset quality showed while 24 banks had GNPA ratios of under 5%, four banks had GNPA ratios higher than 20% in September 2019.

Agriculture, services

The asset quality of agriculture and services sectors, as measured by their GNPA ratios, deteriorated to 10.1% in September 2019 from about 8% in March 2019. For industry, slippages during the period declined to 3.79% from about 5% in March 2019.

The report showed that the share of large borrowers in banks' total loan portfolios and their share in GNPAs was at 51.8% and 79.3%, respectively, in September 2019, lower compared to the 53% and 82.2%, respectively in March 2019. The top 100 large borrowers accounted for 16.4% of banks' gross ad-

vances and 16.3% of GNPAs.

Amid rising macroeco-

nomic worries reflected in falling growth numbers across spectrum, RBI Governor Shaktikanta Das flagged corporate governance concerns across India Inc., including banks, to lift the efficiency of the economy to its full potential. He also said reviving the twin engines of consumption and investment remains the key challenge even while remaining vigilant about spillovers from global financial markets.

Financial system stable despite slow growth

The Reserve Bank on Friday said the country's financial system remains stable despite slowing economic growth. The GDP slowed to a six-year low of 4.5% in the second quarter of FY20, forcing the RBI to slash its growth forecast by 240 basis points to 5% for the fiscal in its December monetary policy review.

"India's financial system remains stable, notwithstanding weakening domestic growth," the RBI said in the Financial Stability Report.

The report said all major risk groups such as "global risks, risk perceptions on macroeconomic conditions, financial market risks and institutional positions" were perceived as medium risks affecting the financial system. However, the perception of risks on various fronts like domestic growth, fiscal, corporate sector and banks' asset quality increased between April and October 2019, it said.

IOB to get ₹4,360 cr. in capital, Allahabad Bank raises ₹1,500 cr.

With second tranche, Centre's stake in IOB to cross 95%

The Centre will infuse fresh capital of ₹4,360 crore in the loss-making Indian Overseas Bank. This would be the second tranche of fund infusion from the Centre. With this, the government stake in IOB is set to cross the 95%mark, said a senior official.

The Centre now holds 94.56% stake. It rose from 92.52% after capital infusion of ₹3,857 crore in October 2019. For the second quarter, IOB had reported net loss of ₹2,253.64 crore, compared with a net loss ₹487.26 crore a year earlier, following a rise in operating ex-

Another public sector lender, Allahabad Bank, has raised ₹1,500 crore through private placement of Basel III-compliant tier-2 bonds with a 10-year tenor.

In an earlier statement, Allahabad Bank had said the Centre had agreed to infuse ₹2,153 crore via preferential allotment of equity shares by the bank during financial year 2019-20. The fresh capital would help the bank in regulatory compliance.

In H1, bank frauds rise to ₹1.13 lakh cr.

Frauds reported by banks during the first half of the current fiscal touched an all-time high of ₹1.13 lakh crore, owing to delay in detection by lenders, according to RBI's FSR report. This involved 4,412 fraud cases of ₹1 lakh and above, as per the report.

In FY19, banks had reported 6,801 cases of fraud involving ₹71,543 crore. "An analysis of the vintage of frauds reported during the FY19 and H1 FY20 shows a significant time-lag between the date of occurrence of a fraud and its detection," RBI's Financial Stability Report said.

Falling revenue risks fiscal parameters: RBI

GST mop-up grows by just 2.5%

The RBI has flagged falling government revenue as a threat to the overall fiscal numbers, with tax and nontax revenues way behind targets. This, along with weaker private consumption and investment, could prove to be a challenge, RBI's FSR said.

The warning assumes importance with revenue mop-up falling and budgeted expenditure crossing 107% as of November, putting a big question mark on the government's ability to meet the 3.3% fiscal deficit target.

mainstay of the government, have grown just 2.5% so far this year against a budgeted 14%, while massive corporate tax cuts have given away ₹1.45 lakh crore of budgeted revenue even as advance tax collections from corporates slipped 5.2% as of the third quarter.

This slice of history aside, the decade has had several turning points of its own: the Baahubalisation of Bollywood, with the Hindi dubbed version of the Telugu-Tamil bilingual, Baahubali 2, beating it in its home turf, Ranveer Singh taking centre stage and the #MeToo movement. We look at these and other big and small mileposts in this ten-year journey...

BMKJ (Bharat Mata Ki Jai) cinema

From vigilante dramas to story lines that take off on government schemes ('Swachh Bharat Abhiyan' became the theme for Toilet: Ek Prem Katha) to the rise of the new, aggressive, nationalist hero who wears his patriotism on his sleeve, as portrayed by Akshay Kumar, Ajay Devgn, John Abraham and Vicky Kaushal, the onscreen notion of patriotism took on a life of its own and peaked with the compelling propaganda and celebration of the "surgical strikes" and "New India" in *Uri*. The Modi makeover was complete before the elections with Vivek Oberoi playing him in PM Narendra Modi.



#MeToo

As the #MeToo movement swept the nation in 2018, 10 men from the Hindi film industry were accused by women of sexual misconduct. Even as Bollywood women took a lead - it started with Tanushree Dutta's 10-year-old sexual harassment claims against Nana Patekar – a misogynistic hero in Kabir *Singh* became the favourite of the masses. Others who made headlines for all the wrong reasons included Sajid Khan, Vikas Bahl, Alok Nath, Subhash Ghai, Rajat Kapoor, Anu Malik, Kailash Kher, Soumik Sen and Raj Kumar Hirani

Getting noticed

Showstoppers who rocked on the side included Pankaj Tripathi, Mohd Zeeshan Ayyub, Vineet Singh, Neena Gupta, Gajraj Rao, Surekha Sikri, Manoj and Seema Pahwa, Vikrant Massey, Ratna Pathak Shah, Swara Bhaskar, Vijay Varma... Right casting became the buzzword and casting directors came into

The new triumvirate

The turn of the decade has thrown a new set of contenders, albeit not starry in the traditional way. Vicky Kaushal with *Uri*, *Sanju*, Manmarziyan and Raazi; Ayushmann Khurrana with <mark>Vicky</mark> Donor, Dum Laga Ke Haisha, Badhaai Ho, Andhadhun, Article 15 and Bala; and Rajkummar Rao with Kai Po Che, Aligarh, Shahid, Trapped and Stree have formed the new boynext-door brigade of stars. Khurrana seems ahead in the race for now with his unique genre of lighthearted, taboo-breaking films defining the 2010s.

Embracing the rainbow...

Has only just begun in the mainstream, uneasily and gingerly at that, with Ek Ladki Ko Dekha To Aisa Laga, Kapoor and Sons and Karan Johar's short in *Bombay Talkies*. And we are not even talking about the relatively offbeat *I Am* and *Margarita with a Straw* here... Delhi Sultanate ruler Alauddin Khilji (Ranveer Singh) in the bathtub with his ghulam (slave) Malik Kafur (Jim Sarbh) in Padmaavat and Tiger Shroff looking longingly at Hrithik Roshan in War. Male bonding got a homoerotic touch. There was pathbreaking bromance in Sonu Ke Titu Ki Sweety with the grandfather (Alok Nath) almost joined at the hip with his bachelor buddy (Virendra Saxena) while the grandmother just couldn't be bothered. A same sex love story with Ayushmann Khurrana – *Shubh Mangal Zyada Saavdhan* – early in 2020 might hopefully push the envelope further in the right direction.

Polarisation and spirit of resistance

As with the rest of the world, Bollywood has been heavily polarised when it comes to politics. As we close the decade the industry is divided on the politics of protest. While Anubhav Sinha, Anurag Kashyap, Sushant Singh, Richa Chaddha and Huma Qureshi are vehemently opposing CAA-NRC, even joining the rallies, Vivek Agnihotri and Ashok Pandit have been expectedly favouring it. The royalty has maintained an uneasy silence and others like Ayushmann and Vicky are being diplomatic in their templated statements.

Buttons up

Péro takes a deep-dive into its decade-long history, with this humble detail that holds it all together

In a year of 'designer' anniversaries, Péro has kept it simple. To celebrate 10 years of her label, Aneeth Arora recently showcased 50 limited-edition jackets from their past 20 seasons. However, what has captured hearts is their Instagram recap, which details how the individuality of their garments is mirrored even in the tiniest of details - from pins and tassels to detailed trims.

The young label has been meticulously documenting and sharing the ways they've built their fun vocabulary, and this includes their 1,043 varieties of buttons. "I think we've crossed 2,000 now," says Delhibased Arora, 36, over a phone call, counting the ones that will be displayed next year. Each post is accompanied by engaging details and anecdotes, like why Péro has horizontal buttonholes.

Turns out, their first handcrafted buttons were so tiny they'd slip out of a vertical buttonhole. Maker videos - of Afghani women crocheting buttons, for instance – have the most engagement, often raking up over 26,000 views. Looking back at the journey, Arora picks five handmade buttons that stand out.

■ The basic Péro button: "With two holes, and [the word] Péro debossed on the surface, this silver button was developed for our first season [2010]. The garments were all white with red stitching, and the buttons were a humble colour [against the fabric]," says Arora, who sought out a jeweller in Udaipur's Old City to make the tiny, ir-



drops of silver. Since then, she's begun using white metal – "because silver is costly and turns black with time" - and has also developed "brass buttons to use against warmer colours".

■ **Heart buttons:** These are rooted in the label's tradition of embroidering hearts into their clothes. "We realised not everybody likes a [prominent] heart on their garments. So, with this, we ensure there's a subtle variation present," she explains.

■ Crochet buttons: "We made crochet buttons in collaboration with Afghan refugees," she shares, adding that the story behind the designs makes them special to the brand. "The women made borders and laces for us. For [a particular] season we didn't use it, but they were dependent on us for work. So we developed these buttons."

Enamel buttons: For their 2015 Autumn/Winter collection, Péro was inspired by military uniforms. "We tried to simulate the insignia of military badges on buttons, and used meenakari techniques," says Arora, "The enamelstyle buttons are very impactful because of their graphic quality."

■ Millefiori: The brand is currently crafting buttons out of polymer using millefiori (meaning "a thousand flowers" in Italian), a technique also used to embellish luxury watches. "You inlay a pattern using polymer clay and cut it", and then arrange the slices together to multiply the pattern. These buttons are being designed for the upcoming season, where the clothes are inspired by florals. "We've used a variety of flowers, such as woven flowers from Banaras, and printed and embroidered flowers of various kinds," she concludes.

Merriment with a dollop of manipulation

Akshay Kumar reclaims his sense of humour even as the sprightly *Good Newwz* turns sentimental

Akshay Kumar has had an interesting funny Wicked, keeling towards the rude, the bawdy and the incorrect; and distinctly his own. His brand of humour has been harnessed well in the past in a Hera Pheri or Bhagam Bhaag and more recently in Jolly LLB2. However, over the last few years, it has largely fallen victim to Kumar's own insistence on playing the self-righteous conscience keeper of the nation – be it Padman, Kesari, or Mission Mangal - or opting to do the brain dead Housefull series.

The good thing about Good Newwz then is that the film gives Kumar a much needed opportunity to shed the boring nobility, let his hair down, and play a normal man-next-door, one who can be despicable and offensive but not irredeemably so.

Kumar is the Mumbai cityslicker Varun Batra, who has it all in life but for a child. While he doesn't have an

ounce of paternal instinct, his wife Deepti aka Deepu (Kareena Kapoor Khan) and his family are bent on him tasting the joys of parenthood. When nothing works, in vitro fertilisation is sought as the way out. All is well; except for a couple from Chandigarh – Honey and Monika (Diljit Dosanjh and Kiara Ad-

vani) - with the same surname, who also decide to use the same fertility clinic. Inevitably, all hell breaks loose when the two sets of sperms get interchanged. Kumar goes about his role with a good mix of poker-faced zing and rakish bluster. Kapoor Khan is a perfect foil to him with her refinement,

cussedness, and a very defined sense of purpose. Dosanjh and Advani amplify the boisterous, kitschy Punjabi stereotype but they play it with an infectious cheer. The disparate worlds collide but eventually come to co-exist. And then there is the third couple, the doctors, underplayed with great relish by

Adil Hussain and Tisca Chopra. The sharp lines, clever wordplay and repartee (writers Jyoti Kapoor, Raj Mehta and Rishabh Sharma) and actors' on-point comic timing, all feed off each other, and keep things playful for the most part.

It's the soppy sentimentality towards the end that's a wet blanket. Also, the film tries hard to balance itself between the progressive and the conservative and is not able to be either. On the one hand is the easy and unapologetic way of dealing with the unconventional fulcrum of the story - sperm - as Vicky Donor had done earlier. On the other is the inability to take a clear stand on issues - it almost walks into a minefield when it comes to ideas of motherhood, abortion, and adoption. Are women incomplete if they have chosen not to become moms? Is the birth of a child always a joyous thing for a woman? What about the postpartum blues?

You have Kapoor Khan giving an impassioned, powerful speech on what motherhood does to a woman physically and psychologically – but the overarching virtues and romanticisation of it, all stay, rather strongly underlined, ironically, by a gynecologist. Then there's the "apna toh apna hota hai (one's own)" angle: the perpetuation of one's genes, name and family above all else. It's a damper of morality and manipulation after an uninhibited and irrepressibly refreshing start.

Character-driven

Gul's character in the series, Anupriya Tiwari, hails from a broken background. She is a stockbroker who finds herself in a sticky situation and is forced to reach out to gangster Amarpal Singh for protection. From then on, she slowly gets involved in his operations and soon begins to change the way

the business functions. bringing her own past experience into mix. A

methodical, intelligent and level-headed woman, Gul's character lends shrewdness to a process that had until then been dictated primarily by violence.

Challenging roles

Gul recently appeared in Amazon Prime Video's spy series The Family Man. Looking back on her experiences working in the new medium, she observed that for actors, the approach remains largely unchanged across cinema, television and the digital format. The new medium, she feels, poses a challenge, especially for writers and directors who compete with an abundance of impressive web content while striving to keep audiences engaged over several episodes.

"It is a great time to be an actor," she admits. Reflecting on the choices she has made in a career where she has juggled various interests, Gul points that she has managed to play diverse characters in a variety of genres over the years.

"Acting has been one of the things that I have pursued in my life, and to that end, I cannot complain either about the quality or quantity of work. I am very content with the kind of work I am doing," she asserted.

Weird is beautiful

A family film for the holiday season, *Spies in Disguise* is a fun mash-up of comedy and action complete with a emotional wallop

There's this thing about even the most mediocre of animation films: the story might be simple, the arc entirely foreseeable, and you know for sure that all will eventually turn out well; but the bunch of animated characters, their inner compulsions, quirks and relationships, somehow manage to strike a chord. Then there are the myriad life-lessons, which can easily lapse into cheesiness but turn out exalting. Spies in Disguise is one such film simple rather than spectacular – that, despite the predictability, sports a good-hearted gentleness, and an old-fashioned cheer.

It is about the young misfit genius Walter Beckett (Tom Holland) who could edit the human genome while still in middle school, and graduated from MIT at the tender age of 15. Walter is into de-

Ultimately it's nonviolence and the device of a "hug" that wins the day, something the world needs in good measure today.

The film "Walterises" the most cynical of souls and makes us see that weird is indeed beautiful.








Brian Lara is best remembered for the numbers he stacked up. Knocks of 375 and 400 not out came 10 years apart and saw him set, and regain, the world record for the highest Test score. He remains the only batsman to score 500 runs in a First Class innings. But here comes a contradiction. Lara never looked at numbers. The evidence lies in the fact that he retired from international cricket when just 47 short of 12,000 Test runs and after having played 299 One-Day Internationals! In this interview, the legendary left-hander, now 50, reflects on various aspects of cricket, past and present. Excerpts:

First of all, Brian, how did you manage to bat on and

■ I remember when I scored my first hundred in Australia, there was a rain-break and I came off the field. My coach at the time was Rohan Kanhai and he said to me, "Set your score." And I asked,

Kohli is cricket's version of Cristiano Ronaldo. I think he's taken fitness to another level. He is leading the charge, not just in India but around the world. His mental strength is unbelievable

> "What do you mean by that?" And he said, "Your next innings starts at zero." So what he meant was, he wanted me to make full use of the opportunity, when I was out there, while I was in form, the bowling team was tired. So, I fell in love with playing the big innings. I never felt 50 or 100 were enough. I wanted to bat, as they sav in the West Indies, till the cows come home!

While on the subject of scoring lots of runs, anything you recall about the unbeaten knock of 501?

■ Well, that was 25 years ago, in 1994. I remember [playing for Warwickshire against Durham at Birmingham], when I was on 18, I

was dropped. The guy who dropped me was wicketkeeper Chris Scott. Easy catch dropped! And one of the fielders said, "Gosh! Now he is going to score a

What was your secret to succeeding on difficult pitches?

hundred." And I scored 500!

■ Batting a lot at the non-striker's end (laughs). But on a serious note, I learnt that from Desmond Haynes. When I first got an opportunity to open the batting with him, he was the main batsman. So when I asked him this same question, he said, you know, Brian, try to spend a lot of time at the non-striker's end, run singles. In any sort of situation, good or bad pitches, you have to have great respect for the bowler. You have to understand what he's doing. You have to appreciate that there's not just a skill war. There is a mental war going on. And sometimes if you win the mental war, you know, you sort of win the battle. Some guys crumble under the pressure. So, I feel for me, whenever I went to bat, I tried to win that war. I felt I was vulnerable at the very beginning, but as time went on, I played better.

How did you deal with a bad

phase or a loss of form?

For me, when I was succeeding, I wanted to make that period as long as possible. When I wasn't doing well, I truly tried to minimise it... [but] I would always appreciate the fact that things are not going to go well all the time. And I was definitely no Bradman, but I felt that I needed to keep a level head. My favourite saying is from Rudyard Kipling: If you can meet with Triumph and Disaster/ And treat those two impostors just the same. I love this because they are impostors. When you succeed, you can get swell-headed or you can be failing and then you are all down in the doldrums. So,

keep an even keel. And was it difficult being Brian Lara?

I try, as much as possible, to

■ The problem is the fact that I grew up in an invincible West Indies era of the 1970s and the 1980s. Thereafter, things, sort of, went on the decline. I spent most of my career on the losing side when playing against Australia, against England, against India. And that was much more nurtiul than actually playing the game when I got out there to play the game. But I was always having fun. I was always in a place where I wanted to

You were just 47 short of 12,000 Test runs and you called it

a day. Did you not look at the numbers at any point?

■ Never looked at the numbers. People said I looked at the numbers. People felt that I targeted 400, I targeted 500. That's all nonsense. It didn't matter to me when I retired after 299 One-day Internationals. I just felt it was the right time to do so.

From your playing days, how much has international cricket changed?

Obviously, there is a push towards the shortest version of the game. And you have to appreciate the fact that even sponsors are willing to dive into a crick-

et game for three hours, instead of five days. And so do the spectators. We've created through T20 a lot of new spectators. Now, Test cricket has got a boost in terms of creating a league. I always felt that, vou know, whenever I played Test cricket and jumped from country to country, you

rack up the numbers and you win a series or lose a series, there was nothing really added onto So having something that culminates in a Test Championship, I think is amazing.

> Any changes that you suggest? ■ I think that the

ICC will have to do a little bit of brushing up. After all, it's the first year of the cycle. I think, you can't play two Test matches, have 120 points available and play five Test matches and still have 120 points!

And I also believe that in any league that you play, you know, all the participants play an equal amount of games. So they must find a way of doing so. Maybe, if England is playing Australia in a series, you pick three of the Tests that carry points. That should even out a few things.

Is it fair to say that the bowling standards have declined in international cricket?

■ I think it's a seesaw. In some countries, yes. In some countries, no. I think I've never seen a pace attack like the Indians have at present - in my time or even before my time.

Also, nothing can take anything away from the young West Indies bowlers. I know they try their best. But how difficult is it to fill the shoes of a Joel Garner, a Malcolm Marshall or a Courtney Walsh? So, I think, in some scenarios, it has sort of weakened, but in other scenarios, it has strengthened. Saying that cricket was tougher long ago, I don't buy into that all the time. I don't think it's tair to say that το the present-day cricketers. I think that they have their challenges.

What do you think of private leagues mushrooming in the cricketing world?

■ It is a bit worrying because, you know, a player can play five, six different leagues around the world and have no care about playing for

his country. I don't know what position the ICC is in. And I would be wrong to have a major opinion on it, but it is worrying. That's what I would say.

Do you think money has helped the game grow?

■ It has trickled down. It does trickle down to the players, which is great. But money in sport is very good. You get to develop infrastructure, you get to develop young talent when you have the funds to do so. I think it's done India very well, Australia very well and maybe England to a lesser ex-

My favourite saying is from Rudyard Kipling: If you can meet with Triumph and Disaster/ And treat those two impostors *just the same.* I love this because they are impostors. So, I try, as much as possible, to keep an even keel

Before we wind up, your take on Virat Kohli's versatility in all three forms?

■ It's unbelievable. He's cricket's version of Cristiano Ronaldo. I think he's taken fitness to another level. When you see guys in the '70s and the fun that they were having, the fitness level wasn't that great. In 2019, fitness is a major part of the game and Kohli is leading the charge, not just in India but around the world. His mental strength is unbelievable.

Finally, just curious to know if there ever was, or is, a complete batsman in your view.

Yes. Virat Kohli. And if you ask me the greatest batsman ever, it's Viv Richards



Tanmay, Mehdi lead Hyderabad's fightback

Delhi requires another 60 runs to complete an outright win

Skipper Tanmay Agarwal and Mehdi Hasan led Hyderabad's fightback to restore some pride and make Delhi bat again. However, the result of the visitor's Ranji Trophy match remains tilted in favour of the host.

Tanmay scored a century and Mehdi, coming in at No. 8 contributed a fighting unbeaten 71, as Hyderabad lifted itself from 97 for six to 298 on Friday. This left Delhi a target of 84 for its first win of the season.

Bad light stops play

When bad light stopped play 76 minutes before the scheduled close, Delhi was 24 for no loss and stayed in the hunt for a bonus point.

The story of the third day was how Hyderabad's last four wickets added 201 runs and ensured the team lived to fight another day.

Delhi, ahead by 215 runs on the first innings, was eyeing an innings victory after reducing Hyderabad to 97 for six. But what followed was Hyderabad's finest phase in the match.

Tanmay batted much like his opposite number and opener Shikhar Dhawan did in Delhi's first innings. He instilled confidence in the incoming batsmen en route to a century

His patient knock, including a six and 13 boundaries, frustrated Delhi no end.

Useful partnerships

With Tanay Thyagarajan, Tanmay added 93 runs for the seventh wicket, and another 60 with Mehdi for the eighth, before being run

Mehdi, a handy late-order batsman, was far more flamboyant in his approach. His

unbeaten knock was studded with four sixes, seven boundaries and came off just 62 deliveries.

Groin-injury to Pawan Suyal, who left the field during Hyderabad's first innings, further exposed Delhi's limited bowling options.

Ishant scalps four

Like in the first innings, Ishant took four wickets and Simarjeet scalped three.

DDCA members object to 'autocratic' functioning

Some key members of the Delhi and District Cricket Association (DDCA) Apex Council have sought immediate intervention from Ombudsman Justice (Retd.) Badar Durrez Ahmed on the "autocratic" decisions taken in recent times. In fact, one of the directors, Sudhir Kumar Agarwal, has shot off a mail to the Ombudsman and the Board of Control for Cricket in India (BCCI) highlighting the irregularities related to the Annual General Meeting (AGM) scheduled for December 29.

No notice

"As per Section 101 (3) of Companies Act, 2013, Notice should have been given to every Director of the Company. I must have received the Notice of the AGM 21 days before (the AGM) but there was no intimation of the same.

"In absence of proper compliance of the law the forthcoming AGM should be postponed," Agarwal wrote in his complaint, which has been marked to the Registrar of Companies and BCCI.

According to a member of the Apex Council, "Things have gone out of control at the DDCA where the left hand doesn't know what the right is doing. Selectors and coaches are being appointed in an arbitrary manner. Support staff is being increased without any justification and proper process of appointment.

"Strange things are happening. A left-arm spinner has been handed the responsibility of an opening batsman."

DDCA joint-secretary Rajan Manchanda conceded all was not well with Delhi cricket. "I have made repeated complaints to the Ombudsman on the functioning of the DDCA," he said.

In another unpleasant development, connected with the Delhi (under-23) team, two players were sent back from Kolkata on disciplinary grounds ahead of the CK Nayudu Trophy match against Bengal that commenced on Friday. "We were neither informed of the incident nor the process followed for picking the replacements," said an Apex Council member.
