No legal rules framed yet for NRC: Ravi Shankar Prasad

'Hidden elements behind protests against CAA'

NISTULA HEBBAR NEW DELHI

Union Law Minister Ravi Shankar Prasad has clarified that while there is a "possibility" that the National Register for Citizens (NRC) "may take place", it will only be through a due legal process, with rules for it being defined "through adequate consultation".

Speaking to The Hindu, Mr. Prasad said, "Prime Minister Modi has clarified that no discussion has taken place so far. There is a possibility that it [the NRC] may happen, but there is a legal process attached to it; NRC preparation has a distinct legal process to be initiated, with defining of rules with adequate consul-

tations. But nothing has been done so far."

He added that the data for the same "would be collected, scrutinised by the registrars, appeals will be heard, but most importantly, the Registrar-General will have to notify the period and duration of the exercise in the official gazette. Nothing so far, not a word, has been done so far." Referring to the protests

against the Citizenship (Amendment) Act, especially in Uttar Pradesh where 19 people have died so far, Mr. Prasad said, "Hidden elements have joined hands to escalate the violence around the protests. In Uttar Pradesh, that is what happened, and the Internet had to be shut down for that reason."

The Minister said that the CAA was perfectly legal and constitutional, and berated the Congress for not repealing the 2003-04 amendment to the Citizenship Act, which enjoins the government to prepare an NRC.

Exactly a month ago, Uddhav Thackeray had taken oath as Maharashtra Chief Minister, which was seen as a loss for the BJP in the power game in the face of rare Opposition unity. Kin of the dead wait for justice in U.P.'s Firozabad

Six persons died of gunshot wounds during CAA protests

Among six persons killed in Firozabad during protests against the Citizenship (Amendment) Act (CAA), 2019, on December 20 was a differently-abled man with a five-year-old daughter. Another victim leaves behind an ailing and depen-

The dead have been identified as Mohammed Shafeeq, 40, Arman, alias Kallu, 24, Mukeem, 20, Mohammed Haroon, 30, Navi Jaan, 22, Rashid, 27 - all residents of areas along the Rasulpur bypass between Naini Glass junction and Jatavpuri junction.

The stretch was the centre of protests against the CAA, which started from the main market in the Mohammedganj area.

Arman, a labourer, was walking back from his factory when his brother Farman met him and told him to quickly go home because the situation was becoming tense. But as he was crossing the bypass, a bullet hit him on his chest and he died instantly.

People nearby informed his paternal uncle Mohammed Taufeeg that Arman was lying dead by the road. Mr. Taufeeq and others then brought the body home and informed his father Yameen who was at their residence in Azadnagar a few metres away.



"We didn't call the police because they were the ones who shot him. Only the police were firing. Protesters were throwing stones. We kept his body at home that night. We didn't know what to do... that's when our elders came and told us to take him to hospital for a post-mortem and also get an FIR registered," Mr. Taufeeq said.

Mukeem was shot at in front of his uncle Kallu. The two were returning from work at a bangle-making factory.

Seeing the crowds, they started running back when Mukeem was hit at the back by a bullet near his shoulder. "I found a wooden cart, put him on it and pushed about 3 km to the government hospital. He was referred to Agra. He wasn't treated well there; wasn't even cleaned," Mr. Kallu said, adding that he was taken to Delhi where he breathed his last on DecemAt Rashid's house in

Kashmere Gate, his father Noor Mohammed, 59, is feeding his five-year-old granddaughter Afreen. It was chicken and rice for lunch. "We'll take care of her now. She doesn't realise he's gone," Mr. Noor said.

Rashid was differently abled. He couldn't move his right hand. Mr. Noor showed his documents and pictures. "How could he be a protester?" asked the grieving father.

Helpless mother

Navi Jaan of Mohammedganj had gone to the factory in the morning after helping his mother Hakeela Begum to the washroom as she has a knee injury and has difficulty walking.

"He had left the house after lunch. I told him he is not eating enough. He said he'll come back and eat well. He will not come now," Ms. Hakeela sobbed.

M.P. gets its first elephant colony in Bandhavgarh forest

38 elephants that strayed into Bandhavgarh from north Chhattisgarh last year have stayed back

Last November, elephants in herds, 38 of them, wandered into the forests of Bandhavgarh looking for food and water, like each year. A year on, they have stayed back in Madhya Pradesh for the first time over seasons and even bred two new calves, choosing not to return to the withering forests of north Chhattisgarh.

The herd has found plenty of space, food and water within the core area of the Bandhavgarh Tiger Reserve, and that's why it may have stayed back, believes Reserve Deputy

Stating that the species is migratory, and often travels hundreds of miles to look for newer habitats with enough food and water, he says: "The animals came in

Organisers of the demonstration, however, refused to budge saying that their demands must be met first.

In a notice said to be pasted near the protest site and signed by the area SHO and issued on Saturday, protesters have been asked to stop the demonstration with immediate effect. The sit-in has been going

on for nearly a week now with scores of residents and others coming out and lending their support. Protesters, led by housewives, who have pitched tents on the middle of the Noida-Kalindi Kunj Highway, have blocked the road.

The blocking of the road is creating inconvenience

35 detained at U.P. Bhawan protest

Delhi Police on Sunday detained 35 people, including two women, when they staged a protest outside the Uttar Pradesh Bhawan against manhandling of Congress general secretary Priyanka Gandhi by the U.P. Police.

The Indian Youth Congress led by IYC president Srinivas B.V. staged a protest outside the U.P. Bhawan but were immediately detained. The protesters were taken to Mandir Marg and Connaught Place police station and subsequently were released.

Amrish Ranjan Pandey, IYC national media incharge, said that there was a complete breakdown of law and order in the State.

"Priyanka Gandhi was in Lucknow on the foundation day of the party. She was stopped and manhandled by the State Police when she was on her way to meet the family members of a retired IPS officer. We seek investigation into the incident," he said.

Ex-constable arrested after video goes viral

A retired police constable has been arrested for allegedly making a video threatening to shoot protesters agitating against the citizenship law. The video went viral on social media.

Police said that the man has been identified as Rakesh Tyagi, who had taken voluntary retirement in 2014. In the video, he is seen wearing the uniform of a Sub Inspector rank officer of Delhi Police.

A case was registered against him on Thursday by the Cyber Cell and he was arrested. However, he was subsequently released on bail.

In the video, the retired constable can be heard addressing the public saying that the Ministry of Home Affairs had given direc tions to police officials and they will abide by it and save the Constitution. He also said that if he or his fellow officials are pelted stones at, then he will shoot them.

DU's notice on 'prior intimation' for protest opposed by students' groups

They say it is a sign of country turning into surveillance State

A notice issued by Delhi University making it mandatory to give prior intimation before organising protest on the campus was condemned by students' groups on Sunday.

The notice, issued by the university proctor states that prior intimation for gatherings, protests or demonstrations outside the Arts Faculty Gate is mandatory. The organisers will have to furnish particulars of the demonstrations at least 24 hours in advance. These include name of the organiser, their institution, contact information, nature of the programme, its duration, use of logistics,

The notice is a brutal reminder of the curbs which are being placed on the students' and citizens' voice all over the country

list of speakers and the expected number of participants. The notice, however, does not mention any penalty in case these pro-

cedures are not followed. Condemning the move, students' group AISA, in a statement said: "Resistance is our right! We won't seek permission to resist!"

Linking the move with reports of Delhi Police's ap-

plication of face-recognition software, it said that the notice was "another sign of our country turning into a surveillance State." It added that to protest was the Constitutional right of citizens and the students and must be free from any kind of paperwork.

Students' group KYS also condemned the notice arguing that it is an attempt to clampdown on the democratic voice of students. "The notice is a brutal reminder of the curbs which are being placed on the students' and citizens' voice all over the country,"it said, adding that it would be mobilising students against the "diktat" in the coming days.

Court lets off man in drunk driving case with softer punishment

Judge takes into account his old age and family dependency

An Additional Sessions Judge has modified three days' imprisonment to a day's stay in the courtroom till its rising for the day and reduced fine of ₹27,000 to ₹10,000 in a drunk driving case on compassionate ground in view of the old age of the accused and his family dependency.

The 56-year-old accused had pleaded guilty and wanted the court to relieve him of the jail term. He was working as an accounts assistant in a private company.

The public prosecutor opposed the plea submitting that the magistrate court had awarded an appropriate sentence to the accused in view of the fact that cases of drunk driving are increasing

Allowing an appeal by the accused against the magistrate court judgment, Special Judge Vidya Prakash said: "The appellant himself voluntarily pleaded guilty to the offences charged against him and out of remorse. Moreover, he is shown to be old, infirm person aged 56years-old and is doing private job to earn his livelihood. In this backdrop, I am of the opinion that he should be granted at least one opportunity to reform himself instead of sending him behind the bars which would rather affect not only his future prospects but also may also cause great hardship to his family members, who are solely dependent upon him," the Judge said.

High Court was hearing a batch of petitions on non-payment of dues of employees and ex-employees STAFF REPORTER

The Delhi High Court has directed its Registry to release "some interim amount" to teaching and non-teaching staff and ex-employees of schools run by the Delhi Sikh Management Committee (DSGMC) who had moved the court over non-payment of their dues.

167 petitioners

Justice Rekha Palli ordered the Registry to release some interim amounts to "the 167 petitioners in chart I and II to whom amounts are payable

as per the respondents and also to Rajni Naik and Harminder Kaur and the eight writ petitioners in chart No.

The High Court's order came while hearing a batch of petitions all relating to nonpayment of the dues of the employees and ex-employees of the schools run by DSGMC.

Some of the petitions have sought initiation of contempt proceedings against the management for "deliberate noncompliance" of High Court order to pay salary and arrears to the staff.

Other petitioners are seek-

ing directions to the manage ment to release "arrears of salary/gratuity/other terminal benefits in accordance with the recommendations of Sixth and Seventh Pay Commission".

In October, the court had

directed the Directorate of Education (DOE) to determine the dues payable to each of the petitioners after taking into consideration the calculations given by both the DSGMC and the staff. The High Court had asked DoE to work out the dues payable not only as per the recommendations of Sixth Pay Commission but also as per the Seventh Pay Commission by way of a separate tabula-

Latika Chaudhary, counsel for the DoE, contended that in some of the matters, neither the petitioners nor the

management has come forward to assist the Deputy Directorate to finalise the calculations. Taking note of this, the

court asked the petitioners and also the management to approach the Directorate concerned, failing which it will be open for the Directorate to file its calculations on the basis of available record along with an affidavit pointing out non-co-operation by the parties. The court directed that copies of the calculations once finalised would be furnished by DoE to the par-

HC directs U.P. DGP to apologise to inter-faith couple for arresting them

Government to pay ₹50,000 compensation each to duo within four weeks

SOIBAM ROCKY SINGH NEW DELHI

The Delhi High Court has ordered the Director-General of Police (DGP) of Uttar Pradesh to apologise to an interfaith couple, who had eloped against the wishes of the woman's family, for illegally arresting them.

A Bench of Justice S. Muralidhar and Justice Talwant Singh also ordered the U.P. government to pay a compensation of ₹50,000 each to Sandeep Kumar and his wife Nisha.

"The amount should be paid within four weeks along with a letter written by the DGP of Uttar Pradesh himself, apologising to each of them for the conduct of police officials," the High Court

Disciplinary actions

It also directed initiation of disciplinary actions against three U.P. policemen for illegally arresting the couple from Jawaharlal Nehru University campus here with-



out informing the local police station.

The court also accepted the report of a panel comprising former High Court Judge and former DGP of the Delhi Police. The panel had given detailed suggestions as to the protocol to be followed by the police in the event of an inter-State arrest.

It directed that the report be adopted for implementation by both Delhi and Uttar Pradesh in their respective iurisdictions.

The committee had suggested that in an inter-State arrest, since the arrestee is to be taken out of his State to a place away where he may

not have any acquaintance, he may be permitted to take along with him (if possible), his family member/acquaintance to remain with him till he is produced before the jurisdictional Magistrate.

The committee also said the arrested person must be produced before the jurisdictional Magistrate at the earliest, in any case, not beyond 24 hours from the date of arrest, excluding the journey time.

The court's order came on a habeas corpus plea by Kumar, seeking to produce

Nisha before the court in July last. The couple had got married in U.P.'s Ghaziabad in June 2018 as per Hindu customs and rituals after Nisha, a Muslim, embraced the Hin-

After marriage, the couple started living at Kumar's residence at the JNU Campus in Delhi. While Kumar's parents had no objection, Nisha's relatives were unable to reconcile with it.

On a complaint by Nisha's brother in Loni police station that she had been kidnapped, two police officers – a male and a female – from Loni detained the couple. While Nisha was handed to her family, Kumar was kept in a police lockup for three days and two nights.

The court had questioned how the police officials had "so easily come to JNU" and take away the couple, despite Nisha being over 21 years of age, and knowing fully well that she had married Kumar of her own free

BJP's lies on unauthorised colonies exposed on DDA portal: Sisodia

'PMUDAY registration is not for regularisation of illegal colonies'

Deputy Chief Minister Manish Sisodia on Sunday alleged that the BJP was misleading Delhiites by claiming that 1,731 colonies have been regularised whereas the Delhi Development Authority's (DDA) portal states that the PMUDAY registration "is neither regularisation of unauthorised colonies nor the structures therein".

"The DDA's portal was launched by the BJP government on December 16 purportedly to register residents of unauthorised colonies to apply for ownership rights. This came soon after the BJP put up hoardings across the city claiming that the 1.731 unauthorised colonies are now authorised. The BIP's lies have been exposed by the DDA's own website. The Frequently Asked Questions section uploaded on the DDA website clearly states that the PM UDAY registration 'is neither regularisation of unauthorized colonies, nor the struc-

Thousands of hoardings proclaiming them "newly authorised" have been installed by the BJP across illegal colonies in the Capital. This is a move which seeks to say more than meets the eye at first glance, said party

The party aims to erect a total number of 21,000 such hoardings - bearing Prime Minister Narendra Modi's image and seeking to reinforce his claim of having "removed the blot of being unauthorised" from their foreheads over the coming days as part of its electoral campaign, said sources.

"The intent of the hoardings is not just to remind the residents of such colonies about the removal of the stigma of being unauthorised by this landmark initiative of the BJP-led government but also to pitch to them, once again, Prime Minister Modi as the sole face of the party in the city," said a source.

Mr. Modi at his rally at Ramlila Maidan last Sunday, calling the residents of such colonies "VIPs" and asserting that words such as "illegal", "bulldozer" and "demolition" had become a thing of the past after the Centre's decision to confer ownership rights on them post the passage of the National Capital Territory of Delhi (Recognition of Property Rights of Residents in Unauthorised Colonies) Act, 2019 by both Houses of Parliament.

Leave aside the projection of a Chief Ministerial face, the hoardings even exclude BJP national president Amit Shah as well as party's national working president J.P. Nadda in line with its strategy to make the Delhi Assembly elections a direct contest between Chief Minister Arvind Kejriwal and Mr. Modi, a source said.

"The decision to confer ownership rights to the residents of such colonies is a big-ticket decision and the party has no qualms in seeking votes either in relation to the decision or in the name of PM," said Pratyush Kanth, Delhi BIP media in-charge

Left out in the cold

The municipal-run Sheetla Mata Mandir night shelter in Gurugram mainly allows devotees to stay in the facility; staff says 'vagabonds' are denied entry due to security concerns

his December has been one of the coldest that Gurugram has witnessed in the past several decades. But despite nearfreezing temperature, the Municipal Corporation of Gurugram's Sheetla Mata Mandir night shelter was nearly empty on December 24 when The Hindu made an on-spot visit.

In a city where hundreds, including children, spend the night shivering on pavements or under flyovers, the shelter's register for December 23 showed that only 39 people had stayed in the facility, which has a capacity to accommodate 150 people.

The two-storey shelter – one of the largest among the eight such facilities run by the civic body – provides drinking water and toilets. There is also a guard.

The security staff of the nearby temple inform that only devotees are allowed inside the shelter. The facility's guard, Prakash Negi, said that "vagabonds" are turned away as it is not "safe" to allow them inside with the devotees - mostly families with female members.

The 39 people that stayed in the shelter on December 23 were all devotees, he added.

Assistant Sub-Inspector Rajender Kumar, who is attached to the Sheetla Mata police post, said there was no separate space for the devotees and that "the homeless and the worshippers cannot be allowed to stay together". "The vagabonds are mostly drunk, disoriented or drug addicts. What if they misbehave with a woman or a girl devotee? We cannot even ask for their identity cards and most of them do no have it. So, we do not allow the homeless inside. The matter has been brought to the notice of the temple management but the issue is vet to be resolved," said Mr. Kumar, wrapped in a blanket with a heater humming nearby.

Four to five guards are on night duty at the shrine but it is not enough for the sprawling premises, he added.

The devotees throng the temple during Shukla Paksha (waxing moon) on Sundays, Mondays and Tuesdays; the shelter, therefore, lies mostly vacant during Krishna Paksha (waning moon), said the staff.

Other night shelters

Besides the Sheetla Mata Mandir night shelter, the municipal corporation runs facilities in Bhim Nagar and Kanhai village, which

have a total capacity of around 200. The three facilities are situated inside permanent structures. The rest of the shelters, at Rajiv Chowk, Sohna Chowk, Rao Mahabir Singh Chowk (near bus stand), Railway Station and IFF-CO Chowk, run from inside porta cabins with a capacity to hold 8-10 people each.

Two more shelters at Kadipur and Badshahpur are under construction.

No food, water

Most of the people at the Bhim Nagar facility complained that free food was not available this year, unlike the previous years. The canteen providing subsided food at ₹10 per person shut down six months ago.

It had been inaugurated by Chief Minister Manohar Lal Khattar under the Antyodaya Aahar Yojana last year.

Bablu, a daily-wager, said there was also no arrangement for drinking water and the sub-

mersible pump had not been working for the past three days leaving them without a drop of water in the toilets. "There are only two toilets for more than 50 people and one of them has been locked for a long time. It would be better if mobile toilets can be stationed here," he said.

A municipal staff member staying on the premises - the facility has rooms for the Group-D employees – said they have to fetch drinking water from the nearby fire station or buy bottles. He said that the local councillor, Rajni Sahni, who also has an office on the premises, is aware of the issue but has done nothing.

years. He is satisfied with the facilities but rued that there was no arrangement for medicines, not even for common ailments such as fever and body ache.

Rakesh, another inmate, said that most of the people who come to the shelter are drunk and create a nuisance.

Security guard Virender Bahadur Singh confirmed that many people came drunk to the shelter but he was helpless to do anything about the menace.

"At least two guards should be deployed for better management," he said, adding that the shelter recently received around 100 new mattresses and quilts after a gap of several years.

'Looking into issues'

MCG night shelters nodal officer Mahender Singh said he was recently made aware of the issue at the Sheetla Mata Mandir night shelter, and a room close to the another daily-wager, has been a temple's main gate was being re-

shelter.

The officer added that the canteen at the Bhim Nagar facility had shifted to Khandsa Road and that the administration was in talks with private firms to arrange free food for the inmates under the Corporate Social Responsibility scheme.

He also promised to look into complaints of shortage of water, locked toilets and extra guards at the Bhim Nagar facility.

'Need more shelters'

"People, including children, sleeping under flyovers is a common sight at Subhash Chowk, near HUDA City Centre metro station, Civil Lines bus stand and Kanhai village," said Vijay Kumar, assistant project coordinator of CHETNA, an NGO.

He added that the combined capacity of the night shelters in the city should be 1,000, and more shelters should be built along Sohna Road in Badshahpur and the outskirts of the city.

It has been the coldest December since 1997 with minimum temperature dropping to 2.4°C, and forecast show that a western disturbance is likely to bring rain in the first week of January. Under these conditions, those living in the city without a roof over their head have been forced to return to night shelters to stay warm, but in Dwarka, several night shelters are not packed to capacity.

In Sector 10, a porta cabin night shelter is home to 48-yearold Surender Chouhan, a rickshaw puller who works in the vicinity. "I am one of the oldest regular occupants of this shelter and I cannot complain about it. We get proper bedding and blankets here, there is hot water to drink and everything is clean," said Mr. Chouhan.

The cabin has a functional toilet but no bathing facility. Mishri Chawdhary, caretaker

of the shelter, said the cabin can accommodate 25-30 people.

But on any given night, there are never more than 25.

Of the four permanent shelters located in Dwarka, two are situated within 500 metres of each other in Sector 3. While one is for men, the other is for women only. The facilities can accommodate a maximum of 70 people each, although the actual number of occupants remains fairly low.

The shelters have working toilets, a geyser-equipped bathing facility, a television and sufficient bedding.

Yogendra Kumar, caretaker of the men's shelter, said: "We have 150 blankets and around 50 matresses, but only 30-35 people come here every night."

One reason for the low occupancy is that the men do not want to leave their families to come and stay here, he said.

Ranjeet Lal (35), who is unemployed, said: "I have been living here for a year and our caretakers treat us like family. They provide us with everything we need." Another regular visitor of the shelter, Mahesh Joshi (42), who is from Uttarakhand, said: "I come to stay here every winter to look for work and go back in March after the snow clears from my village."

Anonymous "Alcoholics holds a meeting here every evening and I do not allow the people here to smoke or drink. I lived here for two years, and our old caretaker and his supervisors felt I was honest and responsible so they gave me a job here," said Mr. Kumar.

Underutilised facility The women's shelter had just

one occupant. The caretaker, Nidhi Kumari (25), said: " There aren't more than 7-8 women on a usual night. A couple of women come during the day sometimes but that is all."

Despite having the same same facilities as the men's shelter and an all female staff, the shelter has remained underutilised, said Ms. Kumari.

"Sometimes the rescue van brings a few women here but most of them can't leave their family on the road to come stay here," said Poonam Yadav (26), who works at the shelter as a security guard.

These shelters are run by the Delhi Urban Shelter Improvement Board in alliance with NGOs and charitable foundations. While ensuring proper infrastructure and facilities are the responsibility of the government, the NGOs function as management agencies that take care of daily maintenance.

Policemen named in Nehtaur death probe

Suleman was shot dead during CAA protests in U.P. town

Nine days after Suleman died during a protest against the Citizenship (Amendment) Act in Nehtaur town of Bijnor, the complaint of the family of the deceased against six policemen has been accepted and made part of the investigation.

Sanjeev Tyagi, Superintendent of Police, Bijnor, told The Hindu that no separate FIR had been lodged. "The complaint of the brother of Suleman has been accepted and made part of the investigation."

When asked if two contrasting versions could be part of the same FIR, Mr. Tyagi said it was routine and the investigation would reveal the truth.

Those who have been named include the then SHO Rajesh Solanki, Sub-Inspector Ashish Tomar and Con-

Afzal Ahmad Ansari, advocate and uncle of Suleman, confirmed that they were only given a signed copy of the complaint and were told that their FIR had been lodged. "It is against natural justice. The law allows us to lodge a separate FIR. It is up to the court to merge them or not," he said.

Separate FIR

Police sources and media reports had indicated that a separate FIR had been registered against six policemen for killing Suleman during the protest against CAA on December 20. Mr. Solanki was replaced by Satya Prakash Singh three days back.

Mr. Ansari alleged that Constable Mohit had earlier been involved in cases of 'encounters' and his role

was suspect. "The District Magistrate has also promised a magisterial inquiry to the family members but it seems the police were trying to save their own".

Brother's complaint

In the complaint, Shoaib Malik, brother of Suleman, said Suleman was picked up by SHO Solanki, S-I Tomar, Constable Mohit, and three others from Agency Chowk of Nehtaur and was shot dead in the nearby Ghasmandi

police had maintained that the S-I's pistol was snatched by a mob and when constable Mohit went to recover the weapon, he was fired at. When he fired in self-defence, Suleman got grievously injured. The ballistic report had revealed that Suleman was hit by a police bullet.

AMU students to continue peaceful stir

Students of the Aligarh Muslim University (AMU) on Sunday said that they would continue holding peaceful anti-CAA agitation on the campus.

This was decided at a meeting of the general body of the students on Saturday evening and a "coordination committee" was formed to decide the future course of the ongoing stir against the Citizenship Amendment Act.

If PM Modi comes to inaugurate 'Khelo India' games, says students' union president

Intensifying its agitation against the amended Citizenship Act, the All Assam Students' Union on Sunday said a "massive protest" will be organised if Prime Minister Narendra Modi comes to inaugurate the 'Khelo India' games on January 10 in the State capital.

Addressing a press conference, AASU leadership said the organisation is keeping a "close watch" on the upcoming T20 match between India and Sri Lanka on January 5 in Guwahati and the 'Khelo India' games scheduled from January 10 to 22,

"After the Citizenship (Amendment) Act was passed, the Prime Minister is likely to visit Assam for the first time. If he visits for the 'Khelo India', there will be a massive protest," AASU president Dipanka Kumar Nath

He said details will be shared in the coming days after getting confirmation of Mr. Modi's visit to Guwahati.

"Mr. Modi and the BJP are planning to destroy Assam and we will not sit idle. The struggle against the CAA will be a long one. We are fighting a legal battle in the Supreme Court and we have full faith in it. Democratic protests will go on simultaneously," Mr. Nath said.

Demanding immediate repeal of the contentious Citizenship Act, AASU chief adviser Samujjal Kumar Bhattacharva said the organisation will observe all the actions of the government to deviate peoples' attention

from the movement. There are two games happening in Guwahati in the coming days. The first one is the cricket match on January 5 and then 'Khelo India' We are keeping a close watch on both," he added.

When asked repeatedly what he meant by "close watch", Mr. Bhattacharya said, "We will inform in due course of time".

The student leader also asked Chief Minister Sarbananda Sonowal to disclose the source of his statement that only a "negligible" number of illegal Hindu Bangladeshis will benefit by the CAA in the State.

On December 14, Mr. Sonowal had said that people benefitting by the amended Citizenship Act will be "very negligible" in number and the exact number of people will be disclosed at an appropriate time.

Different data

AASU general secretary Lurinivoti Gogoi questioned Finance Minister Himanta Biswa Sarma for quoting different figures of illegal Hindu Bangladeshis residing in the State from the National Register of Citizens. "The government is giving misleading figures like four lakh, five lakh and 10 lakh. They are saying that they got this number from the NRC," he said.

The AASU leadership announced a series of agitational programmes along with 30 other indigenous groups across the State till January 17 and appealed to people to join them in large numbers.

Fresh war of words in Bengal over varsities

Governor, Minister take to Twitter over programme cancellations, protests

Attaching an image of the official communication from the CMO, Mr. Dhankhar said that "efforts to ensure improvement in education scenario seem to be bearing

Mr. Chatterjee, however, chose to tweet details of programme cancellations and the December 24 incident at Jadavpur University, when Mr. Dhankhar was stopped from entering the campus by non-teaching employees triggering a fresh war of words between the two

'Amused at gesture'

The Governor said he was "frankly amused" with the Education Minister's gesture. In his tweet, Mr. Chatterjee wrote, "As you (Dhankhar) have posted a letter of Hon-'ble CM to you on a social media platform, I (am) hereby posting necessary details through the same mode for your kind information..."

The dates of formal programmes pertaining to universities "are fixed and chalked out and cancelled depending upon the circumstances by the Vice-Chancellors. The universities are autonomous bodies and the State government hardly interferes in the discharge of

their duties and responsibilities based on available rules 2019," he said in his missive

to the Governor. Referring to the December 24 incident at JU, when Mr. Dhankhar was barred from entering the campus and protests at the varsity the day before, the Minister said, "incidents happened as the students were agitating against the proposed implementation of National Register of Citizens, CAA and NPR by Centre".

"The students and people of the State reportedly want the withdrawal of the same and are dead against implementation of it in West Bengal," he said.

Mr. Chatterjee also clarified that he was "ready to work with the chancellor, provided his approach is cordial" and amicable, in the best interest of the Education department.

In his reply, Mr. Dhankhar said it was not the time for "tit for tat".

Mr. Dhankhar had said on December 24, after the JU fiasco, that the situation in the State was indicative of a "massive downslide" in the education sector.

He told reporters at Raj Bhavan that he would like to meet the Chief Minister to discuss the matter.

Five arrested in RTI activist's murder case

One accused absconding, say police

Five persons allegedly involved in the murder of RTI activist Abhimanyu Panda at Baliguda in Odisha's Kandhamal district on December 10 have been arrested by the police.

Informing newsmen on Sunday, Kandhamal Superintendent of Police Prateek Singh said Panda was killed due to a dispute over a shop at Baliguda Jagannath temple. The arrested persons included prime accused Biswajit Patra and two hired contract killers from Ganjam district.

Two others, S. Balaii Achari and Rasa Bihari Das, who had acted as mediators between the prime accused and the killers, were also arrested.

Revolver, bullets seized Police investigation has revealed that one more person was also involved in the murder, who is absconding. A hunt is on to nab him.

One country made revolver, three live bullets, six mobile phones and a bike were seized from possession of accused.

According to the SP, the motive for the murder apparently was an ongoing dispute over a rented shop at Baliguda Jagannath temple. Prime accused Patra was running the shop.

The deceased was a key member of the temple's managing committee that wanted to evict Patra which irked him.

According to the police, Patra then decided to eliminate the activist. He allegedly took help of his associates Achari and Das to hire the two contract killers from Aska area of Ganjam district.

They were paid ₹1 lakh for the murder, said the SP.

Killed in front of house

On December 10, Panda was shot dead by two bike-borne persons in front of his house at Baliguda. Kandhamal police had formed five teams to track down the culprits

Basing on evewitness account of the shooters, the police had managed to nab the two hired killers, who later confessed to the crime and named the other accused.

Flare-up on Maharashtra-Karnataka border

Bus services halted on Kolhapur-Belagavi route; Shiv Sena activists burn Yediyurappa's effigy

The long-standing Maharashtra-Karnataka border dispute over the status of Belagavi district witnessed a reigniting of tensions, compelling the police on Sunday to suspend bus services between Kolhapur (in western Maharashtra) and Belagavi (in Karnataka) as a precautionary measure.

Protests by the regional outfit Karnataka Navnirman Sena (KNS) in Belagavi and counter-protests by the Shiv Sena in Kolhapur and Sangli districts prompted the police to stop State Transport (ST) bus services from Kolhapur to Belagavi. The Karnataka police authorities took similar measures, causing bus services to come to a standstill along the Kolhapur-Belagavi route.

Retaliatory attacks

Earlier in the day, KNS activists defaced Marathi hoardings and billboards in Belagavi and adjoining areas. Sena activists, in retaliation, blackened Kannada hoardings and hotel billboards in Kolhapur city. A large crowd of Sena activists also burnt an effigy of Karnataka Chief Minister B.S. Yediyurappa near the Kolhapur ST stand.

Meanwhile, Yuva Sena workers stormed into Apsara Theatre in Kolhapur city and halted the screening of Avane Srimannarayana, a popular Kannada film. They also issued a warning to theatre owners to desist from showing Kannada mo-

State Cabinet to be expanded today

Ministers likely to represent different communities, regions

A month after taking oath as the Chief Minister, Uddhav Thackeray's Cabinet will be finally expanded on Monday and is likely to represent different communities and regions in the State. The swearing-in ceremony will be held at 12 p.m. on Monday at Vidhan Bhavan.

Sunday saw the NCP and the Congress camps go into a huddle to work out a final list of ministers. NCP sources said former deputy CM Ajit Pawar's name figures on the list. Earlier, putting an end to speculation, Shiv Sena mouthpiece Saamana had announced that the Cabinet expansion would take place on December 30.

The Saamana said both the Sena and the NCP would have 13 ministers each, including 10 Cabinet ministers

and three junior ministers. The Congress will have 10 ministers. However, on Sunday, it could not be confirmed if the three parties of the Maha Vikas Aghadi have stuck to the 13-13-10 formula.

Mr. Thorat did not confirm the roles that would be given to former chief ministers Ashok Chavan and Prithviraj Chavan.

NCP sources said party chief Sharad Pawar held a meeting with senior party leaders on Sunday and eight names have been finalised for the post of Cabinet minister: Ajit Pawar, Dilip Walse-Patil, Hasan Mushreef, Na-

wab Malik, Jitendra Awhad, Dhananjay Munde, Rajendra Shingne, Anil Deshmukh. Mr. Pawar reportedly called each of these leaders personally to inform them of their role. The NCP is likely to make Aditi Tatkare, Sanjay Bansode and Datta Bharne junior ministers. Without giving an reason, Mr. Awhad put up posters in Thane thanking the NCP chief and called it a 'fruit of loyalty'.

From the Shiv Sena, form-

er minister Deepak Kesarkar, MLC Anil Parab, MLAs Pratap Sarnaik and Abdul Sattar are likely to get a Cabinet berth. However, there is ambiguity about the prospects of former ministers Ramdas Kadam and Diwakar Raote. There is uncertainty over who will hold the reins of the home department. Sena's Eknath Shinde now holds the portfolio.

Sena-Amruta Fadnavis Twitter spat continues

Party deputy leader calls for conflict of interest inquiry

The war of words on Twitter between former chief minister Devendra Fadnavis's wife Amruta and Shiv Sena deputy leader Priyanka Chaturvedi continued on Sunday.

Responding to the article, Ms. Chaturvedi tweeted, "Surprised that she is calling it vendetta because if it were, she agrees that the former CM favoured moving accounts to Axis Bank as she was employed there. If decision to move accounts was business as usual with zilch involvement of her and former CM then where is the question of targeting?"

Cong. alleges drug use at Sunburn festival, Goa Police say no evidence

Sniffer dogs, three undercover ANC teams deployed at venue

The Congress on Sunday claimed that drug overdose could be the reason for the death of two tourists at Sunburn Music Festival, and it indicated sale of narcotics at the venue.

The Goa Police, however, said no case of drug use or sale has been detected at the festival venue at Vagatore in North Goa district so tar.

The opposition party demanded that the permission for the annual electronic dance music festival, which began on Friday and will end on Sunday, be revoked and an inquiry be conducted. Festival organisers were not available for comment.

Sai Prasad and Venkat, who had arrived from Andhra Pradesh, felt uneasy outside the venue of the festival on Friday while waiting for the gates to open. They were declared dead at a hospital in Mapusa the same evening.

The police said the possibility of drug overdose cannot be ruled out, but are yet to get the autopsy reports.

A Congress delegation, including State Youth Congress leaders Varad Mardolkar, Amarnath Panjikar, Janardan Bhandari and Urfan Mulla, met Utkarsh Prasoon, Superintendent of Police (North), on Sunday, demanding that the permission given to the Sunburn organisers be revoked.

Talking to reporters, Mr. Mardolkar said "similar deaths due to drug overdose" had been reported at the festival in the past. He said, "Two deaths is a clear indication that drug-peddling takes place at the festival. Goa has already got the dubious distinction as a place of drugs. We can't allow the image of the State to

be tarnished further."

Leader of Opposition in the Assembly Digamber Kamat, in a statement, demanded that Chief Minister Pramod Sawant take action before Goa is branded as a "drug destination".

Mr. Kamat said, "I have serious apprehensions about the alleged nexus between politicians, police and drug traders and peddlers in Goa. I have raised this in the past too." He said "drugs have reached the far remote areas of this tiny State" and Mr. Sawant should act "before the Bhasmasur [monster] of drugs turns Goa into ashes".

However, the Anti Narcotics Cell (ANC) of the Goa Police said no case of drug use has been found at the festival venue. Drug-sniffer dogs have been deployed at the venue along with three undercover teams of ANC personnel, the Goa Police said.

Hydropower plants likely in Mahadayi basin'

The Centre will explore the possibility of installing hydropower plants in Mahadayi basin of Goa region if feasible sites are identified, Union Power Minister R.K. Singh has said.

Goa is also looking into the possibility of installing hydropower plants at two of its prominent dams, according to State Power Minister Nilesh Cabral. Mr. Singh met Mr. Cabral at the Power Grid Corporation's facility at Colvale village.

After the meeting, Mr. Singh said if Goa identifies some sites for hydroelectricity projects in the Mahadayi basin, then the National Hydroelectric Power Corporation (NHPC) would look into its feasibility. "If you indicate some sites to us, I will ask the NHPC to investigate the sites, and if feasible, we will set up hydropower plants," he said.

It's never over until it is over. This would be the takeaway from the year 2019 for the Sharad Pawar-led Nationalist Congress Party (NCP). If anyone thought that a regional party with an aging patriarch and eroding base did not have much of a future in the face of Bharatiya Janata Party (BJP) juggernaut, the Lok Sabha polls proved them right, but the Maharashtra Assembly polls told a different story.

The NCP continued its alliance with the Congress for the Lok Sabha, but both the parties fared badly.

The Mr. Pawar-led party only retained its 2014 tally of five seats, four of which came from Maharashtra. The Congress was reduced to a single seat in the State.

As Assembly elections drew near, the NCP was beset by desertions. The party, made up mainly of leaders who rule over individual pocket-boroughs across the sugar-belt of western Maharashtra, saw

several of them jumping ship. Prominent among them was Satara MP Udayanraje Bhosale, a descendant of King Shivaji, who joined the ruling BJP. "At that juncture it

seemed it was a difficult task

to retain even 41 seats won in 2014, our worst-ever performance," said an NCP leader, requesting anonymity. But an aggressive campaign by former chief minister Devendra Fadnavis and BJP chief Amit Shah had an unintended effect, he said. "Fadnavis's comment that Pawar's brand of break-andmake parties was now over stoked the fire in the belly of our workers," he said.

Turning the tables Weeks before the polls, the **Enforcement Directorate** (ED) named 78-year-old Mr. Pawar in a moneylaundering case. The wily politician swiftly turned the tables on the BJP by announcing that he would visit the ED office in Mumbai on his own and offer full

The seer visited Dalit colonies, allowed Muslims to hold iftar near temple complex

Vishwesha Tirtha Swami, the 88-year-old pontiff of the Pejawar Mutt who breathed his last on Sunday, will be remembered for his attempts to negotiate through centuries-old traditions and the demand for radical reform in the modern context. While many of them were controversial, he did not shy away from engaging with this

fraught question constantly. He visited Dalit colonies at a time when it was considered taboo. He attracted criticism from both traditionalists and progressives, who saw it as "tokenism". Noted writer U. R. Ananthamurthy had a running conversation with him throughout his life and once welcomed Vishwesha Tirtha going to Dalit colonies.

Nuanced approach

His outreach to Dalits was both nuanced and complex. "While he seemed to have been influenced by Mahatma Gandhi on eradication of untouchability and reform of Hindu dharma, the outreach was also aimed at retaining Dalits in the Hindu fold, preventing conversions and

building a social base for Hindutva politics," said senior advocate and activist C.S. Dwarkanath.

On 'Made Snana' - the practice where devotees rolled on the plantain leaves containing leftovers after Brahmins had their lunch at Kukke Subrahmanya – the Pejawar seer came up what he considered a solution in the form of 'Ede Snana'.

In the alternative practice proposed, devotees rolled on plantain leaves containing the "prasada" offered to the deity. This is being followed at the Subrah-Temple

Muchlugodu under the jurisdiction of Pejawar Mutt. He had recently welcomed the Supreme Court order allowing women to enter Sabarimala Temple, as well.

He incurred the ire of Hindutva groups when he allowed a group of Muslims to break their fast in the dining hall in the outer periphery of Sri Krishna Mutt/temple complex followed by an Iftar, or "Souharda Upahara Koota" as he termed it, on June 24, 2017.

However, the seer stood his ground, stating that he held it to promote harmony among communities.

"We arrested seven sailors and a few more are being questioned. More arrests are likely soon," Mr. Sawang



Barring three States, none of the governments used even half of the sum

The State governments and the Union Territories utilised a mere 30% of the funds released under the Poshan Abhivaan, or the National Nutrition Mission, since it was launched in 2017.

Barring Mizoram, Lakshadweep, Himachal Pradesh and Bihar, none of the governments used even half of the sum granted in the past three years, according to an analysis of the data shared in Parliament.

The Poshan Abhiyaan, the flagship gramme, is aimed at improving nutritional outcomes among pregnant women, lactating mothers and children by reducing the level of stunting, underweight, anaemia and low birth weight by 2022. It is meant to benefit more than 10 crore people and was launched after a Cabinet decision on December 1, 2017, with a total budget of ₹9,046.17 crore for three years, 50% of which is through budgetary support, which is further divided into 60:40 between the Centre and the States, 90:10 for the north-eastern region and the Himalayan States and 100% for the Union Territories without legislature.

Navy plans 24 submarines to strengthen fleet

18 conventional and 6 nuclear attack submarines are on the cards

To strengthen its underwater fleet, the Navy plans to build 24 submarines, including six nuclear attack submarines, a parliamentary panel was told.

The Navy also told the panel that Medium Refit Life Certification (MRLC) of submarine Sindhuraj was held up since the Russian side had not been able to submit bank guarantees and the integrity pact due to sanctions imposed by the U.S.

In its report tabled this month, the Navy said that there are presently 15 conventional submarines and

A majority of the conventional submarines are over 25 years old. Thirteen submarines age between 17 and 32 years, it said.

vy has been revamping its infrastructure, including procuring new ships.

Due to the delay in the submarine construction projects, including the Six Proiect 75 submarines at Mazagaon Docks, Mumbai, the Defence Ministry has approved Medium Refit cum Life Certification or MRLC of six older submarines, the report stated.

With regards to the MRLC of the first submarine, work has already commenced in Russia on July 16 and is on schedule.

"Contract conclusion for MRLC of second submarine,

'Buzo', a silent sentinel of the Army, is among the more than 150 expert dogs with the military that maintain a tight vigil along the Line of Control (LoC) as well as in the hinterland.

Special skills

The dogs are specialised in three wings - assault (who attack the enemy), tracker (who track movements of the enemy) and explosive detection (who sniff explosives).

The canines posted along the LoC in the heights of North Kashmir are generally 'double-coat German Shepherds' which are best suit-

ed for the climate, while Labradors are used in the hinterland.

Part of family

"Man's most loyal friend is always there with the soldiers during rain, snow or any weather ... they go for all operations with the troops like patrolling and ambush and are especially there during emergencies like avalanche rescue," said. Lt. Gen. Kanwal Jeet Singh Dhillon. Other Army officials re-

called the work of 'Roma', a tracker dog, who alerted her companions and got a temporary camp evacuated earlier this year. An avalanche damaged the field within a few hours.

Earlier this year, 'Meena', a Labrador, had alerted the troops about a possible Improvised Explosive Device, planted on the national high-

way. The warning from the specialised 'explosive detection' dog helped defuse 25 kg of IEDs planted on the highway to target an Army patrol, preventing a Pulwama-like situation.

Another German Shepherd named "Devil", who has been trained as an assault dog, keeps "anti-national" elements on their heels. "He does not spare any of his enemies," says his handler.

Arms and the man

General Rawat crossed the lines of military propriety in making political comments

If a diplomat should think twice before saying nothing, an army general should not think of saving ▲ anything at all. The Chief of Army Staff, General Bipin Rawat, should have known better than to offer his views on political controversies and agitations of the day. In making thinly veiled comments on the protests against the Citizenship (Amendment) Act, 2019, the General crossed the line of military propriety. The egregious remarks on student protests and leadership of agitations constitute a serious error in judgment. If the task of a leader is to lead by example, and in the 'right direction', as he himself put it, then Gen. Rawat, who heads nearly fifteen lakh men in uniform, sent out all the wrong signals. The Army Chief's remarks could have been discounted as an unfortunate slip of the tongue or a one-off instance, if it were not for the frequency with which he weighed in on matters he ought to have been extremely circumspect about, in public at least. Berating students from a seminar podium is bad enough but last year, Gen. Rawat felt compelled to point out, at yet another seminar, that the All India United Democratic Front (AIDUF) - led by Badrudin Ajmal - had grown much faster than the BJP in Assam. "Finally, what will be the state of Assam, we have to take a call," he had said, throwing in the politically incorrect word "lebensraum" into the mix for good measure, while referring to migration in the region. On matters such as education in Kashmir too, the General's unsolicited views have stirred controversies.

It is possible to argue that since the Army is so heavily and continually deployed in these areas, the north east and Kashmir, where the Armed Forces (Special Powers) Act operates, the Army Chief can make comments on other aspects of governance and politics as well. The argument that the Army has a political voice in these States will not travel far, though. Among other things, it reflects the failure of the political class to keep the Army confined to duties that they are meant to carry out. If what Gen. Rawat said was deplorable, what V.K. Singh, the Minister of State for Road Transport, spoke in his support was most unfortunate. Especially since he himself was the Army Chief not so long ago. It is likely to encourage soldiers in the making and those in uniform to move in wrong directions. But it is also notable that not many others have flocked to Gen. Rawat's defence. Allowing chiefs of the three services to make political statements undermines the civil leadership in the long run. It is to be hoped the government makes the lines clear to them so that such incidents do

Governance Index

Marking States on different parameters can incentivise performance

he nation-wide comparative study of States on governance carried out by the Government of India, as seen in the Good Governance Index (GGI), s a welcome exercise to incentivise States to competitively deliver on public services to the citizens. This is not the first time that benchmarking of States has been carried out. Different agencies including NITI Aayog, the government's policy think-tank, are evaluating the States on different parameters. The findings of the GGI's inaugural edition are significant in many respects. Although Tamil Nadu has always had the reputation of being a better-run State, it is only now that it is ranked first in any study of this kind. Its strength has been the ability to ensure stable and smooth delivery of services without much ado. But it is not the only southern State to have put up an impressive performance. Three of its neighbours are among the top 10 of the big 18 States, one of the three groups formed for the study with the north-east and hill States and Union Territories being the other two. Of course, traditionally, the south has been ahead of others in several parameters of development. What is more significant about the GGI is that the dubiously-labelled "BIMARU" States are seeking to catch up with others in development. Of the nine sectors, Rajasthan, a "BIMARU" State, has finished within the top 10 in five sectors, Madhya Pradesh in four and Uttar Pradesh in three. In agriculture and allied sectors, almost all the "BIMARU" States are within the top 10 category and in human resources development, U.P. and Bihar figure. In the composite ranking, Chhattisgarh and Madhya Pradesh are ranked fourth and ninth, respectively. The key message is that these northern States can catch up with others in due course of time, if the political leadership shows the will to overcome historical obstacles and stays focused on development.

Any index of this nature is bound to have some shortcomings, at least in the first round, a feature that the framers of the GGI have acknowledged. Some indicators – farmers' income, prevalence of micro irrigation or water conservation systems and inflow of industrial investment – have been left out. The indicator, "ease of doing business", has been given disproportionate weight in the sector of commerce and industries, to the virtual exclusion of growth rate of major and micro, small and medium enterprises. Moreover, there will always be an unending debate over which indicators process-based or outcome-based - should get more importance in the design of such a study. Notwithstanding these shortcomings, what is noteworthy is that the Centre has made an attempt to address the problem of the absence of a credible and uniform index for an objective evaluation of the States and Union Territories. It goes without saying that the GGI requires fine-tuning and improvement. But that does not take away the inherent strength of the work that has been accomplished, keeping in mind India's size and complexity.

A dangerous new low in state-sponsored hate

In Uttar Pradesh, police bias and the scale of violence against the minorities are plumbing new depths

ttar Pradesh is in the throes of what is fast becoming a gravely culpable crime against humanity. It may not be an exaggeration to say that the Chief Minister has declared war on the minority communities of his State, inciting and encouraging his police forces to unleash upon them an unlawful and brutal reign of

It is not as though police bias and violence against the minorities is unusual in communal violence. On the contrary, as I have often maintained, communal violence cannot sustain for more than a few hours unless it is actively encouraged by the state and the police. But it accomplishes this, most of all, by culpable inaction; by deliberately standing by as mobs attack minorities. Often the police inflict grievous hurt on a disproportionately large number of minorities, in firing while dispersing

But what we are witnessing in Chief Minister Yogi Adityanath's Uttar Pradesh is the police force itself becoming the riotous lynch mob. I have handled, as district officer, the 1984 anti-Sikh pogrom and the violence resulting from the movement to demolish the Babri Masjid. Since I left the civil service, I worked closely with the survivors of the Gujarat and Muzaffarnagar (U.P.) carnages, and the earlier communal massacres of Nellie (Assam) and Bha-

galpur (Bihar). What is unfolding in U.P. is on a scale and with a methodological deliberateness which I have not witnessed so far outside Kashmir and the North-East – touching a highly dangerous new low.

Devastation in minutes

I walk through many Muslim homes in U.P., my eyes clouding, my heart sinking in shame, witness to their ruin after a rampage of hate by men in uniform. Cars and scooters are overturned and burned, television screens and washing machines smashed, cash and jewellery looted, crockery, even toys shattered, a lifetime of a family's belongings devastated in minutes, the family inconsolable. I have borne painful witness to these scenes too many times, in 1984, 2002, 2013. The difference in U.P. is that the marauding mob which mercilessly wrecked home after home of its Muslim residents was police personnel in uniform.

The accounts of the families were chillingly similar. Homes of relatively wealthy families were typically selected for the police carnage; probably led there by police informers. Hordes of policepersons would descend on the house, sometimes 40 or even 60 in number. Some included civilians, others did not. They banged and broke down doors. They beat with their batons old people, women, even children, if they tried to block their way, pleading for mercv. They shouted the most vulgar slurs. A frequent taunt was: Here, take the Azadi you ask for.

It is with the same communal war cries that armed policepersons attacked students in Aligarh Muslim University, vandalised



Muzaffarnagar, and set fire to shops and businesses owned by Muslim persons.

Thread from the CAA

Many households reported that policepersons said their houses were now "ours", because the law will ensure that they leave for Pakistan. It was evident that the policepersons commonly believed that the Citizenship (Amendment) Act, 2019, or CAA, 2019, would complete what the Rashtriya Swayamsevak Sangh regards to be the "unfinished tasks" of Partition – namely forcing Indian Muslims to exit to Pakistan. A senior police official in Meerut is caught on camera asking Muslims to go to Pakistan, and questioning their loyalty

Women and children showed us their baton wounds. Even the very old were not spared. Teenaged boys were among those rounded up by the police and held illegally for days. Government hospitals were unwilling to treat them if they reported that the injuries were inflicted on them by policepersons.

As in most corners of the country, people spilled onto the streets to protest the CAA. It is only in U.P. and coastal Karnataka that these protests have turned violent. At mosques, raided a madrassa in the time of writing, nearly 20 people have died in these protests in U.P. There are reports that in some places, protesters turned violent, although they claim that the rage of the rioters was spurred by police attitude and action.

But the violence by the police against the rioters is entirely disproportionate, without following the prescribed protocol of warning, and gradual escalation of violence. Instead, videos show police shooting above the waist, often in hot pursuit through narrow lanes where there are no protests or crowds.

Most of those who bear the brunt of the attacks are very poor working-class men, whose families insist had nothing to do even with peaceful protests.

Deep scars

The police registers literally thousands of "unnamed" police complaints in several cities with high Muslim populations. They use this to detain Muslim people at will, and as a weapon to silence anyone who may complain or testify against the police. People are scared to speak to anyone holding a camera, and if they do, they cover their faces. There is an intense sense of terror among the entire Muslim population in urban U.P., the men dreading being charged with grave crimes; the women of attacks to their homes. Large parts of Muslim settlements have emptied out.

Through all of this, there is call for revenge, from the highest political levels, followed by even more brutal police raids and assaults. Muslim people have received notices to pay high damages for alleged destruction of public property (which includes even police batons broken while beating peo-

ple) – without any judicial finding, as required by law, to prove their responsibility for destroying the properties.

Disturbing complicity

And as news begins filtering in of the outrage of police rampaging in U.P., the unrepentant Chief Minister issues a triumphalist message of self-congratulation from his official Twitter account: "Every rioter is shocked. Every demonstrator is stunned. Everyone has been silenced after seeing Yogi Adityanath government's strict actions."

What U.P. is witnessing is the utter debasement of high public office. Senior civil servants, of the police and magistracy, have most shamefully abdicated their constitutional duties in service to a war of hate launched by the Chief Minister. The war of hate against the minorities in U.P. has shades of what the Kashmiri people have endured for three decades, with security forces raiding and rampaging their homes and beating and rounding up innocents. The Chief Minister hand-picked to lead India's most populous State, is emerging as as a mascot of hate. He is guilty of nothing short of crimes against humanity - acts deliberately committed as part of a widespread systematic attack directed by a government against an identifiable part of a civilian population.

As the rest of the country is heady with protests against laws and policies which divide people based on their religious identity, the Muslim people of Uttar Pradesh are today wounded - this time almost beyond healing.

For a humane and autonomous police

During strife, the focus needs to be on improving the quality of policing in the field than on 'politician management'



These are tumultuous times for the Indian police, especially the Delhi police, in their bid to maintain law and order. After losing the debate inside Parliament, certain elements have regrettably chosen to take some contentious issues out to the streets. Consequently, the floor has been unwittingly yielded to the police – and for them to act in the manner they deem fit, and in the interests of public peace.

Binary picture

Protests and demonstrations no doubt form the core of democracy and are unexceptionable as long as they do not disrupt the life of the common man or cause damage to public property. In an ideal world, we may expect this clearcut theoretical proposition to work perfectly. But in the raw, emotion-ridden and violenceprone streets of the present times, this clinical allocation of respective space has, however, repeatedly proved to be mere pontification. This is established by events of the past few days in the national capital. Some media reporting has tended to be one-sided, tending to

portray the police as the villain of the piece and the protesters as harmless and pacifist. This binary picture is deceptive and misleading, because it is blind to the truism that the police do enjoy a measure of operational autonomy, free from the dictates of other state agencies.

Shadow of politics

Public opinion has been built around a few gross misconceptions about modern policing. It is too simplistic and facile to look upon the police as merely an agency that has been caught in the crossfire between the establishment and protesters. Gone are the halcyon days when life was more orderly and civilised, and the police just received orders from above to be executed as faithfully as they could/can and not necessarily at the speed of lightning. The vicissitudes of politics over the decades have deprived the guardians of law the luxury of resting on the statute book and responding to a developing situation.

They will now have to be proactive and react – and react within split seconds to an incendiary situation arising from contentious political situations. While doing so they are bound to overstep the contours of law. This reminds a reader of the classic situation summed up as: (You're) damned if you do and damned if you don't.

It is fallacy to argue that the police cannot enter campuses unless

they are invited to do so by heads of institutions. Nothing can be a greater incentive to violence. I am happy that the Vice-Chancellor of Aligarh Muslim University has been honest enough to admit that he permitted the police to enter his campus to prevent an already ugly situation from becoming

In Jamia Millia, Delhi, the police appeared to have taken the initiative when no such invitation was forthcoming. There is no law that prohibits such police entry on their own, and any attempt to frame such a law will be preposterous to the core. The police are obligated under law to intervene wherever and whenever they apprehend danger to lives. Imagine the not-so-imaginary and improbable situation where the vicechancellor is himself besieged and threatened by a mob of students and others and is unable to communicate with the police. Can the police wait for a nod from those facing danger? If they did and if the VC was attacked or grievously

hurt, the police would be hauled over the coals.

I am reminded here of the statement of the English jurist, Lord Denning, in Regina v Commissioner of Police of the Metropolis (1968): ... (it) is for the Commissioner of Police of the Metropolis, or the chief constable, as the case may be,to decide on the disposition of his force and the concentration of his resources on any particular crime or area. No court can or should give him direction on such a matter... And 'No Minister of the Crown can tell him that he must, or must not, keep observation on this place or that;... The responsibility for law enforcement is on him. He is answerable to the law and to the law alone."

I do not think the position is different in India. If some police leaders have surrendered their autonomy to the Executive, it is their fault and not of the Executive

On the measure of force

Another bone of contention relates to the quantum of force that the police can use in quelling disorder. Some astonishing statements have been made in this context. There is no scientific formula that applies to explosive scenes that have become routine in the national capital

"How much is too much?" is a question that is impossible to answer. The amount of force used in such situations can vary significantly, and will be related mainly to the strength of the mob, its composition, its mood and the kind of weapons it has at its command. Use of stones has become the most favourite, because of ease of availability and potency. To say that the police or any security agency should not overreact to this kind of barbarity is grossly unfair. Ultimately, it is the decision of the police commander in the field.

Mob control techniques are a part of the police curriculum in major training institutions. Their impact depends on the imaginative nature of the instruction. In the wake of violence across the country, the police leadership would do well to concentrate on this important aspect of policing, even if it means according a lower priority to other areas of routine.

In a democracy such as ours we certainly need a civilised and humane police. This should not, however, dilute the need to have a potent force that will not hesitate to use the resources at its command in order to re-emphasise the dictum that democracy can flourish only when violence is checked and not allowed to hold sway. There is a crucial need for senior police officers to devote time to improving the quality of policing in the field, instead of frittering away their energies in concentrating on "politician management".

India needs a bottom-up growth model

The country requires an employment and income strategy to guide its industry and trade policies



India's bold decision to stay out of the Regional Comprehensive Economic Partnership (RCEP) until the needs of the country's small enterprises, farmers, and poorest citizens are properly addressed dismayed many economists. The Indian government's fear was that the resulting increase in Chinese exports would harm small producers and farmers.

China and India, the two most populous countries in the world, both embarked on new journeys around the same time. More than 70 years later, China has progressed much faster. India, other the other hand, is yet to reach the development indicators that China attained back in the early 1990s.

People-centric policies

A Chinese thought leader said 15 years ago that both countries have the same vision: of prosperity for their citizens. To reach there, they must cross a turbulent stream by feeling the stones underfoot. But how do governments do that?

First, they need to make their policies people-centric rather than growth-centric. The Communist Party of China demands that local officials address the needs of citizens' effectively, as does Singapore's government. The Chinese government derives its legitimacy from citizens' satisfaction with their well-being, not from a vote in an election, Singapore Minister Tharman Shanmugaratnam once said.

In the case of India, its constitutional structure enables its States to adopt different models of development. Thus, there is a 'Kerala model', a 'Gujarat model', and now a 'common man's model' implemented by the Aam Aadmi Party (AAP) in Delhi. Local, participative governance has been a distinction of Kerala's model. and the State has been well ahead of the rest of the country, matching China in its Human Development Indicators in education, health, and women's inclusion.

Delhi's AAP government has adopted a people-centric model of government. It has established School Management Committees with parental involvement. Teacher training budgets have increased fivefold. The performance of Delhi's government schools is not only higher than the national average, it now exceeds the performance of private schools in Delhi. Public health expenditures have more than doubled. Mohalla clinics' have been set up in poor colonies to provide accessible

and affordable health care. The share of unauthorised colonies provided with piped water has increased from 55% to 93% in just five years, reducing the need for poor people to pay for expensive tanker-delivered water. But despite water subsidies for the poor, the Delhi Jal Board's income has increased. Electricity supply has expanded to include 20% more consumers. Amongst Indian metros, Delhi provides the cheapest electricity. Yet, its distribution companies, all in the private sector, have improved their financial performance.

Increase in disposable incomes

The government has computed that its programmes for improving the 'ease of living' of citizens by improving the quality and accessibility, and reducing costs, of a range of public services has increased savings per family by ₹4,000 per month. The in-

crease in disposable incomes has readditional sulted consumer-buying power, estimated at ₹24,000 crore per annum.

This proves that growth must be bottom-up to be equitable and sustainable. India has climbed many rungs on the World Bank's 'Ease of Business' rankings. Yet, investments to expand production ventures have not increased much because consumer demand has slumped, even for basic items like packaged biscuits. It seems odd that democratically elected governments in many countries, including India, who should be focused on citizens' wellbeing, have become so focused on making it easy for global capital to do business in their countries. This has made citizens rise up against the globalisation paradigm promoted by an 'establishment' of policymakers and economists. Citizens want their governments to put jobs in their countries first, and to implement policies that increase incomes at the bottom of the pyramid rather than facilitating only further growth at the top.

India's complex, socio-economic environmental system is under even greater stress. The country must improve on many fronts simultaneously. India ranks very low in international comparisons of human development (education and health), even below its poorer subcontinental neighbours. It is the most water-stressed large economy

in the world; its cities are the most polluted. India's economic growth is not generating enough jobs for its burgeoning population of youth: the employment elasticity of India's growth (numbers of jobs created with growth) is amongst the worst in the world. Bold actions without an understanding of the whole system can cause great harm. The bold move to demonetise the currency notes in 2016 was an egregious example. Unemployment of persons with vocational education has gone up between 2011-12 and 2017-18, from 18.5% to 33%. India now has a larger number of frustrated youth.

More free trade not the answer The RCEP decision shows that India is now standing up to pressure from a rump of Washington Consensus economists who continue to advocate that more free trade is the solution to India's economic problems, even when there is evidence that India has not benefited from the agreements it has entered into.

India's challenge now is to build an Indian ecosystem in which competitive enterprises will grow to create more opportunities for jobs for youth and for increasing citizens' incomes. Growth of incomes in India will make India more attractive for investors. A stronger industrial system will give India more headroom in trade negotiations too. India's industrial and entrepreneurial ecosystem's growth must be accompanied by an improvement in environment. Policies must be managed with a whole systems view. While 'Ease of doing Business' gauges health from a business perspective, 'ease of living' should become the measure of the health of the whole system.

Policy decisions invariably require compromises between competing interests. Here, Mahatma Gandhi's talisman provides a good test. The government should think of the needs of the poorest citizens first. Reduced duties on imports benefit citizens as consumers. However, a citizen's more fundamental need is for a good job and source of income to buy the imported goods. India urgently requires an employment and income strategy to guide its industry and trade policies.

The importance of being the bearer of bad tidings

Newspapers need to perform this vital, democratic role

When I sought readers' responses about the impact of digitalisation, and what measures this newspaper should take to reach out to millions who access news through their hand-held devices, I had three sets of nagging questions which eluded answers on my mind. First, can legacy newspapers retain their original credo of remaining a 'newspaper of record' in an era where news is breaking every minute? Is it important to retain the idea of recording the present for the future or, in other words, of performing the role of being the first draft of history?

Second, when digital marketing ideas like targeting and distributing content, Search Engine Optimisation and framing tweets to trend a story have become major determinants, has the tried and tested inverted pyramid story structure that dominated the news industry become redundant? Do we need a new forms of structuring a story that reflects the relentless nature of the 24x7 news cycle?

Third, in a heavily polarised environment, where does a readers' desire to get news end and where does the wish to have a confirmation bias begin? If closed encrypted platforms like WhatsApp attract more readers because of the lure of confirmation bias, what is the role of journalism whose primary objective is truth?

Giving print journalism its due

Vijay S. Raghavan, a reader from Navi Mumbai, came up with a 2,300 word response in which he touched upon a range of issues, including the spread of multiple print editions since liberalisation of the Indian economy, readers' perception of bias, and why print must be given its due even today.

He argued for more print editions that have a good mix of local and national stories rather than national editions which, in his opinion, fail to offer substantial reading fare. I am not sure whether the present economic reality will permit this newspaper to implement all his suggestions but one seems to be an immediate possibility: bundling the subscription for e-paper and the Internet edition into one.

V.N. Mukundarajan from Thiruvananthap-

uram felt that the news industry was not nimble enough in the first two decades of the 21st century and it took time to understand the aspirations, preferences, attitudes and reading styles of the youth.

In his view, publications are trying to navigate two landscapes – the traditional print and the online. "No two worlds can be as different as these two. The nature of the medium dictates the format, content, and curation of news stories... The screen demands understanding visual cues. The appearance of the page is as important as its content. The print is conservative; the screen is liberal, especially in its comments section," he wrote.

He wanted to newspapers to follow the Carl Sagan Standard' to weed out fake news. The well-known astronomer came up an aphorism, "Extraordinary claims require extraordinary evidence" (ECREE) and Mr. Mukundarajan felt that ECREE should not be restricted to science but test all claims.

Baloney Detection Kit

Let me share Carl Sagan's "Baloney Detection Kit" which was succinctly summarised by the ever-engaging reader from Kerala.

The tools which he wants journalists to use in defence of truth and to deduct fake news are: "1) confirm the facts; 2) encourage debate; 3) remember that authorities can be wrong; 4) develop more than one idea. 5) try not to get overly attached to a hypothesis just because it is yours; 6) quantify; 7) If there is a chain of argument, every link in the chain must work (including the premise), not just one of them; 8) Occam's razor - a rule of thumb. When faced with two hypotheses that explain the data equally well, choose the simpler one; 9) Always ask whether the hypothesis can at least in principle, be

The biggest challenge for a newspaper in a polarised environment is to create a public sphere where debate, doubt, argument and dissent lead to a more informed choices without being subjected to savage personal attack. While discernible vitriol flows from open sources, the quantitatively overwhelming maliciousness is generated in the encrypted messaging world. Is there an acceptable approach to deal with the encrypted world of toxic circulation without undermining the privacy of the individual? If a newspaper fails to be the bearer of impending bad tidings, who else will perform that democratic duty?

State results no indicator of decline in BJP's popularity

It is still going strong in North and Central India

The political events in India during 2019 have left observers slightly confused. The year brought both good and bad news for the Bharatiya Janata Party (BJP) as well as for many non-BJP parties.

In the Lok Sabha elections, the saffron party not only got a massive mandate, it managed to improve upon its electoral performance of 2014, winning 303 Lok Sabha seats with 37% votes. This strong performance made some believe that the party was invincible. But, soon after that, the BJP lost power in Maharashtra and Jharkhand and failed to get a majority in Haryana.

Now, these defeats once again have started discussions on whether the party is on the decline or, at a minimum, whether this is the beginning of a decline. Questions are also being asked if the protests across the country against the Citi-

zenship Amendment Act (CAA) would lead to a shrinking of the party's Hindu support base.

Reduced appeal

The truth is that the verdicts at the State level do not give any indication of the BJP's declining popu-

larity at the national level. A recent Lokniti-CSDS survey in Jharkhand did indicate that there was a reduction in the appeal of Prime Minister Narendra Modi, but that was limited to just one State - Jharkhand. It is also not clear if this decline could accelerate further or if it could be halted as the Central government might engage in some course correction in coming months. However, if the anti-CAA protests continue, they might have a negative impact, with even some favouring the CAA turning against the party.

Now, let's put the fact in a plain and simple manner – the BJP lost power in many big States during last one year, beginning November 2018. The party is in power either alone or in an alliance with other parties only in 16 States. It has a government of its own only in Karnataka, Uttarakhand, Himachal Pradesh, Uttar Pradesh, Gujarat, Arunachal Pradesh and

Tripura, while it is part of the ruling coalition in nine other States. The BJP has also accepted the role of a junior partner of the coalition government in many States of North-East.

However, this alone does not suggest that the popularity of the BJP in general is falling at the national level. Take the case of Madhya Pradesh, Rajasthan and Chhattisgarh, where the party lost power last year. The party's fortunes saw a turnaround just six months later as it won 62 seats of the total 65 seats in these three States in the Lok Sabha elections.

Coming to Maharashtra and Haryana, though the BJP failed to form a government, it still emerged as the single-largest party. In Jharkhand, it managed to win 33% of votes.

Still strong at the national level

These results show that the BIP, and to a greater extent Mr. Modi, still re-

main a popular choice for voters in the Northern and Central parts of the country. But what could be safely concluded from the somewhat contrasting pictures presented by the Lok Sabha and Assembly elections is that voters' choices are diverging in the two

scenarios. The verdicts in the last one year indicate that the BJP is no more the only choice of voters when it comes to choosing a State government. In that regard alone, Mr. Modi's ability to pull votes for the BJP has been challenged.

The Delhi Assembly elections due in early 2020 would be a significant test of Mr. Modi's ability to mobilise votes for the party against a popular State government. Further, the party would face another challenge when Bihar goes to poll in late 2020. Finally, the BJP's CAA narrative would be tested when Assam and West Bengal go to the polls in mid-2021. However, at the moment, the saffron party is certainly stronger than its political opponents at the national level.



FIFTY YEARS AGO DECEMBER 30, 1969

India-made equipment on Moon

Dr. Vikram Sarabhai, Chairman, Atomic Energy Commission, here [Trivandrum] today [December 29] disclosed a move to have one of the Apollo missions carry and leave on the moon Indian-made equipment capable of carrying out important experiments. He hoped this proposal, communicated by the Indian scientific groups to the National Aeronautics and Space Administration of the United States, would be accepted, so that India too could collaborate in the lunar research programme. Dr. Sarabhai said data could be received by the ground based telemetry system if the Indian-made equipment was placed on the moon. India, he said, was specially interested in the study of solar wind, cosmic rays and gamma ray astronomy. The moon surface would be the best space platform for such studies as it was unimpeded by any atmosphere. Dr. Sarabhai, who also heads the Indian Space Research Organisation (ISRO), was delivering

We Publish elsewhere extracts from the address of Sir P.S. Sivaswamy Iyer as President of the Moderates' Conference and a fuller report of the portion of Pandit Motilal Nehru's address as President of the Congress, relating to the Reform Act. It will be noticed that one fundamental difference of opinion is that relating to the Declaration of Rights. Pandit Motilal Nehru attaches the greatest importance to such a declaration, while Sir P.S. Sivaswamy Iyer assigns a very subordinate place to it and dismisses it in a few words stating that there is no no precedent for it in the Empire. The question of the absence of precedent is examined clearly by Pandit Motilal Nehru. In the first place, it is not the fact that there is no precedent. The latest pre-war Irish Home Rule Act contained provisions which were in the nature of a declaration of rights and which guaranteed that the civil liberties of the subject would not be unjustly interfered with. If there is any one feature of that British constitution which is more striking than another, it is the extraordinary power of adaptability that it exhibits; it is the least rigid of constitutions; and wherever a necessity for change based on experience is patent, its tendency is to invite that change and not to resist it.
