# Most CBI fraud cases based on bank plaints

Amid apprehensions of "undue harassment" by the three Cs - the CBI, the Central Vigilance Commission and the Comptroller and Auditor General, figures show that most of the 90odd bank fraud cases registered by the CBI this year were based on complaints from lenders.

In a major crackdown, when the CBI registered 42 cases and conducted searches at more than 190 locations across 16 States in the first week of November, action was taken on complaints received from various banks alleging fraud involving more than ₹7,000 crore. As fears of undue harassment had been raised, CBI Director Rishi Kumar Shukla attended a meeting chaired by the Union Finance Minister, with the chiefs of the public sector banks, the chief executive of the Indian Banks' Association and the representatives of leading private banks.

The Hemant Soren government on Sunday announced it was dropping all cases registered against people involved in the Pathalgadi movement and protests during the tweaking of the Chhotanagpur (CNT) and Santhal Pargana Tenancy (SPT) Acts in Jharkhand.

The first Cabinet meeting chaired by Mr. Soren also gave its nod to change the Jharkhand State logo. In the present State logo, the Ashoka Chakra is placed between

"The State logo will be prepared afresh for which proposals will be invited. The new State emblem will reflect Jharkhand's culture, tradition, history and future," said Ajoy Kumar Singh, Cabinet Secretary, after the meeting.

**Pro-tem Speaker** Veteran JMM leader Stephen Marandi was recommended to be pro-tem Speaker of the newly constituted Assembly. A three-day session of the Assembly has been convened from January 6 to 8 during which the MLAselect will be administered oath of office and the new will also be

finalised. The Pathalgadi movement was a vociferous campaign by people who had asserted that no project or programme can be implemented without the consent of the gram sabha.

**Brutal police force** 

The Raghubar Das government had crushed the move-

ment of self-rule using brutal police power. The movement had then spread to four districts of Jharkhand in 2017. Huge stone plaques, known locally as Pathalgadi, were put up at the entrance of villages. The plaques had main clauses of the Pan-

chayats (Extension to Sche-

duled Areas) Act, 1996 (PESA) carved on them. They also warned outsiders not to enter villages without permission.

"As per our estimate, there were about 29 FIRs registered in five different police stations in connection with the Pathalgadi movement. In those FIRs, 109 persons were named and there was mention of 15,000 anonymous villagers. Many of them were facing grievous charges including sedition," said Prafulla Linda, General Secretary of

Adivasi Adhikar Manch. Similarly, the IMM had fought the Assembly elections protesting against controversial amendment to CNT and SPT Acts.

#### Widespread protests

Although the BJP government had subsequently withdrawn its move to amend the Acts under public pressure, widespread protests had taken place across Jharkhand.

Changes in section 21 of the CNT Act and section 13 of the SPT Act would have enabled the government to allow use of agricultural land for non-agricultural purposes. Civil society groups and tribal organisations had vehemently opposed it. The Cabinet recommended immediate payment of all outstanding dues of all frontline contractual workers including para-

# Pak. to host OIC meet on Kashmir, CAA

Diplomats say ministerial is linked to Saudi ties with Islamabad to counter rival Islamic formation

Pakistan will hold a ministerial meeting of the 57-member Organisation for Islamic Cooperation (OIC) on Jammu and Kashmir in April 2020, said official media in Islamabad. The development, according to diplomats, is linked to a broader Saudi-Pakistan deal.

The announcement came days after recently-appointed Saudi Foreign Minister Faisal bin Farhan Al Saud visited Islamabad and met with the Pakistani leadership, including Prime Minister Imran Khan and Foreign Minister Shah Mehmood Qureshi on December 26.

"I told the Saudi Foreign Minister that the OIC must

make a strong statement on India's Citizenship Amendment Act as well as on the situation in [Jammu and Kashmir]," Mr. Qureshi said in a press conference on Sunday.

According to Radio Pakistan, the officials had discussed holding the meeting of ministers of the OIC grouping of Muslim majority countries, led by Saudi Arabia, to focus on the "human rights situation in occupied Jammu and Kashmir and enactment of an anti-Muslim law in India". The report added that the ministerial meeting "is expected to be held in Islamabad in April

The Ministry of External Affairs declined to comment on the development until the meeting was officially announced by the OIC. If confirmed, the move would be a setback to the government's efforts to increase its engagement with the Islamic grouping, including attending the OIC conference in Abu Dhabi

United Arab Emirates have been muted in their comments on the government's actions in Kashmir as well as the CAA subsequently.

#### **Malaysian initiative**

Diplomats say the decision of the Saudi leadership to send its foreign minister on his first visit abroad to Pakistan, as well as to agree to an OIC statement on the Citizenship (Amendment) Act last week stems from Riyadh's concerns over losing control of key Islamic nations to a parallel formation, headed by Malaysia and Turkey, more than a desire to turn away from India.

On Dec 19, Malaysian PM Mahathir Mohammad had convened the "Kuala Lumpur" summit, with the leaders of Turkey, Iran and Qatar, calling for reforms in the Muslim world.

Pakistan PM Imran Khan, who had agreed to attend the summit, pulled out at the last minute, after the Saudi Crown Prince reportedly advised him to.

"The bargain is clear: Saudi Arabia leads OIC nations to showcase its control of the Islamic world, while allowing its members to use the forum to attack their own rivals," said India's former Ambassador to KSA, Oman and the UAE, Talmiz Ahmed. "While OIC resolutions mean very little in real terms, Pakistan wants to use the forum against India.'

# 'No politicking at educational institutions'

# Due process is a must to seek damages | Chief of the Defence Staff

Guidelines mandate court-monitored system of assessment based on evidence

The Uttar Pradesh government's acceptance of ₹6.27 lakh from the Muslim community as "compensation" for damages caused to public property during anti-CAA protests lacks due process.

The Supreme Court had suo motu laid down 10-point guidelines for assessment of damages and liability in its judgment in Re: Destruction of Public and Private Properties Vs State of A.P and others on April 16, 2009. The assessment of "exem-

plary damages" for property destroyed in incidents of violence should be based on electronic media/private video evidence. The prosecution has to separately prove that the damage occurred during protests and was the result of "direct actions" of

the persons concerned. The claims are to be pro-

cessed under the aegis of the Supreme Court or the State High Court concerned.

The constitutional court involved would ultimately decide the liability for the damages caused. The State government cannot unilaterally decide exemplary damages. It has to be decided after judicial application of

For one, wherever a mass destruction to property takes place due to protests or thereof, the High Court may issue suo motu action and set up a machinery to investigate the damage caused and award compensation.

When multiple States have suffered damages, the Supreme Court should take over cognisance.

In each case, the High Court or Supreme Court, as the case may be, should appoint a sitting or retired High Court judge or a sitting or re-

tired district judge as a Claims Commissioner to estimate the damages and investigate liability. An assessor is appointed to assist the Claims Commissioner.

The Claims Commissioner and the assessor, acting on the instructions of the High Court or Supreme Court, may summon video or other recordings from private and public sources to pinpoint the damage and establish nexus with the perpetrators of the damage.

The principles of absolute liability shall apply once the nexus with the event that precipitated the damage is established. The liability will be borne by the actual perpetrators of the crime as well as organisers. Their shares would be decided by the court.

Exemplary damages should not be greater than twice the amount of the damages liable to be paid. Damages should be assessed for destruction to public or private property, injury or death and cost of the actions by the authorities and police to take prevent and contain the violence.

The Claims Commissioner would finally make a report to the High Court or Supreme Court, which would determine the liability after hearing the parties.

# 'CAA is perfectly legal and Constitutional, does not relate to any Indian'

Union Law Minister says the new citizenship law does not affect Muslim citizens; neither does it create any citizenship nor take it away

Law Minister Ravi Shankar Prasad speaks on the Citizenship (Amendment) Act (CAA), the National Register of Citizens (NRC) and the National Population Register (NPR), as well as the protests against these moves.

It's been suggested that the Citizenship (Amendment) Act (CAA) goes against Article 14 of the Constitution and that there are enough provisions in the unamended Citizenship Act to provide citizenship to persecuted minorities.

■ The CAA is perfectly legal and Constitutional. Under Article 246 of the Constitution, Parliament has got the exclusive power to make laws with respect to any matters listed in the list one in the Seventh Schedule, in that, item 17 is to do with citizenship and naturalisation of aliens. Therefore, only Parliament has got sovereign powers to legislate on citizenship. Article 14, that you refer to, says equality before law and equal protection before law, but the Supreme Court has got more than 20 judgments where they say that if there is a reasonable classification of groups who form a class by themselves then that legislation will be valid. Here a persecuted, victimised group based on faith of six communities from the three countries Pakistan, Afghanistan and Bangladesh, which are declared Islamic countries, form that reasonable classification.

Therefore, this CAA does not relate to any Indian, even Muslims. Neither does it create any citizenship to them nor takes it away. Now take the case of precedents, Mrs. Indira Gandhi gave citizenship to Hindus exiled from Uganda, Mr. Rajiv Gandhi in the case of Tami-

But they never made it religion-specific.

■ But did they say we add Muslims to these groups? Dr. Manmohan Singh in Rajya Sabha in 2003 specifically mentioned minorities fleeing our neighbouring countries. Mr. Ashok Gehlot and Mr. Tarun Gogoi wrote letters on this to the government from time to time. Congress doing it is ok, BJP doing it is bad. What is this logic.

The Congress's argument is

that they did not mention any specific religion either for inclusion or exclusion.

■ What did Dr. Singh say to Mr. Advani in 2003? The video says legacy persecuted minorities should be given citizenship. Coming back to your question on why CAA, individually people can be considered for citizenship, as more than 2,000 Pakistanis have been given citizenship, but the whole group of minorities who have been persecuted only because of faith needed the CAA. It's a fact that there were six-seven lakh minorities in Afghanistan now only 500 left, what happens to Hindus - rape, murder, forced conversion in Pakistan – is too well known. Go to Indore, to Jodhpur, to Majnu Ka Teela in Delhi to see their condition for yourself. Therefore, the entire group of these communities are being given a platform for citizenship. The law provides for that. Individual asylum, protection is always there. One particular provision is rarely talked of in this context is Article 25, which provides for all persons, not just citizens, the right to freely profess, practice and propagate religion, therefore they have that right, after having coming to India.



There is a continuum being drawn between the CAA, the NRC and the NPR by those protesting. What is your

■ There are four concepts – the CAA, the Census, the NRC and the NPR. CAA we have already spoken of, the Census is an enumeration after every 10 years of Indians, it's also a constitutional sanction, but there is one issue, under the Census Act you cannot disclose the statistics of individuals, households. The NPR is a register of usual residents, not citizens. This you get from the Citizenship Act of 1955 and then there is a citizenship registration and issue of National I-card rule of 2003. Rule 3, sub-clause 4 says the Central government Mrs. Indira Gandhi gave citizenship to Hindus exiled from Uganda, Mr. Rajiv Gandhi in the case of **Tamilians** 

may decide the date by which a population register might be prepared. The point is that you can release NPR data for better targeting of welfare, to be used by both Centre and State. On 7th May. 2010, during a debate in the Lok Sabha initiated by late Ananth Kumar, with the participation of Mr. Lalu Prasad, Mr. Mulayam Singh and Mr. Sharad Yadav, then Minister Mr. Chidambaram's reply says that it will be "obvious" that the NRC would be a "subset" of the NPR. Census 2011, he says will be conduct-

ed in two phases, as well as reiterating the aims of the Census to do an "accurate de facto head count of the usual residents in India" within the deemed period. So, these very things I spoke of were spoken by the UPA, but they persist in their hypocrisy. Also the entire political class that is opposing us was supportive of the UPA on the same thing.

Coming to the NRC, it has a defined legal framework, also under Rule 4. The data would be collected, scrutinised by the registrars, appeals will be heard, but most important, the Registrar-General of citizens will have to notify the period and duration of the exercise in the official gazette. Nothing so far, not a word has been done so far.

**Except that Union Home** Minister Amit Shah has said on multiple occasions that it will be undertaken.

■ Prime Minister Modi has clarified that no discussion has taken place so far. There is a possibility that it may happen, but there is a legal process attached to it. NRC preparation has a distinct legal process to be initiated, with defining of rules with adequate consultations. But

UPA did not repeal any of the amendments of 2003, which kicked in only in December 2004 despite heading a government propped up by the Left Front and the socialists. This double standard of the Congress is astounding. There is now a serious competitive, aggressive and, at times, extremist positioning for vote-bank politics. Elements like PFI, MQM, they are the urban Naxalites; the way they have hijacked the issue, it's regrettable that a party like the Congress is competing with them. We acknowledge the right to dissent and protest for all Indians but violence is not ex-

# Women, lawyers held for anti-CAA kolam protest

The Chennai police detained eight persons, including five young women, who were part of a platform called Citizens Against CAA Group, for drawing kolams (rangoli) to voice their protest against the CAA and NRC on Sunday morning in Besant Nagar. Cases were registered against them and they were released later. Among those detained were three lawyers who sought to defend those confined in a hall by the pol-

Political party leaders, including DMK president M. K. Stalin, MDMK leader Vaiko and Manithaneya Makkal Katchi leader M. H. Jawahirullah criticised the police action, while Minister for Tamil Culture Ma Foi K. Pandiarajan defended their detention.

Police said the protesters had informed them that they wanted to draw kolams with anti-CAA/NRC/NPR messages near the Besant Nagar bus terminus between 7 a.m.

But they had not been

granted permission.

According to Gayathri, one of those detained, the protesters assembled in Besant Nagar around 7.30 a.m. and were attempting to draw kolam when the police asked them to leave the place.

"We then went to different streets and requested the house owners to give us permission to draw *kolams*. Some residents did not give us permission and we did not draw in front of their houses," she said.

However, when they were

drawing the kolams, the police picked them up and detained them in a hall.

A senior police officer said, "We just asked them to leave, when they were drawing kolams on the main road. But they started drawing kolams with anti-CAA slogans, in front of people's houses, to which many objected. We have statements from two such residents."

A member of the Citizens Against CAA said that it is shocking they were picked up for drawing *kolams*.

While four young women and a youth were initially detained, later police detained three lawyers who went to meet them. The police registered cas-

The weather office said the cold snap, accompanied by chilly winds and dense fog, was likely to continue for few more days. REUTERS

#### U.S. forces hit Iraqi **Hezbollah bases**

The U.S. has bombed the headquarters of the Iranbacked Iraqi Hezbollah militant group in Iraq and Syria, the Pentagon said on Sunday, following a rocket attack in Iraq that killed an American civilian contractor. "In response to repeated Kata'ib Hizbollah (KH) attacks on Iragi bases that host Operation Inherent Resolve (OIR) coalition forces, U.S. forces conducted precision defensive strikes against five KH facilities in Iraq and Syria that will degrade KH's ability to conduct future attacks against OIR coalition forces," a Pentagon spokesman said in a statement. AFP

# Five people stabbed at New York rabbi's home in 'terrorist' attack

The incident happened during celebrations for the Jewish festival of Hanukkah

An intruder stabbed and wounded five people at a rabbi's house in a New York suburb late on Saturday, in an incident the State Governor said was "an act of terrorism" after a spate of attacks on Jewish targets.

Local media reported that a man with a machete entered the rabbi's property in Monsey, Rockland County, during celebrations for the Jewish festival of Hanukkah, knifing several people before

Victims were rushed to nearby hospitals, with no official details on their injuries. The police said a suspect was later arrested.

"This is an act of terrorism. I think these are domestic terrorists. They are trying to inflict fear," New York Governor Andrew Cuomo told reporters at the scene on Sunday. "They're motivated by hate. They are doing mass attacks. These are ter-

rorists in our country perpetrating terrorism on other Americans, and that's how we should treat it."

Last year, a white supremacist walked into a Pittsburgh synagogue and killed 11 people - the deadliest attack against the Jewish community in the United States.

Earlier this month, six people, including two suspects, were killed in a Jersey City shooting at a kosher deli, which authorities said was fuelled in part anti-Semitism.

A report in April from the Anti-Defamation League (ADL) stated that the number of anti-Semitic attacks in 2018 was close to the record

"I was praying for my life," said witness Aron Kohn, 65, comparing the knife used by the attacker to "the size of a broomstick."

of 2017, with 1,879 incidents.

Mr. Kohn threw chairs and tables in an attempt to head off the assault. "I saw him stabbing people," he added. "He injured a guy, he was bleeding in his hand, all over." Mr. Kohn said the attacker tried to enter the adjacent synagogue, but it was locked.

Yossi Gestetner, of the Orthodox Jewish Public Affairs Council (OJPAC), told The New York Times that one of the victims was a son of the rabbi. "The house had many dozens of people in there," Mr. Gestetner said. "It was a Hanukkah celebration."

# Turkey evacuates victims of Somalia bomb blast

Military plane lands with doctors, medicine in Mogadishu

A Turkish military plane on Sunday evacuated 16 gravely wounded victims of a devastating bombing that killed 79 people and overwhelmed local health services, in the latest attack on a city dogged by insecurity.

The aircraft also brought doctors to help treat the some 125 people injured in Saturday's blast, which happened when a vehicle packed with explosives detonated at a busy security checkpoint.

"The rescue mission continues since yesterday when the blast occurred and after long and diligent efforts, we have managed to evacuate 16 of the wounded people to Turkey for further medical treatment," Mogadishu Mayor Omar Mohamed Mohamud told reporters at the airport.

No group has claimed the bloody attack, however President Mohamed Abdullahi Farmaajo has blamed Isla-

mist group Al-Shabaab, which regularly carries out car bombings and other attacks on the capital, in their decade-long bid to topple the internationally-backed government.

Saturday's bombing was the deadliest since truck exploded in 2017 near a fuel tanker, creating a fireball that killed over 500 people.

# + Taliban council agrees to ceasefire in Afghanistan

The Taliban said on Sunday it has agreed to a temporary ceasefire. It provides a window during which a peace agreement with the U.S. could be signed.

A peace deal would allow Washington to bring home its troops from Afghanistan and end its 18-year military engagement there. The U.S. wants any deal to include a promise from the Taliban that Afghanistan would not used as a base by terrorist groups.

A key pillar of the agreement, which the U.S. and the Taliban have been hammering out for more than a year, is direct negotiations between Afghans on both sides of the conflict. Those intra-Afghan negotiations are expected to be held within two weeks of the signing of a U.S.-Taliban

# Putin thanks Trump for intel on attacks

Russia's President Vladimir Putin on Sunday thanked U.S. counterpart Donald Trump for intelligence that helped foil attacks on Russian soil, the Kremlin said.

Russia's FSB, a successor to the KGB, quoted by Russian agencies, said two citizens were arrested for planning an attack in St Petersburg during the New Year festivities. They appeared to have been preparing a "terrorist act".

Riyadh arrests dozens for +

Saudi Arabia has arrested more than 200 people for violating "public decency" – including by wearing immodest clothing – and "harassment", the police said, in the first such crackdown since the ultra-conservative kingdom began easing social norms.


Some 120 men and women have been arrested over the past week for offending public morals, including wearing "inappropriate clothes", the Riyadh police said in a series of statements on Twitter since Tuesday. It added that unspecified penalties were imposed on the violators.

Another 88 people were arrested in various harass-

ment cases, the police have added in separate statements, after several women complained on social media that they were harassed at the MDL Beast music festival in Rivadh earlier this month. The electronic music festival, which drew tens of thousands of fans, was billed by organisers as the biggest ever to be hosted in

the kingdom. This marked the first such mass crackdown since de facto ruler Crown Prince Mohammed bin Salman began easing social restrictions in the ultra-conservative kingdom, lifting decades-long bans on cinemas and women drivers while allowing gendermixed concerts and sporting extravaganzas.

# Subtleties of devotional life

Suka confesses that though he is a Brahma Nishta sage steeped in meditation of the Nirguna Brahman, he finds much joy and delight in singing the praises of the Lord's excellences. This statement is made when Parikshit asks him the way to salvation. Quoting the Upanishad thought about what is really worthwhile, Suka says that each one has to know about the All-pervading and Omnipotent Lord, and to this end one has to hear His glories expounded, and then remember Him always, pointed out Sri R. Krishnamurthy Sastrigal in a discourse. The Bhagavata Purana is capable of leading people out of samsara by fostering devotion true and simple, regardless of whether they have opted for the spiritual path of renunciation, Nivritti, or the path of a hou-

seholder, Pravritti. There is a story about how the Lord wishes to enlighten Narada on the true devotion practised by even those in Pravritti. The Lord speaks highly of the devotion of a farmer in a village. Noticing that Narada feels disappointed that the Lord has not credited him as an ideal devotee, the Lord entrusts him with a simple task, to carry a bowl filled with oil around the world without spilling even a drop of it. Narada leaves with the oil bowl and proudly comes back to the Lord after carefully finishing the assignment. The Lord is pleased and as He takes back the bowl, asks Narada about the number of times he chanted His name when he was on the errand. Narada admits to the Lord that he had forgotten to chant the Lord's name during his trip as he had to focus on not spilling the oil. After all, he was only doing the work allotted by God, argues Narada. The Lord points out that the farmer too does the work ordained for him, and in the midst of it takes care to remember Him.



Q. Must nominees submit legal heirship certificate and consent letter from related persons along with death certificate while claiming money after the death of the principal depositor?

N R SANTHANAM

A. Nomination in the bank account is only for the limited purpose of operation of the account in case of death of the account holder. Further, the nominee becomes custodian of the funds after the death of the account holder and he acts as a trustee in distributing the money lying in the bank account to the legal heirs of the account holder. The bank is right in asking for the legal heir certificate and no objection letters from other persons mentioned in the legal heir certificate for entitlement of the amount lying in the said bank account.

Q. I am a retired State government staff who is receiving pension. I have been an assessee for three decades. As a pensioner also, I am paying I-T. I also get a monthly honorarium of ₹20,000 from an institution. There is no employee-employer relationship. Can I show this as income from other sources?

A. Honorarium is generally a payment given for services that are rendered nominally without charge. Therefore, honorarium received by a person is chargeable to income tax under the head "Income from Other Sources" as there is neither employee and employer relationship nor is it a profession run for profit/gain. Irrespective of usage of such honorarium received by the person, it is taxable in their hands. It has to be disclosed in the applicable ITR under "other income detail" by describing the source appropriately under "Income from Other Sources". Further reasonable and justifiable expenses incurred for earning this honorarium can be claimed against this honorarium.

Q. I'm now staying in rented accommodation. I don't own residential property. I get rent allowance and there is no HRA. Am I eligible to claim deduction for rent paid? Kindly guide me on how to include it in I-T returns

A. Rental allowance, popularly known as HRA (House Rent Allowance or by whatever name it is called) can be availed as an exemption on satisfying conditions prescribed. HRA is an allowance specifically granted to an assessee by his employer to meet expenditure actually incurred on payment of rent in respect of residential accommodation occupied by the assessee. Exemption available is the least of the following – a. actual amount of such allowance received b. rent paid minus 10% of basic and DA or 50% of basic and DA (in case of Delhi, Mumbai, Kolkata and Chennai) c. 40% in other cases. It is also required by the assessee to possess relevant proof of rent paid and rental agreement. It is advisable you get in touch with HR department to ensure they process your Form 16 appropriately.

Q. I work for SBI. I have availed a housing loan of ₹40 lakh jointly with my husband. The self-occupied property is in my husband's name. Who can avail nousing loan interest exemption of ₹2 lakh and repayment of principal? Loan repayment is from my salary.

A. To claim interest deduction under Sec. 24 of the Act, you must be an/the owner of the house property and the housing loan is to be availed in the name of the owner/s. In your case, though the loan is borrowed in a joint manner, the property is in the name of your husband. Therefore, interest and principal wholly paid by you towards the housing loan during the assessment year cannot be claimed as a deduction under Sec. 24 and Sec. 80C, though the loan is jointly borrowed.

# Points to ponder for women making investments

Understanding the nature and role of asset types will help improve financial returns

Investors build their portfolio from among the choice of products at their disposal. And women, more than men, often work with a limited bouquet of offerings that fit within their comfort zone. To add to this, the risks and return potential of these financial products are not understood. As a result, while they make investments, limited wealth is created.

**Gold buying** One popular choice among women is buying gold. Purchasing the yellow metal is simple, with easy access. Besides, there is ample li-

quidity to

sell the

raise money anytime. And the returns are sweet - if you had bought gold a year ago, you would have got about 20% return. So, why would gold not be a good investment option? For one, the paper returns for gold are hardly realised when buying jewellery, which is the most popular option.

For instance, there are various costs added to the product that greatly reduce the net return, unless you purchased coins. Two, storage of gold can be risky and add to your costs such as the cost for renting a

storage locker. Three,

gold can be un-

wieldy

same. Also, you can pledge it to when building a large portfolio. For instance, if you plan to build a net worth of ₹1 crore, you would need 3 kg of gold. This is not easy to manage.

Suggestion: Consider buying gold in non-physical forms such as ETFs or e-gold. It is good to have less than 10% of your portfolio in gold investments as the long-term return potential is debatable; you can tactically change the allocation based on market outlook.

Chit funds

Another popular choice, due to its accessibility, is subscribing

to chit funds. This is a household product that enables savings and comes with the potential to avail loans. The advantages for many women, especially in smaller cities, is door-step service. While chit funds have reasons for their popularity, there are downsides. For one, there are high risks in unregistered chit funds where frauds are quite rampant. And, default by any bor-

**Suggestion:** Unlike in the past, there are many investment products that are available online. It is good to learn about them and expand your choices rather than go with proximity as the criteria.

**Insurance schemes** 

Insurance providers such as LIC offer schemes that score high among women.

This is primarily due to the push factor from sales agents who are known to them and hence, offer trust and comfort. The problem with many of these schemes is low return. This is not obvious due to the nature of the product. For instance, there is a sequence of investments you make over a period and there are payouts in a later period.

This requires complex calculations to work out the annual rate of return.

Also, if you stop premium payment, the policy would lapse and may lead to loss of money. And often, there is heavy mis-selling in insurance and the agents may not be upfront about the various clauses which adds to risk of loss.

Suggestion: Consider insurance as separate from savings. Ask for annual return numbers for the product and check the terms on payment lapses.

**Fixed deposits** Opening a fixed deposit (FD) seems like a simple and no-risk idea and many women take to this. While there are no risks or complexities in this, the downside is the lost opportunity the rate of interest is usually low, especially if you consider

Also, the term of the FD is often selected without consideration to the interest rate outlook. For example, you may pick a one-year term as it gives a good

But if rates are on a downward trend, locking the rate for a longer period would be better to maximise return.

Suggestion: Keeping a small pool in fixed deposits for emergencies is a good idea. Any further returns on savings may be obtained through debt funds, bonds or other instru-

Women must take a holistic view of their finances and not stay within their comfort zone of investment products.

There are many temptations including sales pressures, proximity, familiarity and anecdotal evidences of returns, to pick the known choices; but knowing the downside of the products will help you see their role in the portfolio and not over-invest in one, to help maximise return and manage risks.

# Giving you focussed coverage

Term life insurance policy covers the risk of death during a chosen period

Term policy is a no-frills life insurance policy. It covers the risk of death during a chosen term, say 20 years or until the life assured reaches a specified age. Once that term is completed, the policy ceases and there is no maturity value for survival beyond the term. The premium for this policy is equally no-frills, making it the most value-for-money policy. All Indian life insurance

companies offer term policies and it is easy to compare premium rates for a given term and the life assured's calculators that every company has to have on its website.

For example, a 25-year old male will pay between ₹7,700 and ₹14,500 a year for a term policy until age 75 for a sum assured of ₹1 crore. This is for a simple scenario where he has a clear medical history and is not a smoker. This policy means that if the policyholder dies before age 75, and the policy is in force, their nominee will receive the sum assured. If the policyholder lives past their 75th birthday, the policy terminates and nothing is payable.

Many companies have a discounted premium if you buy the policy online through their website. This

# How dividends impact NAVs

A lower net asset value is not always bad news

What does dividend in a mutual fund scheme mean?

■ As part of their portfolios, mutual fund schemes hold securities. These securities are churned based on various parameters such as price and fundamentals, among others. When a scheme makes a profit through these transactions, the fund manager, at times, doles out dividends to the unit holders.

A scheme could register gains also on account of dividends announced by the companies whose shares are held under the scheme. Even bond schemes can pay dividends as the debt papers in which the scheme invests pay interest.

How does dividend impact the net asset value (NAV)?

■ The NAV is the price of each unit of a mutual fund scheme. It reflects the total value of the underlying securities. If such securities are sold in order to book profit and distribute dividend to the unit holders, then the NAV would be proportionately affected. Hence, after every dividend announcement, there is a fall in the NAV to reflect the payouts.

Do all schemes give dividend?

Dividend Not necessarily. payouts depend on the scheme's performance. During a downturn in the market, schemes might not announce a dividend. Also, one can keep in mind that most equity schemes have two options - dividend and growth. Under the divi-

dend option, investors get payouts whenever a dividend is announced. In a growth option, the dividend is reinvested in the scheme and the unit holder gets additional units in lieu of the dividend. So, while the NAV might still take a hit, the unit holder will have more units.

Does low NAV mean poor performance?

■ Again, not necessarily. NAV is based on many factors, including the total AUM of the scheme. A fund manager may decide to do regular dividend payouts that would bring down the NAV even though the scheme may be faring pretty well.

One should look at the track record of the fund rather than just the NAV before investing in a scheme. Also, a lower NAV means an investor will get more units compared to a scheme that has a higher NAV. Interestingly, the dividend is based on the face value of the units and not on the NAV and hence, more the number of units, more would be the absolute dividend received.

Renewing our \ vows to Delhi

Take a trip to the city's heritage sites, in order to recommit to its historic past

Now that the new year dawns and the old one expires, it's time to explore fresh avenues and renew acquaintance with old ones. There's no better way to begin 2020 than by visiting Delhi's monuments, which have seen many a sun rise and set on them. So set out on New Year's Day, as the world recovers from hangovers, to discover our city. These dozen-odd monuments are worth a visit to make it a really memorable occasion. You can also pick others that form a part of the thousand and more that dot Delhi. They are a delight to tourists and picnickers, as they wish each other "Naya Sal Mubarak".

#### Red Fort, Old Delhi The Muthamman Burj

is the octagonal tower adjoining the Khwabgah or the sleeping room of the emperor. From here, he would appear every morning before his subjects for the daily "darshan". If people did not see the ruler, it meant that all was not well with him and this could lead to unrest. There's a balcony projecting from the side, built in 1808-09 by Akbar Shah II from where King George V and Queen Mary appeared before the public during the 1911 Delhi Durbar, when the city was reinstated as the capital of Hindustan after its temporary transfer to Calcutta following the Uprising of 1857.

The Dewan-e-Khas, or the Hall of Special Audience for the nobles of the Mughal empire, is the place where the Peacock Throne was installed until it was looted by Nadir Shah in 1739. Nearby is the Rang Mahal where dance performances were held every evening for the entertainment of the emperor, his nobles, and the harem. Through the mahal flowed the Nehar-e-Bhist or stream of paradise on which princes and princesses floated love letters to idle away the time on boring summer afternoons while trying to escape the heat.

Mumtaz Mahal, the ladies' chamber, which became the Mughal Museum in which the Chogha or gown of Bahadur Shah Zafar and the Gharara or skirt or Zeenat Mahal, his favourite queen, were on display, along with the weapons of the Mughal kings, including the rapier of Shah Jahan and the gigantic

## **Qutub Minar, Mehrauli**

The Tower of Victory rises above the plain of Delhi like an eternal sentinel built by Qutubuddin Aibak, the first of the Slave Kings in honour of Hazrat Qutubuddin Bakhtiar Kaki, a Sufi saint. It was competed by Iltutmish, who came to the throne after the sudden death of Aibak. Feroz Shah Tughlak repaired and added to the monument. Alai Minar, within the Qutub Complex, is a rival to the Minar and was planned by Alauddin Khilji. He could not complete it, and so his construction exists like a huge elephant trunk, massive in thought and conception. Alai Darwaza is Alauddin's gigantic gateway.

## Lal Kot, near Siri Fort

The eastern wall of Qila Rai Pithora of Prithviraj Chauhan near the ruins of Alauddin's Siri Fort is a lingering specimen of Hindu architecture constructed by the most famous Chauhan ruler before the Sultanate dynasty came to power.



## Metcalfe's "Folly", Mehrauli Archaeological Park

This landlocked lighthouse built by Sir Thomas Metcalfe, British Resident at the Mughal Court is the only lighthouse built away from the sea, with an adjoining boathouse.



## The past 10 years observed a growing love for indie dogs in online and offline spaces


Two years ago, with bated breath, Raj Rihal waited at Chicago O'Hare airport for a special addition to his home. The Los Angeles-based concept artist was anticipating the arrival of neither a relative nor a long-lost friend, but Khushi, an onyx indie dog with a sharp snout and perked up ears. Yes, Raj had adopted an indie dog flown in from Delhi with the help of International Street Dog Foundation in the United States and Karma Animal Trust in Rishikesh. The vetting process was thorough and the communication about Khushi's initial years was constant between the pup's foster mother and Raj.

"I'd wanted to adopt since I was a kid visiting Delhi and seeing these dogs," recalls Raj. When Khushi was brought to Los Angeles and slowly assimilated in her new surroundings, she became part of a growing community of indie dog transplants. "I can see the ripple effect of what has been happening in India over the last 10 years," Raj

Indeed, indie dogs or canis familiaris have been around for almost 6,000 years but they only truly started being appreciated when animals rights' organisations exerted their collective influence on them during the early 2010s.

Despite the existence of the Prevention of Cruelty to Animals Act, 1960, animals rights' groups, including Hyderabad-based People For Animals claim this Act needs to be updated as indie dogs are culled for numbers when budgets run low for sterilisation, as well as for other loopholes in the legislation. So far these entities have relied on crowdfunding sites which only sprouted around 2013.

Delhi-based Stray Relief and Ani-





mal Welfare (STRAW)'s Compassionate Classrooms initiative formalises concepts of sensitisation and humane treatment into school textbooks, working with Central Board of Secondary Education (CBSE) and state educational

It is not just the major metro cities where indie dogs have been embraced. Cities like Visakhapatnam and Coimbatore have hosted

dog shows for indie dogs; a move which subverts the stereotypical snobbery of dog shows.

## In the media

Social media has also changed the way people consume information about indie dogs. In the mid-2010s, Instagram accounts such as that of The Modern Mowgli in Delhi and Faridabad or Street Dogs Of Bombay help catalyse adoptions.

Arundati Rao in Hyderabad found a tawny-hued indie pup. She created an Instagram post for the adoption announcement which instantly went viral. "People just melted at the sight of her picture, especially the ones of her snuggled up with my golden retriever Sage. I didn't anticipate this much response for an indie; I had over 60 to 75 reposts on Instagram and shares on Facebook," she recalls, "Immediately offers to adopt her poured in, from places like Kurnool, Nellore, Vizag, apart from Hyderabad. In just two days, I got over 50 prospective enquiries for her adoption, then I started filtering them on the basis of suitability to take care of a small puppy." Eventually with the help of a foster, the pup now named Billobabe found her forever home in Hyderabad.

"We all know that if we consume too much beer, cake, pizza and cheeseburgers and all the other things that make life frankly worth living, we will add pounds to our bodies because we have taken in too many calories," says Bill Bryson in his new book, The Body: A Guide for Occupants. The author, who is neither doctor nor scientist, writes for the layperson.

It's apt that he talks of the knowledge we now have of what will make us overweight or obese. Obesity itself was declared a disease in 2013; fat a noun that refers to a food group, never a person. A decade ago, In Defense of Food came out, and over the years, we had internalised author Michael Pollan's guideline to "eat food, not too much, mostly plants." We also got more involved in what we consumed, not leaving it just up to our doctors and dietitians to dictate to us.

#### Power to the people

Celiac disease or even gluten sensitivity has caused people years of suffering with anything from bloating and diarrhoea to breathing difficulty. People suffering from this and various other autoimmune diseases like rheumatoid arthritis, multiple sclerosis, asthma, and allergies that do not have cures in allopathic medicine, have found relief from diet changes.

"People have stood up and talked about food," says Rachna Chhachhi, a Mumbai-based nutri-

Rachna, who reversed an auto-immune condition she was afflicted with, wrote about managing lifestyle diseases through food, in her 2014 book, Restore.

We also know a great deal more, "and understand the science" behind food and health better, says Lovneet Batra, a Delhi-based sports nutritionist. "People today know what inflammation within the body is and what causes it [packaged and refined foods, for instance]," she says. This doesn't mean people won't drink Diet Coke, "but they know it's not a good thing to put into the body."

Lovneet adds that the thought has shifted, from calories to chemicals – people want to eat

how they should regulate what they eat; and there are those looking at weight loss for a wedding. This proactivity and heightened awareness of wellness, combined with the availability of preventive health check-ups has meant that deficiencies too get detected.

"Vitamin D3, B12, and micronutrient deficiencies like magnesium – these have been seen a lot this decade," says Ritika. Which has led to a boom in the supplements market, including functional foods and drinks (such as those that have probiotics), and dietary supplements (from minerals and vitamins to Chyawanprash).

A 2017 publication on nutraceuticals, a sector of dietary supplements, by the Confederation of Indian Industry, reads: "While the Global Nutraceuticals market is growing at a CAGR of 6.5%, as per the Drug Marketing and Manufacturing Association, the Indian nutraceuticals market is growing at a much faster rate of 16%."

This is also because we now have a substantial senior population: According to Sheela Krishnaswamy, a dietitian based in Bengaluru, "The elderly are not able digest or assimilate as







and vegan. "People with obesity and diabetes swore by either when they realised that eliminating one food group could have an impact on the body. But what they did was to feed one imbalance with another," she says.

Keto, this decade's Atkins and Dukan, as well as the vegan diet, both have cult-like followers who hope to 'convert' people. Diets from previous decades did not have this going for them. For every Netflix The Game Changers (a documentary that talks of a vegan diet as best for fitness) there is *The* Magic Pill (a documentary that glorifies keto).

Both work only for a short period, says Rachna, adding that "we now know keto over a long period can impact the kidney and going vegan for long can cause chronic fatigue." This is possibly the first time that fad diets worked "because our earlier eating habits were so bad," she elaborates.

This decade also saw the rise of the Mediterranean diet, fuelled in India by olive oil companies that hoped to displace locally-made traditional oils. They offered junkets to influencers like dieticians and journalists to olive oil-producing countries, selling the benefits of the oil. There was no doubt of the benefits, but we didn't need it either for our bodies or our style of cooking.

#### **Back to basics**

Despite this, our native foods have seen a bump up, thanks to a larger movement in revival of all that's traditional and a new-found pride in our culture itself. They've also been marketed well, with pretty packaging that targets adults, taking us back to our roots (Conscious Food, Kiru), or children, taking the food to them (Slurrp Farm, Akiva Superfoods).

"The scriptures have become the backbone of modern healing and a lot of onus is put on food. We always knew what to eat if we had a stomach upset or poor digestion," says Manjari Chandra, Delhi-based dietician. She says now with the Ministry of AYUSH, we have access to traditional healers who can tell us which texts these come from.

However, there are some nuances here: while people may have found their roots and are willing to try out new health foods in India, they are also travelling more and experiencing world cuisine. All of this comes at a time when there's also stress on living a sustainable lifestyle and eating local and seasonal too. "This has led to the growth of a number of 'foreign' foods, like quinoa being grown in India," says Sheela. We needn't be alarmed though, because foods like tomato that do not form a part of our traditional diets have been incorporated into our cooking.

This East-meets-West approach has led to the nascent stages of integrative nutrition in India. This means that a blend of traditional medical practices that use food as medicine, and nutrition and dietetics as studied in university might soon be practised.

"This is an evolving branch of study, and we always thought our (Ayurveda) system is very different from theirs (the West's allopathy practice). Now we realised that there's a lot in common," says Sheela. The University of Trans-Disciplinary Health Sciences and Technology in Bengaluru, has a course for this.

#### A change in thought

"We have so far been following American and British guidelines which may not have been correct for us in India. For instance, internationally, it is still said that 50% of food should be carbohydrates, based on the food pyramid," says Manjari. But the 2014 book Death by Food Pyramid: How Shoddy Science, Sketchy Politics and Shady Special Interests Have Ruined Our Health talks of how this diagram has no value.

It's also true that the 'big food' industry has manipulated the West a great deal more than it did India. In fact, the American Academy of Pediatrics says that "100percent fresh or reconstituted fruit juice can be a healthy part of the diet of children older than one year when consumed as part of a well-balanced diet."

This is a reference to packaged juices, which Indian dieticians reject for regular healthy children, as we believe packaged foods are best avoided.

However, as the food industry in India grows, it's beginning to have a greater impact on how the government regulates it: Despite planning to, the Food Safety and Standards Authority of India (FSSAI) is yet to pass the colourcoded labelling on foods high in fats, sugar, and salt (HFSS).

Collectively, we have managed to talk a great deal about food and nutrition, without being able to bring down obesity levels in our cities. This is the next decade's greatest worry.

With the exam season coming up, institutions and administrators need to take steps to curb the debilitating issue of malpractice

Exam, in some form or the other, is an integral part of any academic activity. As with all good things, in exams also, malpractices seem to be growing, and it should be curbed.

Any dishonest and improper act associated with an exam, aimed at gaining undeserved advantage, is an exam malpractice. Such malpractices can be grouped under two categories, based on their sources of origin.

One is candidate-oriented, and the other is system-generated. In the first one, either the candidate or anyone interested in the welfare of the candidate, like the parent(s), siblings or friends may be involved. The types of such malpractices could be: copying in the exam hall from bits of information carried by the candidate clandestinely into the hall, or from the neighbouring candidates, bribing examiners for lenience and favourable assessments, altering marks/grades in certificates, impersonation and so on. Plagiarism in project reports and MPhil/PhD thesis, which are also exam materials,

can also be grouped under this. The second type, namely the system-generated malpractices

include inappropriate question paper set by unqualified examiners, repeating recent previous years' questions (that happened recently at Anna University), or question papers set in a hurry without adequate time. Teachers' ineffective teaching methods, failure to cover the syllabus, unethical earning desires through tuitions and favouritism, hall supervisors' carelessness and an institute's greed to produce high results through sponsored mal-

practices like allowing group copying are some more of this kind.

The problem with malpractice is when unchecked, it produces 'square pegs for round holes', with mismatch between result and requirement, imbibing disregard to morality, aiding creation of fraudulent and corrupt citi-

This is an issue that can be addressed with the right education. Enough ethical values must be infused into the students at the ha-

bit-formative school level, with moral instruction classes and/or workshops and lectures by competent personalities. Above all, teachers, administrators and parents must set themselves as examples fit to emulate.

As a negative measure, the perils of punishment for wrongdoers in exams must be made well-known to students and parents. Malpractices will impact negatively on the institutions al-

#### **Deterrents**

Some specific modes of exam malpractices need special attention.

Copying: In almost all competitive exams using objective type questions, including NEET and JEE, a few 'versions' of the question paper are used. All the versions of question papers used for an exam will have the same questions, but not in the same order. Candidates occupying neighbouring seats will receive question papers of different versions, thus making it impossible to copy from neighbours. However, in the case of Tamil Nadu Professional Entrance Exams (TNCCEE), which used such versions, I came across an attempted malpractice, in which a candidate, with a view to pass on to others, tried to write on a loose sheet the first few words of each question (as per the version of his question paper) along with the correct answer code (one of 1, 2, 3 and 4). To outsmart such attempts, in the subsequent years, in addition to jumbling of questions, I jumbled the answers too. This is for the kind notice of the interested examining authorities.

Another interesting aspect of TNPCEE was that the candidates were not informed of the code letter (usually, one of A, B, C, ...), corresponding to their version of the question paper, and hence not troubled with mentioning that code in the response sheet. Before evaluation, the computer captured the version from the identical seven-digit serial number printed on the question booklet and the corresponding response sheet.

Impersonation: Impersonation in entrance exams has

earned prominence with reference to NEET2019-UG. Any admission system based on an entrance exam consists of four major components: (i) an exam (ii) evaluation and ranking, (iii) counselling and allotment, and (iv) actual admission in the allotted institution. The errors that could occur in each of them are independent and not exclusive.

It is true that the impersonator cannot be easily detected in the first three stages. But the real candidate will face the music in the final stage, namely admission, where the beans can be easily spilt - if the admitting authority at the allotted institution does his/ her job properly.

Clearly, there cannot be any compromise on the correct identification of the candidate. Photographs, physiological and biometric methods using fingerprints, face or iris scan and signatures can be used for verifying identities. Even with all these, mistakes still do happen. That is why, attestation of photos by responsible personalities, insistence on using copies of the same photo on all documents produced during the entire duration of study, starting from applying for the entrance test, are some measures that could help to mitigate this evil.

Videographing/photographing the exam hall, with the seated candidates, without infringing on the confidential aspects of the process, may not only be helpful for any later analysis, if required, but also serve as a deterrent to indulgence in such malpractices.

# Transforming lives


Well into its 10th year, Teach For India has + produced a pool of individuals of all ages, across the country, who are helping address a crisis

Some time ago, a photo of a small girl standing outside a classroom with an empty bowl, in the hope of getting some leftovers from the students' meals went viral. However, her fortunes vastly changed when a good samaritan decided to step in, and got her admitted to the school. Not every child, though, is as lucky. Many children miss out on this basic right and that is what Teach for India (TFI), founded by Shaheen Mistri, decided to

A few months ago, TFI marked a decade of service by releasing Grey Sunshine, a collection of stories, authored by its chief of city operations Sandeep Rai, highlighting the organisation's journey. He explains that the book is about human stories underlying a national crisis we see, and yet don't see every day – the state of Indian education.

"Over the last 10 years at TFI, I have met people who have moved me to tears. Their stories have been simultaneously filled with despair and hope. They have also been filled with leadership and courage," reminisces Rai. "Together, those stories have repeatedly reminded me that we have an injustice in this country that today, guarantees that more than 75% of the country's children are destined to drop out. Those kids are destined for a future that is, at best, bleak. Those sto-



come children across seven cities. Children enter their classrooms with strengths and assets that are seldom noticed by the world. They also enter, though, battling challenges. How does one study when one is simultaneously battling issues of malnutrition and scarcity? How does one catch up when one enters school - at the second standard - already multiple years behind one's more affluent peers? And how does one complete school when one shows up, every day, confronting realities of corporal punishment, teacher absenteeism, and of apathy? Rai says

Sandeep Rai that confronting these challenges every day and ensuring that they are rooting themselves in a grounded sense of optimism that doesn't get jaded, has forced them to continuously

"Our children are the direct recipients of India's inequity. They understand the depths and implications of the educational crisis far better than

any scholar or practitioner; that's because they have experienced it. Yet, they are too often powerless and voiceless, largely because of their age and penury. We need our children - the recipients of these solutions – to be cocreators along, and lead change, along

# **Teaching leadership**

Rai opines that leadership and teaching are intricately tied.

"I have had the remarkable privilege of watching more than 4,000 people enter and complete TFI's two-year fellowship. These are young Indians who decided to leave their pre-defined career paths and teach in a low-income classroom for two years. Afterwards, 70% of them continued to remain in education. Today, those leaders are starting their own schools, running organisations that are serving the poor, holding important roles in politics, and so much more. Together, those numbers give me hope. They tell me that we have a country that wants change - and they are willing to do something about it," says Rai.

It is also essential to note that each of those 4,000 stories started out in the classroom. They were made possible because of a decision to get proximate to India's realities. "Our Fellows overwhelmingly point to one big reality underlying their teaching experience: in the process of changing their students' lives, they themselves are growing and transforming into better human beings," explicates Rai. "They are growing into better listeners, planners, and influencers. And because of all that they are witnessing, they are growing more aware and hopeful. It is that transformation – facilitated by the process of teaching – that is equipping them to lead towards a better tomorrow," he smiles, signing off.

# Six Cs of success

Communication and confidence are key qualities one needs to become employable

The world is moving so fast that institutions are not able to catch up with the ever-changing industry requirements. By the time teachers get ready to teach a subject, it gets outdated. Changes in technology, especially artificial intelligence (AI) and robotics will make many jobs obsolete. The need to bridge this gap is what led Rakesh Godhwani to set up School of Meaningful Experiences (SoME), Bengaluru, in 2018.

After getting a job in Wipro in 1997, Godhwani realised that his real strength was his ability to communicate. Wanting to impart this skill, Rakesh started teaching others how to communicate and present their ideas in meetings, sowing the seed for

The School was established on the concept of six Cs of success: Communication, Confidence, Curiosity, Creativity, Collaboration and Competence.

"I believe that when two human beings connect to work together in a professional setting or outside it, the essential skills needed at that time are communication and confidence. But these two qualities are just the tip of the iceberg. If the person is not curious, creative, collaborative and competent, the other two will not work. And this is what we call as the Six Cs of our philosophy," explains Godhwani.

Godhwani believes that it cannot be achieved by students sitting in the classrooms and cramming answers, or solving test papers on their mobiles.

"I also believe that while a learner has to know the subjects, she/he has to also know how to present their ideas in front of others, persuade them to see the bigger picture, manage conflicts, handle bullies, deal with failures, negotiate and persevere in getting things done. All of these are essential skills which we bring inside our programmes at SoME."

There are programmes targeting those between 11 and 25 years of age, and the flagship programme is a Diploma in Six Cs basic version that runs for 21 weeks between July and December.

The first batch of students graduated at the beginning of the month, and stories of their transformation have been encouraging. For instance, one of the students has shared how this programme has helped her gain confidence and speak in front of her class which she was never able to do earlier.

The school plans to push their online platform harder in order to attract students from all over the country. "We have successfully tested a batch of online students, and the tech platforms are so stable that after a point it doesn't feel like I am teaching in a virtual classroom. Teens today are techsavvy and are anyway quite used to using apps and gadgets for learning. Most of them have done some sort of online programme already. In fact, they taught me a thing or two about the technology I didn't know myself," says Godhwani.

Is math the unfortunate albatross around your neck that will guarantee you the course of your choice? Here are some options to bust that myth

Math evinces really strong reactions from students. But, we are told by parents, teachers and counsellors that this nightmare is compulsory in classes XI and XII, if we want to pursue any good business or management courses. And it is

true in most cases, but not all.

Yes, you do not need to compulsorily study math in class XII to pursue a management programme from reputed universities. So, in order to provide relief and a direction to all the non-math students, here are the different universities from across the world, offering management courses without math.

#### India

There are a few reputed universities that offer a foundation programme for students not having a math background whereas some provide direct admission based on class XII scores. A few of these universities are University of Waterloo, York University, Thompson Rivers University and Simon Fraser University

Now, a word of practical advice. You will notice that though you have options, these are limited. So, it will be good for students to opt for math in class XI and XII as it will increase your options. So, really, chin up and eat that frog.

# Big victory for Australia despite Blundell's fighting century

Pattinson begins dismantling, Lyon completes task as Kiwis chase daunting target

It was the second heavy defeat for the Black Caps, who lost by 296 runs in Perth and will be playing for pride in the final Test at Sydney later this week.

Pattinson, playing for the injured Josh Hazlewood, did the early damage. New Zealand had reached 32 without

"But, honestly I am enjoying and glad to put myself back in this kind of position and be able to compete. Something to be very proud off. So, whatever comes now, it will be a bonus," she says.

"I love playing tennis. I feel I have a lot more tennis left in me. It was not a plan all along definitely. For, there were so many unknowns when you are blessed with a baby (Izhaan). Like how emotional you will be, how physically challenging it will be and how your body reacts," said Sania. "The big issue is how long I can do this," she added.

"And, losing 26 kg weight in four to five months and starting from negatives, not even zero, when your body completely changes, you lose all your muscles, it was never easy," Sania explained.

"I have no set goals like winning any title. I just want to see whether I would be able to compete at the highest level or not," she said.

"Yes, certainly, Tokyo Olympics is at the back of my mind for sure. And, it will be great if I can make it to what would be my fourth Olympics," she said.

"But, again, that is not something which is my immediate goal. I have to see how my body reacts, behaves after match-play. So, the first target is to be healthy, not winning or losing," she added.

Will there a critical review after the Hobart and the Australian Opens? "I think it will be too soon to make a judgement.

"After a two-year long gap, at least couple of months and a couple of more tournaments are needed to do that," says Sania.

On her new doubles partners, Sania says she is excited to partner Rajeev. "I never played with him. But, he is a very close friend of mine since I was 12 and he 14 years. It will be lot of fun and more so he is the defending champion in Melbourne,3 says Sania.

"Nadiia is a very solid player, ranked World No.38. Well, I am not saying I am going there to win the Australian Open, but I want to enjoy every moment," she concluded

than this. All they want is power because lucrative contracts have to be handed to their cronies. There is [₹]25 crore to be looted and siphoned off and this is just the beginning," said Manchanda, who told The Hindu that he had to seek police

Another Apex Council member and Director, Sudhir Agarwal, termed it a "black day for DDCA" and called for strict action against the "goons." He claimed,

dent) too opting to resign, in view of what he states loot and corruption in the DDCA, the BCCI must step in to safeguard its funds and to take charge of cricket.

"In fact, a Forensic Audit Report commissioned by Vikramajit Sen proved all this malfeasance but is gathering dust in DDCA. To stop horse trading and also to stop the loot of subsidy and other funds, I implorethe BCCI to immediately appoint an administrator to take charge of DDCA's operations. Also, the funds currently available with DDCA should not be allowed to be swindled, as alleged by the outgoing presi-

Satish, a Commonwealth and Asian Games medallist, booked his berth with a split verdict triumph over Narender. Joining the two was Sachin Kumar, who claimed the 81kg spot with a victory over Brijesh Yadav.

In other results, Commonwealth Games gold-medallist Vikas Krishan moved into the final with a unanimous win over Ashish Kulheria. Vikas will face Duryodhan Negi in the final on Monday. Negi defeated Naveen Boora in a split decision.

Another CWG gold-winner Gaurav Solanki (57kg) too advanced to the final by getting the better of Kavinder Singh Bisht, an Asian silver-medallist and a world quarterfinalist. Next up for Solanki is Mohammed Hussamuddin, a CWG bronzemedallist, who edged past former youth World champion Sachin Siwach.

In the 91kg category, Naveen Kumar won against Gaurav Chauhan in a split decision to set up a final clash with CWG bronze-medallist Naman Tanwar.

NEW DELH In a year when top-ranked teams were busy fighting it out in the Pro League and amping up their game against the toughest opponents, the highlight for the Indian men and women's hockey teams was booking the all-important ticket to the 2020 Tokyo Olympics to round up the

#### **Crucial wins**

Having decided against being part of the elite nine-nation competition - eight for men after Pakistan pulled out the Indian teams had to make do with lower-ranked opponents in the first half of 2019 but came out victorious in the few events that mattered.

And, none more than the Olympic Qualifiers in November, hosted at the Kalinga Stadium in Bhubaneswar that has become the virtual home of Indian hockey.

While the men had an easy outing in the two-leg Qualifiers against a much-weaker Russia that, nevertheless, did expose a few chinks in the Indian armour, the women sealed their Tokyo spot in dramatic fashion, led by captain Rani Rampal, against

The wins managed to soothe the hurt the teams had been carrying since the disappointment of the 2018 Asian Games.

There were other highs as well for the men - Hockey Series Finals winner, runner-up at Sultan Azlan Shah Cup after going down to Korea in the shootout and the Olympic Test Event in Tokyo that gave the team crucial firsthand experience of the venue, conditions and surface that they would face seven months from now.

An additional challenge for the players was getting used to coach Graham Reid's style. The Australian, a former assistant to the legendary Ric Charlesworth when the Kookaburras ruled world hockey and led them at the Rio Olympics, took charge

just before the men travelled to Australia and only had a few months to find his best combination for the qualifiers.

Assisted by analytical coach Chris Ciriello, with whom he worked as a player, Reid managed to find the sweet spot between youth and experience.

It was a different battle for Sjoerd Marijne and his women. The Dutchman, appointed in 2017, shunted to the men's team midway before being moved back to lead the women in 2018, made sure the team went from strength to strength through the year, both physically and mentally. Working with scientific ad-

visor Wayne Lombard - credited unanimously by the girls for their vastly improved fitness, strength and stamina Marijne brought the full weight of his experience as a motivational speaker to work on the mental toughness of

Unafraid to use psycholog-

better, Marijne began with a winning series against Spain and Ireland that laid the template ahead of the Series Finals in Hiroshima. The women exacted revenge for the final defeat to Japan at the Asiad and gathered enough points to ensure they played the Qualifiers at home. It made all the difference.

#### Juniors do well, too

The juniors, both men and women, too did well enough to merit attention. While the men began with a disastrous outing at the 8-Nations tournament in Spain – that saw chief coach Jude Felix being summarily dismissed, a vacancy that remains unfilled they made up with a runnersup finish at the Sultan of Johor Cup.

The women, meanwhile, won the 3-Nations tournament in Canberra towards the year-end. The team also won the Cantor Fitzgerald U21 International 4-Nations tournament, registering 10 wins and two draws in the 16

She did win the junior mixed air pistol gold in the National championship, despite being sidelined by Haryana for the senior mixed event. When the best of shooters – who had secured 15 Olympic berths for Tokyo 2020 – fumbled, Manu stood tall to win the women's and iunior air pistol gold in the National championship apart from the silver in the sports

The shotgun came short, except for the brilliant manner in which Angad Vir Singh Bajwa and Olympian Mairaj Ahmad Khan won the two Olympic quota places in skeet with a dramatic gold and silver finish in the Asian Championship. Indian shooting has no time to celebrate the brilliant season, as it attempts to set its sights on the Olympics in Tokyo.

# Fulfilling my father's dream: Lalrinnunga

Jeremy Lalrinnunga, who became the first ever Indian to win a gold medal at the Youth Olympic Games last year, said he is currently fulfilling his father's dream by representing India in various senior weightlifting competitions. The 17-yearold's father was a junior boxing champion, but couldn't go on to represent India.

## **Biggest inspiration**

"My father has been the biggest inspiration in my career. He has backed me fully since the time I decided to take up weightlifting. He was a boxer so he has shared all his experience of being a sportsperson with me.

"He was a junior champion, but unfortunately, he didn't go on to play for India and therefore I am fulfilling dream." Lalrinnunga.

The weightlifter, who hails from Aizawl (Mizoram), is currently looking to book a berth at the 2020 Tokyo Olympics. Lalrinnunga has clinched two silver medals in the 67 kg category this

"I am training for that competition. I have won two silver medals in the 67 kg category this year. I clinched the first one in the EGAT's Cup International weightliftchampionships in Chiang Mai, Thailand, and won the second one in the 6th Qatar International cup said the Doha," 17-year-old.

Lalrinnunga, who won gold in the first and second edition of the Khelo India

Games, said that the competition is like an internationallevel tournament. He competed in the 62 kg and 67 kg in the first and second edition respectively. "The Khelo India Youth

Games is a very good experience for young athletes. The competition is like an international-level tournament. It's a very good competition. The Indian government

and Sports Authority of India are supporting all the upcoming athletes. With their continued support, India will win Olympic medals in the future," said the weight-

event that does not feature a final, Sib Kumar Ghosh won the men's 50-metre free pistol gold, one point ahead of Gaurav Rana, who won the junior gold.

History-making performances, some selection drama on the sidelines and ignominy due to big-ticket dope fails -Indian boxing was all this and much more in an actionpacked year dominated by pint-sized dynamo Amit Panghal.

To count the positives, 23year-old Panghal fetched India its first-ever silver at the men's world championships, the redoubtable M.C. Mary Kom was mostly in top form and medals poured in internationally courtesy a deep talent pool

In the professional circuit, Vijender Singh remained unbeaten, still looking for an opponent who can stand up to the raw power of his punches.

## **Downside**

On the downside, a flip-flop selection policy led to sixtime World champion Mary Kom being dragged into an unsavoury controversy, and the accomplished duo of Neeraj Phogat (women's camp) and Sumit Sangwan (men's camp) flunked dope tests, sending down shockwaves within the fraternity. For most part, Indian box-

ing had lots to celebrate and it started with the seasonopening Strandja Memorial, one of Europe's oldest and competitive

Panghal's 2019 gold rush began in the tournament, which was also his last competition in the 49kg category.

Former junior World champion Nikhat Zareen and Meena Kumari Devi became the first set of Indian women boxers to finish on top at the same event. Zareen later went on to hit the headlines by vociferously raising the demand for a trial against Mary Kom.

Panghal moved up to 52kg in March, and though he sounded a bit nervous about the shift, the results told a different story. He grabbed a gold immediately, at the Asian Championships in April, to assert his supremacy in the new division.

Pooja Rani, a boxer who felt shy about wearing gloves at the start of her career, ensured that women too went home with a gold with her best ever performance at the event. Mary Kom gave it a miss to prepare herself for the world championships.

Then came the world championships in September and October, the blue-riband event which lost some of its sheen after being stripped of Olympic Qualifier status by the International Olympic Committee due to the alleged administrative mess and financial mismanagement in the International Boxing Association (AIBA).

There was some drama when the Indian women's squad was finalised for it, as Zareen protested after being stopped from appearing for a scheduled trial bout. However, it didn't make much of a difference to the final list as Mary Kom was picked based on her golds at the India Open and an Indonesian tourney besides the consistent performance in the national camp. What also tilted the scales

in the veteran's favour was her victory over Zareen in the India Open semifinals.

## Watershed moment

In the world championship for men, Panghal gave India a watershed moment by making the finals after Manish Kaushik (63kg) fetched the bronze, which had earlier been also achieved, in 2009, 2011, 2013 and 2015.

The silver made Panghal the undisputed top name in Indian men's boxing and he capped the year by winning the Best Boxer Award at the BFI's first ever pro-style league.

As for the women, 20year-old Manju Rani, who lost her father - a BSF man -to cancer in 2010, found the individual glory she was looking for when she took to the sport. She was the lone Indian to make the women's world championship final this time and signed off with a silver medal. The iconic Mary Kom had to be content with a bronze this time.

The BFI had decided that the gold and silver-winners from the women's world championship would be given direct selection for next year's Olympic qualifiers.

However, the body's President, Ajay Singh, stirred up a hornet's nest by stating that the BFI would make an exception for Mary Kom (51kg) and select her without a trial.

Zareen raised the protest card and even wrote to the sports minister, demanding a trial.

The BFI, after maintaining a stoic silence, announced trials and the controversy finally ended after an angry Mary Kom defeated the younger boxer to not just make the cut but also prove a point about her abilities at

The sport itself remained in doldrums internationally with the International Boxing Association taking charge of the Olympic qualification process and the conduct of the competition in the Olympics.

This was after AIBA failed to convince IOC of its financial well-being and integrity, which took a severe hit during the 2016 Rio Olympics due to poor judging.

The coming year promises to be a big one for Indian boxing.

# Mane bags Tata Steel Tour C'ship

The 2019 Tata Steel PGTI season had a fitting finale as the battle for the season-ending Tata Steel Tour Championship went down to the wire at the Golmuri Golf Course with multiple contenders in the fray in the dying stages of the tournament. But it was the Pune-based Mane's "steely resolve' that helped him triumph in 'Steel City' at the ₹ 1.5 crore event by a slim oneshot margin.

Mane's (67, 66, 64, 65) determined final round effort of 7-under 65 saw him establish a new PGTI record for the lowest tournament total as he closed the week with a 26-under 262. It was Mane's eighth

professional title and his second win on the PGTI this season. The impreswinning cheque worth ₹ 22,50,000 catapulted Mane from ninth to third place in the Final PGTI Order of Merit for

Kolkata-based Indian star SSP Chawrasia (63, 67, 65, 68), who was leading by two shots till the 14th hole, carded a 68 on day four and thus had to settle for second place with 25under 263.
