Shan tracks down Vikram, leaves Nasa stunned

Chennai techie Shanmuga Subramanian has helped Nasa identify the crash site of Vikram lander of Chandrayaan-2 on the moon's surface just when the space science community began showing despera-tion at not being able to decipher the disappearance of the lander on September 7 when it was supposed to

soft-touchdown on lunar surface. The 33-year-old engineer posted on Twitter that Nasa has credited him with finding the Vikram debris on lunar surface as his conclusions from Nasa images of the lunar surface helped American premier space agency spot the exact location of the lander that reportedly broke into several pieces on crash-landing.

The IT professional went through Nasa's Lunar Reconnaissance Orbiter Camera (LROC) images "pixel by pixel" to identity a single bright pixel from the its mosaic taken on November 11 and e-mailed his conclusion to both the Nasa and the Isro. While the US space agency responded, albeit a bit late



'SEARCHING

I searched pixel by pixel (each pixel measures about 1.25 meters) of Nasa's images. I spent about 30 hours on two computers. I did not use any additional software tools, but only basic image viewing tools.

images of various findings, Isro does not indulge into the same. Once Isro starts doing something similar, it would be helpful for the scientific community. A large number of people have questioned Shanmuga regarding why he did not approach Isro with his findings, to which he replied that people from ISRO never replied to him.

"I had gone through the LROC images pixel by pixel and found some minute variations at a spot on the lunar surface between the image of December 2017 and the one taken on September 7, when Vikram was supposed to land. I sent my finding to Nasa and what they did was to closely search the lunar surface based on the location I gave and pick up the location of Subramanian told DC, amid the tight stream of media interviews at his

Besant Nagar apartment. From the two LROC Subramanian images, could point out to Nasa that the 2017 image had no white dot whereas the September, 2019, image had it at that spot, and that could only mean that it was Vikram lander, which could only be visible as a dot because it was 1.25 m per pixel. "I saw the internet landing location. From Vikram lander's last known location, I knew it must be somewhere around that. I searched the 2x2 km sq area pixel by pixel—one pixel is around 1.25 m or something like that. Since the lander was so small, I had to search each and every pixel. I was able to find something out of ordinary over there and I sent out a mail to Nasa" recalled the proud 'space

scientist'.
While the nation was plunged into sadness after the much-anticipated moon explained that contact with Vikram lander could have been lost due to 'hard-braking' in the final phase of its descent. The American space agency, Nasa, which has been closely following the mission—as also several international agenciescollaborated in the Isro search for clues about the whereabouts. Nothing much happened, until Subramanian's mail landed at the two space agencies. "I feel happy I could find the debris. I had worked for close to seven hours every day for a week, going through the LROC images from Nasa. It was worth it". Subramanian ■ More on P2

Parliament passes bill to amend SPG Act

The Rajya Sabha on Tuesday passed a bill to the elite Special Protection Group. The bill had already been passed by the Lok Sabha last week.

The passage of the amendments to the SPG Act will pave the way for only the Prime Minister and his "immediate family residing with him at his official residence", as well as any former Prime Minister and members of immediate family "residing with him at the residence allotted to him for a period of five years, from the date he ceases to hold the office of Prime Minister," to be given SPG cover. The Congress has been claiming that SPG Act has been amended only because of political vendetta.

Home minister Amit Shah, rejecting the Opposition's claim, said the government was concerned about security of all 130 crore Indians and not just the Gandhi family. Participating in the debate over the Special Protection Group Protection Group (Amendment) Bill, 2019, Congress MP Vivek Tankha said everyone wants the Gandhi family to be protected and there should not be "a party politics" on it.

Neet opens applications **for 2020**

Chennai: The National Testing Agency(NTA) on Monday opened applications for Neet 2020. The exam is scheduled to be held on May 3, 2020, between 2 pm and 5 pm across India, Aspiring candidates can apply for the common medical entrance examination through the website ntaneet.nic.in. The NTA has announced that the last date for submission of these 'online' application forms will be Dec31, 2019. The NTA has introduced new security 'features' in the application form, evidently in the wake of the Neet scam which was uncovered in Tamil Nadu. Students applying will now have to attest their fingerprints along with a 'stamp size' photo, apart from attaching a passportsized picture. The photo should provide a clear image of the candidate's face(at least 80 percent of the face should be visible). The NTA has also announced that it will use software to screen the pictures provided. The software will match the photographs, flag identical photographs and detect the rest. In the latter cases, the candidates will be informed and will be provided with a link, which will enable them access to click a live photo. The software cross checks if

covery of Chandrayaan-2's crash site by Nasa, aided by Indian engineer Shanmuga Subramanian, is a shot in the arm for 'citizen science' in India and abroad with the free availability of data enabling amateurs to reach for the skies - sometimes literally. Citizen science involves the collection and analysis of data relating to the natural world by members of the public. The crash site of Chandrayaan-2's Vikram lander was discovered thanks to the availability of data from the American space agency for common citizens to analyse and interpret. Nasa's Exploration Mission Mission Planning Office Chief, Nujoud Fahoum Merancy commended anian's efforts and acknowledged the role of citizen science in a tweet. 'Very cool to see citizen science in action with #NASA Good @Ramanean!" she said. But this community-based approach to science has to be a collaborative effort with professionals guiding every step, cautions astrophysicist Sudip Bhattacharyya of the Tata Instof Fundamental (TIFR) Research in Mumbai. "It is essential that most citizen efforts,

which aim to utilize the data of cosmic sources for scientific progresses, should be guided by expert professional astronomers. Bhattacharyya told PTI in soned that such expert guidance is particularly required "so that the interpretation of the data does not take a non-scientific

In India, citizen science largely contributes to ecology and conservation studies. But the recent application of Nasa's Lunar Reconnaissance Orbiter Subramanian to find the Vikram lander's crash site has shown its potential even for other fields, including astronomy. "Astronomy is rapidly becoming such a free datadriven science, where citizens can participate, make discoveries, say of new planets, comets, asteroids and other cosmic sources, and take part to unravel the mysteries of the universe. Bhattacharyya explained. Citing an example, he said the Gaia satellite, a mission by the European Space Agency to chart a threedimensional map of our galaxy, provides free data on billions of stars. Using tools available on the Gaia Archive website, he said

in the galaxy, like stars, and even "new aspects of physics, could be discovered when the data are studied systematically, extensively and in a suitastronomers". able way, with the guidance

According to Bhattacharyya, data from citizen science projects require an additional expert processing and interpreting them, using the professional knowledge of the subject. In his view, the participation of interested citizens in the process of cutting edge scientific research is extremely important as it can significantly help science take root in society and promote scientific temper. He said this is possible when a huge amount of scientific data and user-friendly tools to analyse these data are freely available. While citizen science is under the spotlight with Subramanian's discovery, it has been used in various fields in India. The India Biodiversity Portal initiated more than a decade ago, for instance, is a platform aiming to aggregate data on all species living in India, with a dedicated module running based on citizen science for more than eight years.

"It appears that the initial searches looked at wrong locations and this discovery by Shan was serendipitous," Dibyendu Nandi, a pro-fessor at Kolkata's Indian Institute of Science Education and Research (IISER), told

an's findings about Vikram's "kinematics", the study of motion at the time of impact, made the discovery more interesting. For exam-ple, the depth of the impact crater compared to the spread of Vikram's debris hold clues to deciphering the speed and angle of

impact, Nandi said. "This information would be useful in reconstructing what went wrong with the landing manoeuvre, and at what height above the lunar surface the anomaly set in," he said.

Want to know about Pallikaranai marshland's unique characteristics, its marine ecosystem, its various habitat types and its different species of birds, plants and animals? Pick up *Paradise Regained: Bio* diversity of Pallikaranai Marsh, a coffee table book, published by Conservation Authority of Pallikaranai Marshland, Chennai.

The book has nuggets of information on various types of wetlands of South India and Tamil Nadu, Pallikaranai's biodiversity, its geographical and ecological significance and its degradation through land settlement. The marshland has shrunk from 6000 Ha in 1960 to 593 Ha in 2002. Stress is also laid on the importance Ramsar Convention's wise use of wetlands.

Efforts made by the conservation authority have borne fruit with the marshland playing host to thousands of migratory and resident birds now. It has been a treat for bird watchers.

Speaking to *Deccan Chronicle* V. Subbiah, District Forest Officer, Chennai Division, said, "We don't have any official record or literature on





Pallikaranai marshland. His action, especially in arresting a few senior HR CE officials made the latter allege that he was being "vindictive." They even grumbled that he had not arrested any real culprits in the temple idol theft cases nor filed any chargesheet. While he and the senior HR&CE officials were at loggerheads, the temple executive officers and staff alleged that they being targetted.

In a strange turn of events, the state govt's move to transfer the idol theft cases to the CBI ran into rough weather with the Madras high court cuashing the transfer order in Nov last year. And the court appointed him as special officer for a year, though he was to retire on Nov. 30, 2018.

Now with Manickavel's term as special officer ending on Nov. 30, the state government had on Friday directed him to hand over all the case records and work he and his team had done during his term in office. However, the retired IPS official had replied that it was "legally impermissible" in the absence of a specific direction from the Madras high court or the Supreme Court, as the court made his appoint-

He also initiated contempt proceedings in the Madras high court against the government officials. But on Monday, the Supreme Court stayed the contempt proceedings and upheld the government order directing him to hand over all case files to the Additional Director General of Police, Idol

CBI probe into IIT suicide deaths: orders reserved

The Madras high court has reserved orders on a Public Interest Litigation, which sought a direction to the Tamil Nadu government and police to hand over the investigation to CBI in respect of suicidal deaths committed from the year 2006 onwards in IIT-Madras

A division bench comprising Justices M. Sathyana-rayanan and R.Hemalatha reserved orders on the PIL filed by Saleem Madavoor alias Muhammed Salim, National President, Loktantarik Yuva Janathadal, Kerala, after hearing both sides.

According to petitioner, one Fathima Latheef, a resident of Kerala, who was studying M.A Integrated Course at IIT-Madras died on November 9, 2019. The father of the deceased has

the Chief Minister of Tamil Nadu and Kerala seeking fair investigation and the case of his daughter was homicide. From the year 2006 onwards, so far 14 students committed suicide in IIT campus. It was learnt from the students community that the dean was adamant to listen to the grievance of students. Every time, a student commit suicide the student point out, "how ineffective the present mechanism in the IIT". It was learnt that 5 students from Andhra Pradesh, 3 students from Telangana, 3 students from Kerala and 2 students from Tamil Nadu, 2 students from Uttar Pradesh and one each from Puducherry, Jharkhand and Rajasthan committed suicide. They have faced discrimination on the basis of religion, caste, language, he added.

Five cities in Tamil Nadu will soon boast of having climate-resilient water supply, sewerage and drainage infrastructure, thanks to the Asian Development Bank (ADB), which has come forward to advance \$ 206 Million loan to the government to strengthen urban

services in the 5 cities. The project is aimed at improving the lives of the people in the identi-fied cities by providing universal access to water supply and sanitation and improving sewage treatment and drainage systems. The initiative is also expected to help the State develop the requisite ecosystem for economic growth, according to Additional Secretary (Fund Bank and ADB) of the Department of Economic Affairs in the Ministry of Finance

Sameer Kumar Khare. This is the second project loan for the ADB-supported \$500 million multi-tranche financing for Tamil Nadu Urban

Flagship Investment Program, approved in September 2018, that will overall develop climate-resilient water supply, sewerage, and drainage infra-structure in 10 cities of Tamil Nadu. The first project under the program with \$169 million financing is currently

under implementation.
The project will target four cities: Ambur, Tiruchi, Tiruppur, and Vellore, for developing sewage collection and treatment and drainage systems by setting up or rehabilitating sewage treatment plants, pumping stations, and connecting all households in the project area to the network. sewerage including below poverty line households. Wastewater reuse for industry will also be achieved in at least 4 cities.

Improvement to water supply systems would be targeted in Madurai and Tiruppur through the commissioning of over 1,260 km of new distribution lines to connect nearly 1,90,000 housewith metered water supply, including

below poverty line households. In addition, transmission mains and 230 km of feeder mains would be constructed, along with two new water treatment plants.

The project will also strengthen the capacity of the Commissionerate of Municipal Adminis-tration in Tamil Nadu for new project developand benchmarking quality of services across the 135 urban local bodies in the State.

The signatories to the loan agreement were Mr. Sameer Kumar Khare ADB Country Director for India Mr. Kenichi Yokoyama.

Jumbo tramples mahout in zoo park

Tragedy struck at the Kurumbapatti zoological park, a mini zoo situated in the foothills of Shervaroyan hills near Yercaud, about 10 km from here on Monday evening, when a female elephant trampled its

mahout to death. The 68-year-old pachy-derm, Aandal, brought to the park from Alagar Kovil near Madurai in 2009, had in a sudden fit of anger, when it was being examined by a veterinary doctor, lifted aloft mahout Kaliappan standing near it, thrashed him on the floor and trampled him underneath her massive feet, forest department said Tuesday.

As part of the routine medical check-up, vet-erinarian Dr Prakash had come with his team and was examining the elephant closely when she suddenly went uncontrollable. Shocked by its behaviour, the veterinarian and his team ran for cover even as the badly mauled mahout Kaliappan, who hails from Pollachi, lay dead near her feet.

On information Forest department officials led by DFO A. Periyasamy rushed to the spot, tranquilized the elephant by administering an injec-

and slowly retrieved the mahout's body and sent it to Salem GH post-mortem. Poor Kaliappan is survived by wife, three sons and a daughter.

Aandal has a history of throwing up violent tantrums and it had similarly killed a woman here, forest department sources said, adding, it was a problematic elephant even when it was in Alagar Kovil where three others had met with similar fate.



fills the criteria. Other senior officials say that guns have been misused earlier. Also, nothing indicates that guns prevent rape or other violent crime, barring exceptions. We have come across cases wherein license holders have intimidated people just by showing the weapon," these officials "We do not want a gun culture like the USA's and therefore more rejections.' What if the police is slow or ineffective? Officials had little to offer.

But do guns assure safety for women? Numerous studies in the US suggest that the increasing guns bought by women for self protection have proved ineffective during an emergency. According to a study by the Violence Policy Center, the message that firearms make women safer actually had the opposite effect. In a majority of domestic violence cases, a gun at home ended up killing a woman by a relative. In only a few instances did a woman use a firearm for self-defence. 'In America, guns are not used to save lives but to take them," sums up the report.

Another senior IPS officer feels, however, that in an emergency, a woman pulling out a weapon is enough to deter and repel her attackers. "They need not actually fire the weapon," he says. "Once the attacker notices that the woman is armed, he realises it can be dangerous.

Homilies, impotent rage hide the sickness within

arliament was rightly exercised over the gruesome crime against Hyderabadi vet "Disha" (police officially adopted this pseudonym long after millions had already chanted her real name in street protests, social media posts and newspaper debates). She was the victim of a spontaneous crime by four men who then, perhaps fearing the consequences of their actions given the existing stringent punishment enacted by Parliament with the Nirbhaya law of 2013, burned her with diesel purchased "loose" at a nearby petrol pump. The nation is shocked,

and that was reflected as members across parties rose to speak their anguish of a young and promising life snuffed out.

However, Parliament expressed its impotence by wrongly resorting to bloodlust. "Lynch them," said Rajya Sabha member Jaya Bachchan — in English. Vice-President Venkaiah Naidu spoke of showing no mercy to the rapist-murderers, just in case anyone was contemplating being merciful. Both he and Leader of Opposition Ghulam Nabi Azad spoke of bringing in stringent laws and nipping these crimes in the bud. Others used the occasion to settle political scores. A bunch of homilies which generated a lot of heat but shed no light.

What's happening in Iran?

Since Iran's media isn't free and the state is authoritarian, and Western reporting must be viewed with caution due to the curbs in place, it isn't easy to ascertain the political impact of the protests that rocked the country in November, and the strong governmental repression that followed.

The protests after the November 14 rationing of already very cheap petrol, and raising of its price by 50 per cent, spread rapidly across Iran, suggesting public receptivity. At some places it turned violent. Initial reports of deaths after police firing were modest, but later Amnesty International spoke of 208 deaths, which Tehran denied. This figure is unsubstantiated. But the official Iranian media too have

spoken of many deaths in police action, though no figure was provided. What is undeniable is the frequency of large-scale public protests that spread quickly. In December 2017-January 2018, nationwide protests were set off by a hike in food prices. Two years later, petrol is the trigger.

Officially, Tehran accepts that 75 per cent of the population is vul

ble. The US sanctions under President Donald Trump's "maximum pressure" policy, after Washington resiled from the 2015 nuclear agreement with Iran last year, have evidently taken their toll. The economy contracted nine per cent, inflation is at 40 per cent, and unemployment is high. It's probably to address this situation that President Hassan Rouhani's government decided last month to cut petrol subsidies to meet other pressing needs of the bulk of the 82 million population.

But the timing of implementing the IMF-mandated move seems odd as parliamentary elections are due in two months. If that suggests a quiet move within the higher levels of the ecclesiastical regime to embarrass the moderate President, more information is needed for a confirmation.



If trust breaks down, a society cannot survive

magine going to a restaurant, ordering a meal, paying for it, expecting to be served and then discovering that neither the dishes you ordered, nor anything else that you fancy, are available. Imagine if the person managing the place also tells that you can't have your money back since he does not have change, and that you can come back the next day for your meal. Or imagine the reverse that you are a restaurant owner and a cus-

tomer refuses to pay after having had a meal. Luckily, this does not happen often because there is tacit trust between a consumer and a service provider and both parties respect the deal that something that has been consumed has to be paid for, and

As we know from our day-to-day experience, economic trust, no transaction is possible.

Trust lies at the heart of today's complex global economy.

Prosperous countries often tend to be those where business relations between people can be conducted on the basis of trust, such as Germany, Japan and (perhaps sur-prisingly) the United States, as political scientist Francis Fukuyama famously argued in his 1996 bestseller *Trust*: The Social Virtues And The Creation Of Prosperity: Human Nature and the Reconstitution of

Social Order One should not have to reaffirm such first principles. But recent statements by several public figures, including a former Prime Minister, zeroing in on how mistrust is corroding not only the social fabric but also the health of the economy, tells you how critical it is to address

the issue. In a widely talked

about commentary in *The Hindu*, former Prime Minister Manmohan Singh, a globallyrenowned economist, linked the deeply worrying trends in the economy with a deeper underlying malaise. As nominal GDP growth falls to a 15-year low, joblessness rises to a 45-year high, household consumption sinks to a four-decade low, bad loans in banks breaking all records, and growth in electricity generation standing at a 15-year low, Dr Singh argued that the functioning of any economy is the result of the com-bined set of exchanges and social interactions among its people and institutions and that "mutual trust and selfconfidence are the bedrock of such social transactions among people that foster economic growth. Our social fabric of trust and confidence is now torn and

Lack of trust in the fairness of the system plays out at several levels. If you fear that your action or word may be misconstrued, you could retreat into a shell of silence and inactivity. Dr Singh said that many industrialists have told him that they live in fear of harassment by the government authorities, that bankers were reluctant to give new loans for fear of retribution and that entrepreneurs were hesitant to put up fresh projects for fear of failure attributed to ulterior motives.

In a commentary in the New York Times, titled "India and the Mistrust Economy", Kaushik Basu, a former chief eco-Kaushik nomic adviser to the Government of India and now a Cornell University professor, also pointed out: "A drop in investment is usually connected to a lack of trust in the present and the near future. When businesses worry about

a country's policy environment, they hesitate to sink money into it."
Is it only economists

who are critical of the Narendra Modi govern-ment and are flagging the urgent need to restore trust in the social and economic fabric of the country?

What should an ordinary Indian make of two eminent Indian entre-preneurs publicly talk-ing about the debilitat-ing nature of fear and the lack of trust in the past week?

Biocon chairperson and managing director Kiran Mazumdar-Shaw has been quoted in the media saying that the government did not want to hear any criticism of the economy, while expressing hope that it reaches out to India Inc to work out solutions to revive growth. Her observa-tions come soon after veteran industrialist Rahul Bajaj told home minister Amit Shah at a public event in Mumbai that there was an "atmosphere of fear" and that people were afraid to criticise the government because they do not have the confidence that the government will appreciate

anv criticism Last year, Ravi Venkatesan, a known business leader and former chairman of Microsoft India, publicly pointed out that the strident and polarised debate around Aadhaar was actually a reflection of the fact that India is a low-trust society and this has profound consequences for our future.

Here's why the Chinese model is unsuitable for Pakistan's govt

very few months or so, the demand for a 'presidential system' of government in Pakistan makes an appearance on various social media sites. This happens most prominently on Twitter, where a number of users share similarly worded tweets, all using the same hashtag.

On its own, there's nothing wrong with the demand for a constitutional redesign. Political systems are, theoretically, not set in stone, and neither are constitutions. Parties in a number of countries have contested for power on platforms that seek to change electoral systems, voting formulae, power-sharing arrangements between different social groups, and relations between the executive, legislature, and the judiciary. If anything, initiating a public conversation on institutional redesign is certainly more practical and preferable than cheerleading for ad hoc interventions by a particular organ of the

The most recent chorus of presi-

dential fetishism is also slightly different from previous iterations on at least two counts. One is its frequency, which seems to be picking up pace since this government took office in July 2018. It appears an everincreasing number of people from one side of the partisan divide believe that the lack of executive authority with the Prime Minister's Office, the reliance on largely incompetent ministers, and the cumbersome legislative procedures required to push through 'change', are holding the country back.

The second change is the citation of two countries as case studies worthy of emulation — China and Turkey. While the infatuation with Erdogan has been around for a while, the systemic embrace of Turkey is relatively new. What's also interesting is that believers in the 'China model' seem to be increasing in proportion to the country's enhanced footprint on Pakistan's economic and strategic decision-making. The drawing room logic is some variant of 'if their sys-

tem allows them to build a motorway at lightning speed, it's surely worth importing'. Less facetiously, high growth rates, 'strict rule of law', zerotolerance for corruption, and the overall welfare success of this developmental model are usually cited as reasons for systemic emulation.

This is curious because China's actually existing political system (what drives its well-publicised growth story) is considerably underdiscussed in mainstream political conversations across Pakistan. The print and electronic media doesn't report on China's domestic politics, and it rarely reveals any insight into what drives economic growth. There's a recurring caricature of strong leadership, mythical levels of anti-corruption, and decisiveness, in drawing rooms, WhatsApp groups, and TV studios alike, but that's where the depth of it ends.

Leaving aside the moral and functional desirability of parliamentary democracy in ethnically fractured societies, and China's own authoritarian behaviour with minority groups, it is worth clarifying some important features of China's political economy before embracing it as

In an excellent new book on the past, present, and future of economic systems, titled Capitalism, Alone, Branko Milanovic draws a sharp contrast between two ideal types of capitalism that have shown relative durability. Liberal meritocratic capitalism, exemplified by the US, and increasingly characterised by plutocratic levels of inequality and disparity. And political capitalism, exemplified by China, which stands as the only present-day alternative to organising politics and economics in a particular configuration, since the implosion of communism (or state socialism).

political capitalism, according to Milanovic, rests ironically on certain pillars some of which seem to be at odds with its popular caricature in the Pakistani imagination. Tracing the current system

back to Deng's reform period, Milanovic argues that political capitalism exhibits two main features: The first is a highly skilled, technocratically efficient, and meritocratically recruited bureaucracy. This bureaucracy (which is clearly the primary beneficiary of the system) has as its main duty to realise high economic growth and implement policies that allow this goal to be achieved. Growth is ultimately needed for the legitimisation of continued bureaucratic and party rule.

The second feature is the absence of rule of law, rather than its unequivocal application. This, Milanovic argues, is necessary to ensure that the interests of businessmen (and the private sector in general) are never in a position to become primary drivers of government behaviour. Instead, the state retains authority and autonomy precisely because it can choose to apply the law to whomever and wherever it wishes.

Charwhat the Eiffel Tower is to Paris or the Mahal is to Jaipur. It is its signature monument. The former Hyderabad state had the Charminar on all its coinage. It is as old as Hyderabad itself.

Muhammed Quli Qutb Shah (1580-1611 CE), the fifth sultan of the Qutb Shahi dynasty of Golconda, laid the foundation of the iconic Charminar to symbolise the founding of Hyderabad. He was a contemporary of both Akbar and Jehangir. Hyderabad was intended as a citadel of Muslim power in the Deccan. Qutb Shah was an accomplished poet and wrote his poetry in Persian, Telugu and Urdu. His famous ghazal "piya baaj pyaala piya jaye na, piya baaj ek din jiya jaye na" is still a favourite at soirees today. While laying foundation Charminar, Qutb Shah

recited a couplet in Dakhni: "Mere shahr logon se mamoor kar, Rakhiyo joto darya mein machhli jaise (Fill this city of mine with people as You filled the river with fishes, O Lord)." Clearly the Lord listened to his prayers, for now Hyderabad is India's fastest growing metropolis, and was listed by *National* Geographic magazine in 2015 as the second best place in the world to visit.

How Hyderabad came to be called that is a now a legendary love story that with the young prince falling in love with a beautiful Hindu woman he espied at the exact spot the Charminar stands today. More contemporary versions have another Salim-Deccan. Only this time beauty was rewarded with a city. In 1589, Muhammed Quli Qutb Shah married Hindu woman, Bhagmati, reputed to be a courtesan, who remained with him as his queen till his death in 1611. The sultan bestowed the title of Hyder Mahal on Bhagmati,

and hence the name of the new city came to be Hyderabad. Bhagmati's lowly origins evoked some harsh opinions. Shaikh Abu al-Faiz ibn Mubarak, popularly known by his pen name, Faizi, who was the Malik-ush-Shu'ara (poet laureate) of Akbar's court, after a visit to Hyderabad wrote to Akbar that the place commemorates "a hardened whore".

According to Jean de Thévenot, a French traveller of the 17th century whose narration was complemented with the available Persian texts, the Charminar was constructed in the year 1591, to commemorate the beginning of

the second Islamic millennium year (1000 AH). The event was celebrated far and wide in the Islamic world, thus Qutb Shah founded the city of Hyderabad to celebrate the event and commemorate it with the construction of this building. Due to its architecture, it is also called the Arc de Triomphe of the East. There is now a sectarian

conflict brewing out of a plan to expand the Bhagyalaxmi Temple growing out of the southcorner Hyderabad's iconic Charminar. One must relate the name of this tem-

ple to the demand in cer-

tain rabid RSS quarters to rename the city as Bhagyanagar. A BJP MLA, Raja Singh, from the nearby Hindu-dominated constituency of Maharajganj, has been quite shrill about this. Given Bhagmati's questionable antecedents, the likes of Raja Singh need

is a rare instance of secular Islamic architecture in India. The Archaeological Survey of India (ASI), the current caretaker of the structure, mentions in its records: "There are various theories regarding the purpose for which the Charminar was constructed. However, it is widely accepted that Charminar was built at the centre of the city to commemorate the eradication of cholera", a deadly disease which was widespread at that time.

True, there is a mosque on the top deck. But that was par for the course in all Muslim structures. Even the Taj Mahal, a maqbara, has a mosque. This reflected the socio-political reality of the era.

About the temple named Bhagyalaxmi Temple, that is now located at the southwest base of the Charminar, the ASI, which manages the Charminar, has in no uncertain terms declared the structure as

an unauthorized construction. The Hyderabad high court has stopped any fur-ther expansion of the temple. While the origin of the temple is now disputed, the current structure that houses the idol was erected in the 1990s.

Several magazines and newspapers have pub-lished old photos that show the temple never existed. A temple became visible in the Charminar photos only after 1990. I have been visiting the

Charminar since I was a child and have also seen the small stone with ver-million applied, which grew from a passerby's whim to a small shrine, and now a full-blown temple. It is also said that a stone was placed in that corner as a RTC bus doing a turn around the Charminar brushed it, and

the stone was placed to protect it from future errant drivers. In time the stone gathered vermillion on it. The present governor, a RSS appointee, even visited the temple to offer prayers, further sanctify ing its illegality. It has grown like a giant carbuncle and right under the nose of the Charminar police station.

Over the years I have been asking various people in authority to demolish it. Neither the police, nor any chief minister or even the Majlis (MIM) leadership care about it or dare to do anything about it. Now the builders temple's builders are claiming it was the Charminar that came up around it. This is a travesty, and an outright lie. This temple must be removed and the Charminar restored to its original conception. The two "then" and "now" photos tell the

Over the years we have a tacit understanding that religious encroachments on public spaces and even property will not be removed, even if it causes the people much disloca-tion and distorts the origi-nal pristinity. Thus, we have mandirs and mazars rampantly encroaching on public space and our sensibilities. We need a serious conversation on this. Secularism does not mean indifference to lawlessness. It actually means greater respect for the law. Now that is something for the courts to once again define.

of Indian Islam have decided to file a review petition challenging the recent decision of the apex court in the Ayodhya land dispute. In his recent column on Seek compromise, don't stoke fires', Nov. 22) Saeed Naqvi indicated that a pollster is planning an opinion poll among Indian Muslims on where they stand on the mandirmasjid row. That, I think, is a splendid idea. Leaders don't think they ever need to consult the led: the shepherd must herd his flock and that's that. So the outcome of the opinion poll may leave the self-proclaimed custodians of faith unmoved. But it could be an eye-opener for the rest of us. While we await the results of such a poll, for a foretaste of what the opinion seekers might find, here read the responses of three Muslims from three different districts of Maharashtra.

Meet Akbar Shaikh, a small farmer, author, poet and social activist from Ujni village in Madha taluka, Solapur. Asked what he thought of the proposed review petition, pat came the response: "Woh kahte hain masjid bachao, mai kehta hoon Musalman bachao" (They

say save the mosque, I say save the Muslims). He proceeded to add: "Hamare jaise naujawan proceeded Musalman apne paas ki masjid to jaate nahin; phir hajaar meel door Ayodhya ki masjid ko bachane ki kisko padi hai? Meet political activist

Deshmukh. a native of Lasgaon village, Pachora taluka, Jalgaon. About 25 per cent of the population in this Hindumajority village is Muslim. When the first gram panchayat was set up in Lasgaon in the 1950s, Khalil's father, Dada Miyan Deshmukh was elected the sarpanch and he stayed in that post for 12 uninterrupted years. Years later, Khalil was sarpanch for 10 long years. Even today, the Lasgaon village credit society is run by a team that looks up to Khalil for inspira-

By way of illustration, he cites an example from the time when he was sarpanch. In Lasangaon the gram panchayat office, an Urdu medium school and a small Maruti temple had stood cheek by jowl. In the late 1980s, Hindus demanded more space for a grander temple. "As sarpanch, I fully supported the demand. The gram panchayat office and the Urdu mediwere relocated and the whole issue was amicably resolved," Khalil recalls.

What does he think of the proposed review petition? Khalil: "Muslims must gracefully accept the verdict of the Supreme Court. Whether we agree with the judgment or not, we should desist from doing anything to vitiate the atmosphere. We should treat this issue as a closed chapter and concentrate on issues of peace and progress, for the community and the country.

Meet Halim Siddiqui, social activist and editor of Bedari, a monthly Urdu magazine published from Malegaon, a Muslim-majority textile town in north Maharashtra. A soft-spoken person, he normally measures his words. But ask him what he thinks about the review petition and he erupts.

"Review se kya nikle ga? Bus itna hi na ki hamare ulema aur digar Muslim leadron ki dukaan kuch aur saal chamkegi? Yeh sab hawayee jahaz se hawa mein udenge, taqreer jhadenge. Inke liye shahar

shahar mein shandaar dawatein saiengee. Babri rahi, kya mile ga aam Musalman ko is review se? (What will the review achieve? They will fly around from city to city, deliver stirring speeches, feast on lavish spreads arranged in their honour. Forget the Babri mosque ever being rebuilt, what will the common Muslim gain from this review?)"
While the Babri mosque

in Ayodhya remains among the top priorities of the ulema and leaders such as Asaduddin Owaisi, what continues to agonise Halim is the status of the Muslims of that temple town. Since the mosque's demolition in 1992, he has made three trips there, the last being two years ago. The purpose of his visit each time was the same: to talk to as many as he can, to understand their situation and to enquire if the national leadership which is so concerned with the mosque also ever thinks of the Muslims of Ayodhya.

Jilani who has been there once or twice, no religious or political leader has ever thought it fit to visit Ayodhya and meet those they claim to lead," laments Halim. Here is how he began an

article he wrote in *Bedari*, following his last trip to Ayadhya in 2017: "In Ayodhya in 2017: "In Ayodhya there is no Muslim doctor, no lawyer, no engineer, no teacher. Muslims there do not have a single school or college of their own. There's not even a madarsa, no Muslim organisation, no businessman, no organisation for the welfare of the community worth mention... Such is the fate of Ayodhya's Muslims 25 years after the demolition."

The article notes that survival for a large number of Muslim families depends on the flower garlands the women make daily, for the Hindu pilgrims to offer to the gods at the over one thousand temples in Ayodhya. It also talks of the many mosques in the town which are routinely short of *namaazis*. And several others where no namaaz is offered post sunset as the local Muslims cannot afford to pay electricity

For the Muslim leaderthe demolished Babri Masjid remains a national concern. As for the Muslims of Ayodhya,

Although he was physically helpless for all of my visit, Perry retained his beautiful manners and seemed concerned when I brought his lunch that I might not be going to have some too. I found his company soothing and didn't mind that he couldn't always summon the words that were in his brain. After all, it was more frustrating for him than me.

Many readers will be familiar with the sorts of excuses one hears far too often from friends of those who are suffering from memory loss. "No point visiting. He's too far gone." "No, I haven't been to see her. I gather she's out with the fairies." Are diagnoses of Alzheimer's or dementia perhaps giving potential visitors a get-out? These medical terms, though important concerning medication and future cures, tend to separate 'us' from 'them'. There's also the fear of ending up like 'them', as is eloquently illustrated by the psychiatrist Brewer's new book title: O, Let me not get Alzheimer's, Sweet Heaven! I understand it's painful to see someone you've known as full of life sometimes talking gibberish, but we must not abandon that person.

Cynthia Kee, who turned 90 in May, is another friend of mine with memory loss. It was in her house in Goodge Perry, at one of her parties. Cynthia can be vague about the present but she tells lively anecdotes about her early life. She was told she was too fat to be a -dancer (though in her eighties she jitterbugged regularly at the 100 Club on Oxford Street) so instead she became a journalist. She got a job on Smallholder

magazine. For her first story she had to cover a reception — "John Innes No. 2 Compost". She ending up writing a weekly 'Pig and Poultry' piece. After winning the Vogue talent contest, she went on to work at the photojournalistic magazine Picture Post, and then became one of the few women in television at the time, where she found interviewees as a researcher on the BBC's Tonight programme. (Nina Simone, her favourite, asked Cynthia for "haff a boiled egg".)

The right measure of life: Abide by Buddha's three great truths

pictetus was born into slavery in the eastern outreaches of the Roman empire. Sold as a child and crippled from the beatings of his master, Epictetus was eventually freed. He rose from his bitter beginning to establish an influential school of Stoic philosophy. Epictetus dedicated his life to outlining the simple way to happiness, fulfilment, and tranquillity. Epictetus' teachings rank among the greatest wisdom texts of human civilisation. His greatness lies in simple yet sagely suggestions on how one can lead an ideal life.

At the heart of Buddha's teachings are the three great truths known as the Seal of the Tree Laws: first, "All things are impermanent," that is, all things and phenomena constantly change; second, "Nothing has an which is to say, all things in the universe exist in interrelationship with one another; and third, "Nirvana is quiescence," that is, the ultimate freedom lies in getting rid of greed, aggression and self-delusion. The law, or truth, "All things are impermanent," refers to the unceasing changes occurring in our minds, in all phenomena as also in solid, physical manifestation of matter as trees and stones.

Buddha believed knowing things are impermanent subdues the proud and

gives hope to the wretched, encouraging them both to make spiritual progress. By his own action he showed the wisdom of moderation.

He was born into a life of great luxury, and he soon got tired of it. Then he tried a life of excessive mortification, and before long he grew weary of that too. At last he chose a middle course and found true happiness in the doctrine of "nothing too much" He taught self-control as against selfindulgence. He was equally opposed to the intoxication of lust, the intoxication of power and the intoxication of conquest. An obsession with physical pleasure, Buddha believed, is the sign of the diseased and its craving for mastery over the weak.

Like Buddha, the true teachers have always emphasised the need for retaining the equilibrium between the material and spiritual scales of life. In an analogy, the Sufi master Rumi likens the world to a

river and the individual to a boat. In order to float the boat needs the support of water, but when the boat develops a hole the same water fills the boat and drowns it. Similarly, an individual needs certain basic necessities for his daily sustenance. But once these material things preoccupy his mind, they ruin him spir-

Sufis consider the spirit and body to be one whole. They believe in integration, not dichotomies. What we do in our physical lives affects us spiritually and vice versa. We cannot look at our lives in a vacuum. Spinoza says, "Nature abhors vacuum". He might as well have said that life abhors a vacuum. "Life," says Pavlov "loses its attraction when it no longer has any purpose. Those

who commit suicides make away with themselves because they feel life has lost its meaning"

Thus, the achievement of an ideal and perfect life is not restricted to any particular class of people, nor is it related with the degree of learning, wealth or power. It is a mindset that grows out of a pure heart. The Greek ideal of "the golden mean' and "nothing in excess" contains the true wisdom of life. Overindulgence in worldly pleasures leads to a state of ennui as the body needs to be tempered with the demands of the soul.

Manila: Typhoon Kammuri lashed the Philippines with fierce winds and heavy rain on Tuesday as hundreds of thousands took refuge in shelters and the capital Manila shut down its international airport over safety concerns. The powerful storm, which blew in windows and sheared off roofs, roared ashore late Monday and was due to pass south of Manila — home to some 13 million people - and thousands of athletes at the regional Southeast Asian Games. There were a lot of roofs flying during the typhoon too," said Junie Castillo, a disaster officer in one of the areas first hit. "We have yet to quantify the extent of the damage."

Transfer of stocks to Karvy clients halted on SAT order

The Securities Appellate Tribunal (SAT) has direct-ed the National Securities Depository (NSDL) to stop transfer of the remaining investor securities that Karvy Stock Broking had pledged with lenders.
The decision came after

Bajaj Finance challenged Sebi's decision to return to Karvy's clients the securities that the broking house had illegally pledged to raise money for itself.

Issuing an interim stay, a two-member SAT bench comprising MT Joshi and C.K.G. Nair said the final order will be issued Wednesday afternoon.

The tribunal also asked tne Securities and Exchange Board of India to hear out the lender's concerns by December 4 and pass an order by December 10.

NSDL has transferred securities worth Rs 2,013.77 crore to the accounts of 83,806 clients who have paid full amount for these securities.

Lenders fear that they would be unable to recover



money from the brokerage once the pledged shares are shifted to clients' accounts.

Karvy has taken loans to the tune of Rs 600 crore by pledging securities worth more than Rs 2,300 crore of 95,000 clients with various lenders, including Bajaj Finance.

Of these, 95,000 clients, nearly 83,000 have got back their securities, which were were illegally trans-ferred by KSBL to its own account.

Bajaj Finance, which appealed against the Sebi-NSDL decision, has given loans to the tune of Rs 345 crore to Karvy against

pledged securities.

Most of the remaining accounts are in dispute with Karvy Stock Broking, so they may get their money/securities only after clearing dues with

Karvy.
The latest SAT ruling puts a question mark on the receipt of securities for these investors.

Bajaj Finance had lent Rs 100 crore after Sebi's June circular that mandated segregating client and proprietary accounts. This could indicate that Bajaj Finance does not have a strong

Separately, HDFC Bank. ICICI Bank and IndusInd Bank have also approached the SAT contesting the Sebi decision.

Since most shares were kept as securities for loans made by banks, any "uni-lateral" transfer of shares will have a chilling effect on this stream of lending, tehy argued.

HDFC Bank has lent Rs 400 crore to Karvy based on the pledged shares. The counsel for the

banks sought immediate freezing of all securities that have been transferred to client accounts.
"Pledged shares cannot be transferred without the consent of the banks," the counsel said.

The counsel further argued that going forward banks will be forced to seek additional collateral from all brokers due to Sebi's December 2 action.

The SAT also asked the National Stock Exchange to take a decision on Karvy's trading licence by December 6. Both NSE and BSE suspended Karvy's trading licence on

The regulator, through an order passed on November 22, had barred KSBL from taking new clients in respect of its stock broking activity and also prevented it from using the power of attorney (PoA) given by clients after the broker was found to have allegedly misused clients' securities.

The order was a result of a preliminary report forwarded by the NSE on the non-compliances observed with respect to pledging/misuse of client securities

The SAT has asked the regulator to hear "the appellant (Bajaj Finance) on the basis of their representation and November sentation dated November 23, and or any other addirepresentation which they may like to make.

If the appellant is desirous to make any additional representation it shall be made latest by

December 4.' It further directed Sebi "to consider the representation(s) of the appellant and, after giving an opportunity for personal hearing, pass an order as per law latest by December 10.

Foreign control of airlines mulled to push Air India sale

The government is considering amending a rule to allow overseas control of local airlines, according to a person familiar with the matter, which may help its indebted national carrier lure a foreign suitor after multiple failed attempts for a sale.

At a meeting in early November, the Depart-ment for Promotion of Industry and Internal Trade (DPIIT) asked the aviation ministry if it would be feasible to change the so-called "substantial ownership and effective control" clause, the person said, asking not to be iden-tified as the details aren't public yet.

The rule mandates that control of an airline always remain in Indian hands, one of several reasons global firms have been wary of bidding for Air India Ltd.

Doing away with the "substantial ownership" clause will enable an overseas stakeholder weigh in on major decisions of local airlines. That may lure foreign investors to the Air India sale without forcing the government to go down

the politically contentious route of lifting the cap on overseas equity invest-

Currently, foreign air-lines are barred from buying more than 49 per cent in a local carrier, and foreign investors, other than airlines, need government approval to buy a stake bigger than 49 per cent.

An email to the DPIIT was unanswered. A representative for the aviation ministry didn't immediately respond to a request for Finance Minister

Nirmala Sitharaman in her budget speech in July had said Prime Minister Narendra Modi's govern-ment will look into suggestions of opening up sectors, including aviation, to more foreign investment. It has already eased rules in a number of areas such as retail, manufacturing and

Sugar production halves in Oct-Nov

FC BURFAU NEW DELHI, DEC. 3

Sugar production fell 54 per cent during October-November owing to a steep fall in outout at several Maharashtra sugar mills. which were hit by drought and floods, the Indian Sugar Mills Association (Isma) said on Tuesday.

"Sugar production till November 30, 2019 in the current 2019-20 sugar season is 18.85 lakh tonne, which was 40.69 lakh tonne last year on November 30, 2018," Isma said.

India is the world's largest sugar producer and lower output here could push up sugar prices glob-

Production in Maharashtra fell to 67,000 tonnes during the two-month period compared with 1.9 million tonnes a year ago. Last month, the trade

body had said that sugar output was estimated to fall 21.5 per cent to 26 million tonne in the 2019-20 marketing year. The sugar season or marketing year runs from October to September.

Only 279 sugar mills were operating as on November 30 this year compared with 418 units crushing sugarcane a year ago, Isma said in its latest statement. According to the data,

sugar production in Uttar Pradesh increased to 10.81 lakh tonne during October-November from 9.14 lakh tonne in the year-ago peri-od. In Karnataka, the out-put dropped to 5.21 lakh tonne from 8.40 lakh tonne.

Trade and market sources said about 15 lakh tonne of sugar has been contracted for exports, which includes contracts with port-based refiners.

Stock limits tightened as onion heads to ₹150 a kg

Kolkata/New Delhi, Dec 3: Onion prices could soon touch a new high of Rs 150 per kg in the Kolkata mandis, traders and analysts said, even as the central government stock limits on onion trade on Tuesday. In most markets of the

eastern metropolis, the vegetable is being sold at Rs 110-130 per kg, which is expected to rise to Rs 150 a kg if wholesale prices are any indication, they said. "Åt Nasik, the highest

wholesale rate was Rs 5,400/40 kg, which translates to Rs 135 a kg," agri analyst Sibu Malakar said. Onions will be dear at

least till January, when the new crop hits markets in Nasik and Bengaluru, a trader said. In order to curb the ris-

ing prices, the Centre on Tuesday reduced the stock holding limit for retailers



and wholesalers tonnes and 25 tonnes, respectively.

Earlier, retailers were allowed to hold onion stock up to 10 tonnes and wholesalers up to 50 tonnes. Now, they can hold half of it, as per an order issued by the Consumer Affairs Ministry.

The revised stock holding limit would not be applicable for imported onions.

Onion prices have been ruling high for the past few weeks even as various measures have been initiated to increase supply of

the key kitchen staple The Centre has already banned onion exports and decided to import 1.2 lakh tonnes.

Sources had on Sunday said that state-owned trading firm MMTC, which is importing onion on behalf of the Centre, has placed an order of 11,000 tonnes of the edible bulb from

Many traders in Kolkata claimed that the vegetable is being illegally exported to neighbouring Bangladesh from the border areas of West Bengal.

Gold imports surge 78% in November

Post-festive season, gold imports surged 78 per cent month-onmonth in November, touching a five-month high. However, it was still down from the imports in November 2018.

The country imported 71 tonnes of gold in November, compared with 40 tonnes in October, reports quoting government officials said. Even five months ahead of the festive season in October, the monthly imports were lower than that in November. In value

November imports totalled \$2.94 billion, slightly higher than last year's \$2.76 billion.

According to P. R. Somasundaram, Managing Director, India, World Gold Council, the trade had enough stocks in the run up to the festive season. Hence the imports were lower during the previous months as well as in October.

Post-festive season, the bullion dealers and iewellers found an opportunity to replenish their stocks when the prices fell by around

high levels in the domestic mar-ket. Further, the last quarter of the calendar year usually sees a higher consumption. "Higher import in November makes sense as the prices have stabilised and the market expects the demand to return in the fourth quarter," an industry expert said.

Unrefined dore imports too have bounced back after the discounts went off and gold started becoming available in the bullion market for a premium over the landed rate. This also

is an indicator of a potential demand in the retail market. The share of dore in India's gold imports in November was 33

tonnes, compared with imports of 8.5 tonnes in October, as per reports. According to industry experts, the government calculates dore in absolute terms and not the gold derived out of the dore. If one has to consider the refined gold, the imports will be slightly lower than 71 tonnes.

However, imports were still down 16 per cent from November 2018 levels, indicating that the market sentiments are not that strong.

Phase-I of the project will involve digitisation and indexing of over 40 books of M. K. Gandhi

which will be released and searchable on the portal. The books will be further used to reconstruct the social network of the Mahatma, including his influencers and people whom he inspired.

"We will initially use his book My Experiments with Truth for reconstructing the social network. This work would require AI enabled tools to read the indexed and digitized version. The results will be visualised by the modern powerful network visualisation tools and a dashboard of network statis-tics," said Prof Animesh Mukherjee from Kharagpur's department of computer science and engineering who is lead-

ing the project. involve social bots on Twitter that can regularly post text excerpts from Gandhiji's works and observe how these posts spread over the social media.

Minister Sitharaman Finance Nirmala last month said the government plans to bring in legislation on raising the insurance cover on bank deposits from the current Rs 1 lakh during the winter session of Parliament.

White-collar crimes on the rise: Survey

With massive irregularities in financial transaccrimes are on the rise. It has been observed that a total of 3,766 incidents of fraud were detected in the last fiscal (FY19), rising by 15 per cent from a year ago, while losses incurred due to frauds have also risen by 80 per cent, according to a survey.

Understanding the risk posed by white-collar crimes, Netrika Consulting, a professional risk and integrity management company, conducted a survey covering respondents from law firms, media houses and corporate house.

White-collar crimes are committed for financial gains and usually by people in higher positions. Statistics has, however, showed that there is a trading value of Rs 4,000 crore using fake or duplicate PAN cards. "An approximate 3.2 million people have lost card details at banks ATMs pointing to increasing adoption of technology white-collar criminals," the survey said.

TCIL has been in talks with the liquidator of its UK namesake as it has the right to use the brand in India only till 2024. Now on, TCIL can use rights in perpetuity on a royalty-free basis. TCIL was previously paying an annual brand licence fee of Rs 2 crore to TCUK, informed the company the stock exchanges.

"In 2012 when TCIL were acquired by Fairfax Financial Holdings of acquired Financial Canada, we had entered into a Brand Licence Agreement with the erstwhile Thomas Cook Group of the UK to give us exclusive use of the brand until 2024 across Sri Lanka and Mauritius for an annual licence fee of Rs 2 crore. So when this very attractive investment opportunity of complete ownership of the brand name across these markets, for a onetime payment of Rs 13.9 crore came up, it truly was an opportunity we had to grab!", Madhavan Menon, Chairman & Managing Director, Thomas Cook (India) said.

What'll happen to markets on Dec. 15

President Donald Trump's latest missives on trade are a wake-up call to markets close to record highs that a major deadline is looming

with China.
The Dec. 15 flashpoint on tariffs was thrown into sharp relief on Tuesday when Trump said he sees no urgency to complete a deal. "If tariffs scheduled for Dec. 15 are implemented it would be a huge shock to the market consensus,' said Sue Trinh, MD for global macro strategy at Manulife Investment Management in Hong Kong. "Trump would be the that Grinch stole Christmas," she said.

The following are the views of a number of market participants on what happens if the tariffs on China kick in Dec. 15.

It will be "definitely riskoff across the screen," said Tongli Han, Chief

Investment Officer at Deepblue Global

Investment."What pened recently makes this trade deal more costly for Chinese leaders -- so I'm seeing a gloomy future for the short term, one-to-two months."

With the clock running down on 2019 and a prospects of a trade deal looking more remote it's time for investors to take a little bit of risk off the table, said Steve Brice, Chief Investment Strategist at Standard Chartered bank.

"It looks like it's going to be pushed to the beginning of next year at the best case," Brice said. The message to investors is "maybe trim a little bit of equity exposure, or certainly not chase the market at this stage. But look to do so in the next few weeks if we see a 5-to-7 per cent pull-

Longer term, Brice remains optimistic "the U.S. and China will still

strike a deal of some sort. That will reduce uncertainty and help the global economy do well.

For Kerry Craig, global market strategist at JPMorgan Asset Management, a key concern is markets have already priced in the prospect of a trade deal that has yet to be signed.

"There had been a lot of optimism built in around a trade deal and it's still the thing that will weigh on markets over the coming months," Craig said on Bloomberg TV. "In the meantime we need to see more of a pick-up in the global economy to really offset some of those uncertainties.'

For some, the retreat in equities at the start of the week already presents a buying opportunity.

"I'd fade the correction today," Eli Lee, head of investment strategy at Bank of Singapore, told

Bloomberg TV The renewed tariff pressures on South America

and Europe are likely an effort to bolster Trump's "tariff man" image ahead of a trade deal with China, he said.

"With the economy in a very delicate situation, if this came on, it would seriously ratchet up the risk of a recession-and the White House wouldn't want this situation going into the 2020 presidential election next year," Lee said.

There may be some massive initial market swings in store, said Chris Weston, head of research at Pepperstone Group Ltd. in a note to clients.

'We could face a wild day," he said. The S&P 500 is likely to fall about 2 per cent, with currencies including the yuan, Australian dollar and Korean won also likely to move, he said. A relief rally may be in the offing afterparticularly ward, there's agreement to revisit talks in 2020, he said.

Researchers at Israeli cybersecurity company, CyberArk, said the vulmerability, associated with Microsoft Azure accounts and Microsoft's OAuth 2.0 applications, could have been used to trick users into giving attackers access to their online

accounts.

Twitter to tweak privacy policy amid concerns

San Fransisco, Dec. 3: Twitter Inc. is updating its global privacy policy to give users more information about what data advertisers might receive and is launching a site to provide clarity on its data protection efforts, the company said.

The changes, which will take effect on Jan. 1, 2020, will comply with the California Consumer Privacy Act (CCPA).

The California law

requires large businesses to give consumers more transparency and control over their personal information, such as allowing them to request that their data be deleted and to opt out of having their data sold to third parties.




