43 dead, 16 injured in major Delhi fire

Most of the workers in the illegal manufacturing unit were asleep at the time; building owner arrested

At least 43 people, including minors, died and over 16 were injured after a major fire broke out in a residential building being used as a manufacturing unit in the Anaj Mandi area on Rani Jhansi Road of Central Delhi on Sunday morning.

Most of the deceased are from Bihar.

The building did not have a No Objection Certificate (NOC) from the Fire Department, and no fire safety equipment was found to have been installed. The building was notified as residential and did not need an NOC, said Atul Garg, Director, Delhi Fire Services.

Monika Bhardwaj, DCP (North), said property owner Rehan and his manager Furkan had been arrested under IPC Section 304 (culpable homicide not amounting to murder) and 285 (negligent conduct with respect to fire). The case has been transferred to the Crime Branch for further investigation.

A call about the fire was received at 5.22 a.m., following which more than 40 fire tenders were rushed to the spot. Over 53 people trapped in the building were shifted to hospital, where at least 43 succumbed to injuries during treatment. Doctors say the death toll might rise.

Mr. Garg said that it was a four-storey building. The fire appears to have started on

the second floor and soon spread to all the other floors.

Four people succumbed to burn injuries. The others died due to asphyxiation. Workers on the first floor rushed out of the building after they got to know about the fire. They alerted locals and informed the Fire Department.

"Over 150 fire personnel were involved in the rescue operation. We removed all occupants from the building and rushed them to hospital. Two fire personnel suffered injuries," he said.

There was no ventilation in the building. There was only one window. There

were two exits, but one of the exit routes was blocked and used to store the factory's raw material.

In separate floors, workers used to prepare school bags, purses and hand-held plastic mirrors, said a fire fighter.

Narrow lane

"The whole building became a gas chamber. A team of fire fighters entered the building from the terrace after breaking a window. Most of the bodies were found in the hall located on the fourth floor,

where most of the workers were sleeping," said Mr. Garg. "Fire services arrived at the spot within five minutes, but the narrow lane allowed only one fire engine to enter at a time. We entered the building from the terrace by cutting iron grills. The fire was doused at 10.05 a.m. Cooling operation is underway," Mr. Garg added.

Locals said the buildings in the area were originally used to store grains. But with time, owners switched to other businesses and illegal manufacturing workshops mushroomed.

'Bhaiya, I am going to die'

As smoke entered the fourth floor where he was sleeping, Musharraf Ali, 30, from Uttar Pradesh's Bijnor district, made one last phone call to his childhood friend and neighbour, Monu Agarwal, and pleaded with him to take care of his wife and four children. "Monu Bhaiya, I am going to die. There is no place to run, fire has broken out," he told his friend. "Please take care of my family. Bhaiya, I am unable to breathe." ▶ PAGE 9

There were around 75 workers in the building in the Anaj Mandi area when the fire broke out on the second floor, presumably due to short circuit, said a police officer. The building was packed with combustible material such as cardboard, rexine, plastic and other packaging material that aggravated the fire and resulted in dense smoke, which suffocated the people trapped inside, a fireman said. ▶PAGE 2

Citizenship Bill to be tabled today

It is facing opposition in the Northeast

Union Home Minister Amit Shah will introduce the con-Citizenship tentious (Amendment) Bill, 2019 in the Lok Sabha on Monday.

The Bill seeks to amend the Citizenship Act, 1955, by wanting to grant citizenship to illegal non-Muslims from Bangladesh, Pakistan and Afghanistan, who came to India on or before December 31, 2014.

The Lok Sabha Speaker has allowed the members to submit amendments to the Bill till 10 a.m. on Monday. A copy of the Bill was circulated to all parliamentarians last week, after the Union Cabinet gave a go-ahead on December 4.

If the Bill is passed, it will be the first time that citizenship will be provided on the basis of religion.

Several groups in Assam and other Northeast States


are protesting against the legislation as it will nullify the provisions of the Assam Accord, 1985, according to which all illegal immigrants, irrespective of religion, who entered India after March 24, 1971, were to be detected and deported.

The National Register of Citizens (NRC) in Assam, published on August 31, was updated as per the accord. More than 19 lakh persons, out of the total 3.29 crore applicants, were excluded from the final NRC.

The Bill proposes that all such migrants will be eligible for citizenship if they came to India before December 31, 2014, and all pending legal cases pertaining to citizenship-related matters against them will stand abated.



Narrow staircases, locked terrace restrict firemen

DFS says it took 20 minutes to cut window grills; building packed with combustible material, claims official

Narrow staircases, windows with grills and a locked terrace turned the building, which housed a manufacturing unit, into a "death chamber" where 43 people were killed and 16 others injured at Anaj Mandi on early Sunday.

The victims on the first two floors of the building managed to escape while those on the third and fourth floors were trapped as the fire broke out on the second floor blocking their only exit

A Delhi Fire Service (DFS) official said the team reached the location within five minutes but was unable to enter the building because of the intensity of the fire.

"We tried to enter the building from the terrace but it was locked. Then we tried to get inside through a window but it had grills on it. We cut the grills with a gas cutter and managed to get inside. This process took us around minutes," said the firefighter.

He added that the people trapped in the building were screaming for help but the

The building had a second staircase, which was stuffed with raw material used in the manufacturing unit. "The

workers who managed to come out of the building informed the locals and called the family members of their colleagues who trapped inside. A local informed the fire department about the incident," said Mohammad Rizwan, a resident.

The building, owned by a man named Rehan, rented a portion to a jacket manufacturer, said an official. Rehan manufactures school bags and plastic-hand mirrors in the unit. There were around 75 workers in the building when the fire broke out on the second floor allegedly due to a short circuit, said an officer. "Four workers on the third floor got trapped and later their bodies were recovered. Most of the casualties were on the fourth floor where the workers used to sleep. Marks of their struggle can be seen on the walls," the officer added.

Many die of asphyxiation The workers on the fourth floor died due to asphyxiation as the ventilation window was closed. The workers might have closed it to stay warm in the winter. The building was packed with combustible materials like cardboard, rexine, plastic and other packaging stuff that aggravated the fire and resulted in dense smoke, said a fireman.

Government announces compensation, orders probe

Chief Minister Arvind Kejriwal on Sunday ordered a Magisterial probe into the fire that killed 43 people and sought a detailed report within seven days.

He also announced an ex gratia of ₹10 lakh each for the families of those who died in the incident and a compensation of ₹1 lakh each for the injured persons along with free medical treatment.

Mr. Kejriwal visited the site of the fire at Anaj Mandi and said "strictest punishment" will be given to those who were responsible for the incident. He later visited LNJP Hospital and met the injured persons.

"It is a very tragic incident. The exact numbers of casualties are being ascertained. The exact cause of the fire will come to fore after the probe," Mr. Kejri-

Four families got calls from victims

"Abbu, aag laga hai yahan, bach na payenge [Father, the building has caught fire. I would not survive]." These were the last words of 34-year-old Imran to his 60-year-old father Zameel Ahmed who lost both his sons in the fire at Anaj Mandi. Mr. Ahmed was at his house in U.P.'s Moradabad on Sunday morning when he was wakened up by a phone call from Imran

He also lost his younger son Iqram, 32, in the blaze. Five of my grandchildren lost their fathers, he cried. "We have lost everything," Mr. Ahmed said.

Families of at least four people, who died in the building fire, told The Hindu that they had received phone calls from their loved ones minutes before they died.

'Act with courage'

Mr. Ahmed said Imran told him over the phone that the landlord was not receiving calls. "I told him to act with courage," Mr. Ahmed said, adding: "I kept calling him but no one picked up."



A never-ending search: distraught Anaj Mandi has turned into a hub of illegal manufacturing units

Over 500 such units operate from residential buildings in the area

Once a large grain market, Anaj Mandi, over the years has turned into a hub of illegal manufacturing units.

Anaj Mandi is located on Rani Jhansi Road in Delhi-6 where more than 500 illegal manufacturing units are operating from residential buildings. Narrow lanes, tangled

wires, encroachments, unauthorised parking, and the terrace being used to store raw material are some of the common sights in Anaj Mandi, said the locals. "The residents have illegally extended their balconies and hence the electricity wires run directly overhead. Most of the owners of these buildings have left the area and rented out it for commercial activities. The workers live in a very inhumane condition inside the buildings but don't have other options as it saves their

rent," said Mohammad Iqbal, a local. After the fire tragedy, when media persons went to the area, they were opposed by the locals while clicking pictures. "Even policemen do not dare to enter these buildings. The locals always stand united against any government agency that plan action in the area. The area is packed with furniture stores, butcheries and tyre shops. Irfaan, a local, said illegal manufacturing units have mushroomed

The area attracts manufacturers from various locations as it is close to wholesale markets like Sadar Bazar, Chawri Bazar, Ballimaran and its close proximity to railway station also help these manufacturers to transport their articles, said Ir-An owner of a manufactur-

ing unit said the labourers come from Bihar and U.P. and earn a salary of ₹8,000-12,000 per month. A labourer is assigned a task to get more workers from his village and he gets an incentive for the same. "We offer them accommodation in the factories and for this, their working hours also increase," said the

Party leaders engage in blame game over fire incident in city '10-year-old—

Aam Aadmi Party holds civic bodies accountable for incident; BJP accuses govt. of 'administrative lapse'; Congress blames both parties

Senior political leaders across party lines made a beeline to the spot of the fire, visited hospitals, expressed sympathy and announced compensation for the victims. However, they indulged in a political blame game.

AAP said it was the responsibility of the BJP-run civic bodies of Delhi to ensure that no illegal factories operate out of buildings and that it should be held accountable for the incident.

said the government cannot escape its responsibility by giving ₹10 lakh compensation each and ordering a magisterial probe. BJP MP Vijay Goel said: "This is an administrative lapse on the part of the Delhi government. Has it formulated any policy in the last five years to prevent fire-related accidents? There are many buildings in Old Delhi where such accidents can take place. Illegal constructions need to

be banned too." He also said the government needs to take a lesson from this incident. Union Urban Development Minister Hardeep Singh Puri said the manufacturing units should have been given alternate places and alleged that the government had not shifted Senior AAP leader Sanjay

Singh said it was "shameful" that the BJP was indulging in "politics over dead bodies". "It is the BIP which is responsible for issuing licences for running manufacturing units in residential areas," he said.

The Congress accused both the BJP and AAP for the incident. Delhi Congress chief Subhash Chopra, after visiting the site, said he had spoken to the local residents who "held AAP and BJP responsible". "The compensation an-

nounced by the government for the families of the victims is not sufficient. Dependants of those who perished in the fire should be given jobs," Mr. Chopra said.

A Union Urban Development Ministry statement added that the Redevelopment

plan of Special Area of Delhi was prepared by the North civic body and cleared by the Technical Committee of DDA and that the finalized plan was approved by the Corporation in March 2017.

"It was sent to the Urban Development Department of Delhi the government for notification in the official gazette in April 2017. But despite providing all clarification sought from time to time, it is pending for notification. What were these departments waiting for?" the Ministry said. It also questioned as to why Delhi Fire Services had not taken action despite the building being of required height and occupancy to need safety and fire prevention measures.

"It is clear that precious lives would have been saved if these departments had been diligent," the Ministry said.

The Delhi government, reacting to the allegations, said the Ministry was trying to hide the corruption and inefficiency of the civic body and therefore, The Union Ministry has minted some false claims.

"Delhi Fire Services has made it clear that this factory had no fire clearance/NoC to operate and it was illegal. Why is the Union Ministry defending an illegal factory being run in violation of all rules and has claimed so many lives?" the Delhi government

"It is beyond any reasonable understanding as to why the Ministry, in order to defend corruption and inefficiency of the civic body is stooping to this level," the Delhi government said.

S.N. Jha, who runs a confectionery store in the area, said he was sceptical about its effect on the upcoming elections. "The Rajya Sabha has also passed it and the Delhi Development Authority has started setting up registration booths. Maybe some people will be affected by it. But it looks like [Chief Minister Arvind] Kejriwal will come back, even if he loses some seats," he said.

Credit wars

Vikram Singh Chandela, who operates a vehicle repair shop at the Indraprastha Colony in Burari, which hosts a sizeable number of unauthorised colonies, credited the BJP for ensuring the conver-

sion of the promise to a law. "This promise has been made by every government before every election in the 25-odd years that I have lived in Burari. I was given a provisional certificate [in 2008] and promised that I will get ownership rights like lakhs of others but nothing happened. Credit should be given where it is due: the BIP has done what no other government could in

education," he said. Hemraj Singh, a resident of Amrit Vihar, said Mr. Kejriwal also deserved credit for "nudging" the BJP-led Centre along the "right path." "The AAP government started the process in November 2015 but the BIP did not act for years. This Bill is a result of the work done by Mr. Kejriwal," he said.

Over the 20 years of his residing in Sangam Vihar, according to Suresh Kumar, he had, for the first time, seen "at least some civic infrastructure" being built by the State government. "Water is free, alleyways have been improved, electricity is regular. There is still a long way to go but it is better than before," he said.

Bhagwan Kaur, a resident of the Khadda Colony in Swaroop Nagar, said the colony had come a long way since Mr. Kejriwal came to power. "We still have issues related to garbage collection but the development which we have seen since 2015 – whether the construction of roads in the by-lanes or the provision of free power – is nothing compared to the hellish conditions in this colony before the AAP government came to power," she argued.

According to Asha Devi, a resident of the J block in Swaroop Nagar, both the AAP and BJP governments "deserved equal praise" for the "gradually improving" conditions and status of her colony. "We are aware of the work that both governments have put in and people like me, who have four voters at home, will divide our support for both of them [the parties]," she said.

Simranjeet Kaur, her neighbour, said residents of unauthorised colonies like her were "keenly observing" television and newspaper reports related to the proposed implementation of the policy. "We watch and read all the news stories about our colonies which have always been a political issue but not of the stature that they have become this time; as far as we are concerned, both governments have done their bit and should get the credit for it," she said.

High Court issues direction to Delhi government and prison authorities

The Delhi High Court has directed the city government and the prison authorities here to ensure that convicts and undertrials are provided only those items in jail which are permissible under the rules.

A Bench of Chief Justice D.N. Patel and Justice C. Hari Shankar gave the direction while disposing of a petition initiated by the court on the basis of an Additional Sessions Judge's (ASJ) report.

The ASI's report had state ed that a LED TV, coconut water, crates of mineral water, badminton rackets and household items were some of the prohibited items found in the prison cell of Unitech MD Sanjay Chandra

'Continue awareness programmes on menstrual hygiene'

The Delhi High Court has asked the city government and civic bodies here to keep providing sanitary napkins to schoolgoing girls and those who dropped out for free and continue with their awareness programmes and schemes to promote menstrual hygiene.

A Bench of Chief Iustice D.N. Patel and Justice C. Hari Shankar said, "We expect the respondent to continue providing sanitary napkins for free, continue with the awareness programs and also schemes like UDAAN".

Pad-dispensing units

The Delhi government, represented by its Additional Standing Counsel Sanjoy Ghose, said it was providing

sanitary napkins for free to girls in schools run by it. Mr. Ghose also said that the toilets for girls in its schools have sanitary pad-dispens-

He also said that the Directorate of Education had issued a circular asking all counsellors in the schools to interact with girls and spread awareness on the issue of menstrual hygiene.

The Delhi government also claimed that it was providing sanitary napkins for free in packs of 10 under its UDAAN scheme.

The civic bodies said the schools run by them are providing the pads for free to the girls and also carrying out training and awareness programmes.

The Central government said that education was a State subject and its role was only to provide finance for various schemes and programmes to the departments concerned to be used for the benefit of girls in schools.

Plea disposed of After taking note of the steps

being taken by the authorities, the High Court disposed of the petition by advocate Setu Niket, who had sought directions to establish a mechanism to provide education on menstruation and menstrual hygiene in all schools here.

The petition had sought a direction to the authorities to ensure that menstrual hygiene products were made available to adolescent girls in schools for free or at subsidised rates.

Govt. clears way for selling seized liquor

It will be sold after quality tests in labs within 7 days of seizures

In a first, people can now buy seized liquor at prices which are 25% cheaper than prevailing market rates with the Delhi government having issued an order.

The liquor can be identified through a label on the bottle that will read 'Author-

ized confiscated liquor'. A government official said that foreign and Indian-

made foreign liquor (IMFL) seized during raids by the Excise Department and the police will be sold only after testing its quality in affiliated laboratories within seven days of seizures.

Until now, seized liquor was destroyed after completing legal formalities, in presence of government

According to the standard operating procedure issued by the Excise Department, each of four corporations (government agencies) will designate at least two vends one for foreign liquor and one for IMFL – through which the seized liquor can be sold. The official said that Delhi

would be first city where seized liquor would not be destroyed. In the first phase, eight vends will be allowed to sell seized liquor.

'My priority is to bring Cong. back to power in Himachal'

Party is on a revival path now, says State unit chief Kuldeep Singh Rathore

VIKAS VASUDEVA CHANDIGARH

Days after the Congress president Sonia Gandhi dissolved its unit in Himachal Pradesh, barring its chief Kuldeep Singh Rathore, the party is all set to revamp the organisation in a bid to revive the party's electoral prospects ahead of the next Assembly polls, due in 2022.

"The Congress is on revival path now. My priority is to bring back the Congress party in power. The process of reorganising the unit is a big exercise. I am deliberating with all leaders of the party on different aspects and soon a strong unit will in place. After party's proposed rally on December 14 in New Delhi, we will speed up the process of restructuring the State unit," Mr. Rahore told *The Hindu* here.

The Congress had lost all four parliamentary seats including Mandi, Shimla, Kan-

gra and Hamirpur in the 2019 polls. Party insiders felt factionalism and infighting within the party was one of the key reason behind party's poor show. In the 2017 Assembly polls as well, the Congress was reduced to 21 seats in the 68 member Vidhan Sabha.

Party's central leadership had appointed Mr. Rathore as the State party chief on JaLok Sabha elections by replacing Sukhvinder Singh Sukhu, who had been at loggerheads with senior Conleader and former Chief Minister Virbhadra

The decision was seen as an attempt to cull the factionalism and unite the party. Now, after the All-India Congress Committee (AICC) dissolved the State unit, the move is being seen as an indication to give the new president a free hand to reconstitute the organisation for better functioning.

"No infighting"

"Factionalism is a thing of the past as there's no infighting within the party now. The executive committees of the State, districts and blocks would be reconstituted on the old pattern, which was followed before my predecessor - Mr. Sukhu," said Mr. Rathore, who is believed to enjoy backing of former Union Minister and senior party leader Anand Sharma, besides Virbhadra Singh.

"Party will start a membership campaign, which has not been undertaken in the past over seven years. The focus would be to induct honest and dedicated people," he said.

Mr. Rathore said people are already fed with the ruling Bharatiya Janta Party in the State and were supporting the Congress.

"We have been protesting against the anti-people policies of BJP governments in the State and at the Centre, and the positive response given to our recent protests by the public is indicative of their anger and disenchantment with the BJP regimes be it on the issue of deteriorating law and order condition, price rise, rising drugs menace or economic slowdown," he added.

Inspector General of Police, traffic, Alok Kumar said vehicular movement on the Jammu-Srinagar national highway, the only all-weather road linking Kashmir with the rest of the country, was suspended for the day to allow road maintenance agencies to carry out "necessary repair work".

Meanwhile, the 434-km Srinagar-Leh national highway was reopened for oneway traffic on Sunday morning after remaining closed since November 27 following heavy snowfall in Zojilla pass and adjoining areas, the officials said.

They said the traffic was allowed to move from Kargil towards Srinagar after the Border Roads Organisation (BRO), which maintains the highway, gave the green signal after clearing snow from

Similarly, the officials said that the Mughal road which connects the border districts of Poonch and Rajouri in Jammu region to south Kashmir's Shopian district was also cleared of accumulated snow and thrown open for one-way traffic after remaining closed for more than a

Traffic was allowed from Shopian side but the drivers were cautioned to drive carefully due to slippery conditions at some places, the officials said.

Snowfall blocked road

The Mughal road was closed for traffic on November 6 after most parts of Kashmir valley including Pir Ki Gali experienced first major snowfall.

After several weeks of hectic efforts, the road was cleared on November 26 but a fresh spell of snowfall delayed its reopening, the officials said.

Both Srinagar-Leh national highway and the Mughal road remain closed for traffic during winter months due to heavy snowfall.

Miscreants lock up Odisha MLA in room, torch his vehicle

Braja Kishore Pradhan's SUV, bike were similarly targeted in August

Some unidentified miscreants set a sports utility vehicle of an Odisha MLA on fire after locking him in his room from outside in Angul district late on Saturday night.

The incident took place when Talcher MLA Braja Kishore Pradhan had come to his camp office at Nandira village around 11.30 p.m. on Saturday.

Two hours later, when Mr. Pradhan and his driver had fallen asleep, some miscreants entered his garage and torched his SUV.

When the MLA got up and tried to come outside, he found himself locked in.

He made a call to the mobile phone of his driver who came to rescue him. They found two vehicles - his SUV and an ambulance burning. They tried to douse the fire but in vain.

Probe is on

Although it has not yet been ascertained as to who were behind the incident, Vikrampur police along with forensic team and dog squad are investigating the case.

The incident has taken place barely four months after some unidentified miscreants set ablaze Mr. Pradhan's SUV and a bike at his official quarters in Bhubaneswar in August. The modus operandi was same.

Mr. Pradhan was then not present at his residence. His support staff had, however, felt suffocated as the entire house was filled with smoke and managed to escape through a window. In 2017, a woman, who claimed to be the MLA's wife, had ransacked his Bhubaneswar official quarters.

New chargesheet in murder case names BJP leader Mukul Roy

A new chargesheet in a ten-vearold case has named BJP leader Mukul Roy as a provocateur in the murder of three persons. Mr. Roy has described this as "an act of political vendetta".

The main accused, Birbhum district's BJP leader Monirul Islam, is named in the chargesheet. Former Forward Bloc leader and Trinamool Congress ex-MLA Mr. Roy was instrumental in inducting Mr. Islam, a decision severely

criticised by a powerful section Congress leader. within the Rashtriya Swayamsevak Sangh and the BJP.

In June 2010, three brothers – Koton Sheikh, Dhanu Sheikh and Turuk Sheikh of Birbhum - were allegedly killed by Mr. Islam over a sand mining dispute. Mr. Islam is reported to have said at a public rally that he "squashed the brothers under his feet".

Issued threats

Islam, a close aide of Mr. Roy, was Mr. Islam is known for publicly recently inducted into the BJP. Mr. threatening his political opponents and had also reportedly threatened to "behead" a local

Despite his past, Mr. Islam was acquitted by a lower court in the case. A fresh appeal was filed by the brother of one of the deceased to reopen the case and in September 2019, the High Court instructed the police to re-investigate the case.

TMC secretary general Partha Chatterjee said that his party has "nothing much to add [as] administration is doing its job"

The family of the deceased, particularly the mother of the murdered men Zarina Biwi, welcomed the court's decision.

The train services between lower and upper Assam have been suspended four four days following the derailment, they said.

According to NF Railway officials, 13 goods-laden wagons derailed around 6.40 a.m. The cause of derailment will be ascertained after an enquiry, the officials said.

Accident relief trains with crane have reached the site from Tinsukia and another relief train from Lumding will also reach the site shortly to clear the tracks, NF Railway Chief Public Relations Officer Subhanan Chanda said.

Raut accuses BJP of double standards on women's safety

Sena MP says BJP had created uproar when in opposition

Shiv Sena MP Sanjay Raut on Sunday criticised the Bharatiya Janata Party (BJP) for not doing anything in the aftermath of the Hyderabad rape case as against the uproar it had created over women's safety after the Nirbhaya case when it was in opposition.

He also called the encounter killings of the four accused "the victory of police raj over rule of law", in a co lumn in Sena mouthpiece Saamana on Sunday.

Mr. Raut has kept up a continuous attack on the BJP since the Assembly election results and even after Sena chief Uddhav Thackeray became Chief Minister. Even though Mr. Thackeray is no longer the editor of Saamana, the daily is known to express the views of the party. Its fiery editorials have also helped set the tone of the politics in the State in recent

months. Mr. Raut writes a weekly column for the paper titled 'Rokhthok.'

In Sunday's column, he said, "There is a difference between rule of law and police raj. In this case, police raj has trumped the rule of law. One should look at India to see how a crime like rape is politicised. At the time of the Nirbhaya rape and murder case, the BJP was in opposition at the Centre while Congress was in power. The op-

position capitalised on the case and said women were no longer safe in the country. Now that BJP is in power, it is not ready to take any responsibility ... Nobody is saying the number of rapes increased under the BJP regime, but the reasons given by right-wingers for the rising crimes against women are laughable."

He was referring to people who have said women shouldn't wear short clothes and that rapes won't stop until India becomes a Hindu nation. "What has Hindutva got to do with rape?" the MP

He said Indian society has failed to take necessary steps towards women's safety and needs to change, otherwise stringent laws will not work.

Terming the encounter of the four accused in the Hyderabad case "suspicious," Mr. Raut said there is a need to fast-track rape cases.

In second incident in two days, leopard attacks woman

A 45-vear-old woman was injured in a leopard attack late on Saturday in Amreli district of Gujarat, in the second such incident of leopard-human conflict reported from the district in the last two days.

It is, however, not clear whether the same leopard was involved in both incidents. The woman, Dayaben Malavi, was attacked in Lunghiya village on Saturday night, two days after a leopard mauled to death a farmer who was sleeping at his farm at Mota Munjiyasar village, also in Amreli district, early on Thursday.

Following the latest incident, the forest department has launched a massive operation to trace and capture the big cat.

According to officials. several cases of human-leopard conflict have come to the light in the region. Most of the victims were tarmers.

A senior forest official said a massive operation is under way to trap the leopard "which will be shot dead if it continues to remain evasive for long and keeps attacking humans." The operation involves a team of 150 trained personnel, and 30 cages have been set up at different places, he said.

"As many as six veterinary doctors are ready with tranquilliser guns to rescue the big cat," said conservator of forests, Rajkot, A.M.

Parmar. "We have also undertaken a preliminary survey of the area using a drone to get an idea of the movement of leopards. We are scanning the area, especially cotton and pulses farms, where leopards are likely to be found. If required, we are also setting up CCTV cameras and night vision cameras," Mr. Parmar said, adding that police teams have also been roped in with sharpshooters, who will be used if needed.

2 held for gang rape of minor

Ahmedabad Crime Branch on Sunday arrested two people for the alleged gang rape of a 14-year-old girl in Vadodara.

The accused, Kishan Mathasuriya (28) and Jaso Solanki (21), were arrested from Tarsali locality of Vadodara where they lived, Special Commissioner of Police (Crime), Ahmedabad, Ajay Tomar, said. "The Ahmedabad Crime Branch worked in coordination with the Vadodara city police to crack the case," Mr. Tomar told reporters.

According to the police, the girl was raped on the night of November 28 in Navlakhi Compound on Rajmahal Road, where she had gone along with a friend.

The accused thrashed the boy accompanying her and then dragged her to an isolated place within the compound and raped her, before fleeing.

The police had issued two different sketches of the accused and even announced a reward of ₹1 lakh for information about them.

"Mathasuriya is originally from Tarapur village in Anand, while Solanki is from Jasdan in Rajkot," Mr. Tomar said. "We have gathered enough evidence that supports their involvement in the crime. As per details gathered from them, they were also involved in past cases of burglary, theft, and fight. We suspect they were also involved in some other crimes," he said.

According to Mr. Tomar, the police used human intelligence, CCTV camera footage, technical intelligence, and other means to investigate the crime, which led to the arrest of the accused. The accused will be handed over to the Vadodara police.

Man says wife abetted rape of daughter

Three people were arrested in Bhutiya village in Gujarat's Bhavnagar district for allegedly raping a 12year-old girl over a year, while her mother, who abetted the crime, is absconding.

Goa govt. to revive farming culture: Michael Lobo

State Cabinet Minister says manure will be provided by solid waste management plant

The Goa government will revive farming culture and encourage cultivation of onions in the State so that issues like rising price do not affect the common man, a State minister has said.

Talking to reporters on Saturday, Bharatiya Janata Party (BJP) MLA and Goa's Waste Management Minister Michael Lobo said the Pramod Sawant-led government will also work towards reviving the "slowly dwindling" agricultural economy of the coastal State.

"Twenty-five years ago, Goa was totally self-sufficient. Our parents and grandparents used to grow vegetables, especially onions. Goan onions are famous across India," he said. "We want to encourage cultivation of onions, so that the rising prices of the crop will not affect Goans."

non-chemical fertiliser can be provided from the waste treatment plant in Goa for organic farming. "From next year, we should encourage cultivating more vegetables. Manure, necessary to grow vegetables in organic way, we can provide through the solid waste management plant," he said.

Mr. Lobo also said he would start cultivating vegetables all year round at his own farm. "All kinds of vegetables would be planted

there," he said. Chief Minister Pramod Sawant had recently blamed the sushegad (laid-back) attitude of Goans for the onion crisis. "The State government cannot be held responsible for high onion prices. We (people) are responsible for being *sushegad*...we are responsible because we do not plant onions," he said.

Minor girl found dead in farm in Nagpur district

"The girl went missing on Friday evening. Initially, her parents assumed she might have gone to her grandmother's house. However, they lodged a missing person complaint on Saturday afternoon after realising that she was not traceable," the official said.

Gagged and raped

The latter arrived at the spot a few minutes later. The duo then gagged the girl and dragged her into the nearby

bushes and allegedly raped her. The two then took off on the two-wheeler.

The shocked girl called her parents, who lodged a complaint with the Tiruchanur police. Based on the description given by the girl and with the help of CCTV footage, the police arrested the duo near the Tiruchanur flvover on afternoon.

Delay in NREGS wages hits BPL families

Centre yet to pay ₹1,000 crore for job scheme and material cost arrears to Kerala

THIRUVANANTHAPURAM The alleged delay by the Centre in releasing the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) wage and material cost arrears of ₹1,000 crore due to Kerala has left about 15 lakh below poverty line (BPL) families in the lurch.

The arrears comprises wages of ₹860 crore and material cost and administrative expenses of ₹140 crore. Payment of wages has been indefinitely held up at a time when the State is trying to

overcome the pangs of rural poverty, price hike of essentials, job loss due to economic slow down and such other major ills.

95% women

About 95% of the 12.98 lakh workers registered under the scheme are women and the lapse in releasing the wages would push them to the verge of poverty yet again. Kerala is one State that had set a model worth emulating for others in taking up projects for creating durable assets and providing maximum employment to

the indigent and marginalised sections. The scheme had come as a blessing to a legion of families that are striving hard to eke out a living. Local Self-Government Department sources told *The Hindu* that the audit reports have been submitted and replies to queries too have also been furnished within the time set by the

All other procedures, including inspections, have been completed and a decision to recover ₹25 lakh in connection with some of the works completed under the scheme have been approved. Still, the payment is being delayed without attributing any valid reason.

The Local Self-Government Department Principal Secretary had apprised the Centre of the issue on December 3 and was learnt to have wrested an assurance for releasing the funds soon, but the Union government had not heeded to such moves so far, sources said.

The delay would have a serious impact on the execution of projects, mainly watershed development, sourc-

'Kerala is in for major dengue epidemic'

Kerala could be bracing for vet another major dengue epidemic in 2020 going by the current and early disease surveillance trends, public health experts said.

With serological evaluations showing that there might be a shift in the type of dengue virus hitherto circulating in the community, the possibility of the next outbreak being more virulent, with significant mortality, cannot be discounted, the experts have

warned. Not just dengue, Chikungunya also seems to be rearing its head again, with a significant spike in the number of cases being reported from Thiruvananthapuram. Dengue epidemics occur in a cyclical pattern and the last major epidemic in 2017 resulted in 165 deaths.

Musharraf Ali, who was among the 43 people who died in the devastating fire in Delhi early on Saturday, made a last distress call to his friend Monu Agarwal, as smoke entered the fourth floor hall where he was sleeping.

Knowing that he would not make it out alive, he called his childhood friend and neighbour from Uttar Pradesh's Bijnor district, pleading that he take care of his wife and his four children after he was gone.

Here is a transcript of the conversation that was shared by Mr. Agarwal, who arrived at the Lok Nayak Jai Prakash Narayan Hospital to receive Mr. Ali's body.

The caller was Mr. Musharraf Ali and the receiver was Mr. Monu Agarwal:

Caller: Hello Monu Bhaiya, I am going to die. Please come to Karol Bagh. There is no place to run, fire has bro-

Receiver: Delhi?

Caller: There is no place to run. I am going to die. Please take care of my family. Bhaiya, I am unable to breathe. What should I do?

Receiver: Can't you escape? What about fire brigade? Call them, they will bring water.

Caller: Nothing is happening here.

Receiver: How did the fire break out?

Caller: Bhaiya, please take care of my kids and my family. Please don't tell everything at once. Come tomorrow to take me.

Receiver: Don't worry, nothing will happen.

Caller: Hai Allah! Now, I can't even breathe.

Receiver: Haan... People must have fire brigade's number.

Caller: Downstairs people must have the number and they must have called

them. I can't breathe. Receiver: Hello... Hello... Hello... Have the water vehicles come???

Caller: The fire has come inside the building. I can't breathe. Whatever is God's will. Hai Allah.

Receiver: Try to escape...

Caller: No bhaiya, I can't... Please take care of my family. Today I am going to die.

Receiver: Come outside. Try to come outside.

Caller: Bhaiya, even if I die, I will come to you. Hai

Another call was made by

28-year-old Bihar native Shakir Hussain, a father of three.

Mr. Hussain, who worked in a cap manufacturing unit on the fourth floor, told his pregnant wife: "I am trapped. Won't come out

Yet another call was made by Imran, 35, elder son of Nafees, who had come to Delhi from Moradabad in Uttar Pradesh six years ago.

Mr. Nafees said with a lump in his throat, "I got a call from Imran who said 'Abbu, a massive fire has erupted in the building. I won't be able to come out alive. Please save me'."

"I asked him to call the fire brigade and the call ended soon after. He didn't pick up my calls again," said Mr. Nafees, 58, who lost his two sons in the tragedy.

Building was surveyed last week

Upper floors were found locked and could not be inspected, say official sources

The civic authorities had last week "surveyed" the fourstorey building housing illegal manufacturing units, where 43 lives were lost in a massive fire on Sunday, but the upper floors were found to be locked due to which the entire structure could not be inspected, according to official sources. Officials were to visit the

building again to survey the upper floors and accordingly issue a show-cause notice, a source said.

A preliminary probe by authorities suggested that a short-circuit triggered the fire which started on the building's second floor.

"The building was surveved last week by civic authorities, but upper floors were found locked so the entire building could not be surveyed," an official source

The building is under Del-

hi Laws (Special Provisions) Act, 2006 which protects unauthorised construction from being sealed.

"The unit would have been closed by authorities if not found to be permissible as a household unit under provisions of the Master Plan of Delhi," the source said.

The building, spanning an area of 600 squre yards, had just one door. Fire department personnel had to cut window grills and metal meshes to enter to rescue

Fire Services officials said. Only one fire tender could be sent at a time through the narrow congested lanes, he

trapped people, the Delhi

It took over 150 fire fighters nearly five hours to douse the blaze. As many as 63 people were pulled out from the building. While 43, including one minor, died, 16 were injured. Two fire department personnel were hurt while carrying out the rescue work, officials said.

The massive fire ripped through the building housing illegal manufacturing units in north Delhi's crammed Anaj Mandi area on Sunday morning, in the deadliest blaze in the national capital since the Uphaar tragedy in 1997 in which 59 people were killed and over 100 injured.

Almost all the deceased in the Anaj Mandi fire were migrant labourers hailing from Bihar and Uttar Pradesh.

Police and fire department officials said many of the fatalities occurred due to suffocation as people were sleeping when the fire started at around 5 am on the second floor of the building that did not have fire safety clearance and was packed with combustible material like cardboards, plastic

Heart-rending scenes at morgue

Wedding of one victim was just four months away

Outside the mortuary of the LNJP Hospital on Sunday evening, sporting a black sweater, Mohammad Haider, 32, was among the many inconsolable family members of victims killed in the Anai Mandi factory fire.

"Bhai chala gaya... Baap re...," Mr. Haider kept repeating as he cried out about his brother Mohammad Bablu, 20.

"His marriage was only four months away and he said he will earn something in four months and paint the house, so that it will look good," Mr. Haider said between sobs.

"Kya pata tha, paint ke chakkar mei mera bhai duniya chodke chale jayega. Rang dalte, dalte, muje berang karke chale jayega.. Mera bhai.. Kaha dhundo mera bhai ko.. [How was I to know, in the process of painting the house, my brother would leave my

world colourless and go away]," said the inconsolable elder brother sitting on a footpath outside the mortuary, as relatives tried to console him.

From a 20-year-old who was to get married in four months, to a man whose 25year-old wife is eight months pregnant and a brother who was to go home with a 'lehenga' for his 15-year-old sister, the deaths have shattered families and left

families inconsolable.

Mr. Haider said they had taken a loan of ₹1.5 lakh to build the house and his brother had said they will finish the work fast.

"He said we will plaster the walls and do the painting and then he will get married. Na to plaster huva, na paint huva, bhai mera chodke chala gaya [Neither plastering nor painting happened and my brother left me]," he

Panel pulls up 19 States for tyre disposal

Inadequate management of pyrolysis technique by-products poses health risks

The Central Pollution Control Board (CPCB) has pulled up 270 tyre pyrolysis units in 19 States for employing technology that is polluting and harmful to the health of the workers employed.

Tyre pyrolysis refers to a technique of breaking down used tyres in the absence of oxygen. Shredded tyres, at temperatures between 250° C and 500° C, produce liquid oil and gases.

While this is considered a safer technique than burning tyres, pyrolysis leaves fine carbon matter, pyro-gas and oil as residue and the inadequate management of these by-products poses health

The CPCB letter of December 4 says States should be closing down all pyrolysis units that are not compliant

and that the import of hazardous substances - these include used tyres – ought to be strictly regulated.

Used tyres

India is also a recipient of used tyres from Australia and the U.K., which are sent for recycling and disposal.

As of 2016-17, official estimates indicate 127.34 million tyres were produced in India, which was seen to be a 12% increase from the previous year. A 37% increase in the tyre production has been observed in the two-wheeler segment, a 23% increase in the tractor segment and 16% in the passenger car/jeep segment. India discards about 100 million tyres everyday and only a fraction of it is recycled. India is also responsible for 6% of the global tyre

Two students each from IIT Bombay, IIT Guwahati and IIT Roorkee also ended their lives during this period, it said. During this period, one student each from Varana-

si's IIT (BHU), IIT (Indian

School of Mines) Dhanbad and IIT Kanpur took the extreme step.

The fire affected the sixth floor where the vigilance wing is located.

located. All files and documents pertaining to vigilance inquiries are feared

The CVC is learnt to have raised concerns about the impact of the fire on the wing's functioning and the fate of investigations it is carrying out. The wing usually probes cases against employers evading PF remittances and complaints against its own staffers, who administer the savings of crores of formal sector workers.

The CPFC did not respond to queries from The Hindu about the CVC's intervention and whether there was a backup of the destroyed files.



Trampling on grassroots

It is a travesty of law that local body polls have been delayed by three years in Tamil Nadu

hree years after they fell due in 2016, rural local bodies in Tamil Nadu will witness elections in the last week of this month. And, barring any further judicial intervention, urban local bodies are also likely to have elected representatives early next year. It is a travesty of the law that these elections have been delayed. Cities, towns and villages have been under the rule of unelected officials for too long. Under a Supreme Court order, polls for all local bodies will have to be held, except in those districts that have been divided recently to create new ones. It is the first time since local self-government became the third tier of governance under the Constitution that polls have not been held on time in T.N. – timely elections were held every five years since 1996. Administrative lapses and political litigation over ward delimitation in various local bodies in accordance with the latest population figures in the 2011 Census resulted in the unprecedented delay. Originally announced on time in 2016, the notification was cancelled by the Madras High Court, citing irregularities in it. Since then, the issue of delimitation, the announcement of new districts and occasional litigation have contributed to the delay in setting in motion elections to the vital tiers of grassroots democracy.

There have been frequent changes in the mode of electing mayors of city corporations and chairpersons of municipalities. Originally, direct elections were held, but it was changed to indirect mode in 2006. The present regime has changed its mind twice. In 2016, the Jayalalithaa regime opted for indirect elections, that is, only ward councillors would be elected by the people and these representatives, in turn, would elect mayors and municipal chairpersons. The current Edappadi K. Palaniswami government reversed the decision and chose the direct election mode. Recently, it once again changed its mind and restored the system of indirect election, citing "better accountability and collective responsibility". It claimed that there was scope for conflict between a directly elected head and the councillors, and that this would be eliminated if councillors themselves elected the mayor or chairperson. Beyond all the legal and technical reasons, and political squabbles over the timing of elections, the attitude of the two main parties towards the importance of local bodies has been quite lukewarm. While the posts of the heads of various local bodies are seen as prestigious, there is much politicisation when it comes to devolving funds and letting the various tiers work independently. District panchayats, in particular, are seen as being frequently undermined, as most parties consider them as a redundant third tier among panchayati raj institutions. While the polls are fought bitterly, the State is still some distance away from including local self-government bodies as partners in its development.

Shooting in Pensacola

Saudi Arabia is not doing enough to counter Islamist tendencies at home and abroad

The deadly shooting at Florida's Pensacola Naval Air Station by a Saudi aviation student that killed three and injured eight others is a fresh challenge to the Saudi authorities who are trying to remake the kingdom's image after a series of recent setbacks. U.S. federal investigators say they are vet to establish the gunman's motive, but some lawmakers have already claimed it was an act of terror. The suspect, Mohammed Alshamrani, 21, who had been training in the U.S. for two years, had watched mass shooting videos a week before Friday's assault, say investigators. A Twitter handle that is believed to have belonged to him called the U.S. a "nation of evil" and blamed it for "crimes not only against Muslims but also humanity". This is not the first time a Saudi national is attacking Americans inside the U.S. Fifteen of the 19 al-Qaedalinked terrorists behind the September 11, 2001 attacks, were Saudi citizens. But U.S.-Saudi relations have deepened over the years despite the 9/11 attacks. U.S. President Donald Trump, in his quest to contain Iran, Saudi Arabia's main regional rival, has doubled down on America's ties with the Kingdom. But his push for stronger ties with the Saudis had faced severe resistance from U.S. lawmakers. The murder of Saudi dissident journalist Jamal Khashoggi in 2018, suppression of dissent at home by the Saudi authorities, and the ongoing Saudi-led war on Yemen have all brought renewed global focus on the character of the Saudi leadership.

Riyadh was quick in condemning the "barbaric" Pensacola shooting, saying the shooter did not represent the Saudi people. The incident is unlikely to upset the U.S.-Saudi military ties immediately as both countries need each other in the larger geopolitical setting; 2,000 more American troops could be sent to the Kingdom to take on Iran. But the incident could strengthen the perception, especially among U.S. lawmakers, that the conservative Kingdom is not doing enough to flush out extremism given that the attacker was a second lieutenant in the Royal Saudi Air Force. It also raises questions about the vetting standards of both countries. More important, it is America's lax gun rules that allowed the shooter to buy the Glock 45 9-mm handgun which he used for the attack. Initial reports suggested that he used a loophole in the gun laws to buy the weapon legally. Despite repeated incidents of gun violence - most by Americans against Americans - the U.S. federal government could do little in addressing the problem. Worse, Mr. Trump and his Republican Party are opposed to stringent gun control rules. The U.S. has to first review its lax gun rules and then address issues such as vetting standards, foreign military ties and radicalism in general if it wants to prevent such incidents.

Constitutional justice is non-negotiable

The ends of justice are not served by wanton killing and retributive blood lust; India must follow constitutional morality

ast Friday, the country was rudely awakened to the news of the deaths, in an encounter early in the morning, of the four accused in the rape and murder of the young veterinarian in Hyderabad – an incident, which happened on Wednesday, triggering an angry response across the country with demands for speedy justice. Some politicians demanded the public lynching of rapists. Members of the public were justifiably anguished that a gruesome crime such as this was even possible in the heart of a vibrant metropolis. It brought back memories of a similar and gruesome sexual as sault on a young woman in Delhi in December 2012. Just before the veterinarian's murder, in Asifabad close to Hyderabad, another woman of about the same age was sexually assaulted and murdered by three men; she belonged to an extremely vulnerable nomadic community that eked out a living from wage labour and petty vending. These cases are just two in a long list where women across India have been killed and maimed in the most brutal fashion while we have had a stringent, amended rape law in place and also fast track judicial processes.

Sexual assault is pervasive, these incidents tell us, and the response must be systemic, not epi-

In moments such as this, families react with deep anger and grief. Most times this is exhibited through a demand for instantaneous retribution. For several affect-

ed families, death is the only answer to rape. It is also a fact that this is not a universal view. Grief at loss and pathways to healing speak through different tongues, and we need to be mindful of this fact.

Public responses that equate judicial outcomes and "justice" to immediate and quick retribution are not universal, nor just. When men accused of causing grievous hurt and loss of life to women through acid attacks are simply killed in police encounters, we may hear popular applause and appreciation of the heroism of the police; or we may, as we do now, be mere spectators to the showering of rose petals on police personnel involved in the encounter. Where does this drawing of blood stop? Is retributive justice the way to go in a democratic country that prides itself in its unprecedented historical legacy of resisting violence in fundamentally non-retributive ways?

The larger picture in mind

In thinking through the course of justice, it is extremely important for us to rise above the heat of the moment and provide moral reassurance and comfort to families, while keeping sight of the rule of law and constitutional tenets. The ends of justice are not served by wanton killing and retributive blood lust. The course of justice cannot be determined by the grief and grieving of victims' families. Justice lies in supporting them in their moment of grief and pain and insisting on due process that brings suspects and accused to trial through a robust, stringent and competent criminal investiga-

This is the challenge before governments and the criminal justice administration, especially the

After the December 2012 incident, in response to the wides-

pread demand for a more stringent law and fast track courts, the law on rape was amended substantially based on the recommendations and deliberations of the Justice I.S. Verma Committee. The Criminal Law (Amendment) Act, 2013, or Nirbhaya Act, 2013, as it is christened, is testimony to the possibility of translating public angst into just law. That is a victory for the movement against rape that Nirbhaya's family must celebrate as their own.

A note for the Indian police

There is a procedure prescribed by the law for criminal investigation. This is a procedure embedded in constitutional principles and honed over decades of thinking on keeping constitutionalism alive and throbbing through the most testing times. Article 21 of the Constitution of India – "No person shall be deprived of his life or personal liberty except according to procedure established by law" – is fundamental and non-derogable. The police, as officers of government, are bound by the Constitution – there are no exceptions.

The case at hand: four suspects are apprehended and shot in custody within a week, without the criminal investigation having commenced in any substantive way. They were shot purportedly when they tried to escape during an exercise of reconstruction of crime at the scene of offence – so even that very preliminary step in criminal investigation had not been completed. The police personnel

- unnamed, except for a Commissioner of Police - have caused the investigation of the crime of rape and murder to abate by killing the suspects.

Before we examine the problems in this action, let us refresh our memory of a core constitutional precept as set out in the Salwa Judum case in 2011: "Modern constitutionalism posits that no wielder of power should be allowed to claim the right to perpetrate state's violence against anyone, much less its own citizens, unchecked by law, and notions of innate human dignity of every individual." This is the touchstone of the constitutionally prescribed rule of law, which police officers are schooled in as part of their foundational training.

The Supreme Court of India, by resurrecting Justice H.R. Khanna's dissent in *Puttaswamy* in 2017, has prescribed the interpretation of Article 21: It is non-negotiable, non-derogable, and is not suspended even during conditions of Emergency. We are not living under declaration of Emergency so the duty of care is more onerous on the police. Any argument on the actions being carried out in 'purported discharge of official duties' especially involving the death of unarmed persons in custody cannot stand the narrowest test of Article 21.

There is no law in force in India that authorises the police to kill. The plea of self-defence cannot be used to rationalise a targeted, premeditated killing of suspects in custody. This plea is bound to the apprehension of death at the hands of the suspects at the time that the suspects are shot. There is nothing to suggest that the four suspects posed a threat to the lives of the police personnel since they were admittedly in custody and, therefore, presumably unarmed. The police have confessions of the

suspects while in custody, the evidentiary value of which must be evaluated by the court; but we have on the other hand an open declaration by the police of shooting and causing death. As was argued in the Encounters case before the Andhra Pradesh High Court, the discussion on the law was never whether there should be indictment and trial when homicide is committed in self-defense'. The debate was on 'whether a plea of self-defense where excessive force is used, should be tried for manslaughter or murder'. We have deliberated on this at length in the High Court of Andhra Pradesh and the full bench decision on encounters can scarcely be forgotten especially because these are unarmed commoners in custody.

A part of democracy

Where does that leave us? The case of the rape and murder of the veterinarian abates with the killing of all four suspects. This without giving a chance for the law to operate. However, we now have a fresh case of the murder of four unarmed suspects in custody that must be investigated with police personnel required to stand trial. The pathways of justice are not linear nor without obstacles. But we have, as a people, chosen the route of democracy and the Constitution, so we really have no option but to school ourselves in constitutional morality. For as Dr. B.R. Ambedkar cautioned in anticipation, constitutional morality must replace public morality. It is not easy, because it is not a natural sentiment. But it is non-negotia-

An Asian engine driven by India and China

The region's rise is linked to peace and stability; cooperation rests on a compact between the two countries

The world today is undergoing a fundamental transformation and there are several facets to the emerging uncertainty. Traditional and non-traditional security threats (economic and military competition, climate change, piracy, radical ideology, cyber threats, drug and human trafficking, and energy and food security) have grown in magnitude. Power, whether economic, political or military, is fractured. Trade and technology are at the heart of a new round of competition and contestation. Nationalism and regionalism are on the rise. There is less multilateralism but greater multi-polarity. Hedging and multialignment are the order of the day.

Obstacles ahead

All known paradigms are experiencing stress, which calls for readjustments. At the broadest level, the inadequacies of the post-World War II international institutions are showing up because of the complexities and uncertainties characterising global politics and the economy today. The old consensus is fraying and a new consensus is yet to emerge.

The liberal trading order has encountered protectionism in the form of tariff and non-tariff barriers, which explains why India's service exports which touch \$29.6 billion in the U.S. market, and pharma products, especially generic drugs, which account for

20% of global generic medicines, have barely been able to scratch the surface in the Chinese market. Cheaper imports from China, which practices "state capitalism", threaten domestic manufacturing in India. Movement of talent and the services sector, important for India, have not received satisfactory attention. Many of these concerns are central to India's position on the Regional Comprehensive Economic Partnership (RCEP).

There is a looming danger for developing countries on account of 'zero-sum' mercantilism and rising protectionism in western economies. There is no doubt that the U.S.-China trade war has been

Geopolitical considerations are increasingly driving trade and investment decisions; on the other hand, geo-economic forces unleashed by China's economic rise are redefining the geo-strategic landscape of the Indo-Pacific region.

Worryingly, the global economy is likely to grow at its slowest pace in a decade, at 3% in 2019.

Today, the momentum in manufacturing activity has weakened to levels unseen since the global financial crises. Investor and business confidence even in emerging markets is at a low ebb. Low productivity growth and ageing demographics in advanced economies have further compounded the problem. Most countries appear to be financially vulnerable. Key anchors in the global economy, including China, are experiencing a slowdown. Elsewhere, Europe is in the throes of a major readjustment in the context of Brexit. Yet, amidst the downturn, Asia is witnessing the simultane-



ous rise of several powers. Global engines of economic growth over the past three decades have shifted to Asia, first to the Asia-Pacific and now, more broadly, to the Indo-Pacific region that includes South Asia. The continent, home to over half the global population, has emerged as the new fulcrum for geo-economic and geo-strategic realignments. High economic growth rates across the region are accompanied by some of the highest military expenditures in the

The External Affairs Minister of India presciently said recently that if the world is different, we need to think, talk and engage accordingly. The wheels of change appear to have been set in motion. In the face of automation, countries are undertaking structural reforms and emphasising skills-training to raise productivity. Development and adoption of green technology is also a priority. Even Saudi Arabia, the quintessentially hydrocarbon-dependent economy, has endeavoured to diversify its economy through the Saudi Vision 2030 master-plan.

Shaping trade, economy

Both India and China are expected to contribute to global economic growth in the future. India is also transforming into a knowledgebased, skill-supported and technology-driven society. A liberal FDI regime combined with a youthful demographic profile makes India an attractive destination. India attaches great importance to its relations with China, a large trade partner in goods. Since 2015, there has been a spurt in Chinese FDI in India (at around \$8 billion). There is great scope for China to participate in flagship initiatives such as the 'Smart Cities Mission' and 'Skill India' programmes. As the world's secondlargest economy, China can and must play a constructive role globally and within Asia to help the world return to higher growth rates. Bilateral trade today is approximately \$95 billion. India faces a huge and rising trade imbalance. The decision at the Mamallapuram Summit, in October, to set up a new mechanism to discuss the trade imbalance, is

aimed at addressing this issue. As members of several multilateral institutions, India and China are in a unique position to give shape to their economic destinies. There are suggestions that the era of the World Trade Organisation (WTO)-anchored, Most Favoured Nation (MFN)-based regime is drawing to a close and that the future lies in a web of free trade agreements. However, there is still scope for India and China to work together to strengthen the WTO.

The RCEP should have a wider ambit, including trade in services. Many countries (especially Japan which still boasts the world's second-largest developed economy) have openly favoured a more accommodating position that addresses India's concerns and facilitates its joining the RCEP. China too should pro-actively work to ensure India's membership.

Beyond jointly training Afghan

diplomats under the "India-China Plus One" framework, China and India could explore the potential to work together on Asian infrastructure and connectivity development on the basis of equality and an open and transparent model under the Asian Infrastructure Investment Bank (AIIB).

As China's presence in South Asia grows, greater transparency in its actions and closer consultations with India are also necessary to help allay concerns. China should also be mindful of its forays into the Exclusive Economic Zone of others.

Today, the global energy market is more favourable to consumers in the face of a supply side glut. OPEC and non-OPEC oil and gas producers have come together to prevent a fall in energy prices. This should be a common concern for China and India. As two of the world's biggest importers of oil and gas, the two nations should have a joint consultative mechanism to protect the interests of

It must be remembered that Asia's rise is predicated on peace and stability. It is a sad fact that a stable regional security architecture has yet to emerge organically in Asia. It is worth recalling what Prime Minister Narendra Modi had stated at the Raisina Dialogue in 2017: that there is enough room for all Asian countries to prosper together, and that the Asia of rivalry will hold us all back. It is the Asia of cooperation that will shape this

Demonising the legal system won't help

Some of the existing laws are already too harsh and some other provisions are not being implemented



The killing of the four men accused of the rape and murder of the Hyderabad veterinarian will need to be properly investigated, though the Telangana police's conduct thus far does not inspire confidence. Ever since the police first turned away the victim's family when they went to lodge a complaint, they demonstrated no commitment to the rule of law. Finally, they claimed that the accused, who were under heavy police protection, tried to escape and had to be killed.

The atmosphere of lawlessness that was built up prior to the shooting certainly did not help. From protesters on the ground, to the commentary on social media, to MPs in Parliament, the demand for the instant killing of the accused from all corners created the public opinion for the abandonment of the rule of law that appears to have led to the in-

The argument made by people is that the rule of law is not giving women justice, and that at the very least, laws need to be amended to create a stronger deterrent and provide quicker closure to victims of crimes of sexual violence.

Flawed arguments

Both arguments are flawed and need to be challenged or, once again, hard cases will lead to bad law. The chargesheeting rates in cases of rape as well as rape and murder are higher than that for all other violent crimes, and the conviction rates are higher too, while the pendency rates are roughly the same as the average for all violent crimes.

The court pendency rate for crimes against Scheduled Castes (SCs), on the other hand, is far higher, but you will not see mass public support for killing those accused of atrocities, including caste-motivated rape against Dalits.

Even among those rare few who have professed some belief in the rule of law in the last week, the argument has been that "laws need to get

tougher". The hard truth, after an examination of legal reform recommendations and available judicial data, is this - there is no new law needed; in fact, some of the existing legal provisions are too harsh in ways that harm both men and women, and other important legal provisions are not being implemented.

The most comprehensive review of the gaps in laws around sexual harassment and sexual violence came in the aftermath of the 2012 Delhi rape incident in the form of the Justice Verma Committee Report and its recommendations. (It is worth noting that the report's recommendations began by acknowledging that existing laws were adequate, but some improvements could be made.) The report's key recommendations were centred at improving the status of women in non-legal ways as well, but its legal recommendations included a much-needed broadening of the definition of rape. The report also recommended raising the minimum sentence for rape to 10 years.

Strengthening the law

The 2013 Criminal Law (Amendment) Act, which sought to operationalise some of these suggestions, went well beyond what was recommended by the Verma Committee Report. It introduced the death penalty for some circumstances around rape, including repeat offences, despite the Verma Committee expressly arguing against this. Subsequent laws have raised mandatory minimum sentences and simultaneously raised the age of consent.

These changes have had a few worrisome results. One, there has been further criminalisation (with longer sentences) of consenting underage couples, which my investigation for *The Hindu* in 2014 in Delhi found was very common. Two, laws have removed any discretion in minimum sentencing from the hands of judges. There is evidence from other fields of law that removing such discretion actually lowers the rate of

Two of the largest categories of rape cases I found pertained to consenting couples criminalised by the woman's family (over 40% of the cases in Delhi) and 'breach of promise to marry' (over 25%). Further, conviction in cases other than those involving these two categories was over 75%. What we have now is a situation where there are not any remaining loopholes in laws concerning sexual violence against women; on the other hand, there is no legal protection for adult men from rape, and under the new Transgender Persons (Protection of Rights) Act, the sexual abuse of a transgender person carries a maximum sentence of two years only.

Official statistics on the speed of trials by nature of crime are not maintained; however, there is anecdotal evidence among practising lawyers that the average rape trial in a big city at the trial court stage is now completed within two years, but the appellate process takes longer. In the 2012 Delhi case, the trial was conducted within a year, the High Court appeal by March 2014, and the Supreme Court appeal by May 2017. Subsequently, the appeals of the convicts against their sentence - the death penalty - were heard and rejected.

When the accused is powerful

There remain instances, particularly when the accused is a powerful person, where the process of exhausting the individual's pre-trial options, including attempts to quash charges or shift the trial to a friendlier city, makes a mockery of a fast-track case; the trial of former Tehelka editor Tarun Tejpal, accused of sexually assaulting an employee, only resumed in October 2019 as Tejpal went up to the Supreme Court seeking quashing of the charges filed in 2013.

The argument here is not that the accused should not receive the full range of pre-trial legal options guaranteed by law, but that they be heard at a pace that maintains the spirit of providing speedy justice to the complainants.

Other improvements in existing laws remain essential – the police are still able to ask worried parents to return home without filing an FIR (already a punishable act for the polvictims still cross-examination about their past sexual histories; and there is still little by way of rehabilitation or even therapy offered to victims.

Legal arguments are easy to make from a distance - when one is not suffering the agony of a family that has had to imagine the final, helpless hours of a loved one. There is no doubt that the anguish or the "outrage" of people in the aftermath of such horrific crimes is justified and, for the most part, well-intentioned. However, hard cases have already made bad law in India, and we continue to flail in helplessness for more laws. The tragedy is there is no bandaid left. Instead, by abandoning principles of justice to calm the rage, we are making the country more savage and less safe for women.

The elements of engaged journalism

Readers should know the editorial processes that guide a newspaper

At a time of digital disruption and institutionalised misinformation campaigns, an idea that has caught the imagination of journalists is 'engaged journalism'. The meaning of engaged journalism is described in journalist Michael R. Fancher's excellent essay, "The Ethics of Engaged Journalism". He forcefully argues that "journalism has little purpose if it is not trusted by the public it is meant to serve, so public engagement and public trust are inseparable in the networked world of digital journalism." He writes: "Engaged Journalism's mission is to make journalism more open, accessible, collaborative, and participatory while maintaining the highest standards of accuracy, fairness, clarity, and impartiality. Engaged Journalism is consistent with and supports the historical mission of professional journalism - public good, self-governance, and a better life for all."

Engaging with readers

At *The Hindu* we constantly explore the idea of engaged journalism. The opening of our editorial meetings to readers is a part of this exercise. Last Tuesday, 15 readers attended the noon editorial meeting and the evening news meeting. Kidambi Narayanan, a reader of this paper for nearly four decades, said he sees a decline in flair for sports writing. He felt that the editorial, "Charging Chidambaram" (October 21), on the INX Media case was partisan and could have been avoided. Mr. Narayanan was also unhappy with the reportage on the Ayodhya verdict, particularly the explainer by K. Venkataramanan that pointed out that the unimpeded right in the outer courtyard of the site in effect won the whole site for Hindus. The court held that Muslims had failed to prove an exclusive right even in the inner courtyard, where the mosque was located, the report said.

Sports Editor K.C. Vijaya Kumar explained the impact of live broadcasting on sports reporting. He also pointed out that since the number of pages in the newspaper has been reduced, more reports are now squeezed into fewer pages. In this process of compres sion, sometimes flourishes in writing are removed and only bare bones information about events are presented, he said. Editor Suresh Nambath explained the rationale behind the editorial on Mr. Chidambaram. He spoke of how individual freedom is central to democracy and added that it is not right to view the editorial from the prism of partisan politics. Mr. Venkataramanan explained that his report on Ayodhya was the essence of the Supreme Court judgment. Not reporting it would be failing the readers, he said.

After the meeting, Mr. Narayanan wrote a letter thanking the newspaper for providing an opportunity to discuss his viewpoints without any reservations. His views were endorsed by Srravya. C, a young researcher of news and technology affiliated with the International Institute of Information Technology, Bangalore. She wrote: "Thank you for providing the opportunity to attend and understand the editorial work at The Hindu, spending quality time with us and answering a lot of our questions. The interaction not only helped me better appreciate the newsmaking processes but also understand the historical background and contemporary political economy of news."

Antidotes to misinformation

Participating readers wanted to know why The Hindu decided to open its editorial meeting to its readers. The main reason was that we realised that vested interests are not only undermining journalism but also vitiating the information public sphere with vitriol and rhetoric. Whitney Phillips, in a powerful article in Columbia Journalism Review ("The Toxins We Carry"), argues: "We reach for facts as our antidote to misinformation, false and misleading stories that are inadvertently spread; or disinformation, false and misleading stories that are deliberately spread; or malinformation, true stories that are spread in order to slander and harm. But the problem plaguing digital media is larger than any of these individually; it's that the categories overlap, obscuring who shares false information knowingly and who shares it thinking it's true."

In this context, we felt that readers should know the editorial processes that guide a newspaper and how it is different from the opinions that populate the social media space. We recognise that journalism and democracy are intertwined and credible information makes our democracy vibrant.

No more remixes, please

Music composers should take risks instead of reworking old songs

In October, music composer Vishal Dadlani warned that he would sue anyone remixing any more songs composed by him and Shekhar Ravjiani. The duo, known as Vishal-Shekhar, boast of some of the most enduring hit songs in Hindi cinema in the last two decades, a period that saw a clear decline in melody.

Vishal's sharp words (he called those remixing songs as "vultures") have again put into focus the trend of repackaging a popular song from the past for a new film, often for a steamy dance sequence. It is the easy way out for producers and directors to market their film. Composers will tell you how difficult it is to create an ori-

ginal, catchy tune. While remixes may be here to stay, Vishal's demand for enough credit and remuneration is absolutely fair. "This is not about one song, one person, one company or one re-

mix," he said in an interview to Scrol*l.in.* "This is about a screwed-up system that allows the exploitation of what should be a composer's legacy without any regard for the original composers themselves." When asked about his own reworkings of popular songs, Vishal said those were tributes and that he had spoken to the original composers before putting them

More popular than originals Remixes don't require the kind of ta-

lent that composers like A.R. Rahman possess, yet they are hugely popular. In fact, Vishal's anger is understandable as remixes, if we go by YouTube viewership statistics, are often more popular than the original compositions. Saaki Saaki composed originally by Vishal-Shekhar for *Musafir* has garnered more than 80 million views in eight years, while its remix for the film Batla House, has registered more than 70 million views in just four months. Similarly, Laxmikant-Pyarelal's Ek Do Teen, composed for the 1988 film Tezaab and famous for Madhuri Dixit's iconic dance sequence, has been watched 83 million times since it was posted

on YouTube nearly six years ago, while the new version, for Baaghi 2, has had 113 million views in about vear and a half despite its failure to reproduce the magic of the original. Thus there is little doubt that remixes attract more attention, especially when marketed as refreshed versions of a cult original. And this is not surprising. Viewers from the younger generation, who consume videos on computers and mobile phones more than those from the earlier generations, prefer these modernised versions, especially when these songs also serve as promo for a film.

It is never easy to come up with a tune as captivating and original as Ek Do Teen, but it isn't impossible for a gifted composer even in times like

> these. However, the fact is that there aren't many composers around today who are capable of this, or even directors who can extract such quality music from them. This is a pity given that Indian cinema be it Hindi, Tamil, Ben-

gali, Malayalam, Telugu or Kannada - has a proud, rich tradition of mus-

And yet, despite this rich tradition of music, several composers have been accused of plagiarism. Many have climbed the charts of popularity standing on the shoulders of tunes obviously lifted from other composers producing music in other languages, including Arabic, Afrikaans, English and Turkish. In fact, such is the trust our music lovers have in Indian composers that when they come across an Indian song and a foreign one with an identical tune, they assume that the former is the rip-off!

Given India's rich tradition of music, music composers should take risks and produce original compositions instead of popularising what was already popular decades ago. Old songs bring with them certain memories. Recreating them may be easy, but remixes can never produce the magic of the original. And if composers are intent on reworking original numbers, it is important, as Vishal says, that the original composers be given their due.

FIFTY YEARS AGO DECEMBER 9, 1969

Missing Defence Designs

Excitement ran high in the Lok Sabha to-day [December 9] following the Education Minister, Dr. V.K.R.V Rao's admission of the disappearance of certain Defence designs from the Central Scientific Instruments organisation (CSIO), Chandigarh, although he assured the House that they were "neither secret nor of a confidential nature". Opposition members, particularly those belonging to the Jana Sangh, repeatedly interrupted Dr. Rao while he was making his statement in response to a call attention motion on the subject and challenged his contention that the missing documents were not secret. When Mr. M.L. Sondhi (JS) charged the Minister with misleading the House and hiding the facts, Dr. Rao protested and offered to resign if a Parliamentary body were to prove the charge. The motion had been tabled by Mr. S. Supakar (Cong.-O) and others. Dr. Rao said that in June 1966, the Department of Defence Supplies had sent drawings relating to an instrument needed by it to a number of public and private sector firms and to the CSIO to ascertain their capacity to fabricate and supply it. This was an angle measuring instrument used by the British and Army Commonwealth Forces during World War II.

A HUNDRED YEARS AGO DECEMBER 9, 1919

A Research Student in Tamil.

Mr. P.V. Manickam Naickar, B.C., M.C.I. (Lond.) is already known to many of us as a gentleman of originality. His vast research in Tamil, and in "Universal Phonetics" has forced him to public admiration. The Arni Teachers' Association, very recently, appealed to our University to open their eyes to his astonishing discoveries. I wish in this small article to draw the attention of all lovers of pure literature to his researches in phonetics. The learned scholar has found it possible to transliterate all the languages in Tamil characters, taking as basis for the phonetic rules, Tholkapyar's ancient work. At a lecture delivered by him under the presidency of a member of the International Phonetic Association - the distinguished Rev. Fr. Quin S.J. he (the lecturer) clearly expounded the basisless attempt of the above Association to symbolise individually all human voices. With a little humour, he added that if the earth were turned into a parchment, and if all the symbols discovered and to be discovered were spread on it, there will not be space for all of them.

43 dead, 16 injured in major Delhi fire

The injured were shifted to the LNJP hospital, the RML Hospital and the Hindu Rao Hospital.

People trapped in the building were screaming and shouting for help, but the firefighters trying to get inside from the main entrance were unable to move in because of the congested lane.

Among the dead were a 20-year-old who was to get married in four months, a man whose 25-year-old wife is eight months pregnant and a brother who was to go home with a 'lehenga' for his 15-year-old sister.

A police officer said the identity of 28 deceased was established, and they were making efforts to identify the others.

"Their family members will arrive on Monday. Locals, guardians or friends have reached the hospital to identify the deceased. The bodies will be handed over to relatives after postmortem and other legal formalities. A help desk is functioning at the hospitals," said a police officer.

Citizenship Bill to be tabled in Lok Sabha today

The Bill says the amendments will not apply to the tribal areas of Assam, Meghalaya, Mizoram and Tripura as included in the sixth schedule of the Constitution and Arunachal Pradesh, Mizoram and Nagaland that are protected by the Inner Line Permit (ILP).

The statement of objects and reasons of the Bill says, "The constitutions of Pakistan, Afghanistan and Bangladesh provide for a specific State religion. As a result, many persons belonging to Hindu, Sikh, Buddhist, Jain, Parsi and Christian communities have faced persecution on grounds of religion in those countries. Some of them also have fears about such persecution in their day-to-day life where right to practise, profess and propagate their reliand restricted. Many such persons have fled to India to seek shelter and continued to stay in India even if their travel documents have expired or they have incomplete or no documents."

The Bill says the six non-Muslim communities "shall not be treated as illegal migrant" for violating provisions of the Passport Act, 1920, or the Foreigners Act,

The Bill reduces the mandatory requirement of continuous stay in India from 12 years to five years for "many persons of Indian origin including persons belonging to the minority community from the neighbouring countries" who are unable to produce proof of their Indian origin and are forced to apply for citizenship by naturalisation under Section 6

Almost six years after the Lokpal and Lokayuktas Act, 2013, was signed into law, several key provisions needed for the anti-corruption ombudsman to function have still not been operationalised. The process of constituting the Lokpal's inquiry and prosecution wings has not yet begun, and regulations for how to conduct preliminary investigations have not been made, the Lokpal has said in response to RTI queries.

The movement to ensure accountability through an anti-corruption ombudsman has been long. The term Lokpal was coined in 1963 but it was not until January 2014 that the Lokpal and Lokayuktas Act came into force. It was more than five years later, in March 2019, that the first chairperson and members of the Lokpal were appointed.

More than eight months

later, the institution is functioning out of a governmentowned hotel in Delhi. While it approved a logo and motto for itself last month, the Lokpal has not yet notified a format for filing complaints. Despite that obstacle, 1,065 complaints were sent to the Lokpal office. "After scrutiny, complaints that did not fall within the mandate of the Lokpal were disposed of and complainants have been informed accordingly," says a note on the Lokpal web-

Section 60 of the Act gives the Lokpal the power to make regulations on "the manner and procedure of conducting preliminary inquiry or investigation". It also deals with making regulations on the website display of the status of all complaints pending or disposed along with records and evidence. However, in response to an RTI query, the Lokpal said, "Till now, no regulations have been made by the

Lokpal under Section 60..." Similarly, asked about the setting up of a special wing to prosecute public servants for corruption, as mandated by the Act, the Lokpal's office said, "The process of constitution of Prosecution Wing of Lokpal is yet to be initiated in consultation with the government of India."

The rules for the disclosure of assets and liabilities by public servants have not been notified either. This is a key provision as the amassing of assets disproportionate to the known sources of income is often the basis for a complaint. The draft rules of 2017 were referred to a Parliamentary Standing Committee, which submitted its recommendations to the government in July 2018. The Centre is yet to submit any Action Taken Report to the Raiva Sabha.

Congress firms up House strategy

Despite lack of numbers, it will vote against Citizenship Bill

The Congress will strongly Citizenship (Amendment) Bill, 2019, when it will be tabled in the Lok Sabha on Monday, party leader Adhir Ranjan Chowdhury said after a meeting of the Congress parliamentary strategy group on Sunday.

The meeting was chaired by Congress president Sonia Gandhi at her residence. Though the Opposition doesn't have the number in the Lower House to stall the passage of the Bill, the Congress will vote against it to register its protest.

'Violates Constitution'

"We will oppose the Bill tooth and nail as it violates the basic idea of our Constitution, its secular ethos. What strategy we adopt on the floor of the House, you will get to see tomorrow," Mr. Chowdhury told The Hindu.

Apart from Mr. Chowdhury, Leader of the Opposition in the Rajya Sabha Ghulam Nabi Azad, Congress chief

Congress MP Gaurav Gogoi attended the meeting.

Over the weekend, Mr. Azad tried to rally the Opposition parties to formulate a common strategy.

While the government will get support from the AIADMK and the Biju Janata Dal in the Rajya Sabha where it needs help for smooth passage, the Bahujan Samaj Party and the Samajwadi Party are likely to be part of the Opposition benches.

A chance for Congress With several civil society organisations in the northeast-

ern region opposing the Bill, claiming that it would change the region's demography, the Congress is viewing the Bill as a chance to gion that was once its stronghold but now dominated by the BJP.

The BJP-ruled Assam is witnessing protests. Sixteen Left-leaning organisations have called a 12-hour bandh for Monday in the State to protest against the Bill.

The AIADMK, which has 11 members in the Rajya Sabha, confirmed on Sunday that it would support the Citizenship (Amendment) Bill, paving the way for its smooth passage in the Upper House.

"We have decided to support the Bill. Whatever reservations we have we will express in the House. But if it comes down to voting, we will vote in favour," a top party leader said.

The AIADMK was prevaricating on the issue, but has agreed to come on board. The BJD with seven members, the TRS with six and the YSR Congress Party with two are already on board. With this, the treasury benches will easily sail through the 120 mark.

Ram Madhav defends Citizenship Bill

India is duty-bound to give citizenship to persecuted minorities from neighbouring countries as they are "victims" of the decision to divide the country on religious lines (Partition), BIP general secretary Ram Madhav has said, defending the Citizenship (Amendment)

Non-Muslim refugees, who have come from Pakistan, Bangladesh and Afghanistan after facing religious persecution, will be given Indian citizenship. Mr. Madhav said a similar

legislation was enacted in 1950 by the Jawaharlal Nehru government. "Let me remind the critics of the Citizenship (Amendment) Bill. The Nehru government had passed a similar Bill in 1950 for expulsion of illegal immigrants, mainly from the erstwhile Pakistan [Bangladesh] and categorically said minorities of East Pakistan wouldn't be covered under the Bill," he told PTI.

Pramila tables resolution in U.S. House on Kashmir

The bi-partisan resolution calls for end to restrictions in Kashmir and for India to respect international human rights law

As India stepped up its efforts to lobby Congressional Democrats, a Democratic member of the U.S. House of Representatives, Pramila Jayapal, introduced a bipartisan resolution in the House calling for an end to the restrictions in Jammu and Kashmir and for the Government of India to respect international human rights law.

The resolution, co-sponsored by Steve Watkins, a first-time Republican Congressman from Kansas, says the U.S. House of Representatives "recognises the dire security challenges faced by the Government and India in Jammu and Kashmir and the continuing threat of statesupported cross-border terrorism," and that the House "rejects arbitrary detention, use of excessive force against civilians, and suppression of peaceful expression of dissent as proportional responses to security challenges."

The House, as per the re-

solution, urges the government to adhere to international human rights law in its pursuit of "legitimate security priorities."

'Free detainees'

The resolution urges the Government of India to quickly release those arbitrarily detained: "lift the remaining restrictions on communications and restore Internet access" across the region: "refrain from the use of threats and excessive force" against detainees and those protesting peacefully; refrain from conditioning the release of detainees on them signing bonds prohibiting political speeches and activities.

Ms. Jayapal's resolution asks the government to allow international human rights observers and journalists into Jammu and Kashmir and to operate freely across India, without threats.

It also urges the Government of India to "condemn, at the highest levels, all religiously motivated violence,

including that violence which targets against religious minorities.'

'Unique relationship' In its introduction, the resolution notes the "unique and important" relationship between the U.S. and India and refers to India being the birthplace of four major world religions.

The resolution has just been tabled thus far and has to go through a process before it is put to vote. However, Indian officials questioned how much support it would get from the Republicans.

"Indian Embassy staff had met with Steve Watkins's key staffers on a number of occasions and were categorically told by them that he would not be signing on to the resolution and that the Republican caucus was not in favour of the resolution," a spokesperson for the Indian Embas-

sy told The Hindu. Ms. Jayapal, who is Chennai-born and represents the 7th Congressional district from Washington state, is the co-chair of the Congressional

Progressive Caucus. Recent issues she has supported include legislation to prevent the separation of migrant families at the U.S. border and the monitoring of China's treatment of Uygh-

"I hope to work with the Indian government and my colleagues in Congress to strengthen the U.S.-India partnership, while protecting the human rights of the Kashmiri people," Ms. Jayapal said on Saturday.

She welcomed the release

from jail on Friday of Mubeen Shah, a Kashmiri-origin, Malaysia-based businessman, who was detained under the Public Safety Act. Mr. Shah's niece had approached Ms. Jayapal about the case.

Briefing lawmakers

Indian officials have taken to explaining the country's position to a number of U.S. lawmakers at federal and state level as Capitol Hill's scrutiny of the restrictions in Kashmir began since Article 370 was removed by Parlia-

ment in early August. The Indian Ambassador, his deputy and the Consul General in San Francisco met on separate occasions with Ms. Jayapal in the recent past to brief her on the situation and to explain to her that restrictions in Kashmir had been significantly eased, In-

dian officials told *The Hindu*. "She has however remained rigid in her position, from when she initiated this resolution, until its tabling a few days ago. As such, the resolution is imbalanced, factually incorrect and prejudicial to the close and cooperative relations and strategic partnership that India and the United States enjoy," the officials said.

"The longer these detentions drag on, the more you will hear not just in the United States but around the world from voices who, again, have been supportive of India more generally," Alyssa Ayres, a former highranking U.S. diplomat for South Asia, now with the Centre on Foreign Relations, told The Hindu.

"My sense is that there is broad sympathy for the terrorism challenge India has faced from Pakistan. But that question, four months on from August 5, is to some extent separable from the concerns this new legislation addresses: concerns for the indefinite detention of Kashmiris without charges, and the communications block remaining," Ms. Ayres said.

Officials dismiss concerns over U.S. resolution

India reaches out to Congressmen

The External Affairs Ministry has refused to comment on the U.S. House resolution on Jammu and Kashmir introduced by Indian-American lawmaker Pramila Jayapal, even as the government stepped up efforts to ensure that the resolution is not passed, with officials reaching out to Congressmen and women as well as the Indian

diaspora. Sources said India is also hopeful that House members of the India caucus will move the process in their favour, while former diplomats said the larger fallout was in the optics, not in its substance. "I think [the resolution] has a lot of sensation value, because while a motion on human rights in the U.S. House or Senate is not uncommon, but one tabled by a person of Indian origin is rare, and countries like Pakistan will use this for their propaganda purpos-

es," former Ambassador to the U.S. Lalit Mansingh said.

"I think we have enough support on Capitol Hill for this resolution not to see the light of day this time as well," he added.

According to other diplomats, the introduction of the resolution is a concern because it is among the first such resolutions criticising India for restrictions in Jammu and Kashmir since 2000. However, officials dismissed those concerns and the fact that the resolution has been introduced by Republican representative Steve Watkins, and Ms. Jayapal, a Democrat, and said it had "limited resonance" and would not be endorsed by many.

Congress leader Shashi Tharoor tweeted that it was a "shame" that Parliament was yet to discuss the situation in Kashmir while two U.S. lawmakers moved a bipartisan resolution in the House of Representatives.
