# Love, betrayal and caste oppression in an Unnao village

Rape victim was promised marriage and attacked when she pursued case

Overshadowing the emotional farewell to the Unnao rape victim, who was laid to rest beside the graves of her grandparents on Sunday, is a tale of love, betrayal and caste oppression in a tiny village in Uttar Pradesh.

As in most cases of rape. the victim and the main accused had known each other since they were in school. In an FIR lodged in March, the woman accused Shivam Trivedi, 24, and Shubham Trivedi, 25, of raping her at gunpoint in a field in Rae Bareli last December. The FIR was registered only after a protracted struggle by the family and the intervention of a local court.

In the sequence of events described in the FIR, the victim said Shivam had first "lured her in a love trap" and raped her. He allegedly videographed the act. In her complaint, the woman alleged that after the initial incident of rape, Shivam continued to rape her by giving false promises of marriage and threatened to make the video public.

According to the complaint, Shivam even lived with her in a rented room in Rae Bareli for a short while, and allegedly prepared false marriage papers to mislead

#### **Different versions**

However, the victim's family and villagers give different versions of the events. Her sister said the victim never pressured Shivam to marry her and her father said the boy's family had agreed for marriage, but the village pradhan did not allow it because of caste differences the victim's family belong to a backward caste and her

father is a blacksmith.

"For this reason, the matter got entangled. The talks [of a compromise] were almost final. But the pradhan said this marriage won't happen. This clash continued due to that," the father said.

Inspector-General of Police, Lucknow, S.K. Bhagat told presspersons on Thursday, after the woman was set ablaze that prima facie it appeared that the woman knew

Shivam, who "physically ex-

ploited" her on the promise

of marriage.

Even as the victim was buried amid a large contingent of police as a crowd including leaders of the Samajwadi Party and Congress looked on, an eerie quiet enveloped the other end of the village

where the dominant Brahmin families live.

The families of Shivam and Shubham, the rape accused, their fathers Ramkishor Trivedi and Harishankar Trivedi (the pradhan's husband) and a fifth associate Umesh Bajpai, said they were being falsely implicated, and demanded a probe by the Central Bureau Investigation.

Shivam's mother, Saroj Trivedi, insisted that her son was innocent and falsely charged in the rape case and the murder.

On December 5, when the woman was set ablaze around 4.15 a.m., Ms. Trivedi said her son and husband were asleep at home.

"At 5.13 a.m., Shivam's friend called him for a run. He was preparing for a police job. At 5.30 a.m., he put on his clothes and left home. The police came at 6 a.m. and asked about him. After that, the police went to the location near our borewell in search of him along with my nephew," she said.

**Seeking justice** 

But outside their thatched hut, the victim's grief-stricken sister, her face covered in a dupatta, was determined to

"First and foremost, I want those who burned my sister to be shot dead in an 'encounter'. If they [government] don't do it and show laxity in getting me justice, I will commit suicide in Yogi's [Chief Minister Yogi Adityanath's] durbar," she told The Hindu.

Family members say the victim was walking to the railway station to catch a train to Rae Bareli to inquire from the court how Shivam was granted bail in just twoand-a-half months.

While Shubham, the pradhan's son, was not arrested for the rape, Shivam was put behind bars on September 19. However, he was granted bail by the Allahabad High Court on November 25 and released five days later.

Over the past one year and more recently after his release on bail, Shivam and his associates had threatened the victim with dire consequences if she did not withdraw the rape case, her sister

Woman's complaint dismissed

Despite the outrage over the death of the Unnao rape victim who was set ablaze by the accused, the police in the Uttar Pradesh district have allegedly refused to register a woman's complaint of attempted rape.

The woman from Hindupur village, where the rape victim was set on fire on Thursday, alleged on Saturday that the police had dismissed her complaint.

The police allegedly asked the woman to come after the rape had taken place.

"Rape toh hua nahi; jab

hoga tab aana (Rape has not happened; come when it happens)," a policeman at

the station told her.

The woman said three men from the village had attempted to rape her some months ago when she was on her way to buy medicines. "I was going to buy my medicines. These three men stopped me and started pulling my clothes. They also attempted to rape me," she said.

She has also identified the accused, who have been allegedly threatening her.

The woman said she had been visiting the police station for over three months.

# Minister wants faster trial of rape cases

'Will write to CMs, HC Chief Justices'

Union Law Minister Ravi Shankar Prasad on Sunday said he would write to the Chief Ministers and the Chief Justices of the High Courts to complete investigation into cases of rape and those registered under the Protection of Children from Sexual Offences Act in two months.

'Trial in six months' Trial of such cases should be within six completed months, the Minister told presspersons.

"I am going to write letters to all the Chief Ministers urging them to complete the investigation within two months in rape and POCSO cases," Prasad told repor-

**Highly condemnable** Incidents of rape and

crimes against women are unfortunate and highly condemnable, he said.

"I will write to the Chief Justices to dispose of expeditiously all cases relating to rape and POCSO pending in the fast-track courts," he said

Mr. Prasad's comment came in the backdrop of nation-wide outrage over the alleged rape and murder cases at Hyderabad and Unnao.

At the meeting held on the premises of the Indian Institute of Science Education and Research, Pune, the officers brainstormed on several policing issues.

According to a government press release, "The conference deliberated on a gamut of policing and security issues, including border protection, the linkage of narcotics and terrorism, upgradation of forensic capability, threat from radicalisation in the digital era, and

evidence-based policing." There was no exclusive session on women security or safety, an official said.

A detailed discussion was also held on the threat posed by the Islamic State (IS) in In-

The IB and the Telangana police apprised the delegates of the arrests of IS-inspired modules in the past few years. So far, 155 IS members have been arrested across the country by the National Investigation Agency (NIA) and the State police forces. The bulk of such arrests, 127, were made by the NIA in 28 cases.

Punjab DGP Dinkar Gupta gave a presentation on radicalisation to propagate Khalistani activities.

The NIA and the Punjab police have registered nearly 10 cases in the past three years for alleged attempts to create "communal disharmony" in Punjab on directions from Pakistan.

**New universities** The Home Minister announced the government's plans to set up an All India Police University and All India Forensic Science University, and underscored the government's resolve to initiate changes in the Indian Penal Code and Code of Criminal Procedure (CrPC) to make them more conducive to today's democratic set-up, the press release said.

# Terror poses a challenge in South Asia: PM

Countries in South Asia should take steps to resist terrorism that poses a challenge to prosperity and peace in the region, Prime Minister Narendra Modi has said in a letter to the Secretariat of the South Asian Association for Regional Cooperation

(SAARC) in Kathmandu. "SAARC has made progress, but more needs to be done. Our efforts at greater collaboration have repeatedly been challenged with threats and acts of terrorism. Such an environment impedes our shared objective of realising the full potential of SAARC. It is critical that all countries in the region take effective steps to defeat terrorism and the forces that support it," he said in the letter written on the occasion of the 35th Charter Day.

SAARC was set up on December 8, 1985, in Dhaka. Ever since its beginning, the organisation has faced difficulties, mainly because of India-Pakistan hostilities. The regional body, which is headed by the Secretariat, has failed to hold its annual summit after the November 2016 summit in Islamabad was cancelled following the terror attacks on the Pathankot airbase and the military hub in Uri.

The latest meeting of the SAARC Foreign Ministers took place in New York on September 26, on the sidelines of the UN General Assembly, when Indian and Pakistan Ministers S. Jaishankar and Shah Mahmood Oureshi delivered speeches separately.

The problems were most recently highlighted by Dr. Jaishankar, who pointed at the lack of optimism about Pakistan and argued that India's 'neighbourhood first' policy was not meant for Pakistan.

# Hong Kong marks 6 months of protests

Organisers say 8,00,000 joined rally, biggest since recent polls; police arrest 11 people & seize weapons

Vast crowds of black-clad demonstrators thronged Hong Kong on Sunday in the largest anti-government protests since local elections last month that boosted the prodemocracy movement seeking to curb controls by

It was the first time since August that the Civil Human Rights Front - organiser of million-strong marches earlier in the year that paralysed the Asian finance centre had received authorities' permission for a rally. It estimated turnout of 8,00,000 while police said 1,83,000.

Chants of "Fight for freedom! Stand with Hong Kong!" echoed as demonstrators, from students to professionals and the elderly, marched from Victoria Park towards the financial

# FBI presumes shooting at U.S. Navy base was an act of terror

On social media, he charged that 'Americans are anti-Muslim'

The FBI is working under the presumption that a fatal shooting at a Florida naval base carried out by an aviation student from Saudi Arabia was an act of terrorism, the agency said on Sunday.

All international students at the Pensacola base have been accounted for, there have been no arrests, and the community is under no immediate threat, special agent Rachel L. Rojas said. A Saudi commanding officer has ordered all students from the country to remain at one location at the base, officials said.

Additionally, authorities believe the gunman made social media posts, in which he talked about U.S. support for Israel and charged that Americans are anti-Muslim, a U.S. official said on Sunday. Investigators also believe the

gunman visited New York City, including Rockefeller Center, days before the shooting and are working to determine the purpose of the trip, said the official, on condition of anonymity.

The FBI and others had said they were trying to determine whether the gunman, 2nd Lt. Mohammed Alshamrani, 21, of the Royal Saudi Air Force, acted alone. Alshamrani was a flight student at Pensacola, where members of foreign militaries are routinely trained by

Earlier in the week of the shooting, Alshamrani hosted a dinner party, where he and three others watched videos of mass shootings, another U.S. official said.

The U.S. has sought Saudi assistance to piece together information about the gunman and his motive.

Alshamrani opened fire inside a classroom at the base, killing three people and wounding two sheriff's deputies, before one of the deputies killed him. Eight others were also hurt.

The official said one of the three students who attended the dinner party recorded video outside the classroom building while the shooting was taking place. Two other Saudi students watched from a car, the official said.

# Sunni leaders back Hariri to return as Lebanon's PM

Formal consultation to designate the premier begins today

Lebanon's leading Sunni Muslim politician, Saad al-Hariri, reemerged as a candidate for Prime Minister on Sunday when businessman Samir Khatib withdrew his candidacy to lead a government that must tackle an acute economic crisis.

Mr. Hariri quit as Prime Minister on October 29, prompted by mass protests against an entire political

class blamed for state corruption and steering Lebanon into the worst economic crisis since the 1975-90 civil

Under the country's power sharing system, the PM must be a Sunni Muslim. Mr. Hariri has continued to govern in a caretaker capacity.

There were differences between Mr. Hariri, who is aligned with Western and Gulf Arab states, and his adversaries, including the Iran-

backed Shi'ite group Hezbollah, on a new Cabinet.

Grand Mufti of Lebanon, Sheikh Abdul Latif Derian. informed Mr. Khatib that a "consensus has been reached to name Mr. Hariri

Formal consultations to designate the PM will take place on Monday. President Michel Aoun must designate the candidate with the maximum support among Lebanon's 128 lawmakers.

# Iran hopes to use Russian fund to counter U.S. sanctions

'Budget of resistance' with \$5 bn from Moscow in the works

Iran's President Hassan Rouhani announced on Sunday a "budget of resistance" against U.S. sanctions targeting the country's vital oil sector, backed by a \$5 billion Russian investment.

Mr. Rouhani said the aim was to reduce "hardships" in Iran where a shock fuel price hike last month triggered nationwide demonstrations that turned deadly.

After unilaterally withdrawing from a 2015 nuclear deal between Iran and world powers last year, the U.S. imposed sanctions on Tehran, including on oil exports,

which it aims to squeeze to zero in a campaign of "maximum pressure".

Iran has suffered a sharp economic downturn, with a plummeting currency sending inflation skyrocketing.

Mr. Rouhani told Parlia-

ment that the budget of 4.845 trillion rials (\$36 billion), was devised to help Iran's people overcome difficulty. "We know that under the situation of sanctions and pressure, people are in hardship. We know people's purchasing power has declined," he said.

The budget would benefit from a \$5 billion "investment" from Russia which was still being finalised, said Mr. Rouhani.

"We hope that \$5 billion in capital will enter the country, either through plans that have already been finalised or which will be finalised next year," he said.

# Kim has much to lose through hostility: Trump

N. Korea conducted new weapons test

President Donald Trump warned on Sunday that North Korea's Kim Jong-un had "everything" to lose through hostility towards the U.S., after Pyongyang said it had carried out a major new weapons test.

"Kim Jong-un is too smart and has far too much to lose, everything actually, if he acts in a hostile way," Mr. Trump tweeted in response to the unspecified test.

The announcement of Saturday's test came just hours after the U.S. President said he would be "surprised" by any hostile action from the North, emphasising his "very good



relationship" with Mr. Kim. Both leaders have met three times since June 2018, but with little progress towards denuclearisation. Pyongyang has set a December 31 deadline for the U.S. to make new concessions to kickstart stalled talks.

#### Interest on home loan

Q. My wife and I are the joint owners of our self-occupied house property. But I have taken the home loan on my own. Can I claim the entire interest of up to ₹2 lakh on the home loan as deduction in my IT return?

A. In order to claim deduction of interest under Section 24 of the Act, you must be an/the owner of the house property and the housing loan is to be availed in the name of the owner/s. In your case, though the ownership is held in a joint manner, loan has been availed only in your name. Therefore, interest wholly paid by you towards the housing loan during the assessment year can be claimed as a deduction under Section 24 up to ₹2 lakh. It is also necessary that the interest and principal repaid by you in the said assessment year is confirmed by the lender in the form of an interest certificate in order to claim deduction under Section 24

#### LTCG on inherited shares

Q. I would like to know the period for which long-term capital gains tax is calculated on the sale of shares where the cost and date of acquisition is not known. I had inherited shares from my father by demat transfer from his account after he expired. Some of these shares were inherited by him from his grandfather in physical mode and converted into demat form later. However, we have no clear records of the date of purchase or the purchase price. If I now sell these shares. what is the period for which the long-term gains will be calculated?

I personally felt I could consider the share value as on 31.1.18 as the acquisition cost. Or, should it be the cost on the day of transfer to my account? Please advise

DR. NIKHIL S. GOKHALE

A. Transmission of shares in the event of inheritance from an ancestor poses a very unique situation after the introduction of long-term capital gain tax levy on listed equity shares/securities. In cases where cost of acquisition is not known, the act spells out that fair market value on the date of acquisition by the ancestor needs to be considered as the cost of acquisition.

However, in cases where both are not known, it is advisable that closing prices as on 31.01.2018 for such shares for which securities transaction taxes (STT) was paid on acquisition be considered. In your case, when your father/grandfather purchased shares in physical form, STT would not have been paid. In such cases, the shares will be treated as a regular capital asset and fair market value as on 01.04.2001 can be considered. However, long-term capital gains will be taxable at regular rates with indexation benefits.

Q. This refers to your reply to the query of Mr. Subir Mukhopadyay in the edition dated October 21. I am also a very senior citizen and in my case, the company from which I retired pays the insurance premium of ₹6,500 per year for hospitalisation expenses only. I spend about ₹6,000 per month on buying medicines for me and my wife. Based on your reply, I assume that I can claim the balance of ₹43.500 under Section 80 D by enclosing all the bills given by pharmacies. Kindly

A. In this case, the company is paying for hospitalisation expenses per year directly. It is assumed that this amount is not deducted from the pension receivable by you. There is no question of claiming deduction for health insurance, as the premium is not being paid by you. You may claim up to ₹50,000 towards actual medical and healthcare expenses incurred for self and wife.

# Ring-fence your money

Investments in shares, corporate deposits, banks et al. can be risky in these times if caution is not exercised

f you thought debt funds were a bad idea earlier this year, then the DHFL saga in June 2019 would have given you a shock about corporate deposits. If you then consoled yourself saying there are still banks, the PMC Bank episode would have broken that thin confidence left.

After the PMC Bank episode, a friend of mine mocked that even equities look safer than banks as they can at least be liquidated any time. But he said it too soon as the plight of the risk-takers in the equity world just got worse. For no fault of theirs, equity investors who had a broking account with Karvy Broking are now left wondering if they indeed hold all the shares they actually own.

Did you know?

Who would have thought a marquee lender of home loans like DHFL, that too, several decades old (don't tell me you don't trust vintage), would have reached the endgame, going into bankruptcy? Did you know that NBFCs gave loans to you for a longer time frame (like home loans) but

borrowed money for shorter time frames from large institutions? Did you know this can lead to what is called asset-liability mismatch and can spell doom when the money tap from such institutions suddenly run dry?

And the NBFC can become bankrupt when it is unable pay back its

shorter-term borrowings because there is no fresh money (à la Ponzi)?

Or, did you even realise that having ₹1 lakh as bank deposit insurance (yes, PMC Bank has it too) means nothing because you can't get your money when you want? The insurance kicks in only when a

bank goes into liquidation. The insurance cannot help when you need to withdraw for your monthly needs.

> Forget the poor depositors and savers. If you consider yourself smart and are therefore investing in equities, did you know that the power of attorney you give your broker can be misused, to move/misappropriate your shares and even pledge them for the broker's own needs? This is what allegedly happened in the Karvy Broking case.

> It is simply not possible to predict events such as these. So, you can only do what is in your control - that is, stick to the basic principles of investing diligently. Here are

> > Diversify

some of them.

If you have deposits in co-operative banks, or are testing waters with small banks, make sure you do not park a chunk of your savings and investments there simply because interest rates are higher. You need a large public or private sector bank to add to it. If you are already with a large private or public bank and hold several lakhs, consider holding additionally in any of the domestic system-

ically-important banks (identified as SBI, HDFC Bank, ICICI Bank, by the RBI) to keep some emergency money.

These banks are supposedly too big (whose assets account for more than 2% of GDP) to fail. That also means if they do fail, the government is expected to act; failing which the entire financial system can collapse.

If you are a regular corporate deposit investor, diversification matters much more. While the recent event of DHFL may have shaken your faith in the system, in general, NBFCs have higher disclosure norms than companies. The additional disclosures they are required to make with respect to liquidity and asset-liability mismatch (please do your reading about this, there is no other choice) provides some cues. The credit ratings alone won't do any longer.

As a general thumb rule, if you are a senior citizen needing regular income, invest first in post office, Vaya Vandana Yojana and RBI bonds before jumping into corporate deposits.

And in general, for all corporate deposit investors, a time frame of over three years is risky as it is hard to predict what can happen to even a sound company.

It is better to take out your

money and reinvest (not withstanding the risk of lower interest) than losing it. Remember, corporate deposits are unsecured, and you will not have first right when a company goes defunct.

### Some checks

If you are a demat account holder, you don't need multiple demats, you only need to monitor carefully. Make sure your broker has a process of regularly communicating with you on your settlement. Regularly open the e-CAS statement mails you receive from NSDL or CDSL or open an account with them to check if what is reflected there matches with your brokerage account. In case of any discrepancies, write to the depositories and the regulator SEBI through SCORES.

With all this too, your money may not be safe.

You only reduce your risk. I had a neighbour commenting that it was so much easier when people invested in real estate instead of complex financial products. My reaction was: What was DHFL into? How did PMC Bank lose? Where did the pledged share money from Karvy Brokers go? And real estate is a haven

# The name's Bond, Bharat Bond

Conservative investors, including retirees, can consider investing in these bond ETFs

The Union Cabinet has recently approved launching a bond ETF (Exchange Traded Fund). Called the Bharat Bond ETF, this fund will track the index comprising debt securities of Public Sector Undertakings with the highest credit rating.

Edelweiss Mutual Fund is launching the NFO (New Fund Offer) which is open for subscription between December 12 and 20,2019. ETFs are passively managed mutual funds that aim to generate a similar return as that of the index they follow. ETFs are traded on the BSE and NSE. The AMC plans to mop up about ₹7,000 crore from the NFO, sources say.

Unlike existing ETFs in India, the Bharat Bond ETF will have a defined maturity date just like bonds and fixed maturity plans of mutual funds. On maturity, investors will get the investment proceeds along with returns. Edelweiss MF is launching two series of Bharat Bond ETFs – one matures in April 2023 and the other after 10 years (ie April 2030). Only growth option is offered here.

These ETFs will invest only in AAA-rated bonds issued by PSUs maturing on or before the maturity of the ETFs. The ETF will hold the bonds till maturity and coupons received from those bonds will be reinvested in the fund. Post the NFO period, ETF units will be listed on

NSE and BSE. Through demat accounts, investors can buy and sell units at the prevailing market prices. Edelweiss MF plans to launch a fresh tranche in both ETFs, once a year. The older three-year and 10-year tranches, will continue to be available with shorter residual maturity in the secondary market. It may also be launched as a further fund offer (FFO).

Edelweiss MF charges an expense ratio of 0.0005% for managing the Bharat Bond ETF. This is the cheapest among MF schemes and ETFs in India. A lower expense ratio helps earn higher returns than a scheme with a higher expense ratio.

## Series to track index

Bharat Bond ETFs will track the index constituted by the NSE. Each of the ETF series will have a specific index to track.

Bharat Bond ETF-April 2023 will track 'Nifty Bharat Bond Index-April 2023' as benchmark. This index that measures the performance of portfolio of AAA rated bonds issued by 13 government owned entities.

The total number of constituents in the index is 99 as it holds different series of bonds from the same issuer. For instance, the index holds 10 series of bonds issued by PFC. The REC, NABARD and PFC are the top three issuers comprising 45% of the weightage in the index. The maturity date of the

index is April 15, 2023; hence, it is same for the ETF too.

Similarly, Bharat Bond ETF-April 2030 will track 'Nifty Bharat Bond Index-April 2030' as benchmark. This will measure the performance of portfolio of AAA-rated bonds issued by 12 PSUs. The total number of constituents in the index is 50. NHAI, IRFC and Power Grid Corporation are the top three issuers comprising 45% of the index weightage. The maturity date is April 15, 2030. Since these ETFs have a defined maturity structure, it would be easier to predict the returns that they are likely to deliver at maturity. As per the NFO document, if you invest in the ETFs during NFO and hold till maturity, you will get an annualised yield of 6.59% and 7.52% in the ETFs maturing 2023 and 2030, respectively.

Note that these returns are indicative and not guaranteed by the MF or the government.

Post the NFO period, investors can buy these ETF units on the exchanges. According to Edelweiss, the indicative yield (Yield to Maturity) of each ETF series will be displayed on the AMC's website daily.

Trading volume is key Liquidity or the trading volume plays an important part while you transact on the exchanges. In India, most debt ETFs are thinly traded which makes ETF transactions cumbersome.

Liquidity in an ETF is mostly determined by corpus and market makers. Normally, a large asset size in an ETF implies the likelihood of more active trading in the exchanges. Since the Bharat Bond ETFs are expected to collect a large corpus, there could be ample liquidity available in these ETFs. Market makers are authorised participants appointed by AMCs to keep the price of the ETF at any point in time close to the fair value of its portfolio. SEBI has mandated multiple market makers for these ETFs to ensure liquidity.

To incentivise market makers for making the market more liquid, SEBI allows AMCs to spend ₹20 crore for such activities. This will enable active participation of market makers.

Second, units of Bharat Bond ETFs are now eligible for repo transactions. Though the corporate bonds repo market in India is at a nascent stage, there is a chance that market makers can use their holding in Bharat Bond ETFs to raise funds

The bonds held are rated the highest grade of AAA. Debt instruments with this rating are considered to have the highest degree of safety for timely servicing of financial obligations. Such instruments carry the lowest credit risk. These entities are backed by government, ensuring safety of capital.

Bharat Bond ETFs provide a good opportunity to retail investors to participate in the corporate debt market while taking the lowest credit risk. The buy and hold strategy mitigates the interest rate risk too. The yields offered in these ETFs are more or less equal to the rates offered by the PSU banks on their deposits of similar tenure. Conservative investors including retirees, whose investment horizon matches the tenure of the available bonds, can consider investing in these bonds.

Bharat Bond ETFs are treated at par with debt mutual funds where the sale of units after 36 months from the date of purchase qualifies for long term capital gains tax; the gain is taxed at 20% with indexation.

## Points to note

Any deterioration of credit quality of the bonds held in the basket of the index may lead to capital erosion for investors.

Considering the higher allocation to a few issuers, investments may also be exposed to concentration risk. One needs a demat and broker's account to transact in the ETFs. Anyway, the fund house is planning to launch a fund of funds (FoFs) scheme. These FoFs enable investors to participate in the underlying ETFs without a demat or a broker's account.

# Step out of the spiral

Promoting mental health literacy among students and educators is the right step towards addressing the rising suicide rates in higher education institutions

Of late, the number of suicides in the (Indian Institute of Technology) IITs and other higher education institutions has been on the rise. This year, three IIT Hyderabad students committed suicide, and it was reported that in their suicide notes they had mentioned 'academic pressure' and 'depression' as reasons for their decision to end their lives. Four cases of suicides were reported at IIT Kharagpur, and the institute was criticised for its failure to prevent students from taking such extreme steps. Many more cases of suicides in other higher educational institutions have been reported in the recent past.

Very recently, a first-year postgraduate student of Humanities and Development Studies at IIT Madras, allegedly committed suicide. She was found hanging in her hostel room. It is said that the girl had mentioned that a professor was the cause of her death, and the case is being investigated by the Central Crime Branch. Hopefully, the public will come to know the real cause of her alleged suicide. Some IIT sources say that she was a bright student and therefore academic pressure could not have driven her to take her own life (if we assume that it is a suicide). Why did the meritorious student decide to commit suicide? Was she subjected to any form of mental torture or harassment? Was she not prepared to face challenges? Did she not seek help from anyone? Should the education system be blamed for the rising number of suicides in higher education institutions? Many such questions have been raised and, unfortunately, some questions remain unanswered.

The purpose of the article is not to unravel or unlock the mystery behind the death of the girl, but to ana-



lyse the causes of suicides in higher education institutions and to suggest measures to tackle the issue.

### **Triggers**

What are the causes of climbing suicide rates among students? There could be so many reasons, but some common ones include unrealistic expectations of parents, peer pressure, academic stress, attitude of faculty towards students, unhealthy competition, career issues, feelings of rejection, discrimination,

health problems such as depression and psychological distress, lack of help-seeking skills and access to professional counselling.

The myths that engineering and medicine are the top courses preferred by academically brilliant students, the best brains go to IITs and AIIMS or other top medical colleges, and all IITians get placed in top companies and are paid high salaries, make some parents nurture unrealistic dreams and push their wards to make their

Every year, over 10 lakh candidates prepare for IIT JEE and only around 9,500 students are admitted to the IITs. When parents push their children to achieve unrealistic goals and when the children fail to fulfil their parents' dreams, the seed of depression is sown in their young minds. Some students are able to crack highly competitive exams, thanks to vigorous coaching, and get seats into the IITs, but are unable to cope with academic pressure. As a result, they

are subjected to depression

and some of them are forced

to discontinue their studies. According to the data shared by the Ministry of Human Resource Development, 2,461 students (both UG and PG) dropped out of various IITs during the past two years. We can imagine the trauma experienced by the dropouts and others who are not able to cope with academic pressure and unfriendly campus environment that pushes them into the pool of depression.

The negative attitude of some faculty members to-

wards students is also a cause for some students' mental stress. According to a source from an IIT, some students being labelled 'slowlearner', 'not fit for IIT', 'not IIT stuff', 'good for nothing', etc. by the faculty members affect the self-esteem of the students.

Research shows that around 20% of students in higher education institutions have mental health problems due to various factors. Students' poor mental health can affect their studies, career and lives. What measures should be taken to deal with students who have depression, anxiety, suicidal thoughts, addiction, and so on? Promoting mental health literacy among educators and students is important.

Awareness Mental Health Literacy

(MHL) is not a familiar term in Indian educational institutions. Most education administrators and educators have never felt the need for promoting MHL among teachers and students. Very recently, while discussing its importance with a group of school teachers, I noticed that they did not seem to have a clear idea of what it is and the need for it. I wasn't surprised because only a few years ago, I came to know about its significance while going through an article related to it.

MHL includes "the ability to recognise specific disorders; knowing how to seek mental health information; knowledge of risk factors and causes, of self-treatments, and of professional help available; and attitudes that promote recognition and appropriate help-seeking".

**Educational** institutions should take steps to enhance the MHL of students as well as educators. This will help everyone understand their mental health and enhance their help-seeking and selfmanagement skills. According to some research, those who have high levels of MHL seek help for mental health issues more compared to those with low levels of MHL.

Educators, teachers and others who are in constant touch with students should have MHL and know how to identify the students who struggle with depression and help them come out of it.

# Decoding CLAT 2020

With the exam coming up in May, here are few tips to prepare, keeping in mind the new pattern

After more than a decade of conducting the Common Law Admission Test (CLAT), it is time to embrace a major pattern change. Recently, The Consortium of National Law Universities issued a press release which indicated changes to the pattern and number of questions in the forthcoming CLAT 2020 on May

An entrance exam is designed to test the students' aptitude to pursue a course in a university. When this objective is not fulfilled, it is important to revamp the exam to suit the end. The two most important skills for budding lawyers include comprehension and critical reasoning skills. Law schools also mandate that students possess these two skills to cope with the teaching methodology adopted by most law schools. In the recent years, the professors at National Law University (NLUs) have felt that CLAT has failed to test these skills, and has instead tested the memory quotient of law aspirants. In short, CLAT has not succeeded in testing students' real aptitude to pursue law, resulting in a mismatch between selected students and law school requirements.

## Changes

CLAT Consortium has proposed to substantially reduce the number of questions in CLAT from 200 to 120-150 questions. This is a welcome move and brought relief to students as cracking 200

questions in 120 minutes put tremendous time pressure on students.

Further, students will no longer be required to cram facts for the General Knowledge (GK) section as questions in this section will be asked only on current affairs, rather than static GK topics such as history, geography, science and so on.

The English section in CLAT 2020 will comprise of only comprehension passages with a view to test their understanding of the passages, contextual meaning of words and inferences drawn from the passages.

Instead of testing the arithmetic aptitude of candidates, the focus of the math section will be on testing data interpretation skills of students, which is more relevant for law aspirants.

Logical Reasoning (LR) section will place more emphasis on critical reasoning skills. This section will include a variety of questions to determine students' ability to reason through an argument logically and make an objective decision. It will test their deductive reasoning skills.

The CLAT Consortium has realised that it is rather unfair to quiz students on their knowledge of legal concepts even before they enter the law schools. This section will now test students' ability to deduce conclusion from a given set of premises. The section would continue to have propositions and a set of facts to which the said proposition has to be applied.

With less than 200 days for the D-day, it is important for the CLAT Consortium to release the sample paper and detailed syllabus at the earliest.

# Spotting a match made in heaven

The bond or rapport you share with your therapist will go a long way when you seek professional help

In past editions of this column, when we discuss mental health, we always stress on the importance of getting help. Often, this might mean turning to mental health professionals - psychol-

ogists, psychiatrists and so on. But what if you took a chance on meeting a psychologist and left feeling ambivalent?

The fact is, meeting a psychologist is like meeting a doctor - sometimes, you find yourself wanting to seek out a second opinion.

Not all psychologists are built alike, and it is important that the professional you meet establishes a good rapport with you, because that forms the basis of your therapy. This does not mean you and your counsellor have to be friends (quite the opposite, in fact!), but it means that you are comfortable with this person, believe that they understand you, and trust them to help you get to a better place.

## **Red flags**

Here are some signs that you and your psychologist may not "click":

1. They pass judgement on you: Here you are, bravely deciding to be vulnerable and open up to another person about your issues, and your therapist acts like those annoying aunties you are always trying to avoid? Yes, therapists are meant to ask probing questions to get you to think, but not at the expense of your self-worth. If you are constantly leaving therapy session feeling worse about yourself because of the judgements passed by your therapist, that's a sign to start looking elsewhere.

2. They push the boundaries of the relationship: Constantly talking about themselves or trying to become friends with you are red flags. It is a tricky balance to strike, but a good therapist keeps things professional while staying

3. They don't have time for you: Constantly taking calls during sessions, getting interrupted frequently by office staff, or not putting in the effort to explain concepts to you suggest that maybe this person has too much on their plate to invest his/her energies in helping you.

4. Their experience and specialisation do not gel with what you are looking for: Therapists practise different types of therapy, the most common of which is CBT, or Cognitive Behavioural Therapy. They also tend to have specialisations - for instance, working in the area of anxiety, depression, obsessive-compulsive disorder, child psychology, and so on. It is important to find a therapist who has knowledge or experience of working with the issues you are grappling with,

using a therapy you are comfortable with. 5. It is a gut feeling: Sometimes things just don't "feel" right, though you are unable to pinpoint just why that is. That still is a perfectly acceptable reason to look for another therapist. You are under no obligation to continue with a therapist, if you do not want to, no matter how many sessions have been completed; and therapists are

well aware of this. It is not always possible to ascertain in the first session itself whether things will work with your therapist. And in the event that they don't, it is important not to give up - you would put in the effort to find doctors to provide second opinions on physical health issues. The same effort needs to go into finding the right therapist for you.

Neha was in class VII and struggled to study in a mainstream school. She also had a low self-esteem, gradually turned into a recluse, and refused to talk. She was assessed and found to have dyslexia. She came to Madras Dyslexia Association (MDA) for help, and hugely benefited from the therapy. Today, Neha is a designer, photographer and is into digital marketing as well. She is also a confident speaker and often gives talks on topics associated with dyslexia.

While Neha was lucky to have found the right source of help, many students with dyslexia still suffer without proper diagnosis and therapy, mainly owing to lack of awareness.

Discussions and deliberations led to a group of educationists empathetic to this cause to come together, and philanthropists joined them. Thus was born MDA in 1992. D Chandrasekar, Founder and President, sheds light on the learning disorder, and what schools could do to be more inclusive.

Could you throw light on what dyslexia is and what we should be looking out for, in terms of first noticing the signs? How different is it from other learning/developmental disorders?

Dyslexia is a learning disability that occurs in one out of every six school-goers, irrespective of the economic, language and geographic status. These children are intelligent with an IQ of 85 and above, but have difficulty in reading, spelling, writing, and speaking. This can be easily re-mediated using multi-sensory techniques. The earlier one does it, the better it is, as the gap between their achievement and active potential will be minimal in the early stages. Hence, it is important to address this condition as soon as one notices

One can start noticing this even at the age group of three to five, by looking at the developmental milestones. Unremediated dyslexic children become social delinquents and cause major social problems. Hence, it is not just an educational problem. Children who come here (to MDA) have learning difficulties due to multiple reasons. If the child has learning difficulty with an IQ of less than 70, it could be due to underdevelopment of the brain. If the child has an IQ between 70-85, it can be due to multiple reasons such as autism, down syndrome, slow learning, and so on. If the child has an IQ above 85,

At what age does it first appear?

One can start suspecting from the age of three to five itself. However, the confirmation that the child is dyslexic will take place only at the age of eight. Dyslexia is a life-long condition. Though this condition does not begin in mid-life, it is possible that this remains unnoticed till the person is an adult.

What does the therapy involve?

Children with dyslexia will be weak in executive functions such as punctuality and tidiness. If they are trained in these areas, they will excel. There are a number of successful people with dyslexia such as industrialists, businessmen, sportspersons, artists, builders and designers.

are given many coping strategies and they must be given more opportunities to work in the area of their strengths. It is not difficult for them to continue with their regular

Does being a dyslexic categorise one as a special student?

The Government of India has brought dyslexia as a disability under the Rights of Persons with Disabilities Act 2016, and hence, whatever special provisions and concessions are available to other disabled people are extended to those with dyslexia too. In this way, these children are considered special. They are offered special provisions while they appear for public exams in the state and central boards, and also in a number of joint

entrance exams, and so on.

Are mainstream schools equipped to cater to dyslexic students?

Some time back, most of the mainstream schools had no facilities to cater to them. But due to increasing awareness, many schools have started to come forward to look after these children. MDA has been helping schools to set up resource rooms in the respective campuses. They are also empowering the teachers by providing training. Teachers and parents need to be sensitised, and it would also be beneficial if the identification and re-mediation of dyslexia is a part of the curriculum for B.Ed.

There are a number of successful people with dyslexia such as industrialists, businessmen, sportspersons, artists, builders and designers. Can dyslexic students pursue regular careers? Also, what extra efforts do they have to put in, compared to others?

Dyslexic children are very intelligent, but their intelligence is focused onto the creative side. If they are supported and encouraged to pursue a regular career in areas of their strength, they can supersede. However, if they are forced to take up careers that are unrelated to their strength, they are bound to fail, much like anybody else. Hence, it is important that they choose careers hat suit them.

#### What are some of the biggest challenges for dyslexic students?

One of the biggest challenges is being accepted by their parents, community and in schools. Once that is taken care of, most challenges can be overcome. Parents need to spend more time with the children and identify their strengths, and use these strengths to help children overcome dyslexia.

Any self-help technique for those having learning disabilities?

Madras Dyslexia Association has developed a reading application called MDA Avaz Reader, an assistive device for dyslexic children. Such devices and applications that help children to read, write and spell, will be the best technique.

# Disruptions in a shared space

Noisy or not, distractions in a classroom can break the train of thought of not just students, but teachers too

The speaker is deep into the talk. Many students are furiously scribbling notes; others are listening intently. A few are not paying attention, are restless and distracted. Some in this group are trying hard to get involved, but for whatever reason, the lecture fails to grab them. A few minutes in, the door creaks as someone opens it to go out – presumably, to get a drink of water or to take a bathroom break. Some moments later, the door creaks again to let the person back inside. This happens repeatedly through the hour, each time caus-

ing a bit of a rustle. In many college classrooms, the rules are flexible enough to allow freedom of entry and exit. It is assumed that students will take care to not disturb the class as they exercise this freedom. But the truth is, every time the door creaks, or someone gets up, a small ripple of distraction runs through the room, affecting people in different ways. Some may be so in-

volved in the discussion that their focus doesn't shift. Others will look up and take note of the interruption but quickly go back to what they were doing. Yet others will get a bit flustered and take a moment to regain their rhythm. And a few will be unable to recover their concentration.

**Etiquette matters** The classroom is a shared space, accommodating a variety of personalities, each with their own way of handling attention. In school, we give the teacher the authority to commandeer attention, and it is not unusual for her to loudly call out those who seem to be wavering. Often, children don't have the luxury of going out during a class, without the permission of the teacher. They must wait for the break. In college classrooms, it is expected that students will have already learnt the etiquette of participation, and so, these rules often remain unsaid. It is assumed that individuals will

disruptive, that they actively contribute to the shared attention of the classroom, and are respectful of both and other speakers

ruption as something noisy and visible, and that creaky door is not even close. But as a teacher, I find myself looking up each time someone walks in and out, and I find that several others are similarly distracted. Expressing respect for a classroom may be as simple as preparing oneself for the hour to come, by getting a bottle of water ready ahead of time, by taking that bathroom break before the class, by turning off the mobile phone and settling in quietly. Isn't that what we do in a movie theatre before a film plays? Granted, a lecture may not be as riveting, but there may be others who want to pay attention.

From starting out as an apprentice to a minor Parisian jeweller, Louis-François Cartier spent two-and-a-half decades building his business. His humble beginnings as a metalworker's son could not be further from the glamour associated with the family name now. The brand counts royalty like Queen Elizabeth of England and Princess of Monaco, Grace Kelly, as patrons. Actor Elizabeth Taylor received her iconic ruby and diamond set while she was in the pool! There are no less takers for the jewellery maker's work today. At a Christie's auction in June this year, Cartier pieces may have accounted for only 5% of the lots, but brought in a quarter of the \$109 million value.

This is where Francesca Cartier Brickell begins her book, The Cartiers: The Untold Story of the Family Behind the Jewelry Empire. A search for more Champagne at her grandfather Jean-Jacques Cartier's 90th birthday had led to a treasure that has defined her life's work for more than a decade now. In the cellar, instead of the bubbly, she found a battered old trunk, covered in faded stickers from Parisian railway stations and exotic Eastern hotels. "Inside were hundreds of long-lost family letters and documents, everything from birth certificates to love letters to jewellery designs to old war telegrams. They essentially told the story of four generations of Cartiers, and the evolution of the jewellery business the family had founded back in 1847," she says.

The narrative is interspersed with quotes from corresponding letters, and Jean-Jacques' recollections. Of course, there are over 100 photographs of the family, sketches, and the iewels they created. She writes about how Louis-François and the firm survived "revolution, a disastrous economy, a coup d'etat and fire" all within a dozen years. Most remarkable were his marketing techniques: he courted the





elite - like Princesse Mathilde Bonaparte, niece of Emperor Napoleon. He well knew that even a visit to the store by such patrons would pique interest.

His son, Alfred, took the Cartier name across the Channel to London, laying the foundation to expand. His three sons - Louis-Joseph, Pierre-Camille and Jacques-Theodule - took care of the Paris, New York and London branches respectively. Louis-Joseph's innate need to experiment led to Cartier coming out with their first men's wristwatch in 1911. His strategic arranged marriage - to the granddaughter of designer Charles Frederick Worth – was not to his liking, but

he agreed, for the sake of securing the family business.

Pierre got the Americas (and an American wife), where he handled transactions such as the "cursed" Hope diamond, and sold to heiress Evalyn Walsh MacLean for \$1,80,000. One of his most prized deals was exchanging a pearl necklace worth more than a million dollars at the time, for a townhouse on Fifth Avenue, New York, which remains the firm's American headquarters even today. Jacques' mandate included Britain and the colonies, leading to a clientele of maharajas who kept the firm afloat during the Great Depression.


Discovering lost correspondence between generations of her ancestors led Francesca Cartier Brickell to record their history in her new book

The book also covers later generations, including Brickell's grandfather (Jacques's son), who kept Cartier in the family until 1962. While the luxury maison is now owned by Switzerlandbased Richemont, Brickell took on the role of an independent researcher, choosing to tell the "human story, with their weaknesses, talents, anxieties, loves, losses and dreams". After a launch at the Victoria & Albert Museum in London last week, she will be travelling to America this month, and will be speaking at Jaipur Literary Festival at the end of January.

Edited excerpts from Brickell's exclusive email interview with Weekend.

What was the kind of research that went into the book?

 Reading through the letters was an enormous job in itself, as they were in both French and English, and many had hard-to-decipher handwriting. talked about them at length with my grandfather, and spent many hours recording his memoirs. I travelled all over the world, tracking down as many people linked with the firm of old as I could, to try to fill in the picture and triangulate the story, be-

cause I knew only part of the history was in the trunk.

Where did your travels take you? • In India, I followed my great grandfather Jacques Cartier's footsteps. On his trips to meet the maharajas, he would sketch royal jewels in order that he might come up with new designs for remounting them in a more western fashion. It was a moment of real excitement to see the jewels that matched the sketches, such as a stunning diamond aigrette that he'd seen in the palace of Baroda. In Sri Lanka, I visited sapphire mines; in London, Paris and New York, I met many elderly designers and craftsmen who'd worked under my family. It was surprisingly

moving.

• How the Cartier women played such a critical role in the growth of the business. Strategic marriages helped keep the firm afloat in the difficult early days, and later helped it to expand. Another interesting discovery was just how important a market India was. The Great Depression was terrible for luxury brands, and one of the reasons Cartier survived when their western clients reined in spending was because of commissions from the maharajas.

What was your writing process?

I spent a long time researching. But I was also bringing up two young children, so I had other distractions as well. In fact, I often took them with me on research holidays. But a couple of years ago, I came to realise that I could be turning over stones forever each time I made a new discovery, it just opened up a whole new avenue of research possibilities. I needed to get on with the writing or this story would never make it out into the world.

# An Emperor's gift of stone

Long after the immortal love between Shah Jahan and Mumtaz Mahal, lovers over the centuries have a fascination for meeting at the iconic Taj Mahal

Late into the night, the moon would peep through the veil of darkness. I had made special arrangement for going to the Taj with my sitar. I would sit on its roof with my face towards the Jamuna. As moonlight began to spread itself, I would start a tune and lose myself in it. I don't have expression to tell what magical experiences the imagination then brought before the eyes," exclaimed Maulana

All this comes to mind as a belated tribute to Rajendra Mehta as someone croons, "Jab anchal raat ka lehraye...Taj Mahal mein aa jaana". What a beautiful tribute by the maestro to the memorial of love of a heart-broken emperor for his dear departed consort!

Last week Reshmi Dey demonstrated and talked about the art and craft of glass blowing at the Embassy of the Czech Republic in Delhi, in an event called The Story of Czech Glass. Her work stood with eight Czech companies, as she, along with Jiri Pacinek, one of that country's well-known glass makers, gave a glass-making demo in her

mobile studio. Dey discovered glass when an ex-partner ordered in some glassware from Firozabad, a hub of India's glass-making industry. She says she was mesmerised: "The light, the reflection, the refraction. I still remember there was a teal vase and a fine handengraved smokey flower vase." That was in 1999, and she was 25.

Dey, who grew up in Tinsukhia, Assam, and Kolkata, and dabbled in the hospitality industry that was just opening up in the area, boarded a train to Delhi in 1995, looking to do her MBA, much to the horror of her family, "because Delhi was this big, bad place". Born to a conservative government employee father and a mother who wanted her to strike out on her own, she savs her whole aim in life was, "To find myself, create my own identity, see what I was capable of."

Once she determined that she'd work with glass the rest of her life, she trained at the Centre for the Development of Glass Industry, Firozabad, and also at the factories there, "at a time when people wouldn't even send their sons to the area." The men would look at her strangely, because she'd be the only woman in the workshop. She remembers an incident when the then principal director introduced her to one of Firozabad's prominent industrialists, saying she was a promising student. "I still remember him saying, 'Does she make it in her kitchen?""

Despite the scepticism, she started her venture in 1999, selling her gold to start a small studio with ₹33,000 ("There was no studio culture in In-

# Back to BASICS

#### WHAT IS WATER BIRTHING?

It is also referred to as hydrotherapy, where the baby is born through normal vaginal birth with no or reduced use of medication such as epidurals or drugs to speed up contractions.

When a woman starts getting labour pain, she gets into a bath tub (not deeper than two feet) or the inflated baby pool that has warm water controlled at 36 to 37 degrees C (the normal body temperature).

The buoyancy in water is said to reduce the pain and length of labour, making it less traumatic and more relaxing for the mother

The mother remains in water till the child is born. The postpartum blood loss is less than a traditional delivery, and damage to the perineum is minimised.

It is considered a peaceful transit for the baby who's been in amniotic fluid for nine months and so there is no immediate shock of air.

It is recommended for women who are fit and have no high-risk factors such as hypertension and diabetes and are not carrying twins.

Water birthing as a technique is largely assisted by midwives. A few doctors in Mumbai, Delhi, Chennai and Bengaluru are now encouraging the natural water birthing process.

What people need to understand is that labour is not a disease that requires medical intervention but a natural process that requires medical assistance, she says.

Dr Sabharwal strongly believes that every woman deserves a natural option and needs to be informed about alternative ways to give birth. In the last 16 years, 100odd women have chosen to have water births in her clinic. "These



ter birthing. She was clear and determined from the beginning," she says.

Kalki says she loves water and "the idea of relaxing in a warm pool is kinder both on the mother-to-be and the baby-to-be-born." "If the mother is stress-free, the baby will also be born stress-free. What better can you ask for?" she says.

"My mother brought me into the world through natural birth at home three decades ago. It was 5 am, there was no electricity, my dad was holding a kerosene lamp. It was quite rustic and also the environment at Auroville was different with lots of naturopathy and alternative living styles. It seemed appropriate for my parents," says Kalki. "You cannot avoid the legacy in motherhood," she laughs.







# Pollard's men blow away India, take series to the decider

Simmons, Pooran and bowlers deliver in a crunch game for the visitors; Dube, Pant come good for the Men in Blue

### WI IN INDIA

THIRUVANANTHAPURAM It was the World T20 champion West Indies that turned up at the Greenfield Stadium on Sunday night. Not the side that has been playing plenty of insipid white ball cricket of

Kieron Pollard's men proved too good for India in front of a full house in the second T20I. They won by eight wickets with nine balls

They not just ended their losing streak to India in the shortest format, but also ensured that the third match of the series in Mumbai would be the deciding one.

The visitors' confident chase of a challenging total was anchored by Lendl Simmons, who remained unbeaten on 67 (45b). His firstwicket stand of 73 with Evin Lewis (40, 35b) gave them the perfect start, and his 61run partnership for the unbroken third wicket with Nicholas Pooran, who played an eve-catching cameo (38 not out, 18b), gave them the perfect finish.

### **Brilliant catch**

Shimron Hetmyer, too, delighted with his strokeplay before his promising knock was ended by a brilliant running catch by India captain Virat Kohli at long-on. That sensational bit of fielding wasn't the norm, but an exception for India.

In the fifth over, Washington Sundar had dropped Simmons off Bhuvneshwar Kumar at mid-off and that would prove costly. The offspinning all-rounder from Chennai was having a horrid time on the field for the second match in a row.

He redeemed himself a bit by beating Lewis and having him stumped, but that wasn't enough to stop the aggressive Windies top-order from racing to the target.

Earlier, Shivam Dube showed why Royal Challengers shelled out ₹5 crore for

him – an uncapped player then - in last year's IPL auction. Coming in, rather surprisingly, as early as the fourth over, at the fall of K.L. Rahul's wicket, he smashed 54 off 30 balls.

His maiden international fifty – in only his fifth match - mattered to India on this night, when its stalwarts at the top of the order failed to click. Sending him in at No. 3 turned out to be an inspired

### **Dube flays Pollard**

After an average effort in the PowerPlay (42 for one), it was his assault on West Indies skipper Kieron Pollard in the ninth over that gave the Indian innings the impetus it badly needed. He pulled two short ones over the leg-side boundary and then sent a full toss above the ropes on the off-side. Twenty six runs came off that over.

He, however, did not last long after that stunning bit of fireworks. He holed out to

Hetmyer in the covers off the impressive leg-spinner Hayden Walsh. He could not make use of the dropped catch by Pollard off the first ball of that over.

Dube's dismissal brought Rishabh Pant to the middle and the wicket-keeper, who had shown glimpses of form at Hyderabad in the last match, ensured that India ended up with a decent total.

His unbeaten 33 off 22 balls will do a world of good to the confidence of the young man who has been under some scrutiny.

It was a disappointing night with the bat for India's big three, though. Rahul was caught at deep square-leg trying to slog-sweep left-arm spinner Khary Pierre, Rohit Sharma was bowled in his attempt to paddle Jason Holder

and Kohli's upper cut turned into a comfortable catch at short third-man.

Interestingly enough, it was Kesrick Williams who took the Indian captain's wicket, but there was no 'notebook' celebration this time; he just put his finger on his lips, demanding silence.

On this night, that wasn't the only command from the Windies that worked

# Stenson fends off Rahm's challenge


Henrik Stenson delivered under pressure to clinch the Hero World Challenge title at Albany Golf Course here on Saturday. Stenson (18-under overall) held firm despite a late surge from Spain's Jon Rahm, who eventually finished one stroke behind the champion.

### **Woods fourth**

Tournament host Tiger Woods carded a disappointing three-under 69 to take the fourth spot.

This was Stenson's first title since the 2017 Wyndham Championship. The 43-yearold Swede took home the winner's cheque for \$1 million.

Stenson made the big move with an eagle on the par-5 15th hole, crushing a spectacular 259-yard approach shot to within inches of the pin. He then kept his cool and completed the task by making par in the last three holes.

"Walking down the 16th, I saw that Jon had finished 17under, so I knew that three pars would most likely close the deal," he said.

Stenson was relieved to get his hands on the trophy, after a sustained period of poor results and injuries.

"I just haven't played to more than probably 75% of my capacity in the last couple of years. This is good gratification for the patience and hard work that we've done," he said.

Defending champion Rahm, meanwhile, put himself into contention with a birdie-eagle-birdie run between the 14th and 16th. He could only manage pars in the next two holes, and narrowly missed out. Any disappointment is unlikely to last for long as Rahm is set to get married in a few days.

Woods raised hopes by taking the sole lead after making birdie on the seventh, but a bogey on the 14th derailed his run.

"I blocked a couple of putts today (hitting a putt right of intended startingline), and I can't stand that feeling. I'd much rather hook the hell out of a putt than hit some kind of block," Woods

He will now make the long journey to Melbourne to captain the USA team in the President's Cup.



# Suryakumar Yadav confident his time has come

Has shed his tag of inconsistency with his performances of late

If there is an award for the best performer with the bat this season in white-ball cricket, Suryakumar Yadav will be a prime contender. Mumbai may not have won a title in both the inter-State tournaments so far but the captain has been in such scintillating touch that fans and experts alike are confident that an India call-up is just around the corner.

Still, as he enters the Ranji Trophy season, Surya has a touch of uncertainty in his mind. Not about his game he feels he has never been as clear as this all through his career – but the fact that he has to balance the art of leading Mumbai in the red-ball format while waiting for the call-up to India's squad in the shortest format.

"It is a little difficult when you see there's a lot of whiteball cricket around (in India's calendar) and your name is doing the rounds. But at the end, you have got to stay in the present. If it has to happen, it will anyway, in a few days or weeks or months," Surya told The Hindu.

#### Job at hand

"For now, the challenge is to play Ranji games, lead the team well, perform with the bat and help the team recover from an average season last year. The thoughts of an India call-up in T20 do keep crossing my mind, but you've got to keep that aside and focus on the job at

So far this season, Surya has excelled at it. He finished the Vijay Hazare Trophy with an average of 113, the highest in the tournament. The stylish right-hander continued in the same vein in the Mushtaq Ali Trophy. His tally of 392 was the third highest while his strike rate of 169 was the second-best among batsmen with 250 runs in the

tournament.

Ever since making his First Class debut in 2010, Surya just like his Mumbai senior Rohit Sharma in the first half of his international career has lived with the tag of "talented but inconsistent". But the maverick who stresses that he has "calmed down having taken to meditation since off-season" hopes that his performances in domestic cricket and the Indian

Premier League over the last couple of seasons have justified his talent.

#### Never in doubt

"Obviously I used to hear this a lot. But I never doubted my skill. I never had that question mark in my mind, ki boss kyun nahi kar raha hai, kaise karega, kar sakta hai ki nahi (why isn't he doing it, how will he do it, whether he will succeed or not). I backed myself in any situation," Surya said.

"Whatever opportunity I got – be it T20s, one-day or Ranji Trophy - I just tried to enjoy the game as much as possible. Keep batting, keep scoring runs and rest everything will fall in place. Of course it has taken a lot of time. Even I know that. But the time has come."

wanted to run it; I was the one-stop shop," Warne was quoted as saying by the Australian paper.

Warne, who has also been a coach-cum-mentor and then Brand Ambassador of the Royals, led an unheralded bunch of players to an unlikely triumph during the inaugural edition of IPL back in 2008.

In fact, current India

star Ravindra Jadeja was a talented uncapped player back then, whom Warne had backed to the hilt terming him a "rockstar".

"We were the underdogs, we were the least favoured, no one gave us a chance to win. It was the first ever year of the IPL of franchise cricket where owners bought players and players went into auctions.

Rajasthan Royals franchise is currently worth \$200 million and Warne, according to the report, believes that the valuation will be doubled in next couple of years.

"Three per cent of \$400 million is all right,' said Warne, which effectively means that he could earn up to \$12 million.
