Is a new India rising?

The new generation is laying down its own terms for the country's future discourse



The tsunami of protests across the length and breadth of the country has several fascinating facets. Are there any significant pointers in it?

First and foremost, these are clearly the civil society's autonomous protests, devoid of any organic links with any political party. Barring issuing some statements in support or occasional visits by leaders to a protest site, even political parties have kept themselves at a distance from these protests. Underlying the autonomy is perhaps an unarticulated feeling that the issues evoking the protests go beyond electoral battles; that these concern the very life and blood of society's future. There is also an unarticulated assumption that the solution lies beyond the ken of one or the other political party or indeed all parties together. Therefore, reliance on a party or a group, any group, might end up in diversion, which often becomes equivalent of betrayal. The one possible link with political parties is perhaps a potential realisation by them that they might be left aside by the people if they keep the distance intact – a case of people leading the parties instead of the other way round.

The power of resistance

A consequence of civil society's direct involvement is that it is refusing to buy the current regime's divisive Hindu-Muslim formula. This formula has already fetched the National Democratic Alliance two terms in Parliament but seems to have hit a wall. Resistance began with society's response to uncalled-for police brutality on students in Jamia Millia Islamia and Aligarh Muslim University. And soon the chief target of resistance became the Citizenship Amendment Act-National Register of Citizens-National Population Register strategy devised by the regime to pit the Muslim community against the rest. The wide-ranging and unrelenting participation of people from all groups in the protests is clear enough signal of society's refusal to fall for it. Interest-

ing also is the Muslim community's refusal to fall for the strategy of making their identity dichotomous with their Indian identity; the Muslims have instead sought to assert their religious identity in full concert with their Indian national identity by flaunting both at the same time, which in any case is far truer than the one which counterposes the two.

The resistance from the students is an amazing aspect even as it is wise to remind ourselves that their community has been the most energetic element in India's various resistance movements – and for that matter elsewhere around the world, whether in the anti-colonial struggles in Asia, Africa and Latin America, or the anti-Vietnam war protests in the U.S. Their protests have also grown in dimensions from repression in universities to the regime's hitherto successful Divide and Rule policy and its latest version encapsulated in the CAA-NRC-NPR. Neither has the government's incessant attempts to convince them of the honesty of its purpose, which could also be called brainwashing, failed to persuade them, nor has the repeated assertion by Home Minister Amit Shah of not budging an inch deterred them.

One of the most vociferous charges made against the government has been its grave attempt to prevent students and others from questioning it by simply branding such people as "anti-nationals" of which various equivalents have been newly minted: "anti-Modi", "anti-Hindu", "Urban Naxal". The government has also unleashed a barrage of filthy abuse and threats on social media through a highly organised IT machine under the BJP's control. A good segment of the media – now being called 'Modia' - has also pitched in with its aggressive campaign of malice against anyone with the mildest of doubts against the government's extravagant claims.

Yet, all this could not crush the spirit of questioning, especially on campuses, repression notwithstanding. The examples are now beyond

count: there are protests in Hyderabad University, Jadavpur University, Banaras Hindu University, the Indian Institutes of Technology, Aligarh Muslim University, Jamia Millia Islamia, Delhi University and even in some of the safe and secure private universities. Jawaharlal Nehru University is an outstanding instance of standing up to repression for over four years now. Repression in any case is not the most durable of all forms of governance; this is one of history's abiding lessons. The wider society is waking up to the limits of repression as state policy and responding.

Quality of leadership

One of the most endearing aspects of the current wave of protests is the exemplary quality of leadership displayed by students from the underprivileged social strata. Kanhaiya Kumar has become a national figure thanks largely to the Modi government's atrocious handling of his "crime" which enabled him to demonstrate his extraordinary oratorical skill and his clear-headed perspectives to put forward his case with almost devastating ease. It is fascinating that the extempore slogan he raised on the JNU campus for "azadi" on his release from jail in 2016 has now become the national war cry for students and the youth. But he is one among innumerable other emerging leaders of student movements across the country. It is heartwarming to see young women taking up verbal, and now even physical, challenges to articulate their feelings and thoughts lucidly, fearlessly and forcefully. JNU Students' Union president Aishe Ghosh has once again occupied premier space on this front, thanks again to the mishandling by the Modi regime. One also comes across a large number of such promising student leaders on local channels speaking in their local language. This is where one sees promise of a new generation refusing to buy any "line" of any party but laying down its own terms for the country's future discourse. The conflict is no longer between the BJP and the Opposition parties' vote banks; it is now firmly situated between the BJP government and the people of India.

In the name of self-defence

The U.S. strike in Iraq that killed Soleimani was in violation of UN norms proscribing such unilateral use of force

The killing of Iranian General Qassem Soleimani near Baghdad in drone strikes carried out by the U.S. earlier in January raised the spectre of war in West Asia. Later, U.S. President Donald Trump threatened to attack cultural sites in Iran in the event of reprisals by Tehran. The next week, Iran retaliated by carrying out missile attacks on two facilities housing U.S. troops in Iraq. These incidents give rise to some interesting legal questions: Was the U.S. attack on Soleimani legally justified? And can cultural sites be legitimately attacked in any armed U.S. response?

Under international law, there is a general prohibition on the use of force, articulated in Article 2(4) of the UN Charter. The Article proscribes any use of force by members against the "territorial integrity or political independence" of a state. However, the Charter recognises two limited exceptions: first, in the use of force by a state in the lawful exercise of its right to self-defence; and second, when such an act is carried out with the prior authorisation of the UN Security Council (UNSC) and acting pursuant to the Council's emergency powers "to maintain or restore international peace and security".

Without prior consent

The use of force by the U.S. in Baghdad to kill Soleimani without prior consent from Iraq or the UN was, hence, a violation of such proscription, unless the U.S. can justify it as a lawful exercise of its right to self-defence. Not surprisingly, the Donald Trump administration was quick to claim that the killing was in exercise of its right to "anticipatory' self-defence. Mr. Trump claimed, without any further elaboration, that Soleimani was planning "imminent and sinister" attacks against U.S. diplomats and personnel.

The legal basis for "anticipatory" self-defence remains deeply controversial and contested. There are both legal and policy arguments against recognising a right to anticipatory self-defence. First, Article 51 of the UN Charter recognises the inherent right of every state to use force in self-defence, only "if an armed attack occurs". Second, unlike an "armed attack", which is an objective standard, an "anticipated" armed attack is a subjective one, open to abuse by states. Since the object and purpose of the general prohibition on the use of force is to minimise

resort to unilateral use of force, a stricter and restricted notion of the right to self-defence is perhaps more appropriate.

Those arguing in favour of a right to anticipatory self-defence, however, stress on its customary character and frequently reference the Caroline incident. In 1837, British militia from Canada crossed into U.S. to set ablaze the ship Caroline, which had been used to ferry American insurgents that had mounted attacks in Canada. In diplomatic correspondence following the incident, the U.S. Secretary of State noted that Britain must show "a necessity of self-defence, instant, overwhelming, leaving no choice of means, and no moment of deliberation". In reality, the destruction of Caroline was a response to an attack and its expansion rather than for averting any not-yet-mounted attack. Moreover, the incident took place before the conception of the UN Charter.

An anticipatory move

Nevertheless, contemporary Western scholarship, in view of the rise of terrorism and advancement of weapons technology, continues to advocate for a right to anticipatory self-defence. However even assuming that any such right has come into fruition, its contours are to be narrowly understood. As indicated, the threat of an armed attack must be so imminent that the need to act in self-defence should be "instant, overwhelming, leaving no choice of means, and no moment of deliberation". The legality of the Trump administration's decision to target Soleimani through drones in Iraq would, therefore, hinge on the disclosure of facts with regard to the imminence of a planned attack. Moreover, the administration will have to show that the strike was proportional to such (imminent) armed attack and necessary to respond to it. It will also have to justify its use of force in Iraqi territory and prove that Baghdad was either unable or unwilling to prevent the imminent attack. Finally, the U.S. will have to provide an explanation for the use of drones during peacetime, which resulted in collateral casualties.

Further, Mr. Trump's specific threat to target cultural sites in Iran was in breach of the 1954 Hague Convention for the Protection of Cultural Property during armed conflict. It also violated UNSC Council Resolution 2347, sponsored by the Trump administration, which in the context of the Islamic State (IS) invasion declared that destruction of cultural property would constitute "war crimes". It was therefore not surprising that Pentagon distanced itself from Mr. Trump's position.

Protest is at the core of poetry

In poetry, dissent does not mean only raising your voice but also creating new forms of expression

IIT-Kanpur was recently at the centre of a controversy over "Hum Dekhenge", a popular Urdu nazm, or poem, written by Faiz Ahmed Faiz. The poem was recited by a group of students on campus during an agitation. This enraged many others, including a faculty member, who found the *nazm* offending their religious sentiments. Few cared to understand Faiz's poem in context. In the ongoing protests surrounding the Citizenship Amendment Act and the National Register of Citizens, there have been several occasions when protesters have chanted the poems of Gorakh Pandey, Vaidyanath Mishra (Nagarjun), Dushyant Kumar and Gajanan Madhav Muktibodh, to name a few.

Renowned Bengali poet Joy Goswami wrote a poem in support of INU students who were brutally beaten up on campus. It went viral on social media. Goswami ends his poem with a lament that silence is akin to mass slaughter. Recently, an installation with Miya poetry (written by Bengaliorigin Muslims) from Assam was removed from an art festival in Goa. Martin Niemöller's "First they came" is another poem that has gained wide currency in these protests. There are many names that could join the list including Langston Hughes, Maya Angelou and Adrienne Rich. The ongoing protests perhaps endeared many more people to poetry, who discovered its subversive character.

Understanding poetry

That begs the question: why do so many people appear to be scared of poetry? Weren't we always told that poetry is about emotions recollected in tranquillity and the gentle expression of sentiments? Or about beauty, which ought to be desired and cherished, about daffodils and nightingales that are far removed for many from their immediate contexts? Sometimes, in childhood, it felt like a conspiracy to equate the ornate or the decorative with the poetic as if the only purpose of poetry were to soothe agitated souls and offer relief

from the vagaries of life. Reflecting upon this narrative about poetry in my childhood, I am

filled with outrage. Only later, when I began to read and understand poetry on my own terms, did I realise that dissent or protest is at the core of poetry. Poetry has always been antihegemonic. Dissent, however, must be broadly understood in this context. It could surely mean raising your voice against oppressive powers or ills that prevail in the social structure. In poetry, or any art form for that matter, dissent or protest could also be interpreted as breaking boundaries, creating new forms, genres and vocabulary of expression and thus looking at the world with a fresh pair of eyes and sensibility. Poetry has always done that. Filmmaker Ritwik Ghatak used to say, "Poetry is the art of all arts." Art doesn't adhere to set standards. In defiance, it seeks self-renewal. If poetry is art, how can it resist defiance?

The political events of today suggest that that poetry is a spontaneous reaction to our time. It is more adaptable to forms of protest and performance. These events also show that poetry is deeply historical. It bears testimony to the times we live in and serves as a reminder of our past. A large contingent of our Bhakti tradition poets are critical of religious dogma. Is there any other way of reading

Giving rise to future poets

Namdeo Dhasal showed us the underbelly of Mumbai and exposed us to Dalit life in the city. Narayan Surve did something similar by tracing the history of his father's arrival in Mumbai and the life of perennial humiliation that followed till his last day. Dilip Chitre once said that all poetry is protest.

Poetry is confrontation. It echoes the joys of living but also embodies its despairs and agonies. If so much of our lived experience and reality is a constant encounter with despair, how can poets desist from showcasing the same? Protests also birth new art and uncover new voices. Perhaps future poets will emerge from the ongoing protests and their verse will bear witness to our treacherous times.





"This Court cannot tell how religion is to be practised," Mr. Dhavan submitted.

They drew the Bench's attention to the Shrirur Mutt judgment of the Supreme Court of 1954. According to the verdict, the essentiality of religious practices should be decided in accordance with the religious doctrines of each faith.

The Supreme Court has limited power of judicial review, they argued.

The 1954 judgment held that any regulation could only extend to religious practices and activities which were economic, commercial or political in their character.

Opposition demands CAA withdrawal

Former Prime Minister Manmohan Singh, NCP supremo Sharad Pawar, Left leaders Sitaram Yechury and D. Raja, Jharkhand Chief Minister Hemant Soren of the JMM, RLD's Ajit Singh and LJD chief Sharad Yadav were among those who were present.

He also emphasised that caste names be included in the census when it is done.

"It (the NRC) would be needless (koi zarurat hai nahin) and have no justification (koi auchitya nahin). And I think the Prime Minister, too, has spoken clearly on this," he told the House, while thanking it for unanimously ratifying the Constitution amendment for extending quotas for SCs and STs in Parliament and state assemblies by another 10 years.

About the CAA and the National Population Register, he said he was agreeable to having a debate in the Assembly.

"This session has been convened for a specific purpose. However, there is a lot of turmoil over CAA, NRC and NPR. I agree with the Leader of the Opposition that there should be a discussion on these," he said.

Earlier, Leader of the Opposition Tejashwi Yadav had said, "The nation is on fire" on the issues of CAA, NRC and NPR and sought to know whether the Chief Minister "stands with Lalan Singh or Pavan Varma and Prashant Kishor."

Rajiv Ranjan Singh alias Lalan Singh is the JD(U) leader in the Lok Sabha. The party had voted in favour of the Citizenship (Amendment) Bill in both houses of Parliament, to which Mr. Varma, a national general secretary, and Mr. Kishor the national vice president had taken strong exception.

Nobel laureate arrives for lecture tour

Ramakrishnan will speak in four cities

Nobel Laureate Venkataraman Ramakrishnan arrived in India on Monday, ahead of a four-city lecture tour this month. He was in Lahore. Pakistan, to deliver a scientific lecture, and arrived in India via the Wagah-Attari border on Monday.

"It's good to be back in India and I'm looking forward to my lecture tour," Professor Ramakrishnan, who is President, Royal Society of London, said in a video message, uploaded on Instagram by his communications team.

Dr. Ramakrishnan, recipient of the 2009 Nobel Prize in Chemistry, will be the 2020 Speaker of the TNQ Distinguished Lectures in the Life Sciences. It will be the 10th edition of this lecture series.

In Lahore, he was a plenary speaker at ThinkFest. which featured discussions on science, art, diplomacy and politics. Dr. Ramakrishnan spoke on Gene Machine, his popular science memoir. India-born Dr. Ramakrishnan will be lecturing in Bengaluru, Mumbai, Chennai and New Delhi.

House panel looking into surrogacy issues

Members will visit Anand and Mumbai

The parliamentary select committee set up to look into the Surrogacy (Regulation) Bill, 2019 will travel to Anand, Hyderabad and Mumbai from January 21 to 24 as part of deliberations on the shape of the Bill.

Anand, a town in Gujarat, has a large number of commercial surrogates, while Mumbai and Hyderabad also have many clinics on the cutting edge of fertility medicine. A member of the commit-

tee told *The Hindu* that the panel was deeply engaged with the question of whether or not single parent surrogacy be allowed. The Bill asks for a couple to have been married for at least five years with proven infertility before applying for surrogacy. "But there are many children brought up by single parent families who do well. So why deny singles? The committee is engaged with that question," the source

The committee will look at the technology and the ethical gap to be bridged in terms of its use. While the

Bill currently seeks to ban commercial surrogacy, even altruistic surrogacy can become problematic without a nuanced definition of "close relative". "There are things that are moral and immoral, but also extra-moral, that is, technology by itself is shorn of morality, but it can be used for moral and immoral purposes, family dynamics in many cases can lead to undue pressure on less powerful members of the family being forced to be surrogates, etc. So the definition and regulatory framework has to be nuanced," said the panel member. While commercial surro-

gacy is banned under the Bill, the committee will study just such arrangements during the Anand visit. When the Bill was introduced in the Lok Sabha during the last Parliament session, several amendments, including removal of the necessity of the clause asking that only married couples, that too with at least five years of marriage, be allowed for surrogacy. The panel members say they are determined to make it more up to date law.

West Bengal BJP chief kicks up a storm

Dilip Ghosh's comments on shooting protesters irresponsible, say Babul Supriyo and other BJP leaders

The remarks of BJP West Bengal president Dilip Ghosh justifying the killing of some of those protesting against the Citizenship (Amendment) Act triggered an outrage on Monday. Leaders of his own party called them "irresponsible".

"See, our government in Assam, Uttar Pradesh and Karnataka has shot them [the protesters] like dogs, put them behind bars and also filed cases against them," Mr. Ghosh is heard saying in a video. Continuing his argument that "infiltrators" should be treated with raw power, he added, "They will come here, eat, stay, and then destroy property. Do they think this is their zamindari? We will hit them with sticks, shoot them and



also sent them to jail."

Mr. Ghosh made the remark at a party meeting in Nadia district on Sunday evening. The video, which was not verified, surfaced on Monday. In his speech, he also questioned why there was "neither baton-charge, nor firing, nor any FIR filed against protesters in West Bengal".

"Is it anybody's paternal

property? The rail tracks, roads, buses and trains were made with the money we pay in tax. You are not taking any action only because they are your voters?" he said, before justifying the killings in the States under the BJP.

'Figment of imagination' Union Minister Babul Suprivo, of the BIP, described Mr. Ghosh's remarks as a "figment" of imagination. "The BJP, as a party, has nothing to do with what Dilip Ghosh may hv [have] said. It is a figment of his imagination & BJP Govts in UP, Assam hv [have] NEVER EVER resorted to shooting people for whatever reason whatsoever. Very irresponsible of Dilip Da to hv [have] said what he said," he wrote on

However, Mr. Ghosh held his ground after Mr. Supriyo's reaction. He said, "Our government has done that, and if we get a chance we will do the same in Bengal." Mr. Supriyo retorted that Mr. Ghosh's remarks were his personal views.

Swapan Dasgupta, a Rajya Sabha member of the BJP, retweeted Mr. Supriyo's tweet, indicating that he did not support Mr. Ghosh's comments.

Locket Chatterjee, another party MP and head of the BJP's Mahila Morcha in West Bengal, said, "The BJP does not want anyone to live in fear. The party wants to provide security to all, and this is the vision of our Prime Minister.'

The Trinamool Congress criticised the comments. Its MP Abhishek Banerjee wanted to know whether the remarks were personal, or those of the party. "Although @DilipGhoshBJP correctly characterized his party, his own MP refuting his stance publicly raises serious doubts over his credibility to lead BJP in Bengal. Dilip Babu please let us ALL know if your statements are to be seen as personal opinion or views of your party," Mr. Banerjee said.

NGO files plea on the need for NPR

It cites PM's speech denying NRC

A petition filed in the Supreme Court on Monday questioned the need for preparing the National Population Register (NPR) if the government has decided to abort the National Register of Citizens (NRC) exercise.

"When the Central government has already taken a policy decision to not go ahead with the NRC (as mentioned by the Hon'ble Prime Minister of India in his speech dated December 22,2019 and as per the stand of the officials of the Ministry of Home Affairs - as per the media reports dated 24.12.2019), the preparation of the Population Register is nothing but a waste of time, energy and valuable re-

sources of the nation," Minority Front, an NGO, submitted in the court.

Besides, the NPR, according to media reports, would the exchequer ₹3,941.35 crore. The NPR would be prepared within the period of April 1, 2020-September 30, 2020.

The NGO quoted provisions from the Citizenship (Registration of Citizens and Issue of National Identity Cards) Rules, 2003, which point out that the NPR is the first step towards conducting the NRC, and both are intrinsically linked. These Rules provide for preparation of the NRC and for issuance of a National Identity Card to those persons whose names have been entered in the NRC.

JNU professors want data preserved

Delhi High Court issues notice to police, Google, WhatsApp and Apple

The Delhi High Court on Monday issued notice to the Delhi police, Google, WhatsApp and Apple on a petition filed by three Jawaharlal Nehru University (JNU) professors seeking preservation of data pertaining to the January 5 violence on the campus.

Justice Brijesh Sethi posted the case for a detailed hearing on Tuesday as counsel for the social media sites were not present when it came up in the morning.

During the brief hearing,

the police said they were taking all necessary steps to preserve the CCTV footage and messaging records on

Request for footage

Advocate Rahul Mehra, Delhi police standing counsel, said the agency had written to the INU administration for footage of 135 CCTV cameras on the campus from January 3 to 6.

Mr. Mehra added that the police had not received any response to the request.

The police had also written for data regarding two WhatsApp groups that were allegedly used to plan and coordinate the attack

The petition, filed by protessors Ameet Parameswaran, Atul Sood and Shukla Vinayak Sawant, claimed that the particulars of the January 5 incident "seem to indicate that the entire attack was premeditated and coordinated". The professors also said they had been perso-

nally injured in the violence. "Unless the same had been the result of a preplanned conspiracy, it would not have been possible for a mob in such large numbers, many of whom appear to be outsiders, to enter the JNU campus," the petition said.

"The existence of a premeditated and well-organised attack is further clear from the fact that these persons were covering their faces wearing masks, without any proper identification, carrying weapons and so on," it stated.

The petition said several persons appeared to have used WhatsApp to create different groups for the purpose of inciting hate and violence against the teachers, staff, and students.

Asked whether the panel could finalise the "definition of Assamese", the retired judge said the members were yet to take a decision on it and hoped to come to a conclusion

"All members of the committee will soon meet to finalise the report and all remaining issues will be resolved," he said. The meeting took place four days after Assam Chief Minister Sarbananda Sonowal met Mr. Shah and discussed with him various aspects of Clause 6, under which the Central government had promised to provide constitutional safeguards to the indigenous people.

Home Affairs panel grills Delhi police chief

Mr. Patnaik was also asked about the recent sit-in by Delhi police officials outside police + headquarters. "The Commissioner of Police was told that if the police sits on a dharna, then questions are raised on his leadership," a member of the committee said.

Without mentioning the recent incidents of violence at Jawaharlal Nehru University (INU) and lamia Millia Islamia. members of the panel questioned the way in which the police handled the protests.

JNU faculty members send feelers to other institutions

IIT-Delhi Director shows willingness to hire them

JNU's loss may become IIT's gain. Senior faculty members at Jawaharlal Nehru University, faced with a "deteriorating situation", have expressed interest in moving across the road to the Indian Institute of Technology, according to an e-mail sent by IIT-Delhi Director V. Ramgopal Rao.

In the December 19 e-mail to the department heads, Dr. Rao encouraged them to facilitate lateral hires of senior JNU faculty members with distinguished records.

"I am receiving many feelers from senior JNU faculty [members] showing a willingness to move to IIT-Delhi, considering the deteriorating situation in JNU," said the email. "I am told that some of them are also applying to other institutions given the impression that IIT-Delhi doesn't encourage lateral movement into higher positions. It will be a pity if we lose out on such good people beof any these reasons/perception.'

In his e-mail, Dr. Rao added that he would leave it to the judgment of the department heads how they wished to deal with the situation, emphasising that the "Institute will be very open to recruitment of senior faculty [members] who have a distinguished track record."

The Hindu has confirmed the

authenticity of the e-mail. Ramakrishna Ramaswamv made the move across the road in the last year, taking the post of a visiting professor at IIT-Delhi after retiring from a 32-year stint at JNU. Dr. Ramaswamy, who had been on the short-list for JNU Vice-Chancellor in 2016, says the current crisis has affected students and teachers and hampered research activities.

"For good research, you need a stable environment. With the kind of upheavals going on now, research in the life sciences would be severely affected," he said. The shutting down of buildings would especially harm experiments using live tissue, he said. While the JNU is known for its humanities and social science research, it owes much of its high ranking to excellence in the sciences.

Dr. Ramaswamy added that he still supervised Ph.D students at JNU, who come from poor socio-economic backgrounds, meaning they have been hit hard by the hostel fee increase that caused the current crisis.

JNU Vice-Chancellor M. Jagadesh Kumar, accused of precipitating the crisis, made the move in the opposite direction. He was an electrical engineering professor at IIT-Delhi.

5 countries to discuss action against Iran

The countries whose citizens died when the plane was shot down by Tehran will meet in London

SINGAPORE

Five nations whose citizens died when an airliner was shot down by Iran last week will meet in London on Thursday to discuss possible legal action, Ukraine's Foreign Minister said.

Speaking on the sidelines of an official visit to Singapore on Monday, Vadym Prystaiko said the countries would also discuss compensation and the investigation into the incident. All 176 people on board the flight died in the crash on Wednesday, minutes after the plane took off from Tehran airport.

Mr. Prystaiko said suggestions from Iran that the Ukrainian International Airlines plane was downed as it flew near a sensitive military base during a time of heightened tensions were "nonsense". He said Tehran had agreed to hand over the plane's black to Kiev investigation.

"We have created this group of Foreign Ministers from the grieving nations. On January 16, we will meet in person in London to discuss the ways, including le-

Iran denies 'cover-up' as protests rage on

Iran denied a "cover-up" Monday after taking days to reveal an airliner was accidentally shot down last week, a disaster that sparked demonstrations and calls for a fully transparent investigation.

"In these sorrowful days, many criticisms were directed at relevant officials and authorities," said government spokesman Ali Rabiei.

"Some officials were even accused of lying and a coverup but, in all honesty, that was not the case," he said. "Lying is intentionally and knowingly faking the truth. Lying is covering up. Lying is knowing a fact and not expressing it or twisting the

The spokesman said all details provided by officials prior to Saturday's revelation had been based on the information available to them at the time. "All of

those who expressed opinions on those days, at the peak of America's psychological war against the Iranian nation... did so based on existing information at the time."

Meanwhile, Iranian antigovernment protests were met with tear gas and left at least one person wounded, videos on social media appeared to show on Monday. Videos show large crowds

Mr. Mahinda Rajapaksa's visit to New Delhi comes about two months after President Gotabaya Rajapaksa went to the Indian capital, following his decisive win in Sri Lanka's November presidential polls. Last week, Sri Lanka's Foreign Relations Minister Dinesh Gunawardena met External Affairs Minister S. Jaishankar in New Delhi, in the series of highlevel visits from Colombo.

While key bilateral issues, including regional security

and the much-discussed development cooperation at the East Container Terminal in Colombo and the Trincomalee oil tank farms, are on the table, Mr. Mahinda Rajapaksa's India visit will be closely watched for more reasons.

Addressing a joint press conference during Mr. Gotabaya's visit in November, Mr. Modi said that he was confident that Sri Lanka will carry forward the process of reconciliation, "to fulfil the aspirations of the Tamil for equality, justice, peace and respect." In this context, the Indian PM also referenced the implementation of the 13th Amendment to the Sri

Lankan constitution - an outcome of the Indo-Lanka Accord of 1987.

PM Mahinda, who served as President for two terms since 2005, has in the past assured India that he would implement the 13th Amendment - which envisages greater power devolution to provinces including those inhabited by Tamils - and "go beyond it". On the other hand, Mr. Gotabaya, who has promised to "be frank" with New Delhi, has repeatedly emphasised the need for development, not devolution, for the war-hit community.

Global outreach

The visit comes at a time when the new government, helmed by the Rajapaksa brothers, who have outlined a "neutral foreign policy", is engaging with international partners at high levels.

Priesthood is not for married men: ex-Pope

Pope Francis for allowing it in Amazon

Former pope Benedict XVI has publicly urged his successor Pope Francis not to open the Catholic priesthood up to married men, in a plea that on Sunday stunned Vatican experts.

The ex-pontiff, who retired in 2013, issued the defence of clerical celibacy in a book written with arch-conservative Cardinal Robert Sarah, extracts of which were published exclusively by France's Le Figaro.

"I cannot keep silent!" Pope emeritus Benedict wrote in the book, which follows an extraordinary meeting of bishops from the Amazonian at the Vatican

last year that recommended the ordination of married

circumstances. The Pope emeritus, 92,

and Cardinal Sarah weighed in on the controversial question of whether or not to allow "viri probati" – married "men of proven virtue" – to join the priesthood.

Pope Francis is currently considering allowing it in remote locations, such as the Amazon, where communities seldom have Mass due to a lack of priests.

The pair asked the whole Church not to be "swayed" by "bad pleas, theatrics, diabolical lies, fashionable errors that want to devalue priestly celibacy".





The Tamil word 'aram' is not easy to translate. Some translate it as dharma. Qualities like envy, anger and greed predominate in most of us. Overcoming such qualities can be

called 'aram,' said Malayaman, in a discourse. Many Tamil poets have written about 'aram'. Vilambi Naganar says love towards all leads to empathy and kindness, and these may be taken to be the foundation of 'aram'. Munaippaadiyar wrote a work called Aranericchaaram. It talks of worldly attachments and of being freed from attachments, which eventually leads to liberation from the cycle of births and deaths. It says that to live without malice towards anyone, to have love for all mankind, is the proper way to live. Deceiving others and turning away from those who need help are traits to despised. This poet lists ten qualities as desirable: honesty, patience, lofty thoughts, penance, humility, impartiality, selflessness, saintliness, desire to do good to others and adherence to 'vratas'.

Kanimedhaviyar says honesty, spurning alcohol, not befriending wicked people, not abusing others are the qualities one must have, and a person who has such qualities does not need to read works that preach dharma, for he already knows the dharmic way of living. Poet Avvaiyar said we should have the urge to do good things. She said there is nothing better than domestic life. The Tamil work Pinkalandai says a person who has no gratitude towards those who helped him deserves to be punished. Thiruvalluvar says he who has a pure heart is a good man. This might seem easy, but having good thoughts is difficult. We may pretend to be good, but our hearts are filled with envy and ill-will towards others. If we can get rid of such negative thoughts, we will qualify to be called good human beings.

Govt. gets cracking on GST evaders with data analytics

Official teams have booked 6,641 cases involving 7,164 entities till November last year and have, so far, recovered about ₹1,057 crore

The Department of Revenue has identified as many as 931 cases of fraudulent GST (Goods and Services Tax) refund claims through data analytics and has now tasked the GST data analytics wing to scrutinise all past and pending refund claims filed all over the country for inverted duty structure, sources said.

Refund claims worth more than ₹28,000 crore are said to have been filed by over 27,000 taxpayers so far on account of inverted duty structure in the current financial year.

The sources said such identified taxpayers, who had purchased goods from tax-evading, non-filers, would face verification and scrutiny as necessary.

This is being reviewed and

monitored weekly by Revenue Secretary Ajay Bhushan

The sources said to curb input tax credit (ITC) frauds, data analytics is to be done on all refunds since 2017, keeping an eye on the modus operandi of unscrupulous refund claimants or fly-bynight or shell business entities for availing fake ITC.

GST formations booked 6,641 cases involving 7.164 entities till November last year and have, so far, recovered about ₹1.057 crore.

The highest number of such fraud cases have been booked in the Kolkata zone, followed by Delhi, Jaipur and Panchkula (Haryana), the sources said, adding that fraud recently detected by central tax authorities in Delhi, involving GST refund for inverted duty structure, was deliberated at the second Na-

tional Conference on GST last week.

Fake ITC credit The sources also said investigators in Delhi had cracked -

through data analytics - a significant fraud case wherein fraudsters created a network of over 500 entities comprising fake billing entities, intermediary dealers,

distributors and bogus manufacturers of 'hawaii' chappals for availing and encashing fake ITC credits.

The bogus 'manufacturers,' created in Uttarakhand,

were making supplies to other fictitious entities and retailers in Gujarat, Maharashtra and Tamil Nadu.

The raw materials for the chappals, known as EVA compound, are chargeable at 18% duty whereas chappals are chargeable at 5%, sources said, adding that as a result, the law allowed the manufacturers to claim refunds of the inverted duty structure in cash. GST investigators found an ongoing parallel investigation in Uttarakhand to be connected and took swift action in preventing refund claims of ₹27.5 crore.

Through meticulous cyber-planning, fraudsters had created over ₹600 crore of 'fake credit' which they would have continued to encash had it not been busted.

The main accused in this case was arrested in December and continues to be in judicial remand.

It was also through data analytics that recently, GST formations had identified a few exporters with 'star' status who were fraudulently availing IGST refund and were untraceable at their registered addresses

In these cases, an exporter with over ₹50 crore of shipments of readymade garments had taken refund of ₹3.90 crore while the entity's total GST payment in cash was a mere ₹1,650.

In another case, tax payments in cash have been made for ₹51,201 while the exporter had obtained refund of ₹9.59 crore. The GST data analytics wing had been able to identify all such cases involving fake invoicing and fraudulent tax credits, which have been encashed through the facility of IGST refunds, the sources said.

Antitrust probe ordered against Amazon, Flipkart

NEW DELHI India's antitrust body on Monday ordered an investigation into alleged competition law violations by Amazon.com Inc. and Walmart's Flipkart, the latest setback for U.S.-based e-commerce giants operating in the country.

The Competition Commission of India (CCI) said it was ordering a wider probe following a review of allegations that Amazon and Flipkart were promoting some "preferred sellers" and in turn impacting the business of other smaller sellers.

The complaint was filed by Delhi Vyapar Maha-



sangh, a group representing small-and medium-sized businesses, which alleged that several of Amazon and Flipkart's preferred sellers were affiliated with or controlled by the companies themselves, either directly or indirectly.

As many as 160 of the top 500 listed entities are yet to split the MD and the CEO posts, according to data from Prime Database. The list includes most public sector undertakings, private sector entities such as Adani Ports & Special Economic Zone, HCL Technologies, Dr. Reddy's Laboratories, MRF, Bharat Forge, Edelweiss Financial Services, PVR and Escorts, among others.

"Industry had various concerns in implementation, including seeking a clear regulatory demarcation on the role and responsibility under the Companies Act, 2013 and SEBI's Listing Regulations for chairman and managing director," said Sumit Agrawal, founder, Regstreet Law Advisors.

"Certain boards had also asked for bright-line tests for segregation of overlapping roles. For instance, section 27 of SEBI Act, 1992 casts no liability on chairman but MD continues to be responsible for the acts of the company or its board of directors," the former SEBI officer added. The SEBI notification state

ed that with effect from April 1, 2022, the chairperson of any of the top 500 listed entities would be a non-executive director and not be related to the MD or CEO as per the definition of the term "relative" defined under the Companies Act, 2013.

ways to operate more efficiently, which requires us to review our corporate structure to ensure that we are organised in the right way. As part of this review, we have let go 56 of our associates across levels at the corporate office," Krish Iyer, president & CEO, Walmart India, said in a statement.

Of the 56 impacted emplovees, eight are in senior management and 48 are from the middle and lower management levels. Mr. Iver



said that these associates had been offered "enhanced severance benefits and outplacement services to support their transition". He further denied reports of a second round of lay-offs in "baseless and incorrect".

Mr. Iyer added that Walmart, which first entered India in 2007, remained committed to growing its business-to-business Cash & Carry business in India.

Nusli Wadia withdraws suit against Tata

Industrialist Nusli Wadia withdrew a criminal defamation petition and a ₹3,000-crore civil defamation suit filed against Tata Sons' chairman emeritus Ratan Tata, a week after the Supreme Court asked them to amicably settle their differences like 'mature leaders of industry.'

The Tatas' side had already made a statement saying they did not intend to defame Mr. Wadia.

Mr. Wadia had alleged that Mr. Tata had made defamatory statements against him shortly after the removal of Cyrus Mistry as Tata Sons' chairman on October 24, 2016.

Later, Mr. Wadia was removed as an independent director on the boards of the Tata group companies.

late Ms. Kochhar's contract of service, therefore has no locus to make a claim."

The affidavit said the dispute was purely contractual and "the petition pertains to termination of various contractual benefits concerning Ms. Kochhar (including stock options) and clawbacks of bonuses (which, too, were contractual in nature)."

The affidavit also relied on

retired Justice B N. Srikrishna's report that noted, "Ms. Kochhar had not made mandatory and appropriate disclosures and failed to discharge her fiduciary duty to rescue and avoid conflict as required by the Code of Conduct as well as applicable laws and rules."

Meanwhile, on January 10, 2020, the bank also filed a monetary suit against Ms. Kochhar for recovery of amounts towards the clawback of bonuses given to her from April 2006 to March 2018 pursuant to the termination of services. The suit says, "the question regarding the validity of Ms. Kochhar's service being terminated for cause is an issue that will arise in the commercial suit. Therefore, she ought not to be permitted to raise the same issue in the petition." The matter will be heard on January 20.

Slowing economy hitting payroll creation, says SBI report

New recruitments 15.8 lakh lower this fiscal than in the last

The current economy slowdown is impacting employment generation significantly as payroll creation, a proxy for employment generation, could be at least 15.8 lakh lower in the current financial year than the previous year.


In the previous financial year, the country had created 89.7 lakh new payrolls, as per EPFO data.

"The slow growth is now having a visible impact on payroll creation. In FY19, India had created 89.7 lakh new payrolls, as per EPFO data. In FY20, as per current projections, this number could be at least 15.8 lakh lower," State Bank of India's (SBI) group chief economic Kanti adviser Soumya



The EPFO data primarily covers low-paid jobs as the salary is capped at ₹15,000 per month. Government jobs and private jobs are not within its ambit as such data had moved to the NPS beginning 2004.

"Interestingly, even in the NPS category, State and central governments are [expected] to create close to



The country's growth rate is expected to fall to an 11-year low of 5% for the current financial year, the government said last week. The SBI report noted that

the extent of formalisation had declined steadily and is now currently at 9.5% of overall payroll creation versus 11% in FY19. Hence Goods and Services Tax (GST) collections may stay below the ₹1.1 lakh crore per month mark the Centre is hoping to exceed. The prospect of lower payroll creation in government shows it was not recruiting afresh in lieu of retiring staff, it added.

RHF shares tank 4.9% despite clean chit

'Disclosed group exposure voluntarily'

Shares of Reliance Home Finance (RHF) tanked 4.9% on Monday even after the company claimed that the forensic audit report by Grant Thornton gave a clean chit, as no siphoning off or diversion of funds could be established.

The forensic report alleged regulatory anomalies with regard to group exposure and limit for non-housing loan portfolio and deviation from certain policies and procedures. RHF said the National Housing Bank (NHB) had taken note of the same and initiated action.

Shares of RHF ended 4.92% lower on Monday at ₹2.32 apiece. The firm said the forensic report had confirmed the potential group entities' exposure through

several intermediate unlisted entities at ₹7,984 crore, including interest. "Prior to the commence-

ment of the forensic audit and also as a part of the forensic audit, the company transparently submitted full and complete details to its auditors, regulators, lenders, and also in the latest annual financial statements which were duly approved by shareholders, to conclusively establish that the aforesaid amount outstanding of ₹7,984 crore has almost entirely been utilised by the potential group entities only for making payments of principal repayment and interest to banks, financial institutions, NBFCs, NCD holders, etc. There is no adverse finding in this regard either in the forensic audit report," the firm said.

Railways invites RFQ from private train operators

Aim is to cater to 'huge', unmet demand, says official signing, procurement, fi-

Indian Railways has invited interested parties to submit a Request for Qualification (RFQ) document by January 17 for selection of private parties to operate 150 passenger trains on 100 routes.

The Ministry of Railways and NITI Aayog said the indicative cost of investment would be about ₹22,500

As per the draft proposal, the Ministry has grouped routes into 12 clusters that are to be operated through Public Private Partnership (PPP) on design, build, finance and operate basis, with a concession period of 35 years. Railways will adopt a 2-stage bidding process for selecting bidders. The first stage involves qualification.



be eligible to take part in the second stage comprising Request for Proposals

The entire project is expected to be awarded in about 180 days from January 2020. Each bidder is entitled to bid for a maximum of three clusters. Selection would be based on highest revenue share. The project work broadly includes denancing and operation and maintenance of passenger trains comprising a minimum of 16 coaches with the right to collect marketlinked fares Mumbai-New Chennai-Okhla, Howrah-

Delhi-Patna are some of the routes on which private trains will operate. "The idea here is to meet the huge unmet demand that led to loss of passenger business to other modes in recent times," said a senior

On accents and Insomnia

Indie musician Mr Kev evokes laughter and tugs at heartstrings in his new EP comprising his old favourites

"I don't like writing songs that are serious. I do write about difficult situations, but very rarely do I write a song intending it to be serious. Most of my songs are fun, even if they don't stem from necessarily fun experiences," says Kevin Paul aka Mr Kev, while discussing his softly hummable track "Tera Mera". One of the five songs in his recently-released EP titled Dummy In Love: Detox Overdose, the song stands out for two reasons. One, it was not penned by the Chennaibased singer-songwriter, but by his former roommate Alamshah Wahab. Two, it is one of the few songs in the EP – indeed, in Kevin's roster as a whole – that does not try to evoke laughter, or sniggers, or at least a few eye rolls.

Humour is part and parcel of Kevin's work, so much so that anyone

who has been following his gigs, walks in expecting to be entertained. His EP consists entirely of old favourites, most of which the indie music circuit has been chortling at, for years.

A case in point is the song "Iddly Vada Dosai", which begins as a racy, flirtatious track, before swerving into a chorus comprising solely of those three words pronounced in defiantly accentuated Tamil.

It is Kevin's journey towards acceptance of his own accent, back when he was working in Kolkata and had to face some jibes about it, that led to this piece.

"I have a South Indian accent, and I have decided to own it. At one point, even I used to be among the group of people who would judge people for singing with an accent. Lots of people do still think like that, and I decided I want to shut it

In contrast to the story behind it, the song itself is funny, and is usually introduced in gigs by the singer saying something like, "I love Kolkata, but I think my friends from there will agree that it has no place that serves some good idli, vada, dosai." And invariably, someone in the crowd agrees.

Oddly enough, that is not the most unusual feature about this EP. On the album cover, seated with Kevin and sporting some cool sunglasses, is Manny, his friend and pet mannequin. "My landlord is a textile businessman. When I first walked into my room, he was just there. He creeped all my friends out, so of course I decided to keep him," explains Kevin. Manny the mannequin, thus became a recurring figure in his online musical acts, the butt of numerous jokes, and the face of this EP.

In fact, the only time Mr Kev comes up with something that is not funny, is when a real-life premise behind a song is rooted in laughter. Like "Tera Mera", which he first sang to make fun of his lovelorn roommate.

"He was really low, and I got tired of it, so I started mock-singing what he had written, to irritate him. But instead of getting angry, he went, 'I like it! We should make this song'," laughs Kevin.

"Doc!", on the other hand, is a

tongue-in-cheek number that brought him back to writing after a long bout of writer's block and insomnia.

Consequently, says Kevin, it also restored the self-esteem that he had been struggling with. So, naturally, it is not a serious song at all.

And then there is the slyly suggestive "May-On-Knees", and the coo-ing ballad "Shaira", two more favourites from his frequent gigs that complete the EP. If the singersongwriter's popularity in the circuit is anything to go by, it is certainly worth checking out.

As civilians we don't really know what goes into putting up a strong defence for the country. For a lot of us, army life is vaguely about immaculate uniforms, night-vision devices, and the perks of sports infrastructure.

To help people understand the training practices better, Maj Dinesh Sharma started Delta 105, an armythemed park, named jointly after his company (a group of soldiers and officers) and the pincode for Manesar, where the facility is located.

Where it all started

"The idea is to let people do something interesting and fun while learning something as well," says Maj Sharma, who was commissioned into the 6th battalion of the Rajputana Rifles regiment and served for four years in the Uri sector during the Kargil war. He left the army in 2004 at the age of 29 and did an MBA in Human Resources at the Symbiosis Institute of Management Studies, Pune, working with corporations like Wipro and Mercer for about 12 years before starting this venture.

About a year ago, after identifying his calling of sharing the struggles and triumphs of military men and women with civilians, he took agricultural land on lease and revamped it. The idea was to design it in a way that would resemble an army camp, along with the expertise of a Delhi-based design-

er. The facility opened a couple of months ago.

All that's green

The park is set in village Pada, a 30-minute drive from Gurugram, and is spread over a lush 26 acres, away from a densely populated area, much like most army areas are. "We wanted a big space so people don't feel claustrophobic," Maj Sharma says.

He's right. The fresh air reminds you of how rare a commodity it has become. On entry you are greeted by two commandos, both ex-army jawaans, sliding down from a rope, marking the onset of the action movie-like experience. He talks of a recent visit by a group of school children, who on seeing the commandos in action, immediately produced whatever paper they had on them, for autographs.

There are about 10 activities to keep you on the move, all led by an ex-army personnel. "We have a war zone which looks like an international border. Here we explain how the enemy enters, how to stop them, what weapons are used. There is a grenade range where they can learn to throw a dummy gre-

nade, and a crawl trench where people learn that the lower you keep yourself, the lower your chances are of getting hit in an attack," he says. There's also a firing range, an obstacle course, a race course where people have to move with a 'battle' load, an assault course where big groups can learn teamwork, a paintball arena.

"We conduct sessions on how to fold a national flag, how to tie a knot. We have map related activities as well," says Maj Sharma, talking about the various facilities available.

The food too takes a leaf out of each regiment's speciality. This month, it's the Jat regiment, so there's makki ki roti and sarson ka saag. As with any army establishment, chai and nimboo pani flows freely.

What lies ahead For Republic day, Delta 105 is

organising a Military Fun and Food Carnival, where a few of Maj Sharma's army friends will share their life stories. "We are trying to arrange food from the four regions of the country." There'll be an army band showcasing military tunes. "We'll be inviting civil bands to compete with each other as they play patriotic songs."

For those of us who spend most of our time sitting in office chairs, Mai Sharma tells us, "The more you sweat in peace, the less you bleed in war." While we will hopefully not have war, it helps to stay fit in peace.

Tennis dreams

Ten Ballkids from India, among 38 from counties other than Australia, are a part of the year's first Grand Slam



Kia Motors India announced the winners of the Australian Open Ballkids India Programme 2020 at Kia Beat 360, their experience centre in Gurugram. The final squad, 10 kids between the ages of 13 to 15, were chosen and will be a part of a group of 360. This is the second year for the programme in India.

During a tennis match, Ballkids retrieve loose balls, feed balls for service, and assist players. They have an important role in ensuring that tournaments run smoothly. "Many professional players have also been Ballkids, Roger Federer and John McEnroe included," says Aditya B. M. V., 14, from Hyderabad, a Ballkid who's a national-level player. "It's a great opportunity," he says, to meet the pros and experience a Grand Slam at close quarters.

The squad left for Australia right after the programme, on their fully-sponsored three-week trip. They will be trained at Melbourne with 28 other international Ballkids from Korea, China, and France, before finally taking part in the Australian Open 2020.

'The victory's still sinking in," says Sanskruti's mother, whose daughter has been playing tennis since she was four. Sanskruti Vadakattu, 14, from Hyderabad, is one of only two girls selected from India.

"It's a dream 'made' true" says Yashvardhan Gaur, 15, one of the two Ballkids from Chandigarh. "We worked hard for it." The process began with young tennis enthusiasts being asked to upload videos online showing their Ballkid-skills. Over 250 kids from 10 cities were selected based on their videos. They were further tested for athleticism, rolling, and servicing technique, and also for on-court communication, among other skills. Then, 100 were shortlisted, before the final 10 were chosen.

Kia Motors, sponsor of the Australian Open since 2002, sees itself as a global custodian of sports. In 2018, they had chosen two boys from India to be Official Match Ball Carriers at the FIFA World Cup, where they were automotive partners. The Ballkids programme for next year's Australian Open is likely to open early this November.





CONSUMER ELECTRONICS SHOW 2020

Towards practical futurism

This year's Consumer Electronics Show lived up to its slogan of 'global stage for innovation'. Here are the main new conversations and gadget highlights from the international trade show

If there is one thing to say about technology in the 2010s, it is that the industry went through an identity evolution. This was reflected in the annual United States-based CES, hosted and organised by Consumer Technology Association. Though CES 2020 (January 7 to January 10) took place across three geographical areas: Tech East, Tech West and Tech South in Las Vegas, the rest of the world is never left out, thanks to the live-streams.

Since its first show in 1967 in New York, the innovations got weirder, but there was a purposefulness in even the most indulgent exhibitions. And this year's expo was no different. Already making headlines, are a 5G PC from Lenovo, humanoid robots, alien-esque cars from Mercedes-Benz and Byton Ltd, the far reach of 5G, and increasingly immersive gaming gear.

Like the eye-catching gadgetry on show, the Supersessions (dis-

cussions) around what the world could expect – in not just 2020 but the next decade, too - drew lots of attention.

That said, the interest around CES lies in the fact that, unlike most tech expos, CES sees perspectives from both enthusiasts

Drive to be 'good'

The ongoing Fourth Industrial Revolution we live in raises a lot of questions around ethical technology, and one cannot only allude to the right implementation and consumption of technology, but also research and development of smart infrastructure

At a fireside chat titled 'What's Next for the Fourth Industrial Revolution?', Barbara Humpton, CEO of Siemens USA, suggested that rather than waiting for regulatory practices to be enforced, tech companies can be ahead of the curve and integrate that behaviour from the get-go to establish the norm.

These practices, adds Humpton, can be applied to largely societal and sustainable goals food practices, climate change, philanthropy, etc - for corporations across the spectrum in any given geography. On the floor, the advent of faux pork by Impossible Foods played into this.

Privacy by design

The horror stories around smart homes have been prevalent, and tech giants Google, Facebook, Amazon and Apple were placed in the hot seat.

Google introduced two new voice commands - 'Hey Google, that wasn't for you' and 'Hey Google, are you saving my audio daand chief privacy officer, Susan Shook, global privacy officer at The Procter & Gamble Company, as well as Rebecca Slaughter, commissioner at the Federal Trade Commission, the US watchdog agency that imposed a \$5 billion penalty on Facebook over privacy breaches.

All the panellists agreed that enough can never be done in the realm of privacy. Slaughter added that what needs to be done cannot be generalised; potential actions taken are industry-specific and company-specific, and that the whole conundrum is a "solvable problem" on a policy level.

Egan announced Facebook's updated their Privacy Checkup tool; a move they claim will promise better transparency... but the world has learned that everything Facebook says should be taken with a bucket of salt.

One of the biggest concerns in the 2010s was targeted advertising, to which Shook revealed P&G's focus is now on a "consumer-centric privacy framework."

Unfortunately, in response, many of the audience members bemoaned that the epiphany of information sovereignty has come too late, and that it is time for these corporations to walk

the talk.

The era of anticipation

CES always hints that many of these technologies which initially sat on the fringes would become the norm someday – which be exciting and unnerving.

A CNET Next Big Thing talk titled 'IoT: Moving Into An

Anticipatory Tech World' addressed how, in the next few years, technology actually "will make things happen [for consumers] before they ask for them to happen."

The talk had experts such as Cindy Cohn, executive director of the Electronic Frontier Foundation, Rana El Kaliouby, co-founder and CEO of Affectiva, Doug Clinton, managing partner at Loup Ventures, and Michele Turner, senior director of Google Smart Home Ecosystem.

The home and wellness sectors will see far more automation and more control from the consumer, says Lindsey Turrentine, senior vice president of CBS Interactive Tech. In other words, leave the terminology of 'smart' behind, the more becoming term being anticipatory'.

The latest television launches from Samsung, LG and other big names, which play into the growing 8K ecosystem, are a testament to this advancement.

Dwayne Bravo was recalled to the West Indies squad on Sunday, more than three years after his last appearance as the Caribbean side builds up to the defence of its title.

The 36-year-old all-rounder, a two-time winner, was named in a 13-man squad for a three-match series against Ireland later this month.

However, the West Indies is thinking long-term with the next World Cup in the game's shortest format taking place in Australia in October and November.

Bravo last played for the T20 side against Pakistan in September 2016 before he quit to concentrate on franchise cricket.

"Dwayne Bravo was re-



called with the specific intention of bolstering our 'death' bowling which was identified as an area that really needs improving," said West Indies chief selector Roger Harper.

"His record in this department speaks for itself. He will also be able to act as a mentor to the other 'death' bowlers and lend his experience wherever needed."

Bravo has played 66 T20

internationals for West Indies, taking 52 wickets and scoring 1.142 runs. However his career has often been controversial. He played the last of his 40 Tests in 2010 and was dumped as ODI skipper in 2014 after leading a walkout during a tour of India over a pay dispute.

Fellow all-rounder Rovman Powell has also been recalled having played 23 T20 internationals. Jason Holder, the team's regular skipper, is being rested just as he was for the three ODIs against Ireland, a series which ended on Sunday.

Evin Lewis smashed a dazzling century as West Indies defeated Ireland by five wickets on Sunday to complete a 3-0 sweep of the One-Day International series.

Opener Lewis hit his third one-day ton off 96 balls with six boundaries and five huge sixes at the National Stadium here as West Indies reached its rain-revised target of 197 with 64 balls to spare.

The 28-year-old, lefthanded Lewis had made an unbeaten 99 in the first game in Barbados which his team won also by five wickets. "All the hard work I've done in the nets has paid off," Trinidadian Lewis said at the trophy presentation.

"This was an opportunity for my first hundred in the Caribbean, and it's great to get a series win. I've been hungry for runs."

Lewis had reached his 50 off 41 balls while laying the foundation for a comfortable win thanks to a 100-run partnership with Brandon King (38 off 43 balls) for the third wicket.

He reached his century with a mid-wicket flourish off medium-pacer Craig Young before falling next ball trying for a big drive, caught by Kevin O'Brien.

By then the West Indies was only five short of its target which had been revised after a brief rain stoppage.

Young suffered the worst punishment with his nine overs yielding just one wick-

to point and was caught. For Balbirnie, it was his ninth ODI half-century while his innings featured six boundaries and two sixes. Andy McBrine was Ireland's second highest scorer with an unbeaten 25.

"We've managed to get in but not kick off, we were outclassed today but we can take improvements from the three games," insisted Balbirnie, whose side were playing a series for the first time in six months.

"We don't have the quickest bowlers in the world or the biggest turners, but we can be disciplined. The second game was a big positive, we just didn't have that composure." The two sides now play a three-game T20 series from Wednesday.

ICC plans to expand T20 WC

Says it is the best way to increase the reach of the sport

The International Cricket Council (ICC) is considering expanding the T20 World Cup from 16 to 20 teams from the 2023-31 cycle, according to a media report

The ICC, which views the T20 format as the best way to increase the reach of the sport, is mulling the option as a way for cricket to try and match the popularity of sports like football and basketball, according to the Telegraph.co.uk

that this consideration is "a part of broader discussions for the shape of international cricket calendar from 2023-2031". The first T20 World Cup in this cycle is scheduled for 2024.

The ICC had earlier put forward a proposal to organise a flagship event every

year as a plan to enter the global media rights markets and the a bigger T20 World Cup will also increase the viewership.

A bigger tournament will

also increase the likelihood of the participation of the USA, a market where ICC has recently made several attempts to spread the sport. Other teams that could take part are Canada, Germany, Nepal and Nigeria.

Two options

The ICC is looking at two options for the format if the tournament expands to 20

teams. One of the options is the current two-tier format used in the T20 World Cup with lower-ranked teams playing the qualifiers to reach the main draw which includes the top countries.

Second possibility

The second possibility could be four groups of five teams each with the top sides from each group progressing to the knockout stage.

The ICC is carrying out several discussions about the future of the sport, including shortening of fiveday Tests to four days.
