After Modi's call, Trump likely to visit Delhi in late February

President keen on trip but impeachment process could influence the dates

Security and logistics teams from Washington are expected in Delhi this week to prepare for a possible visit by U.S. President Donald Trump, multiple sources have confirmed to The Hin-

The visit, which has not yet been announced, would bring Mr. Trump to India a year after he declined an invitation to be the chief guest at the Republic Day celebrations, and will go ahead at the end of February as long as dates don't need to be changed to accommodate the impeachment process in the Senate.

The sources said the decision to visit India, at Prime Minister Narendra Modi's invitation, was discussed during a telephone call between the leaders on January 7. Ac-

cording to the sources, Mr. Trump is "keen" to visit early in the year, ahead of elections in November, and both sides are working towards a visit in the last week of February. India's Ambassador to Washington, who is now the Foreign Secretary-designate, Harsh Shringla met Mr. Trump before returning to Delhi, and will begin preparations for the visit.

With just weeks to go to the proposed visit, New Delhi is understood to have intimated its choice of Mr. Shrinreplacement and Washington is expected to expedite its 'agreement' for his appointment.

Trade deal

Among the agreements the leaders hope to wrap up is a trade deal that has been pending since November 2018, when talks went into a standstill.

In June 2019, the U.S. cancelled India's preferential export 'GSP' status, and the government hopes Mr. Trump will announce a revocation of that decision during the visit.

India is also expected to announce further investments in the U.S., and a substantial increase in Amerioil imports. In particular, a major deal on civil aviation is being discussed, officials said.

SC rejects curative pleas of 2 Nirbhaya death row convicts

No merit in their appeals to spare them the gallows: Bench

NEW DELHI The curative petitions of Vinay Sharma, 26, and Mukesh Singh, 32, who were sentenced to death in the 2012 Nirbhaya gang rape and murder case, were rejected by a five-judge Supreme Court Bench, led by Justice N.V. Ramana, on Tuesday.

In a three-page order, the Bench concluded, after an in-chamber consideration that began about 1.45 p.m., that there was no merit in their pleas to spare them from the gallows.

"We have gone through the curative petitions and relevant documents. In our opinion, no case is made out within the parameters indicated in the decision of this court in Rupa Ashok Hurra versus Ashok Hurra. Hence, the curative petitions are dismissed," the Bench held.

Curative is a rare remedy

devised by a Constitution Bench of the Supreme Court in its judgment in the Rupa Ashok Hurra case in 2002.

A party can take only two limited grounds in a curative petition – one, he was not heard by the court before the adverse judgment was passed, and two, the judge was biased.

A curative plea, which follows the dismissal of review petition, is the last legal avenue open for convicts in the Supreme Court. Sharma was the first among the four convicts to file a curative.

The Bench also rejected their pleas to stay the execution of their death sentence and for oral hearing in open

Besides Justice Ramana, the Bench comprised Arun Mishra, Rohinton Nariman, R. Banumathi and Ashok Bhushan.

Mercy plea

Shortly after the Supreme Court ruling, Mukesh filed a mercy plea before the President, Tihar jail authorities said.

Mukesh, Sharma, Akshay Kumar Singh, 31, and Pawan Gupta, 25, are scheduled to be hanged at 7 a.m. on January 22 in Tihar jail. A Delhi court issued their death warrants on January 7.

Who says you cannot protest, asks judge

She was hearing bail plea of Bhim Army chief Chandrashekhar Azad

Additional sessions judge Kamini Lau, while hearing the bail plea of Bhim Army chief Chandrashekhar Azad in connection with the protests against the Citizenship Amendment Act in Daryagani last month, observed on Tuesday that the prosecution was behaving as if Jama Masjid was Pakistan.

When the prosecutor, representing the Delhi police, read out some social media posts of Mr. Azad to allege that he had incited violence, Dr. Lau said: "Where is the violence? What is wrong with any of these posts? Who says you cannot protest? Have

you read the Constitution?" The judge said: "You are behaving as if Jama Masjid is Pakistan, Even if it was Pakistan, you can go there and protest. Pakistan was a part

of undivided India." The police pointed out that no prior permission had been taken for the protests, to which the court said: "What permission? SC [Supreme Court] has said repeated use of [Section] 144 is abuse [referring to the recent decision in a case related to Kashmirl." When the prosecution

said it had only drone images of the gathering in which Mr. Azad allegedly gave inflammatory speeches, the court said: "Do vou think our Delhi police is so backward that they have no recorded evidence? In small matters, Delhi police have recorded evidence, why not in this

incident?". Mr. Azad's lawyer, Mehmood Pracha, said he [Mr. Azad] had only been reading the Constitution and speaking against the CAA-NRC.

AAP releases full list of 70 candidates for Delhi

24 new faces in the party list while 15 sitting legislators have been denied tickets

The Aam Aadmi Party on Tuesday released its full list of 70 candidates for the Delhi Assembly elections due on February 8.

All seven AAP Ministers got party tickets and three of its 2019 Delhi Lok Sabha election candidates - Atishi, Dilip Pandey, and Raghav Chadha – made it to the list. Also, leaders who joined the party in the last one week -Ram Singh Netaji, Vinay Mishra and Shoaib Iqbal -

got tickets. The party has announced 24 new faces while 15 sitting MLAs have been dropped.

The other two parties the Congress and the Bharatiya Janata Party – have not yet announced their candidates for the elections.

be complacent. Work v hard. People have lot of faith in AAP and u. God bless [sic]," AAP national convenor Arvind Kejriwal said in a tweet.

46 MLAs retained

Of the existing 61 MLAs, 46 have made it to the list and the party has fielded eight women candidates, compared with six in 2015, said senior AAP leader Manish Sisodia.

In the 2015 Assembly elections, AAP had swept 67 of the 70 seats in Delhi. Later, the BJP won the Rajouri Garden bypoll after AAP le

ed the seat to contest the Punjab Assembly elections in 2017. In 2019, after the Lok Sab-

ha election, five AAP MLAs were disqualified by Delhi Assembly Speaker Ram Niwas Goel under the anti-defection law.

AAP is also expected to +come out with its election manifesto later this week.

The last date for filing of nominations is January 21 while January 24 is the last date for withdrawal of candidature.

The elections results will be out on February 11.

Kerala govt. challenges CAA in Supreme Court

Suit has been filed under Article 131

Kerala became the first State to join citizens across the country to challenge in the Supreme Court the constitutionality of the Citizenship Amendment Act (CAA), 2019, which fasttracks grant of citizenship on the basis of religion.

The State has approached the Supreme Court nearly 15 days after the Assembly unanimously requested the Centre to abrogate the law on De-

cember 31, 2019. And it comes just three days after the CAA came into effect on January 10.

'Original' jurisdiction

The original suit has been filed under Article 131 of the Constitution. The SC has "original" jurisdiction in disputes between States or the Centre and State(s). The Article allows it to directly take cognisance of such a dispute.

Kerala said in its suit that it would be compelled under Article 256 to comply with the CAA, which was "manifestly arbitrary, unreasonable, irrational and violative of fundamental rights".

The suit, represented by senior advocate Jaideep Gupta and G. Prakash, submitted, "Thus, there exists a dispute, involving questions of law and fact, between the State of Kerala and the Union of India, re-

garding the enforcement of legal rights as a State and as well for the enforcement of the fundamental, statutory constitutional and other legal rights of the inhabitants

of the State of Kerala." However, there have been two conflicting judgments from the SC by coordinate Benches on whether a State can file an original suit under Article 131 to challenge the constitutionality of a central law.

The first judgment re-

ported in 2012 - State of Madhya Pradesh vs Union of India – held that States cannot challenge a Central law under Article 131. The second judgment – State of Jharkhand vs State of Bihar – took the opposite view in 2015 and re-

ferred the question of law

to a larger Bench of the Su-

preme Court for final deter-

mination.

The Centre may object to the maintainability of the Kerala suit when it comes up for hearing. CONTINUED ON PAGE 12

Hallmarking made must for gold jewellery

NEW DELHI No jeweller will be allowed to sell gold jewellery or artefacts without hallmark from the Bureau of Indian Standards

(BIS) from January 15, 2021,

onwards, Consumer Affairs Minister Ramvilas Paswan announced on Tuesday.

If jewellery or artefacts made of 14, 18 and 22 carat gold are sold without a BIS hallmark, then the jeweller could be charged penalty five times the cost of the object or even given imprisonment up to one year. Gold hallmarking is a purity certification and is

Why has no govt. official come to meet us?'

Protesters say they respect HC order

Protesters at Shaheen Bagh on Tuesday said they respected the High Court's position that law and order must be maintained but asked why no government official had come to meet them till now.

'We are talking to lawyers to plan our future course of action," said Shaheen Kauser, a social activist who has been part of the anti-citizenship law protest at the site since it began on December 15. Ms. Kauser condemned the Centre for failing to take cognizance of the demands of the protesters.

"There has been no representation from the government," she said, while demanding that a roll back of the Citizenship (Amendment) Act and the National Register of Citizens must be announced in writing.

On Monday, the area Station House Officer had appealed to protesters to leave one side of the road open

Meraj Khan, one of the organisers of the protest, said that such as move would cause safety issues.

but to no avail.

"On multiple occasions outsiders have tried to cause trouble. Right now we keep a check on who is coming by checking ID cards, if one side is opened up, who will take that responsibility?" he said. Protesters also pointed out that the HC had not issued any directions to have the demonstrators removed.

Shortly after the HC's direction were reported by the media, panicked protesters called up more supporters

to come to Shaheen Bagh. The situation, however, remained peaceful with the sit-in entering its 30th day on Wednesday.

Police to hold dialogue with protesters

The Delhi Police will hold a dialogue session with residents and traders to initiate the process of clearing the Kalindi Kunj-Shaheen Bagh stretch in Delhi which has been blocked for a month by people protesting against the amended citizenship officials said on Tuesday.

The move comes after the Delhi High Court directed the police to look into traffic restrictions on the stretch.

"The police has initiated the process of clearing a road at Shaheeen Bagh near Jamia Millia Islamia. The police is following the policy of persuasion rather than force to clear the busy arterial road," a government official said. Officials said that the pol-

protest and the traffic. "It all depends upon ground reality and the wisdom of the police, where situation may keep changing every 10 minutes," it said.

The order came on plea by advocate and social activist Amit Sahni who contended that the road closure was causing huge inconvenience and hardship to lakhs of commuters everyday who have been compelled to take different routes for the last one month.

The plea said that the Kalindi Kunj-Shaheen Bagh stretch was crucial as it connects Delhi, Faridabad (Haryana) and Noida (Uttar Pradesh). It added that commuters are forced to take alternative routes such as the Delhi-Noida-Delhi (DND) Expressway and Ashram, which is causing mas-

The plea said that the temporary closure of the stretch and the Okhla underpass has been extended repeatedly.

"Apart from the temporary road closures, traffic has also been affected as part of Mathura Road is dug up for the construction of an underpass, which is expected to ease the congestion at Ashram Chowk, Mathura Road and the adjoining arteries by connecting Nizamuddin to New Friends Colony," the plea added.

The plea further contended that children who used the blocked stretch to reach their schools are now compelled to leave their homes two hours early in order to reach in time. It added that the authorities have failed to take appropriate action to give relief to the residents of the locality and lakhs of commuters of Delhi, U.P. and Haryana.

On January 10, the HC had refused to entertain a separate plea seeking directions for removal of demonstrators protesting against CAA at Shaheen Bagh.

NHRC team talks to Jamia students

Protesters converge at Jantar Mantar, assert their identity

Hundreds of people gathered at Jantar Mantar to protest against the Citizenship (Amendment) Act (CAA), National Register of Citizens (NRC) and National Population Register (NPR) besides the "categorical mistreatment" of Muslim community at the hands of the police across the country.

The protesters said that the idea behind asserting their Muslim identity while registering dissent against the government is to challenge Prime Minister Narendra Modi's remark that "those protesting can be identified by their clothes".

Iqra Raza (20), a student of Delhi University, alleged that a policeman yelled "in burga walon ko pakao" at her during an anti-CAA protest. She said: "Policemen have constantly been using Islamphobic slurs while dealing with Muslim protesters, especially burga-clad women, and that is extremely problematic. They justify their violence by saying that

they have been ordered to disperse the crowd but who has ordered them to mistreat us who are dressed differently."

Songs of resistance

The protesters raised slogans like "Ye desh humara aap ka, nahi kisi ke baap ka", "Inquilab Zindabad" and "Aazadi". Many of them also sang songs of resistance and read out poems as an ode to Muslim women who have been at the helm of anti-CAA protests.

Addressing the crowd, Aamir Aziz (30), an alumna of Iamia Millia Islamia, said: "Pluralism is the very essence of India and that is what we are trying to protect by protesting against CAA and NRC.



The Delhi police had filed the FIR in March 2000 after they intercepted a conversation between blacklisted bookie Sanjeev and Hansie. In the conversation, Hansie was striking a deal in return for losing matches against India.

Police personnel under scanner for getting jobs with fake documents

They have been working for over 10 years; probe initiated

NEW DELHI A few Delhi police personnel have been found to be employed in the force on fake documents and working for over 10 years. The police have launched a probe into the findings.

A senior police officer said that a complaint was submitted by the Establishment Unit stating that two police officers were found to have

submitted forged documents for getting the job. The inquiry into the complaint was initiated by the Crime Branch which gathered the facts and on their basis an FIR was registered at the Ashok Vihar police station.

During the probe, it was found that 8-10 other personnel were also employed in the same manner. They are working as drivers in different units of the Delhi police.

Sources said that they had provided fake driving licence issued by the Mathura authority in 2007. It was further found that document verification was done at the time of employment and a letter was received from Mathura authority stating that the documents were genuine.

Police suspect that the policemen "managed" the verification at the time and it is being probed.

JNU violence: police quiz 2 more suspects

Two more suspects were auestioned by the Delhi police SIT on Tuesday in connection with the violence on INU campus on January 5.

A team of cyber-forensic experts also visited the university to retrieve relevant data from its server.

Sucheta Talukdar and Priya Ranjan were questioned for two hours each in connection with the attack by a masked mob, said the police. Four persons who were injured in the attack were also examined. Th police are also trying to contact people who had made PCR calls during the violence.

The cyber-forensic team will visit the university again on Wednesday, said Assistant Director (Crime Scene Division) Sanjeev Gupta.

Forensic Science Laboratory director Deepa Verma said, "The data are voluminous and work is ongoing. After the data is submitted to the lab, it will be seen as to what has to be retrieved and what is already available."

A senior police official said that three students: Akshat Awasthi, Rohit Shah and Komal Sharma are absconding. Akshat and Rohit, both first-year students of JNU, were featured in a sting operation conducted by a TV news channel.

The police had identified Komal, a student of Daulat Ram College, as the masked woman who was purportedly seen in the videos of violence shared on social media wearing a check-shirt, a light blue scarf and carrying a stick.Her phone has been switched off since Saturday night. When police had contacted Akshat and Rohit, they said they would join the probe but their phones were later switched off. All the three have been sent notices

to join the investigation.

3 hurt as youth open fire during Lohri celebration

Accused damaged cars during escape

Three persons sustained bullet injuries when five young men gatecrashed into Lohri celebration at Sector 40 here late on Monday night and opened indiscriminate fire. The accused also hit the cars parked outside

in their attempt to escape. One of the accused, Jai Narayan, 28, a resident of Madhya Pradesh, was arrested from Sector 22 on Tuesday. A pistol, two live cartridges and the vehicle used in the commission of crime were seized. The police claimed that Jai was previously involved in several cases of robbery and was arrested on four occasions.

Jai purportedly told the police that he was drunk the previous night and was driving around aimlessly with his friends when they spotted a tent set up for Lohri celebration and gatecrashed into it. However, they opened fire on the guests after they were identified as outsiders.

AAP campaign gets a head start with declaration of candidates

Several nominees release videos appealing to voters; Cong., BJP yet to release lists

With the Aam Aadmi Party releasing its full list of 70 candidates for the Delhi Assembly elections, the party's campaign has got a head start over the Congress and the BJP which are yet to release their lists.

Chief Minister Arvind Kejriwal will fight the election from the New Delhi Assembly seat and Deputy Chief Minister Manish Sisodia from Patparganj, same as 2015 elections. In the last Assembly elections, AAP had registered a landslide victory by winning 67 of 70 seats.

"The tickets were allotted after surveys by the party in all constituencies," AAP leader and Social Welfare Minister Rajendra Pal Gautam said. Asked about protests by MLAs who have not got tickets, he told The Hindu, "This happens in all parties. AAP has calculated all these things while taking the decision. Also, in a first for Delhi, the postal ballot facility extended to senior citizens aged over 80 years and persons with disabilities (PwD) in the 2019 Jharkhand Assembly elections would be implemented in the national capital as well, as per a January 8 notification by the Election Commission of India.

The ECI, on January 10, notified those employed by the Delhi Metro and Northern Railway Transportation (passenger and freight) Services in Delhi as well as mediapersons who have been authorised to cover polling by the ECL as "essential services".

These electors, "who on account of being on duty on the day of poll in the current general election to Legislative Assembly of NCT (National Capital Territory) of Delhi-...will not be able to be present in their respective polling station", will be allowed to vote by postal ballot, the

On January 10, the ECI wrote to the Chief Electoral Officer of Delhi to inform Delhi Metro and Northern Railway about the postal ballot facility and instruct them to nominate nodal officers for the same. The ECI had on September

2, 2019, recommended to the Union Law and Justice Ministry to extend the postal ballot facility to absentee voters electors who are unable to reach polling stations due to different degrees of disability, as well as those discharging essential services.

The Ministry had issued the relevant notification on October 22, 2019, after which postal ballots were given to those above 80 years and PwD in seven constituencies as a pilot in the Jharkhand polls in December.



Addressing a press conference on Tuesday, senior AAP leader Manish Sisodia said: "Each vote for the BJP will be for costlier electricity, water, healthcare and there is clear evidence for these in the NSO figures that the BJP is responsible for rising inflation across India. It has now become a part of their politics, their governance model. Each vote for the BJP will be for inflation."

He said that while high inflation under the BJP government is making it difficult for people to meet daily expenses, the AAP government's policies are helping people to run households.

"Just as we prepare for elections, some very worrying figures on inflation have been released by NSO. They are worrying not just from the perspective of economic slowdown or unemployment, but most importantly because it has become difficult for the common man to meet even basic household expenses. This is the BJP's gift to the people in the last six years with data clearly showing that inflation is at



its highest in six years."

He said that prices have been constantly rising since the BJP has come to power with inflation increasing from 2.1% to 7.4% in just one year and the prices of vegetables increasing by 60% across the nation in just one

"The abject failure of the BJP government in devising economic policy and their inability to contain inflation is breaking all records, especially in the last one year," said Mr. Sisodia.

Builder told to pay ₹68.51 lakh for violating environmental norms

The National Green Tribunal (NGT) has imposed an environmental compensation of ₹68.51 lakh on a builder for construction in the green area of a Gurugram housing complex.

A Bench headed by NGT Chairperson Justice Adarsh Kumar Goel directed the developer to deposit the amount with the Central Pollution Control Board within one month.

"Powers of regulatory authorities were required to be exercised in accordance with these principles. Environmental Impact Assessment procedure was required to be duly followed.

"The Act was amended not to dilute the spirit of the Assam Accord but to address some of its unresolved issues," he said.

Pointing out certain "gaps" left while amending the Citizenship Act in 1983, 1997 and 2003, he said the cut-off date for the detection and deportation of illegal migrants was 1966 and not 1971

according to the "only fourpage" accord.

"The accord did not incorporate many issues that evolved gradually... The cutoff date of 1971 was just a provision for those who came to Assam after 1967 and declared before foreigners' registration officers that they were from Bangladesh," he

The accord was violated

when a provision was added that the names of the 1967-1971 stream of foreigners would be kept out of the electoral rolls for 10 years and later regularised. The fear that the CAA would bring in millions of people needed to be dispelled, he said.

AASU chief advisor Samujjal Bhattacharyya said, "Assam cannot be burdened with even one illegal migrant from 1971 to 2014. Clause 6 of the Accord was thought of for providing constitutional safeguards to the indigenous people."

The Opposition parties lodged complaints with Assembly Speaker Hitendra Nath Goswami for the Facebook live from the House during the special session and Mr. Goswami has ordered a probe.

'Conduct survey to find out number of refugees'

Arunachal is exempted from the CAA: students' union president

The All Arunachal Pradesh Students' Union has asked the Pema Khandu government to conduct a comprehensive survey to ascertain the number of refugees in the State.

The Citizenship (Amendment) Act, 2019, made such a survey necessary though government claimed that the State was exempted from the purview of the amended law, the un-

Arunachal Pradesh has three sets of refugees – the Bangladesh-origin Buddhist Chakmas and Hindu Hajongs who stay together and the Buddhist Tibetans.

"We welcome Chief Minister Pema Khandu's statement in the Assembly that the government would fight a legal battle against granting of citizenship to the Chakma-Hajong refugees. We have also taken note of his assertion that neither the refugees can apply for citizenship nor the government can process their applications as Arunachal Pradesh is exempted from the CAA," AAPSU president Hawa Bagang said.

'Creating confusion'

But the union underlined the 'discrepancy' about the number of refugees that the authorities had been providing. "A comprehensive survey is thus required to clear the confusion," one of its spokespersons said.

On January 8, Mr. Khandu told the 60-member Assembly that the State government had challenged the Supreme Court's judgement on September 17, 2015, granting citizenship to the Chakma-Hajongs. But the apex court dismissed the government's review petition on October 26 that year.

'Take action against Bajwa for revolt against CM'

Punjab Ministers on Tuesday demanded disciplinary action by the Congress leadership against party leader and Rajya Sabha MP Partap Singh Bajwa for raising a banner of revolt against Chief Minister Amarinder Singh on public platforms.

Ahead of the Cabinet meeting here on Tuesday, senior party leaders pointed out that despite repeated pleas asking Mr. Bajwa to express his opinions within the party forum, he continued to criticise Capt. Amarinder and his government in media and other platforms.

'Wrong message'

The Ministers also accused Mr. Bajwa of playing into the hands of the Shiromani Akali Dal and the Aam Aadmi

Party by pitching himself against his own party leadership.

No tree felling for Munde memorial: AMC to CIDCO

Earlier, Chief Minister Uddhav Thackeray had assured that no trees would be cut for the proposed memorial to Shiv Sena founder Bal Thackeray in the city after a row over the

The CIDCO had asked permission to fell 110 trees to construct the Munde memorial in November. The site is located in a densely populated area, but enjoys thick tree cover. According to local environmentalists, the wooded patch is home to four species of snakes, 15 types of butterflies and some 25 types of birds

Deputy municipal commissioner Sumit More said he had written to the executive engineer of CIDCO on Monday, seeking a new plan which will avoid tree felling. "Municipal Commissioner Aastik Kumar Pandey looked into the issue, after which we sent CIDCO a letter, saying the existing trees at the site must be saved," he said.

Anti-CAA kites: police enter GV campus

Students say event at Gujarat Vidyapith disrupted; police say they only carried out routine patrol

The police entered the Gujarat Vidyapith (GV) campus in Ahmedabad on Tuesday, where students had organised an event to fly kites bearing messages opposing the Citizenship Amendment Act (CAA).

While students claimed the police disrupted the event, a senior officer said they entered the campus as part of "routine patrolling" based on inputs that some members of rival student outfits, NSUI and ABVP, might confront each other over the anti-CAA kites.

'Asked for I-card'

Some students of the university said a group of police personnel entered the campus on Ashram Road while they were preparing to celebrate Uttarayan by flying kites with messages like 'India Against CAA', 'No NPR,

They claimed that police personnel also demanded their identity cards. "When confronted by us, the police personnel told us they had the right to enter the campus without taking anyone's permission," some students said in video clips shared with media persons.

"They stopped us and asked us to show identity cards. If required, I would show my I-card to the varsity guard, but why to policemen when we are already inside the campus? They didn't tell us who allowed them to enter the campus," an agitated student said.

Solidarity with varsities

The students had organised the kite-flying event to express solidarity with their counterparts in Jamia Millia Islamia and Jawaharlal Nehru University (JNU) in Delhi. While the police had





allegedly entered the Jamia Millia Islamia during anti-citizenship law protests in December, JNU witnessed violence by masked attackers on January 5.

'Law and order issue'

Deputy Commissioner of Police P.L. Mal said the police entered the campus over a "law and order issue, after receiving inputs that members of NSUI and ABVP may enter into confrontation as some students were planning to fly kites with messages against the CAA".

"The police went to the campus as it was a law and order issue. They came back after conducting a routine patrolling there," Mr. Mal

The GV administration could not be contacted for comment.

Students of the Indian Institute of Management, Ahmemdabad, had said on January 5 that policemen had entered the campus when they were organising a candle light march to express solidarity with the students of JNU and Jamia Millia Islamia.

Kites on CAA dot Gujarat skies

The ideological battle between the pro- and anti-Citizenship Amendment Act (CAA) camps was literally fought in the skies on Tuesday, with kites bearing messages on the citizenship law marking the Uttarayan festival in Gujarat.

The skies virtually turned into a battleground, with flyers competing to knock out each other's kites. The kite flyers included local leaders and supporters of the BJP and Congress, and common people and civil society members.

Chief Minister Vijay Rupani, too, flew a pro-CAA kite from the rooftop of a residential society at Khokhra in Ahmedabad. "Life should also soar like kites and achieve new heights. Gujarat is a

progressive State and we will continue to progress like a kite soaring high in the sky," Mr. Rupani said.

Kites with the messages for and against the law on them were distributed in thousands in the State.

The kites distributed by members of civil society among students and common people bore messages like 'India Against CAA', 'No NPR, No NRC', 'Save Constitution, Save India', 'Hindu-Muslim Bhai Bhai, NRC-CAA Bve Bve'.

The BJP, too, used the occasion to spread a message in support of the new law. A BJP leader from Rajkot said he had distributed 50,000 kites with the message 'We Support CAA'.

BJP supporters and local residents also carried placards asking people to give a missed call on a dedicated phone number to register their support for the Act.

Congress leaders used kites to criticise the government over rising inflation, unemployment, CAA and NRC. "Inflation, economic slowdown, unemployment, rising crimes against women are major contemporary issues in Gujarat. We hope that the kites we fly on Uttarayan will take away the pain of the people and will destroy these demons," Leader of Opposition in the Assembly Paresh Dhanani

Meanwhile, police stepped up patrolling and combing in sensitive areas in Ahmedabad. Rapid Action Force and State Reserve Police Force teams were also deployed in Ahmedabad, a senior official said. In Vadodara, police conducted flag marches in sensitive areas.

State to propose changes to new Motor Vehicle Act

Govt. to seek parity in offence, penalty

The State government is drawing up proposals to counter certain provisions under the Centre's amended Motor Vehicle Act, 2019.

According to officials of the State Transport Department, the proposals will be aimed at bringing more parity between the quantum of penalty and the nature of the offence, which in certain cases has been deemed too high.

State Transport Minister Anil Parab said they are working on the proposals, and will present them to Union Minister for Road Transport and Highways Nitin Gadkari. "We felt that in some cases, the penalties for certain offences were too high. One needs to look at the nature of the crime while penalising the per son," he said.

The Minister said that broadly, they are seeking to reduce the amount of fines or penalties for offences that did not pose an imminent threat to the person driving or those around him, or those that were minor transgressions. "If a person is riding a bike without a helmet within the confines of a residential area for his daily chores, he would not be speeding and doesn't pose the same threat as someone on a main road," he said.

Senior officials from the Transport Department said in cases of speeding, a single penalty for all those who breach the threshold may not be accurate. A person driving at 40 km per hour in a place where the speed li-



mit is 30 does not pose the same threat as someone driving at 90 km per hour, one official said.

Mr. Parab, however, said they plan to be extremely strict against those committing traffic violations knowingly, such as driving under the influence of alcohol or driving on the wrong side of the road. "We will make sure that the punishment is so harsh that not only will they not commit the offence again, but it will also act as a deterrent to others," he said.

Mr. Parab said they plan to finalise their proposals within eight days and then meet Mr. Gadkari.

After the amended Motor Vehicles Act was passed in 2019, several States refused to implement it. The Centre had written to all States earlier this month to implement the Act, failing which they would attract provisions of Article 356.

The new law has increased fines for not wearing a helmet from ₹100 to ₹1,000, along with a threemonth disqualification of licence. For speeding or racing, the fine has increased from ₹500 to ₹5,000.

+ State to merge liquor taxes to plug leaks

Single point of collection will help government rake in more revenue

The State government will merge taxes and duties levied on liquor to increase revenue collection and plug leakages. Deputy Chief Minister Ajit Pawar on Tuesday approved slew of measures to shore up collection and boost the State's economy, which is reeling under a debt of ₹4.72 lakh crore.

One of the proposals suggested merging the sales tax charged on liquor served by restaurants with excise duty levied at the manufacturers' end. This would increase revenue collection by ₹200 crore, senior officials said.

The decision will effectively abolish value added tax (VAT) charged on liquor at restaurants, and subsume it into excise duty without impacting the eventual MRP on the bottled liquor. "The proposal is among four other measures, including reducing the number of dry days,

suggested by the State Excise Department to boost revenue. Overall, a decision was taken to approve the merger," said a senior government official.

The government currently collects ₹17,000 crore in excise levies, which are its third-largest source of revenue. About ₹9,000 crore of the collections are made by the Sales Tax Department in the form of VAT, but the Excise Department has been demanding a single point of

collection to plug the leaks. The State government col-

lects 35% VAT on the MRP of country liquor, Indian Made Foreign Liquor (IMFL) and beer. "The move would certainly improve collections and at the same time make it easy to do business related to liquor. We are expecting improvements in compliance as well," said the official.

Excise duty is paid at the manufacturers' end, while the sales tax in the form of VAT is collected much later.

Multi-member ward system to be reviewed

The State Cabinet will Wednesday reconsider the multimember ward system introduced in the local bodies by the previous government. It will also review the direct election of chiarmen in local bodies introduced in 2017 by the earlier government to gain control of local bodies.

States like Kerala and Karnataka have already merged the taxes and successfully managed to reduce evasion. The one-point collection of tax will improve liquidity in the State system, officials said.

Sahitya Akademi Award winner says book rejected over 'obscene' words

Failed to get reply to multiple RTI queries, says poet

Sahitya Akademi Award winner Neelba Khandekar has said the State-run Goa Konkani Academy has refused to buy and circulate his collection of poems, claiming it contains some "objectionable and obscene" words.

The poet said the Goa Konkani Academy's executive committee approved the purchase and circulation of his book, titled The Words, in 2018, but rejected it recently. "The executive committee has said the book contains some objectionable and obscene words," Mr. Khandekar said.

He said the academy's executive panel has taken objection to two words in Konkani in one of the poems.

The academy had sent the purchase order for 90 copies of the book to the poet in in January 2019, but cancelled it recently.

Mr. Khandekar also filed applications under the Right to Information (RTI) Act to different government bodies to find out why those words were deemed objectionable. He said the words also appear in his work Gangrape which won him the Sahitya Akademi Award last year.

"I filed four RTI applications, two each with the Goa Konkani Academy and the Official Language Department," he said. After not getting any response from both, Mr. Khandekar also appealed to the Goa Infor-

mation Commission, but could not get any satisfactory reply from there, the poet said. "What hurts me is that at least the Official Language Department, which funds the Goa Konkani Academy, should have questioned the logic behind rejecting my book," he said. No member of the acade-

my's executive committee was available for comment.

This is not the first time that the State-run body is in news for objecting to contents of a book. In 2017, it cancelled an award announced for a collection of poems, titled Sudirsukt by the late Vishnu Surya Wagh for alleged derogatory references about a particular community.

Students bunk classes to fix road for bus service

They had to walk 10 km every day

Village sarpanch Monica Salve demanded construction of a proper road for hassle-free transportation.

'Don't see him with 1962 lens'

Krishna Menon's contributions were remarkable, says Jairam Ramesh

Former Defence Minister V.K. Krishna Menon was often "seen with the lens of 1962" [war with China], while there was more to him before 1946 and during the 1950s, said senior Congress leader and Rajya Sabha MP Jairam Ramesh here on Tuesday. Menon's contributions in the drafting of the Constitution before 1946 and his actions during the 1950s were remarkable.

During a public discussion on 'The Making of Independent India and V.K. Krishna Menon' organised by The Hindu Centre for Politics and Public Policy at the Music Academy, Mr. Ramesh recalled incidents from Menon's life since his college days until his death to capture various phases - both personal and political.

In his conversation with former West Bengal Governor Gopalkrishna Gandhi, Mr. Ramesh said it was Menon who first came up with the idea of 'Make in India'. When India had options

from the United States of America and the United Kingdom from whom it had to purchase fighter aircraft, he wanted the purchase to be from a country that allowed eventual manufacturing of aircraft in India.

'That was how fighter jet MiG-21 came to be manufactured in India," pointed out Mr. Ramesh, who authored A Chequered Brilliance: The Many Lives of V.K. Krishna Menon. The Defence Research and Development Organisation (DRDO) came during Menon's about tenure.

Though Menon enjoyed proximity with then Prime

Minister Jawaharlal Nehru and the latter too believed in the former's judgment, the Council of Ministers did not approve of Menon's ideas, Mr. Ramesh pointed out.

Even a few years before the war with China, Menon was for a settlement with the neighbouring country, but did not enjoy support from the Cabinet, the opposition and the media. "But, eventually Prime Minister Atal Bihari Vajpayee in 2003 put in place a boundary talk mechanism with China," Mr. Ramesh said.

Respond to Odisha's plea on Polavaram'

Odisha has raised concerns about the project and the conduct of the Centre in not informing the State on the issue of 'stop work order' being kept in abevance periodically leading to the unhindered continuation of the project work.

The State is apprehensive that the construction of the dam by neighbouring Andhra Pradesh and the spillway would result in the submergence of considerable amount of its territory, including protected tribal areas. Rajiv Gandhi case: SC unhappy at CBI report on larger conspiracy

The Supreme Court on Tuesday expressed its unhappiness about the CBI's status report on the probe into the larger conspiracy behind the assassination of former Prime Minister Rajiv Gandhi at Sriperumbudur in Tamil Nadu in 1991.

Instead of revealing the progress made to unearth the truth, the report filed in the Supreme Court by the investigating agency merely parroted its past reports over the years. "We are not happy with the report," a Bench of Justices L. Nageswara Rao and Hemant Gupta said.

The court called for the presence of a senior law officer, an Additional Solicitor General, to appear, and kept the case on hold to be taken up later.

After half-an-hour, the case came up again. This time, Justice Rao expressed the court's dissatisfaction without mincing words.

"There is no difference between this report and the ones filed before. Everything said is quite the same as before... going to Bangkok or something... What we want to know is what progress has been made [in the investigation] in the past two years at least," Justice Rao observed.

Senior advocate Gopal

Sankaranarayanan, appearing for Rajiv Gandhi assassination convict A.G. Perarivalan, submitted that the CBI's Multi Disciplinary Monitoring (MDMA), probing the larger conspiracy behind the killing, was yet to conclude its investigation pertaining to the origin and make of the

The Bench allowed Perarivalan's lawyers to peruse the CBI report in the courtroom. The report was filed in a sealed cover. The court finally ordered the CBI to file a fresh report detailing the work done. The case is

listed on January 28. Perarivalan, who is in his mid-forties now, has spent about a quarter of a century inside jail serving life imprisonment. He was 19 at the time of his arrest. Perarivalan has sought an order from the court to stay his life sentence till the MDMA probe is completed. He has argued that the CBI has still not been able to question Nixon alias Suren, one among the 21 suspects the MDMA is waiting to investigate, who allegedly knows

CRZ rules eased for 'Blue Flag' beaches

States can construct infrastructure to enable international recognition, says Environment Ministry

NEW DELHI

The Environment Ministry has relaxed Coastal Regulation Zone (CRZ) rules that restrict construction near beaches to help States construct infrastructure and enable them to receive 'Blue Flag' certification.

Last year, the Ministry selected 13 beaches in India to vie for the certificate. This is an international recognition conferred on beaches that meet certain criteria of cleanliness and environmental propriety.

The earmarked beaches are - Ghoghala beach (Diu), Shivrajpur beach (Gujarat), Bhogave beach (Maharashtra), Padubidri and Kasarkod beaches (Karnataka), Kappad beach (Kerala), Kovalam beach (Tamil Nadu), Eden beach (Puducherry), Rushikonda beach (Andhra Pradesh), Miramar beach (Goa),



'Policy on rare diseases another piece of paper'

Nothing more than an illusion: patient groups

Calling it just another piece of paper that is far from reality, groups working in the area of rare diseases in India have said that the National Policy for Rare Diseases-2020, released recently by the Union Health Ministry, is nothing more than "an illusion". It offers no clarity on long-term financial assistance, they said.

The government, in its policy paper, has proposed financial support of up to ₹15 lakh under an umbrella scheme of the Rashtriya Arogya Nidhi for rare diseases that require one-time treatment. Beneficiaries for such financial assistance would not be limited to Below the Poverty Line (BPL) families, but extended to 40% of the population eligible as per the norms of the Pradhan Mantri Jan Arogya Yojana, for their treatment in government tertiary hospitals only.

'Alternate funding'

It has also proposed that the Government will "endeavour to create alternate funding mechanism through setting up a digital platform for voluntary individual and corporate donors to contribute to the treatment cost of patients of rare diseases".

For prevention and control, the Ministry has noted that it will work at encouraging people to seek pre-marital genetic counselling, identification of high risk couples, and create awareness about early detection rare diseases. "The 2017 policy on rare diseases had proposed a ₹100 crore corpus fund allocation for the treatment of patients with rare diseases, which was a Centre-State partnership of 60:40, with each State forming a technical committee to evaluate patients' applications. That has come down to ₹15 lakh support for diseases needing one-time treatment. Clearly, now, after a major lag, the policy has come with no hope in sight," noted a release from the Lysosomal Storage Disorders Support Society.

The society's president Manjit Singh said, "Policy 2020 is far from reality and lacks genuine interest in providing muchneeded treatment to 'treatable' Rare Diseases." Prasanna Shirol, founder of the Organization for Rare Diseases India (ORDI), said that the policy is a "plain mockery of the situation of patients", and that proposed solutions such as the creation of a digital platform for crowd funding were not reliable. "The policy is just another document without much substance," he said.

PM must prove his charge or apologise: IMA

Гhe Indian Medical Association (IMA) on Tuesday asked Prime Minister Narendra Modi to deny or prove his alleged statement that top pharmaceutical companies bribed doctors with women escorts. The country's largest doctors body demanded that the PM should apologise if he fails to do so.

"Reports have appeared in IMA said.

The PM reportedly spoke about ethical marketing practices during a meeting with top pharmaceutical companies earlier this month. "IMA wants to know if the government had details about companies involved in supplying women to doctors why it chose to invite them for a meeting in PMO rather than initiate criminal proceedings," the IMA statement said.

Theological thicket

SC must mark limits of religious freedom, against which legality of practices can be tested

The opening hearing before a nine-judge Supreme Court Bench, constituted to give an authoritative pronouncement on the nature of religious freedom under the Constitution, has revealed the conceptual confusion over the reference made to it. The Bench, headed by the Chief Justice of India, S.A. Bobde, has asked lawyers to "re-frame" the issues, or add to them, following submissions that the questions framed by a Bench of five judges were too broad. Further, the CJI has clarified that the Court will not be deciding the petitions seeking a review of the verdict in the Sabarimala temple case. Instead, it would limit itself to "larger questions" such as the interplay between freedom of religion and other fundamental rights; and the extent to which courts can probe whether a particular practice is essential to that religion or not. At the same time, he has said, "We will decide questions of law on women's entry into mosques/temples, genital mutilation among Dawoodi Bohras, entry of Parsi women who marry outside the community into the fire temple. We will not decide the individual facts of each case." It would be prudent if this approach means that the Bench would set out the limits of the freedom of religion, against which such practices can be tested and their legality determined. However, it would be unwise if the examination of every discriminatory practice becomes a fresh treatise on Articles 25 and 26, instead of being subjected to a simple test whether the particular practice is protected by the freedom of religion, or can be curbed on the grounds of "public order, morality and health".

A signal flaw in the reference is that it did not emanate from Benches before which these matters were pending. Normally, such issues are referred to a larger Bench only if the Court is faced with apparently contradictory precedents, or feels that the settled law requires reconsideration. A five-judge Bench, while hearing the Sabarimala review petitions, had referred a set of questions to a larger Bench. But two dissenting judges had pointed out that it was up to Benches before which such cases came up to decide whether they should go by existing precedent, or refer the matter to larger Benches for fresh consideration. That the strength of the Bench was fixed at nine may indicate that the court is leaving scope for revisiting the 1954 seven-judge Bench decision in the Shirur Mutt case, holding that religious denominations had the autonomy to decide what religious practices were essential to them. A reconsideration of this "essentiality doctrine" will be useful only if it is a means to rid the court of the burden of entering the theological thicket. However, even without revisiting the judgment, courts have often given verdicts that protect individual rights, and uphold equality and dignity over regressive religious practices.

Inflation shocker

With growth sagging and prices rising, the economy is entering a difficult phase

he inflation devil is back and at the wrong time The 7.35% rise in consumer price inflation in December is a shocker even to those who were prepared for an elevated level of inflation in the backdrop of the rise in prices of food commodities in general, and the astronomical rise in the price of onions, in particular. The disturbing December print has set off fears over whether India is entering a period of slow growth accompanied by high inflation, in other words, stagflation. Such fears have to be weighed against a few facts. First, the headline inflation number is driven mainly by food inflation at 14.12% - it was 10.01% in November and -2.65% in December 2018. While onion was the prime villain pushing up price inflation in vegetables to a huge 60.50% compared to December 2018, prices of other food items such as meat and fish (up 9.57%), milk (up 4.22%), eggs (up 8.79%) and some pulses were also on the upswing. These are a largely seasonal rise in prices and are driven mainly by supply-side factors and the prices will reverse once the supply shortfall is addressed. An analysis by State Bank of India's research team shows that minus the increase in prices of onion, potato and ginger, headline CPI inflation would be just 4.48%. Second, core inflation, which is the one that should be of concern, has only inched up marginally from 3.5% in November to 3.7% in December. That said, it would be worrisome indeed if core inflation were to shoot up or if food inflation does not cool down in the next couple of months. Also, the effects of the increase in telecom tariffs, rail tickets and in fuel prices need to be closely watched.

The sharp jump in the CPI has queered the pitch for the Reserve Bank of India's monetary policy review in February. The central bank stood pat on rates in the December policy precisely due to fears of inflation and had even revised upwards its inflation projection for the second half of the fiscal to 4.7-5.1%. The December print is way above the monetary policy committee's (MPC) mandated limit of 6% (4% plus 2%) which means that a rate cut is pretty much off the table for now. Yet, with growth sagging, there is pressure on the central bank to cut rates at least one more time to stimulate growth. It would be interesting to watch the deliberations of the MPC in February. While the market may be prepared to accept a standstill policy for now, any change in the RBI's stance from accommodative to neutral may not go down well. A lot would also depend on the fiscal arithmetic that would emerge from the budget to be presented on February 1. Meanwhile, the government should engage all levers to address the supplyside issues that are behind the rise in food inflation. A calming down of food prices will help the bank do what the government and markets want – lower rates.

The long wait for empowered mayors

Mayors in many global cities go on to lead their country; in India it is the opposite story, with politics to be blamed

s he attempts to repeat the overwhelming 2015 victory (AAP) in the Delhi Assembly election, Chief Minister Arvind Kejriwal is challenging political Goliaths on just one plank: his government's performance.

The face of changes

The iconoclast who overran Delhi's established political trenches with an anti-corruption campaign is pinning his hopes on the unprecedented fiscal measures he has taken to change the paradigm of education, health and urban development in the National Capital. In office, he has pressed on even in the face of non-cooperation from the Central Government, which controls important departments providing civic services mainly through the Urban Development and Home Ministries.

The AAP's annual budget five years ago raised the outlay for education by 106% over the previous year's plan of ₹2,219 crore, and focused on building 20,000 additional classrooms. It sent government teacher-mentors abroad for training to modernise the system. Shiny classrooms, new teaching tools and eager students changed the public view of government schools as decrepit dungeons.

Delhi's ambitious budgets for development stand apart from those of other cities, and built the Chief Minister's reputation more as a super Mayor in a city-State. The 2015 education outlay was no flash in the pan. Four years later, it was 27.8%, says an analysis by PRS Legislative Research, and continues to tower over the States that average 15.8%. For health, the allocation of 13.8% dwarfs the 5.2% that others spend on average, and Delhi's Mohalla Clinics – to pro-

vide coverage to all within a range of 1 km - are seen by public health researchers as a good model for a national universal health coverage programme. In budget 2019-20, the highest increase was for transport, at 38%, raising hopes of reduced pollution partly through support for electric vehicles. Municipal budgets for 2014-15 analysed by Open Budgets India reflect a similar trend for urban education expenditure vis-à-vis Delhi. On the income side, cities collect far less property tax than they should due to undervaluation and lack of scientific assessment.

Although he is criticised for his style of functioning, the AAP leader does not have his back to the wall and is pushing to extend his authority, fighting the Central Government's attempts to clip his wings. This is not the situation in other big metropolitan cities, which cannot aspire to have strong leadership due to the prevailing system.

Hardly empowered; a 'threat' Metros have been deprived of empowered Mayors who can raise efficiency, productivity and liveability. Mayors in many global cities go on to lead their country, which possibly explains why they have been reduced to obscure, ceremonial figures by national parties in

The Economic Survey of 2017-18 notes that a third of the population now lives in urban areas which produce three-fifths of the GDP. But India's overflowing cities lack capacity, infrastructure and leadership. The Survey acknowledges this, attributing it to the absence of a single city government in charge, and low spending on infrastructure. State governments amass the large economic output from urban agglomerations, but are averse to a strong Mayoral system.

Chief Ministers see a potential threat from a charismatic and empowered Mayor with progressive policies. Some of them have used the excuse of poor performance of urban local bodies as a justifica-



tion to replace direct election of

Mayors with an indirect system. The All India Anna Dravida Munnetra Kazhagam government in Tamil Nadu issued an ordinance last year to amend the law, and remove any possibility of prominent Opposition politicians becoming the face of any big city. The memory of M.K. Stalin, son of Dravida Munnetra Kazhagam leader M. Karunanidhi as a high-profile Mayor in Chennai even after a quarter century is obviously still fresh. Congress leader Rahul Gandhi refreshingly promised ahead of the 2019 Lok Sabha poll that he would support directly-elected Mayors, since smart cities depend on good leaders.

Weakening governance

In some States, elections to urban local bodies have not been held for years, defeating the lofty goal of decentralised governance. Tamil Nadu is a prominent example. The idea of giving more authority to the third tier of governance has suffered serious stunting, in spite of the 74th Constitution Amendment Act of 1992 identifying 18 local level functions to be devolved, including planning for economic and social development, regulation of land, construction of buildings, urban planning and public health. The average of subjects devolved in all these years is nine, and does not include the major municipal services which continue to be run by parastatal authorities that answer to State governments. Newer devices used to bypass local bodies and priorities are styled as special schemes, such as urban renewal and smart cities, directly supervised by the Central government and partnered by State governments.

Several States are averse to directly-elected Mayors even for their biggest cities, in spite of the Mayor being deprived of any significant powers. The appointment of the executive in-charge, the Municipal Commissioner is a good example. Empowered Mayors, such as those in New York, Paris, London or even Shanghai, could steal the limelight through spectacular successes, leaving Chief Ministers and legislators with little direct connect with urban voters.

Even on a salient issue such as climate change, Mayors are much in demand. The Mayor of Paris, Anne Hidalgo, assumed the leadership of the climate movement in iconic ways, with a move to prescribe green roofs in the vast French capital capturing the public imagination worldwide. Mr. Kejriwal is alert to the global traction that climate change is getting, and addressed Mayors gathered in Copenhagen via video link last year, because the Central government refused him permission to attend. The AAP Health Minister was similarly denied permission to go to Australia to explain the working of Mohalla Clinics.

The present system, of course, does not help directly-elected Mayors. They have not been able to raise service delivery standards, regardless of long or short tenure, and the poor outcomes are quite evident, as the Economic Survey points out. Ironically, because powerless Mayors have running battles with municipal councillors, States such as Rajasthan and Tamil Nadu, to name just two, abandoned direct elections to the post.

The Annual Survey of India's City-Systems (ASICS) 2017 covering 23 cities across 20 States published by Janaagraha Centre for Citizenship and Democracy found 33% of medium and large cities with a provision for directly-elected Mayors, but none in the mega cities. A tenure of five years for Mayors is available only in a fifth of the biggest cities, and half of ur- ananthakrishnan.g@thehindu.co.in

Unified governance and empowerment through elected municipal systems is a distant prospect, but the Central government glibly claimed at the UN Habitat Conference in Quito, Ecuador, in 2016, that the 74th Amendment had made Indian cities self-governing entities with adequate powers and financial autonomy. Of course, nothing could be further from the truth, but then the statement was made by the Secretary to the Union Ministry of Housing. At the conference plenary, the Indian statement did not contain any reference to Mayors.

Hampering development

Much hard work must be done, before cities can progress beyond John Kenneth Galbraith's famous description of India as a "functioning anarchy". Government departments will feel accountable for urban services and infrastructure only under the watch of an empowered leader, who enjoys the mandate of the city's residents.

A lot of time has been lost, as recalcitrant State leaders, who often have remote rural bases of support, stymie the pace of orderly urban development. Lack of coherence in government is hindering better productivity, and causing losses through pollution, congestion and poor outcomes on infrastructure investments. The priorities are flawed, the administration is fragmented and the capacity of city governments is low.

In the coming decade, progress Sustainable Development Goals, the Paris Agreement on Climate Change and the UN Habitat New Urban Agenda will come under close international scrutiny. India's cities need a new deal, one that is focused on development. Only elected, empowered and accountable Mayors can deliver on

Chalk and cheese in private vs. government schools

The Annual Status of Education Report findings make a clear case for strengthening early childhood education centres



ne of the big debates in early childhood education is on children's "school readiness" and whether early childhood education provides them with the requisite skills to cope with the school curriculum. A vast literature exists on the importance of certain cognitive abilities that are supposed to be developed during the years children spend in pre-school, so that they are "ready" when they enter school in grade one.

Home and other factors In terms of what children learn in school, one of the big debates is whether children in private schools perform better than those in government schools. In the Indian context, the consensus seems to be that a large proportion of the differences in the learning levels of children enrolled in private and government schools can be attributed to "home factors". And, while the private school effect remains positive, even after taking into account the child's home environment, learning outcomes in

private schools are nowhere near

grade competency. But, when do these differences start to manifest themselves? Do children who start grade one in private schools have a learning advantage? Let us look at 🛭 the case of language. According to the grade 1 curriculum, children are supposed to be able to identify \succeq and read words and simple sentences. According to the Annual Status of Education Report (ASER) 2019, 21% children in grade one of government schools could read words compared to 46.7% in private schools - an advantage of 122%. How is this possible? Is this a fair comparison? Are we comparing apples with apples? The answer is clearly no.

First, the age distribution in grade one of government schools is very different from that in private schools. The Right to Education and national policy mandates that children enter grade one at age six. However, 26.1% children in grade one of government schools are four or five years old compared to 15.7% in private schools. At the other end of the spectrum, 30.4% children in grade one of government schools are seven-eight years old compared to 45.4% in private schools. Therefore, comparing learning levels in grade one between government and private schools becomes problematic. The higher learning levels in grade one, in private schools, may be partly due to the fact that grade one in those schools has a higher



proportion of older children.

Second, it is well known that children who go to private schools come from relatively affluent backgrounds. They also tend to have more educated parents. This affords them certain advantages which are not available to children who are from less advantaged families and are more likely to attend government schools. For instance, 30% of government school grade one children, in the ASER 2019 sample, had mothers who had never been to school compared to only 12% of grade one private school children. Further, 27.3% of grade one children in private schools had private tutors compared to 19.5% in government

schools. Third, early childhood education is supposed to prepare children for school. Children are supposed to be exposed to activities that build their cognitive abilities and early literacy and numeracy skills. For instance, the National Early Childhood Care and Education curriculum framework talks about developing skills related to sequential thinking, predicting

patterns, observing, reasoning and problem solving in the preschool stage. These cognitive and early language skills are highly correlated with the child's ability to acquire further language skills. Therefore, children who enter grade one better prepared with these skills are likely to perform better. For instance, among the cognitive tasks administered in AS-ER 2019 (seriation, pattern recognition and puzzle) only 23.8% children of grade one in government schools could do all three tasks compared to 43.1% in private

Once we take into account all these factors – age distribution in grade one, home factors such as affluence, mother's education, home learning environment, and some baseline abilities that children enter grade one with, private schools still have a learning advantage. Where is this coming from? Since we are talking about grade one, this difference cannot be attributed to an accumulated effect of better teaching practices in priv-

Pre-school learning

What private pre-schools are doing is to start children on the school-based curriculum in preschool itself. In other words, the private sector keeps children longer in pre-school and exposes them to school-like curricula even before they have entered school. For instance, 14% children in anganwadis could recognise letters or more compared to 52.9% in private pre-schools; and 12.9% children in these private preschools were already reading words (something they are supposed to learn in grade one) compared to 2.9% in anganwadis. It is not surprising, therefore, that children from private pre-schools perform better in school.

Finally, children in anganwadis do worse than private pre-school children on cognitive as well as early language tasks such as picture description. For instance, while 23.4% of private pre-school children could do all three cognitive tasks, only about half (12%) of the children in anganwadis could do them.

India has a huge investment in its early childhood programme. administered through 1.2 million anganwadis under the Integrated Child Development Services Scheme. The findings of ASER 2019 make a clear case for strengthening these early childhood education centres so that they implement appropriate "school-readiness" activities. A case can also be made for streamlining the curriculum at the pre-school stage so that all pre-schools focus on activities that build cognitive and early literacy and numeracy skills. These will aid further learning.
