## V-P replaces saffron robes to avoid tension

Just about two months after a controversy broke over the draping of a Tiruvalluvar statue in saffron, the office of the Vice-President of India committed a faux pas by carrying an image of the Tamil saint poet in saffron robes, along with a tweet remembering him on his 'Jayanthi Day'.

The photograph was immediately taken down, after tweeple pointed to the objectionable colour of Tiruvallur's attire. A note was put out that it was posted by mistake, but not before the goof-up had created another round of flut-

ter on Twitter. The state was rocked by a series of events last November relating to the dress of the cultural icon who gave Tamil one of its best literary treatises. It started with digitally dressing up Tiruvalluvar in saffron since in all earlier images he had been only in white.

Then, a controversy raged. First, his statue at Pillariaripatti near Than-

javur was smeared in cow dung, under cover of darkness, and later on draped in saffron by a leader of a Hindutva outfit.

During those days, several BJP acolytes circulated visuals of the digitally dressed Tiruvalluvar, which was viewed as a cultural invasion as the official image of poet was constructed by scholars based on his explicit philosophy, evidenced from his writing, which is primarily secular.

So the painting by Venugopal Sharma, in which Tiruvalluvar is draped in white with no sacred thread, was used in the postal stamp released in his memory and for the

portrait adorning the Assembly walls and hence accepted by all. Though the image of

Tiruvalluvar in saffron was first circulated when Prime Minister Narendra Modi released a Thai translation of Tirukural in Thailand, Friday's tweet of Modi had no images and just said: 'I bow to the great Thiruvalluvar on his Jayanti. His rich thoughts and literary works give strength to millions. He inspires us to work toward social equality, justice and compassion.' However, the tweets of Tamil Nadu BJP stalwarts, particularly H Raja and S Ve Sekar, had images of the poet in saffron robes.

BJP Tamil Nadu also put out a tweet that gave a religious twist to Jallikattu. It said, 'When Lord Shiva took the form of a hunter and wrestled with Arjuna with a view to testing his strength. Ariuna had the privilege of embracing God. Based on that episode. Hindus embrace the bull, which is a form of Nandhi that is Lord Shiva's vehicle.'

## Children being radicalised in **Kashmir: Chief of Defence Staff**

Chief of Defence Staff (CDS) Gen Bipin Rawat on Thursday suggested that highly radicalised voung people in the country could be put in de-radicalisation camps as a way to deal with terrorism.

He said that to end terrorism, ideology, and radicalisation has to be addressed on priority.

"Anything that has started can be put to an end. To say that radicalisation cannot be countered. I don't quiet agree with it. Radicalisation can be countered," said Gen Rawat.

He said that one has to



start countering radicalisation by looking where it is happening and who are the people who are radicalising people. "It is happening from schools, universities, from religious places and sites and then there are group of people who are spreading it," said Gen Rawat. He said that one has to get to the nerve of the whole thing by identifying who is radicalising the people.

"You can start isolating these people gradually. And then start a counterradicalisation programme by identifying people who have been radicalised to what degree. You got to segregate them in degrees and then look at those who have been completely radicalised, first target them," he said.

"But then also start looking at the future like what we are seeing in Kashmir. We saw radicalisation happening. Today we are seeing radicalisation being undertaken even among the young people, girls and boys as young as 10 and 12, are now being radicalised.' said Gen Rawat.

#### **Pondy CM dares Bedi to prove land** grab charges

of the charges before issuing the press release. Hitting back at the Chief Minister, Bedi said he should challenge MLA Dhanavelou for making the charges instead of wasting energy on her. The former IPS officer in a WhatsApp message to Narayanasamy said, "the Chief Minister needs to counter the allegations made by his own party man who according to media reports has been suspended temporarily today instead of

challenging me." She advised Narayanasamy to challenge his own party MLA, who has been making the allegations against him. Bedi, who has been at loggerheads with the Chief Minister ever since she assumed office in 2016, also

said she has advised Dhanavelou to hand over the evidences to the CBI exclusively dedicated to the Union Territory. She pointed out in no uncertain terms in her message that challenging her was only a "verbal tirade and is misdirected". Bedi also told Narayanasamy that he could as well counter the allegations before CBI if the investigating agency so probed the matter.

Suggesting to the Chief Minister to convene a special session of the territorial Assembly, she said Narayanasamy could ask the MLA to make the allegation

on the floor of the House and then make his statement. "DO not waste your energy on me. You should challenge the one who challenges you. I have already told your party MLA to go to CBI.

We will await their investigation and facilitate their enquiry if they seek help. We are duty bond to assist the investigation agencies," she stated in her message.-PTI

## Prepare fresh provisional selection list: HC to TRB

J.STALIN | DC CHENNAI, JAN. 16

In a major relief to the candidates who were not selected to the post of PG Assistants in Chemistry, the Madras high court has directed the Teachers Recruitment Board to prepare a fresh provisional selection list for the posts of P.G.Assistants Chemistry.

Justice Anand Venkatesh gave the directive while disposing of a batch of 10 petitions from K.Shobana and others. According to

Jothimanian, counsel for

the petitioners the TRB issued a notification on June 12, 2019, inviting applications through online from eligible candidates for direct recruitment to the posts of PG Assistants/Physical Education Directors, Grade I in school education and other departments for the year 2018-2019. Petitioners had applied online for the posts of PG Assistants in Chemistry. After written examination and certificate verification, the TRB published the provisional selection list and the petitioners did not find their names in the list. On going through the list, the petitioners found that the TRB had fitted meritorious candidates under MBC quota instead of general turn and thereby, 34 vacancies which ought to have been considered under general turn were fitted in to MBC.DNC quota. Aggrieved over the same, they filed the present Jothimanian petitions, added.

Also, in the instant case, the highest mark that was secured was 109 and, up to 90 marks, the candidates were fitted in general turn. Where the candidates have secured high marks and come within the merit category, the candidates will have to be selected under general turn irrespective of their community. While undertaking this process, the community does not play any role and it is only merit that is taken into consideration. The candidates, who fell within the category of BC and who secured the marks between 109 and 90 have rightly been fitted in general turn. However, when it came to MBC/DNC catego-

ry instead of fitting the candidates thereof in general turn, they have been fitted in MBC/DNC category. This mistake is very apparent on the face of the impugned provisional selection list that has been made the subject matter of challenge in these peti-tions. The TRB went wrong in understanding the pur-port of section 27 of the Act. The said provision merely provides that the backlog vacancies will have to be first accommodated and thereafter only, the regular vacancies should be accommodated. This does not mean that the backlog vacancies of a particular community will not be considered under general turn irrespective of the merits/rank", the judge added.

The judge said in view of the discussion, this court was of the considered opinion that the provisional selection list prepared by the TRB has to be reconsidered and in lieu thereof, a fresh provisional selection

list prepared.

While preparing the fresh provisional selection list, the TRB was directed to fit general turn, only based on their merit and ranks, irrespective of their community and when it comes to the selection of candidates belonging to a particular community, who do not fall within the merit/rank, they should be considered under the community quota, based on the marks fixed for that community.

While doing so, the backlog vacancies must be first accommodated and only thereafter, the current vacancies must be filled up. ## **RAUT TAKES BACK 'INDIRA COMMENT**

Shiv Sena leader Sanjay Raut's comments about former Prime Minister Indira Gandhi created a furore in the state, leading to the Rajya Sabha MP finally retracting his statement. However, the incident has again exposed the cracks in the newly appointed Maharashtra Vikas Aghadi alliance government.

Raut, whose party is part of the ruling alliance with the Congress and the NCP, on Wednesday had claimed that Ms Gandhi used to meet Karim Lala, an underworld don active during the 1960s and 1970s in Mumbai. Lala was one of the three top underworld dons of Mumbai for over two decades, from the 60s to the early 80s, the other two being Mastan Mirza alias Haji Mastan and Varadarajan Mudaliar.

Following the widespread criticism from the Congress, Raut finally withdrew his comment saying, "If someone feels my statement hurt Indira Gandhi's image, or someone's feelings, I take it back.'

However, several Congress leaders expressed outrage over his comments. Terming Raut's comment as 'wrong,' state Congress chief Balasaheb Thorat on Thursday said such remarks would not be tolerated.

The state revenue minister cautioned all leaders against making remarks criticising great leaders.

# R-Day terror module busted

DC CORRESPONDENT SRINAGAR, JAN. 16

The Jammu and Kashmir police on Thursday claimed that it has busted a Jaish-e-Muhammad (JeM) module which was planning a major terror strike ahead of the Republic Day by arresting five of its members.

Deputy inspector general of police (Central Kashmir), V.K. Birdi, while addressing a hurriedly-called press conference here, said that, following the investigations into a grenade attack in Srinagar's Habak area on January 8, the police arrested five persons involved in the incident.
"During the course of investigation, these persons are formally appropriately appropri

sons confessed their involvement in executing a terror attack (a grenade blast) near Sir Syed Gate of University of Kashmir's main campus at nearby Hazratbal on November 26 last," he

The police officer identi-fied the arrested as Ajaz Ahmad Sheikh, Umar Hamid, Imtiyaz Chikla alias Imran and Naseer Mir — all residents of Hazratbal — and Sahil Gojri of Soura area of Srinagar.

Birdi said that "incriminating material including arms and other explosive substance were recovered during the course of investigations" and that "further investigation in the matter is in the matter

also investigating their complicity in other terror crime incidents.

Later, the J&K police tweeted, "In a major success the Srinagar police busts Jaish module. Two grenade blasts in Hazratbal area worked out. Major attack averted ahead of Republic Day. Five terror operatives arrested. Huge explosive material recovered." (sic)

A police statement said The investigation so far has revealed their motives to enforce shutdowns and paralyse nor-mal life in Srinagar city and further plan to execute sensational incidents like terror attacks and causing improvised explosive device (IED) explosions.

## **LALU IN COURT IN LAST FODDER SCAM CASE**

Ranchi, Jan 16: Jailed RJD president Lalu Prasad appeared before a special CBI court here on Thursday and recorded his statement in connection with a case pertaining to fraudulent withdrawal of Rs 139.35 crore from Doranda Treasury when he was the Bihar chief minister in the 1990s.

Prasad's advocate Prabhat Kumar said his client will produce witnesses and other pieces of evidence in the court on January 20.

This is the fifth and last fodder scam case against the RJD president in Ranchi.

There is a sixth case against him in Bhagalpur in his native state Bihar relateed to the multi-crore fodder scam.

Accompanied by close aide and senior RJD leader Bhola Yadav, Prasad entered the courtroom around 11 am and left around 2 pm.

The RJD supremo, who wore a blue half-sleeved sweater, shawl and woollen cap, appeared unperturbed when he returned after recording his statement.

An ailing 71-year-old Prasad, who is lodged in the Rajendra Institute of Medical Sciences (RIMS), was taken to the special CBI court, about four km away, under heavy security.

## Ministers' J&K visit a pointless exercise

n Saturday, a drove of three dozen Union ministers are to descend on the newly-created Union territory of Jammu and Kashmir. Their job is to promote development plans the Centre has for J&K after the reduction in the former state's status, and the severe political and communications clampdown which accompanied the drastic action effective from August 5 last year, setting off serious uncertainties. In the past five months, little development efforts have been noticed by the Kashmiri people, though much official hype was created around tourism

possibilities, especially in the Valley.

None of this has materialised. Faith in official pronouncements appears to be at an all-time low. Greater energy by the Centre seems to have been expended on crafting "a new politics" for Kashmir — after locking up prominent politicians of Valley-centric political parties, including three former chief ministers of the state — rather than on doing anything to give

concrete shape to development plans. The key question is: Is development possible in the absence of mobile telephony, which was the case for much of the time since August, and the snapping of the Internet? The Supreme Court recently grappled with this question but did not offer justice, although it held that cutting off the Internet for an indefinite period was "impermissible".

The official reason for cutting off Kashmir's links with the outside world was that this was necessary to curb terrorism. This is what the government sought to impress upon the international community. And now a non-Muslim decorated police officer has been discovered to be mixed up with terrorists. The default line is for people of the Valley's majority Muslim community to be suspected of terrorism. To what extent terrorism has been eradicated on account of disrupting communications and locking up politicians can only be tested once all curbs are removed. But will they be removed any time soon? If not, then is it possible to posit any meaningful development activity and economic acceleration? These are key questions worthy of debate.

Sending to Kashmir Union ministers — a cast of characters who have little knowledge or interest in the region except to routinely revile it in communal terms as being a hotbed for militancy — to spread the message of development at a time when practically all economic indicators in the country are showing negative results — cannot possibly be taken seriously, at least not by J&K residents. The only likely explanation is that the ministers' visit is a part of a massive propaganda exercise that is especially aimed at an international audience.

While Indian politicians have been prevented from visiting Kashmir, and obstacles have been placed in the path of journalists, in the past two months the government has organised conducted tours for members of European Parliament of the far-right persuasion and a clutch of foreign ambassadors in New Delhi. With US President Donald Trump expected in India sometime soon, the planned visit of a horde of Central ministers seems little more than a shoddily choreographed mind-bending exercise.

## Why snub for Jeff Bezos?

mazon founder-CEO Jeff Bezos' India visit, weeks before the gov-ernment's rollout of the National Ecommerce Policy, has led to headlines in both India and the United States. While the official reason for his visit was to inaugurate Amazon's engagement with small businesses, the government cold-shouldering the world's richest person by denying an appointment to meet either Prime Minister Narendra Modi or

commerce minister Piyush Goyal took away the focus of this visit.

The three-day visit, ahead of the announcement of the National Ecommerce Policy, seems aimed at lobbying for ease regulations for foreign players. In October, Doug McMillon, CEO of Walmart, which owns Amazon's competitor Flipkart, urged Mr Modi to ensure certainty and a predictable business climate in India. However, if Mr Modi denying an appointment is seen as a pointer, the government may act tough against foreign ecommerce players. The regulatory stance too has turned hostile to foreign ecommerce firms. Recently, the Competition Commission has begun a probe into deep discounts offered by Amazon and Flipkart.

It is, therefore, no surprise that Amazon's CEO tried a charm offensive by promising an additional billion dollars of investment to boost small businesses' sales on its platform. As a sweetener, Mr Bezos predicted vnorte from Indian emall businesses on Amazon's global platfo touch the \$10-billion mark.

While scheduling issues were blamed for Mr Modi refusing an audience, there was speculation that it was a reaction to the editorial stand by the Washington Post, the iconic American newspaper Mr Bezos owns, on India's actions in Kashmir and the controversial Citizenship (Amendment) Act. If this is the reason, the government should be advised caution as it should not forget that the UPA-2 government's woes started after it locked horns with Vodafone on retrospective taxation. Global investors want a stable policy and any deviation for political reasons would be counter-productive for the economy.





## Australia aflame: Doing nothing is consent for doom

f a picture is worth a thousand words, it was perhaps the indelible image of a scampering kangaroo silhouetted against a wall of fire on New Year's Eve that seared the ongoing Australian bushfire tragedy on to the international consciousness. In fact, the driest continent on earth has been alight since September, the onset of spring in the southern hemisphere calendar. The fires have been spreading ever since. Millions of hectares have been reduced to ashes. Bushfires have regularly recurred across Australia for thousands of years. But the extent and intensity of the past five months' seemingly unquenchable flames is unprecedented in living memory.

It is, or by now should be, common knowledge that climate change exacerbates natural disasters, in terms of frequency and ferocity. That scientific conclusion may be considered incontrovertible elsewhere but remains controversial in Australia. A couple of years ago, in his capacity as federal treasurer, Scott Morrison, infamously carried a black lump into parliament, where he declared: "This is coal. Don't be afraid. Don't be scared. It won't hurt you." Last month, in his capacity as prime minister, Morrison went on a holiday to Hawaii with his family, while the flames were getting higher in the country he is supposed to govern.

Everyone is entitled to a vacation, even if it's poorly timed, but to leave behind instructions, as Morrison apparently did, that his location must not be revealed to the media or anyone else goes beyond the pale of the proverbial Aussie "fair go". The

truth was leaked even before fellow Australian tourists in Hawaii had the chance to tweet selfies with a grinning prime minister.

The vacation had to be cut short, but when Morrison visited a few of the devastated communities, many of the victims did not hesitate to convey their true feelings in chaste Aussie slang. The unfiltered comments were a reaction not so much to his tendency towards climate change denial as to his insouciance, which included avoiding a meeting requested for months by the heads of nationwide firefighting outfits, who wished

to alert him to dangers they foresaw. Perhaps chastened by the rebukes and dwindling poll numbers, a seemingly contrite Morrison has hinted at changing course and offered to hold a public inquiry. There is no evidence

so far, however, of any intention to step up Australia's thus far dismal response to the multiple challenges posed by climate change — not least because the conservative coalition the prime minister represents is peppered with denialists and those interested chiefly in preserving the privileges, profits and export potential of the fossil fuel industry.

Such attitudes are not restricted to Australia, of course. The Paris Agreement may have outlined wholly inadequate measures for restricting global warming, but it obviously doesn't help when one of the world's biggest polluters pulls out and its chief honcho begins dismantling already inadequate environmental constraints. Australia experienced its hottest year on record in 2019, but it wasn't the only such country. Who

has ever heard of artificial snow being deployed to impart a festive semblance to New Year festivities in Moscow, or of temperatures soaring into the mid-teens in Norway at the height of winter, or of glaciers around Mount Everest making way for greenery?

Even nations far more alive than Australia to the threats that lie ahead are falling far short of the drastic changes required to curb the consequences of global warming. The tipping point was probably reached long ago in the relentless march to hell on earth. Immediately adopting green new deals may help to restrain the fires next time — or, more likely, the time after that. But doing next to nothing is a green light for doom.

## Soleimani: Lavrov-Zarif duet, Trump solo in offing

he presence in New Delhi of Iran foreign minister Javad Zarif and Russian foreign minister Sergei Lavrov provides just the sort of balance required to cope with the imminent Donald Trump visitation in the near future. Who knows, he may turn up with CEOs of Lockheed Martin and General Atomics whose dazzling Hellfire Missiles and MQ-9 Reaper Drones were employed in the murder of Iran's Gen. Qasem Soleimani and deputy head of Hashd al Shaabi or Iraq's Popular Mobilization Front, Abu

Mahdi al-Muhandis. It is unlikely that reverberations from Gen. Soleimani's assassination were not felt at the Raisina dialogue, which the two foreign ministers attended. Like Banquo's ghost, Soleimani will be present during the Trump visit, too. It is, therefore, important to understand the sequence leading to the ghastly murder in Baghdad.

As the post-Cold War world transited to the post 9/11 Islamophobia, New Delhi, by choice and circumstance, held firmly onto American coat tails, even putting up with an insult or two. Pakistan, and not India, was first incorporated into the global war on terror. US Ambassador Robert Blackwill was terse: "Yours is an old regional quarrel with Pakistan; that country is partnering us in our global war on terror." Only after the December 13, 2001, attack on

Indian Parliament, did New Delhi become a bonafide "victim of terror". It was a strange triangle: New Delhi and Islamabad were not on talking terms, but both were yoked in the US-led war on terror.

This was the state of play when in April 2003, George W. Bush was pushed into occupying Iraq by his neo-con drum beaters sketching designs of "full spectrum dominance" in the New American century. It was all very tempting when the Americans invited New Delhi to be their partners in Iraq which was now "theirs". Troops were readied but Atal Behari Vajpayee as the Prime Minister put his foot down: it was a foolish idea.

The real author of the Iraq expedition, vice-president Dick Cheney, choreographed his victory speech on April 9, 2003, to synchronise with the pulling down of Saddam Hussain's statue at Baghdad's Firdos Square. The celebrating Iraqis did not appear.

In desperation, Americans contacted Shia clerics like Muqtada Sadr. The cleric was an iconic figure in a Shia ghetto north of Baghdad named

Saddam city. Muqtada Sadr it was who mobilised Shias to come out in celebration, beating Saddam's photographs with *chappals* even as the marines pulled down the statue with cranes. In deference to this act, the occupying power renamed Saddam city as Sadr city.

Abu Mahdi al-Muhandis was clearly Soleimani's eyes and ears in Iraq. But he was only the second in command of the Hashd. Where was the leader of the Hashd, Falih al Fayyadh? Last month he had made a surprise visit to Washington to meet defence secretary Esper, the very same person who alerted Prime Minister Mahdi about the action which killed Soleimani, Muhandis and a host of others.

The information obtained by Esper directly may have encouraged him to believe that the anti-American line up in Iraq was a divided house. Even Muqtada Sadr's visit to Riyadh some months ago would have

been taken into this calculus. The consequence is that the assassination-in-a hurry has united even disparate forces in Iran, Iraq and the larger West Asia. It left Europe dazed, Britain embarrassed and the rest of the world wondering as to what would happens next. The only country to have expressed support for the action is Israel. And Israel is on notice by the leader of Hezbollah, Hassan Nasrallah.

Hezbollah, Hassan Nasrallah. Incidentally, New Delhi has been in interaction with Falih al Fayyadh. He arranged for the Institute of Defence Studies and Analysis to be affiliated with al Nahran Centre for Strategic Studies in Baghdad. Studies by IDSA will surely augment the pool South Block will require for the Trump visit.

Soleimani caused extreme discomfort to the US, Israel, Saudi combine not because he was plotting military actions. He was hated because by knitting together powerful proxies on the periphery of Israel and Saudi Arabia he had defeated an idea: the strategic faultline invented by US-Israeli strategists. salience gloated the new theorists. Sunni Shia was the new strategic faultline. The inauguration of the Kuala Lampur summit of Islamic countries, and the winning lineup in West Asia has altered the picture. US and its allies look increasingly cornered and isolated. In this Soleimani had a decisive role as he did in defeating ISIS much to the chagrin of those who had begun to see terror groups as an asset to be relocated from one theatre of conflict to the other.

Once the dust settles, Soleimani in his death will be seen to have achieved something he strove for: US departure from Iraq. A US field commander's letter leaked to Reuters suggests plans for an exit strategy. Ofcourse, the shooting of Air Ukraine carrying 176 passengers has altered the mood in Tehran. But the detention of the UK Ambassador, Robert Macaire among the protestors, places a question mark on the new demonstrations.

# Why are thermal power plants still being encouraged by the state of Telangana?



he climate crisis is slated to have a drastic effect on the economy. Although the Government of India and subsequently the state governments have made policies to address the problem, either by switching to renewables or thwarting fossil fuel power production, we are far from combating climate change and switching to renewables.

The states of Telangana and Andhra Pradesh are home to five of the top ten districts which are expected to face severe environmental consequences if the causes of climate change are not addressed. These states are gearing towards a climate catastrophe and the state policies aren't exactly helping. The national and state plans

The national and state plans start off by emphasising on the current abundance of CO2 in the atmosphere as compared to the year 1750, which now stands at 395.5 ppm. The document stresses that greenhouse gases (GHGs) need to be cut by 40-70 per cent by 2050, from the level in the year 2010, and that fossil fuels should be phased out completely by 2100.

As part of its National Action Plan for the 11th Plan period, the Government of India announced a domestic goal of reducing the volume of carbon emissions released per unit of the country's GDP. The government has outlined how "low carbon strategies will particularly require enhanced deployment of renewable and clean energy technologies, and capital finance for improvements in tachnelogy."

technology".

But, when it comes to Telangana, no such state emission targets have been set yet. It seems rather puzzling to know how the state's policies are laid out without an emission count

and target. Especially considering how the state of Telangana has been experiencing extreme weather events in the past few years in the form of climate variability, affecting its agricultural output, and leading to intense droughts, heatwaves and floods. In the year 2018, the state of Telangana lost "1,682 hectares of forest cover as negative changes in forest cover were observed in 410 forest compartments." With increasing emissions from the upcoming thermal power plants and decreasing forest area in the state, how will the state sequester the forthcoming emissions?

emissions?

Currently, the state of Telangana is at an installed capacity of 4,422 MW from thermal coal-based power

generation.

If you look back, in the year 2009, the Government of India directed all the state governments to draft a State Action Plan on Climate Change (SAPCC), in keeping with the approach laid out by the National Action Plan on Climate Change (NAPCC). So far, 28 states, including the state of Telangana, are known to have rolled out state action plans. (Environment Training Protection Research Institute) prepared the SAPCC for combined Andhra Pradesh, which was endorsed by the National Steering Committee on Climate Change, Ministry of Environment, Forest and Climate Change (MoEFCC) in 2013. After the bifurcation of the state, a state action plan was prepared for the state of Telangana in 2015.

The state action plan lays out the importance of how the state is being sourced by a mere 20 per cent of the total energy supply from hydropower projects, and outlines the importance of finding "renewable and noncoal based sources". The state action plan also outlines how the use of fossil fuel is the principal contributor to climate change. Over "81 per cent of the emissions from fuel production can be attributed to six states where coal, oil and natural gas

state of Andhra Pradesh. This month, the state government of Telangana exempted TS Genco from conducting a social impact study for acquiring 234 acres for the ₹20,000-crore 4,000 MW thermal power plant at Veerlapalem village in Nalgonda's Damaracharla mandal. Just last month, the Singareni Collieries Company Ltd (SCCL) in Telangana got the green signal for expanding its ₹5,879.62 crore thermal power project in the state, fi om the existing 1,200 MW to 2,000 MW capacity in Mancherial. With

these projects, the state will be

increasing its power generation capacity from 4,422 MW to 10,222 MW from thermal power plants

The state action plan also lays out an estimated budget of ₹3,425 crore from 2017-2022 for electricity generation using non-conventional sources.

Despite this, the renewable transition is suffering, and the state is actively gearing towards investment in coal-based power generation. With this active coal-based power generation, the state will experience a setback in its carbon emissions target, which is yet to be decided or even outlined in the State Action Plan documents. Studies have found that for every fossil fuel burned in India "at least three quarters of a ton of carbon is released as CO2. It has been found that 0.8-0.9 kg/kWh CO2 is emitted in Indian power plants". Moreover, emissions from combustion of coal are currently responsible for over 60 per cent of the enhanced green-

house effect.
Although Telangana's action plan has an estimated ₹312 crores for the promotion of affordable alternative energy sources i.e. solar home systems,

solar street lights, solar thermal systems, the renewable energy industry is slowly and gradually failing to make it in the market because of de-incentivisation from state governments of Telangana and Andhra Pradesh. For instance, the state of Andhra Pradesh has either lowered the energy tariffs for renewable energy or has stopped its generation altogether because of mounting dues. While all this is linked to the slump in economic growth, the effect, nonetheless, is on energy transition.

transition.

So, the bigger question here is, why is the state still pursuing thermal power generation instead of divesting the money towards renewables? While the state of Andhra Pradesh is still drafting its State Action Plan, the Telangana documents do not mention or suggest that there will be divestment from fossil fuel energy to renewable energy. Cutting down of fossil fuels energy production is not even a priority, and neither is replacement

Otherwise, I'm going to have Canadian security surveilling my cottage in Ontario as a node of Sussexite sedition. Yet maybe I had glimpsed something. A poll has suggested that 60 per cent of Canadians would support the appointment of Prince Harry as governor general. When the Sussexes announced their intention to spend last Christmas in Canada, Justin Trudeau tweeted: "You are always welcome here." He may not have intended "always" to mean "permanently"... but the invitation is in writing.

eventeen years ago, I was part of a presidential administration that chose war with Iraq. We had with us a broad international coalition, an authorising vote in Congress, majority support in public opinion. We were acting at the zenith of US power, at a time when and China had only barely become one. And still we failed to leave behind a stable, Western-oriented Iraq. In the weeks since Christmas, President Trump has been driving to a similar conflict with Iran. But Trump can claim none of the advantages behind George W. Bush in 2003: no support from Congress, massive public opposition, no international coalition, and a much less favourable international situation. Unlike the Iraq hawks of 2003, today's Iran hawks deny they intend a war. They say the plan is to squeeze Iran to the point where the Iranian people arise in democratic revolution. The Iranians themselves will change their regime. But violent revolutions seldom lead to liberal outcomes, in the Middle East least of all. The peace of the region may depend on Trump's impulsiveness. Last month, he unpredictably picked the harshest measure on a menu of options, a targeted killing of the terrorist-general, Qassem Soleimani. Back in June, Trump equally impulsively vetoed at the last minute a military response to the shooting down of a US drone. Who knows what he will do next? Certainly not him.

eanwhile, the peace of my house has been hugely improved by the completion of the last revisions of a new book about US politics after Trump (it is released on 5 May). I spent my first post-book weekend starting a long-awaited project to digitise our family photos. It's been very moving to scan my way through 30-plus years of marriage and the raising of three children. Every phase has been different; all have been sweet. Yesterday's task was the period 1993-95: the double toddler years. Almost every image of my wife's beautiful face is shaded by an expression of faint worry. Even when smiling on a beach, the worry appears in her eyes. As Danielle now says: 'The most beautiful sentence in the English language is, "The bathroom is over there."

y youngest daughter Beatrice is completing applications to university this fall. The looming departure casts gloom upon a house that has grown larger as the resident population has dwindled smaller. But at least we'll have tuition bills for company. A year at a prestigious private college such as Stanford and Princeton costs more than twice as much, after inflation, as it did in 1980. At a state school like the University of North Carolina or the campuses of the University of California system, tuition costs as much as 15 times what it did a generation ago. If young Americans seem in a Bolshie mood, it may be because so many of them are subject to Tsarist-style predation and exploitation.

The next weeks of the US political calendar will be crowded. Trump delivers the 2020 State of the Union on 4 February. If the impeachment trial is still pending, be prepared for an outburst of world-historical insanity. The British election of 2019 offers an obvious warning to Republicans as well as Democrats: unpopular candidates tend to lose. Trump is the most unpopular first-term president in the history of polling, the only president never to attain 50 per cent approval in any reputable poll. A plurality of Americans want him impeached and removed. Trump's fluke success in the 2016 College startled many pundits into doubting the usual rules of politics. Yet as former Romney campaign manager Stuart Stevens memorably reminds: 'The casino does not always win. Still, that's the way to bet.'

Geneva, Jan 16: More than half of millennials fear there will be a nuclear attack some where in the world within the next decade, according to a survey by the Red Cross released on Thursday. Of the 16,000 respondents, aged between 20 and 25, from 16 countries, some 47 percent believed it was more likely than not that there would be a third world war in their lifetime. "Millennials appear to see cataclysmic war as a real likelihood." Peter Maurer, pres ident, International Committee of the Red Cross, said in his foreword. The ICRC took note of "worrying trends", such as around 41 percent saying they would support torture of enemy combatants in some circumstances. Only 54 per cent had heard of the 1949 Geneva Conventions, to protect prisoners of war and civilians in war time. Maurer said the results also revealed "a worrying acceptance of dehumanising language or actions towards perceived or real enemies that is prevailing in an era of fake news, disinformation and polarised viewpoints". There was some optimism — 60 per-cent of Syrians polled believe the current civil conflict would end in the next five years. Syrians also had the highest support among respondents for showing humanity in war, with 85 per cent saying captured combatants should be allowed to contact relatives.

## Speaker Pelosi names managers for 'historic' trial as House submits Articles to Senate

Washington, Jan. 16: The US House of The US House of Representatives passed a resolution and submitted the articles of impeachment against Donald Trump to the Senate for a historic trial to remove him from office, a move described by the unfazed President as "another con job" by the Opposition Democrats.

The House, controlled by the Democratic Party, on Wednesday voted to send articles of impeachment against President Trump to the Senate, in a major development to remove him from office for his alleged abuse of power obstruction Congress.

In a 228-193 vote, which was mainly on party lines, the House appointed seven impeachment managers who will argue the Democrats' case for removing Trump from the office of the US President. managers named by House Speaker Nancy Pelosi. "We are here today to cross a very important threshold in American history," Pelosi said, addressing the House before the vote. "This is what an impeachment is about," she said earlier, announcing the sevenmember prosecution team led by Congressman Adam Schiff, chairman of the Permanent Select Committee on Intelligence.



## 45M need urgent food aid in S. Africa

Johannesburg, Jan. 16: Roughly 45 million people in southern Africa are in urgent need of food aid as a result of drought, flood-ing and economic hard-ship, the UN said Thursday.

"This hunger crisis is on a scale we've not seen before and the evidence shows it's going to get worse," World Food Programme (WFP) regional director Lola Castro said in a statement.

The agency warned that it had secured only \$205 million of the \$489 million it requires, saying families across the region were already skipping meals, taking children out of school, selling off precious assets and falling into debt to stave off agricultural losses. In southern Africa as a

whole - where temperatures are rising twice as fast as the rest of the world - people are experiencing the worst drought in 35 years, according to

Low growth, rising population, drought and floods have combined to worsen food insecurity in the region.

"If we don't receive the necessary funding, we'll have no choice but to assist fewer of those most in need, and with less," Castro said. — AFP

## PoK avalanches death toll 100

Muzaffarabad, Jan. 16: A 12-year-old girl was found alive on Tuesday after being buried in snow for 18 hours when an avalanche in Pakistan-occupied Kashmir engulfed the family house, her mother said on Wedne-

Samina Bibi recalled shouting for help as she lay trapped in a room under the snow.

The death toll from Monday's avalanches in Pakistan-occupied Kashmir's Neelum Valley, rose to 74, according to Pakistani officials, as rescuers continued to recover bodies.

Samina was one of the lucky ones. "I thought I would die there," she told from a hospital bed in Muzaffarabad, where she and dozens of other injured people receiving treatment after being airlifted out of the avalanche-hit area.

For Samina's mother,

Shahnaz Bibi, who lost a son and another daughter, the rescue was nothing short of a miracle.

After being pulled out of the snow earlier, Shahnaz said she and her brother, Irshad Ahmad, had given up hope of finding Samina alive.

Samina said she could not sleep while she waited to be rescued. Her leg was fractured and blood was oozing from her mouth.

For the family, the disaster happened very fast. "We didn't hear a rumble," Shahnaz said, recalling the moments before the avalanche buried the three-storey house where she and her family were sheltering with others from the village. At least 18 of them died.

Samina and her family were huddled round a fire when the avalanche hit. "It happened in the blink of an eye," said Shahnaz.

## Rain brings relief from Oz bushfires Volcano threat in

Melbourne, Jan. 16: Thunderstorms and rain across parts of bushfiredevastated eastern Australia brought some relief to the harried people and firefighters but posed a new challenge of flash floods.

The raging Australian bushfires, one of the worst in its history, burned over 10 million hectares of land, destroyed over 2,000 homes and pushed many species towards extinction, apart from claiming the lives of 28 people.

The air quality in Melbourne deteriorated to the "worst in the world" on Tuesday due to the smoke from the massive bushfires.

While 16 fires are still burning across Australia's Victoria state, thunderstorms on Wednesday night brought some relief from the dense smoke

In the state of New South Wales, where many of the worst fires have burnt, there were "good falls" on some blazes early Thursday, the local meteorology bureau reported. "Relief is here for a

number of firefighters

working across NSW"" the

state's Rural Fire Service said. Change in cooler weather conditions that hit the state came with new warnings for flash flood-

ing and dumping hail-

The rain is offering some relief for fire crews battling blazes, but there are concerns the wet weather could cause landslides, flash flooding and contaminate water, the Australian Broadcasting Corporation

reported.
Cool, wet conditions are good news for firefighters, who have been battling hundreds of blazes across the state since September, it said. A huge volume of rain from Wednesday has caused a sinkhole in Melbourne's north-west.

Sydney, Jan. 16: A secret operation by specialist firefighters has saved the world's last stand of Wollemi Pines, a pre-historic species known as "dinosaur trees", from Australia's unprecedented bushfires, officials said. Fewer than 200 of the trees exist in the wild, hidden in a gorge in the

World Heritage Mountains, northwest of Sydney, an area hit by one of the biggest bushfires that have ravaged much of Australia for months.

With flames approaching the area late last year, air tankers dropped fire retardant in a protective ring around the trees.

# Telcos get no relief from SC

The Supreme Court on Thursday rejected a plea by the telecom service providers (TSPs) for a reconsideration of the court's 2019 verdict that directed them to pay Rs 92.000 crore of past dues over sharing of adjusted gross revenue (AGR).

The TSPs that had sought a reconsideration of the order included Bharti Airtel, Vodafone Idea and many now defunct telecom companies.

Dismissing the TSPs' plea, a bench of Justice Arun Mishra, Justice S. Abdul Nazeer and Justice M.R.Shah said, "Having perused the review petitions and the connected papers with meticulous care, we do not find any justifiable reason to entertain the review petitions. The review petitions are, accordingly, dismissed."

With this, the court also rejected the plea for an open court hearing of the review petitions.

Bharti Airtel said it was disappointed with the Supreme Court's decision and it would evaluate filing another petition.

"The industry continues to face severe financial stress and the outcome could further erode the viability of the sector as a whole," Bharti said in a statement.

The internet service providers (ISPs) supported the TSPs and exhorted the government to step in immediately to review the definition AGR for the survival of the telecom sector.

"It is going to be a disaster for the telecom industry. Dismissal of review petition will lead to a duopoly situation, which is not good for consumers. Small ISPs will not be able to survive unless government steps in to review AGR definition," Internet Service Providers Association of India president Rajesh Chharia said.

Analysts were also worried about the development. "We wonder how weaker operators like Vodafone Idea will make this payment, and not that Bharti Airtel is getting any respite as the amount has to be paid up," said Gaurang Shah, vice president at Geojit Financial Services Ltd. "It isn't easy to raise tariffs and retain customers. It remains to be seen how companies now respond to this decision because the court has twice spelled it out for them.'

For two decades, the TSPs had challenged the way authorities calculated their AGR, a share of which is paid as licence and spectrum fees. But in October, the court upheld the government's method while rejecting the companies' plea to exclude revenue from non-telecommunications businesses

The top court by its October 24, 2019 verdict had directed the cashstrapped TSPs to pay up Rs 90,000 crore—around 3 per cent of AGR as spectrum charges and 8 per cent as licence fees.

The court had said that except for termination fee and roaming charges, all revenues coming to telecom service provider would be counted in AGR.

According to sources, the CBI has booked Adani Enterprises (Ahmedabad) and NCCF;'s former chairman Virender Singh, former MD G P Gupta and its senior advisor S.C. Singhal under IPC sections related to alleged criminal conspiracy and cheating and provisions of the Prevention of Corruption Act for allegedly favouring the Ahmedabad-based company in the tender and violation of guidelines.

Andhra Pradesh Power Generation Corporation (APGenco) had floated a limited tender enquiry for the supply of six lakh MTs of imported coal from sea ports to the Narla Tata Rao Thermal Power Plant in Vijayawada and the Raya-laseema Thermal Power Plant (RTPP) in Kadapa on



June 29, 2010, sources said. The tender enquiry was forwarded to seven public sector undertakings, including NCCF, a cooperative under the Union consumer affairs ministry.

The CBI FIR alleged that the NCCF officers "committed irregularities by way of manipulation in the selection of the bidders, thereby giving undue favour to Adani Enterprises Ltd in award of work for supply of imported coal to APGenco despite its disqualifica-

The CBI, sources said, alleged that NCCF's Hyderabad unit, which had alleged received the APGenco tender enquiry on June 29, had forwarded it to its headquarters in Delhi to Singhal. "The same day the head office selected a single party, Maharishi Brothers Coal Limited (MBCL), to transport the coal at a margin of 2.25 per cent, instead of floating an open tender to call for bids from the competitive bid-ders, citing lack of time as the deadline was July 7".

Six days later, on July 7, APGenco informed NCCF, Hyderabad, that the date of tender has been extended to July 12, following which allocation to MBCL was cancelled and an open tender was floated, they said.

Six bidders—Adani Ent-erprises, MBCL, Vyom Trade Links, Swarna Projects, Gupta Coal India and Kyori Oremin—responded to the NCCF tender on July 10, 2010. The bids were tabulated and sent to the headquarters by Hyderabad unit on the same day.

Gupta Coal India had quoted 11.3 per cent mar-gin for NCCF while MBCL had kept it at 2.25 per cent, but the remaining companies had not quoted any margin, it said.

'dark-fibre issue'. The former officials who have been absolved from the charges are the exchange's senior VP (operations) R Nanda-kumar, colocation head Jagdish Joshi, chief technology officers N Muralidharan and Ravi

The current officials of the exchange, who have been exonerated are its chief operating officer chief operating officer (trading) Mayur Sindh-wad, CTO-projects San-karson Banerjee, CTO-operations G Shenoy and VP-Regulations Supra-bhat Lala.

The order came after an investigation by the Securities and Exchange Board of India against several former and current NSE employees and stock brokers in the co-location matter. It was alleged that cer-

tain stock brokers were permitted to avail of point-to-point (P2P) dark fibre connectivity from Sampark Infotainment Pvt Ltd, a non-empanelled service provider, and the connectivity provided by this company conformed a latency ny conferred a latency advantage to a few brokers which resulted in substantial increase in their turnover during the period from April-August, 2015.

## **Goyal says Amazon not doing** India a favour by investing

Goyal said investors in e-commerce platforms should not try and look for loopholes in the existing framework of laws that regulate business in the country. "A probe into Amazon's activities has already been initiated and the company is not doing India any favours by investing \$1 billion in the country," Goyal said at the Raisina Dialogue here.
The Goyal's statements

comes at a time when the fair trade regulator Competition Commission of India (CCI) opened an investigation Amazon's business practices, which came under the radar after several small traders complained about the e-commerce behemoth's excessive sway over the market. Besides Amazon, another major e-com player, Walmart-owned Flipkart, is also being investigated by the watchdog.

On Wednesday, Bezos announced his plan to invest \$1 billion into digitising India's small and medium-sized business enterprises, with the company setting an aim of exporting \$10 billion worth of goods from India.

The country does not allow foreign investment beyond 49 per cent in multi-brand retailing and has not yet approved any application of overseas retailers. "The company

like Amazon may have put in a billion dollars but if they make a loss of a billion dollars every year, then jolly well will have to finance that billion dollar. So, it is not as if they are doing a favour to India hen they invest a billion dollars," Goyal said.

The minister further questioned why an e-commarketplace model, where a firm provides an IT platform for buyers and sellers, incurring huge losses, adding that it needs to be looked upon. "They are investing money over the last few years also in warehousing and certain other activities, which is welcome and good. But if they are bringing in money largely to finance losses, and those losses are in an ecommerce marketplace model," Goyal noted. The minister said India

allows foreign investin e-commerce marketplace model and in this model buyers and sellers are free to trade. but the marketplace player cannot own the inventory, or they cannot determine prices. "There are several established market rules for an e-commerce marketplace business in India and I think as long as everybody follows these rules, we very much welcome e-commerce into India," he added.

## Exchanges can launch options in goods

The Sebi has allowed stock exchanges to launch 'option in goods' in their commodity derivatives segment. It has also notified the product design risk management framework for the option. The 'options in goods' will be available in addition to 'options on commodity futures', which already exist in the market.

"Earlier, the underlying was the commodity futures. Now the options will be based on the spot price of the commodity. This will increase clarity, ease and make trading less uncertain," said less uncertain," said Himanshu Gupta, vice president and head of commodities and currenresearch, Globe Capital.
"This is a progressive

step towards integration of spot market with derivatives market. It will play a major role in stimulating agricultural marketing and enable farmerfriendly options prodsaid Narinder Wadhwa, president, Commodity Participants Association of India and CMD, SKI Group. Only those goods shall

be eligible as underlying for these options, on which the exchange either is already trading the futures contracts or is proposing to launch the

futures contracts on or before the day of launching option in those goods. These option contracts shall have same quality specifications, delivery centres, final settlement rice methodology etc. as in the case of corresponding futures contracts.

"The provision shall pave the way for launching options contract in commodities based on underlying spot market price and settlement through compulsory compulsory delivery. Option will reduce the risk for the hedgers, said Sanjit Prasad, managing director and CEO, ICEX, adding, "Options in agriculture commodities can prove to be an important tool to replace minimum support price intervention scheme of the government.' Exchanges willing to

start trading in options contracts with goods as underlying shall take prior approval of Sebi for launching such contracts. Exchanges will have to make necessary disclosures such as open interest of top 10 largest participants/group of participants in "option in goods" (both long and short) and the details of their combined open interest in underlying constituents.

The exchanges should also augment their monitoring and surveillance capacity, Sebi said.





## **Asiatic Society's 2019 Reprints:** Looking back at a glorious past

review

ndians are fond of mentioning their glorious past without knowing too much about it. Mythology generally is equated with historical knowledge. Curiously, this mindset was what the first Europeans encountered when they started setting up trading, and later ruling, establishments here.

The Hindus, the initial Europeans wrongly believed, belonged to an old pagan race, whose beliefs and past were nothing more than a motley collection of superstitions and folk tales. It was only with the coming of the first Orientalists, such as the famous William Jones who established the Asiatic Society in Calcutta in 1784, that the dust began to be cleared over India's truly remarkable past, its histories, philosophies and body of forgotten scientific

knowledge. Men like William Jones who came as part of the English ruling contingent to India where men of the Enlightenment and were intensely curious about antiquities, new worlds and discoveries. India proved to be an unparalleled treasure trove. The East India Company's first gover-nor-general, Warren Hastings, was himself an Enlightenment man, an associate of men like Benjamin Franklin, Joseph Priestly and others, and a great patron of literate men in Bengal.

It was the patronage of Hastings and the vision of Jones that led to the creation of the Asiatic Society. Both men sought out Indian savants, Hindus, Muslims, Buddhists and more, to learn from them about India's past and true beliefs. These men commissioned maulanas and pundits to translate important historical, religious and juridical works into English. Among the first books to be trans-lated was the Bhagavad Gita, the laws of the

Gentoos, Muslim law and so

The meticulous translations of Sanskrit, Persian, Urdu, Bengali, Tibetan and other works opened up India's past to the rest of the world. It also proved that India has heir to an astonishing, ancient and highly sophisticated culture, far from the pagan, superstitious worldview suggested

by the average Hindu. The Royal Asiatic Society of Bengal, as it was called during British times, was the single most important institution for the identification, translation, collection and annotation of Indian historical treatises. More than two centuries of hard work, patronage and one of the largest repositories of ancient texts in the


130,000 volumes, all of which are housed within the Asiatic Society in Kolkata's

For many years, the society had endured neglect and a sad decline in academic interest. It is of great significance that the society is now showing signs of revival. Most notable is the new 2019 catalogue which shows evidence of several reprints and lists more than 300 classic works.

A large number of rare books long gone out of print have been reprinted after a gap of several decades. This is a great relief for scholars, book lovers and those interested in our exceedingly interesting past. There is also a handful of

new publications including "Persian Studies under the Sultans of Bengal", by Gholam Sarwar, which contains several essays on the Persian language, administrators, Sufis and sultans in medieval Bengal.

But the catalogue's real gems are the classical translations handed down to us over the decades by scholars long departed and usually

forgotten. Many of these have been classified by the Asiatic Society under its "Bibliotheca Indica" series which is composed of orienworks translated into

From this collection, I picked up a strange little book called the *Qanun-i*-Humayuni of Khwandamir, written originally Persian in 1535 during the reign of the Mughal emperor Humayun. This work was translated into English by the Indian scholar Baini Prashad, and printed by the society in 1940. The account provides a fascinating view of life during Humayun's times and his strange inventions including palaces of barges of the river Yamuna, his division of his administration into those looking after jurisprudence and the-ological matters, military and administrative matters and, of all things, a ministry

of mirth. Among other classics written in Persian would include the *Tabakat-i-Nasiri* of Aby Umar Usman, the Tabaqat-i-Akbari, Ma'Asir-i-Alamgiri, Abu Fazl's famous Ain-i-Akbari and the Ma'athir-ul-Umara. Many of these works are today available in reprints by various publishers, but the society's catalogue

reminds us how they came

into common circulation. The Ma'athir-ul-Umara, which lists the names and titles of important Mughal officials during the period 1556-1780, was originally composed in Persian by Nawab Samsam ud Daula Shah Nawaz Khan and his son Abdul Hai Khan. This voluminous work was painstakingly translated by the scholar H. Beveridge, and then later revised, annotated and completed by the redoubtable Baini Prashad in 1941.

Another classic is the Tabakat-i-Nasiri, written by the Afghan from Ghori, Minhaj-i-Siraj. This happens to be the oldest history of Muslim Bengal covering the first century and a half following the conquest of Bengal by Bhakhtiyar Uddin Khilji. It was translated into English by Henry George Raverty and published in 1864

The men and women behind these priceless

were not just remarkable scholars of the past but also fascinating individuals in their own right. For instance, Henry George Raverty (1825-1906) came to India as an infantry officer and fought in a number of campaigns, including the ones in Punjab (1848-49) and Swat (1850). During his stay in Peshawar, he learnt Pushto and later Persian. This began a long and illustrious career in Orientalist studies. He translated over a dozen significant works into English and kept up his passion all his life after retiring to his native England. Similarly, there is the lit-

tle-known Scotsman who first translated the Ain-i-Akbari into English, signing his works under the name of H. Beveridge. He was actually a senior British administrator and later judge, Henry Beveridge (1837-1929). His major works include "The Trial of Maharaja Nanda Kumar, A Narrative of a Judicial Murder (1886)", and he is best known for his superb translation of the Akbarnamah and Ma'athir-

Baini Prashad (1894-1969) was an unlikely scholar of ancient manuscripts that he helped translate, rectify and annotate. He was primarily a zoologist more interested in the mating habits of fish and the behaviour of molluscs and the like. He was the first Indian director of the Zoological Survey of India. His fertile interests, which included knowledge of the Persian language, at some point led him to take up the job of correcting and revising the English translation of the Ma'athir-ul-Umara of Beveridge.

To peruse the catalogue of the Asiatic Society therefore is also to travel back to the time of outstanding scholars and an age of rediscovery of India's splendid past. The new catalogue is a treasure, and one can only hopes that the Asiatic restores reprints more of its many critical works.



One of my walking routes recently in the rural south of France was a disused rail-track that once connected Carnoules, Brignoles and Aix-en-Provence. A tourist train occasionally plies on this route in peak summer season, otherwise the tracks are overgrown with auburn weeds and wild flowers that glow golden and ochre in

the late evening light. The track is maintained intermittently by the military because of its strategic importance — and if it weren't for them, the shrubbery and adjoining forestry would have completely covered the rail-lines (as it already has over many stretches) — and unless you had prior historical knowledge of their existence, you would not even know that the lines were there.

There is something otherworldly about walking on abandoned tracks, something that reminds you of your childhood reading of Enid Blyton's Famous Five or Secret Seven or similar adventure-mystery stories of the time.

My walking point started at the outer limit of Carnoules village, at times towards Aix, and on other

days towards the lake village of Besse. It was also the point where the electrification abruptly ended, as if suddenly arrested, without any apparent reason. Perhaps this was the dividing line of the axes of power during the Wars sign of technological advancement stalled due to political histories or commercial needs of the time.

track went **t**hrough several twists and turns — its disappearance, its languid curvature and the relics of abandonment most interested me. As I walked on the cracked wooden sleepers, I noticed variety of nails, rivets, bolts, fishplates and other fasteners that held the rails down. They were individually etched in robust industrial fonts with letters and numbers — RM, PM, CS, 53, 55, 58, 72 — part of a very complex and intricate analogue of railway-codes.

Many of these metal and wooden bits had come loose over time and with disuse. I collected some of these little remnants — the errant pieces stained my bare hands with a strong aroma unique only to the locomotive world. The metal possessed a fresh, pungent, engine-oil smell typical of the steam or diesel engines of the past. Even rust and time had not been able to erase this sharp scent. A few miles on, I found a dis-

dagger-shaped

engaged,

ded with its own stories. For decades now, the railway-signal lights here have been permanently red, the green and amber blackened out by dirt, cobweb and lack of electrical power. The single, semaphore, outstretched paddle-arm has not moved its limb-position

for years, or even witnessed the once-regular drills — a balletic, coordinated series of shunting exercises that engine and wagons engage in to keep movement fit on tracks. What does one do with memory and objects that accompany them? Either

you leave them where they

are and let them slowly erode and vanish with time; or if you are nostalgic, collect the relics as talisman. So my collection includes a wooden sleeper-shard, some crooked nails, rivets and other metallurgy and many photographic images recording the track's length. These are the only tactile elements left to preserve the history, albeit a fractional and personal one. But at least the abandoned steel felt the touch of life again, a human hand that found it worthwhile to resurrect their narratives.

When I put my ear to the metal of the rail tracks, I can still hear the rumbling roar of a distant defunct train and the shrill tweet of the whistle of a steam engine that pulls the coachwagons. Whether it is in my imagination or reality, it does not matter - what matters is memory itself. Tom Waits wrote, "Their memory's like a train: you can see it getting smaller as it pulls away.'

Even at the height of the Mutiny of 1857, Bahadur Shah Zafar promised Indian owned railway tracks for native merchants if Badshahi rule was restored in Delhi.

The depth of their mental preparation was seen in the way the Aussies dismantled India in Mumbai, a rare feat of upending India in a first game because teams usually take a while acclimatising to India. Of course, this is the IPL era in which touring India is no more an exotic adventure and playing cricket on its pitches not experiments in futility. The Aussies know Indian conditions well and they had proved it last time too when they came from 2-0 down to win 3-2 in ODIs last year.

The margin of the Mumbai defeat might have seemingly shamed Team India. But its chances of coming back strongly to even win the series are not to be discounted. The one missing factor was a sense of adventure in the batting, which Shikhar Dhawan alone was able to bring in, even if he played a disproportionate number of dot balls. Dhawan's prowess in the white ball is not to be doubted again, particularly against an opponent like Australia who can put pace to the ball off the pitch. Dhawan might not be a sensation in T20 cricket, but he must be given his due in the 50-overs game.

There was just a feeling that Dhawan's return would muddle up India's plans in the white ball game as he seemed rot have become a bit of a laggard. However,
