AFTER PRESIDENT REJECTED MERCY PLEA OF ONE CONVICT

February 1 is new date for hanging of 4 convicts in Dec 16 rape case

THE DATE to hang four convicts in the December 16, 2012 gangrape and murder case has now been fixed for February 1, after a Delhi court Friday issued fresh death warrants.

The court had earlier set January 22 as the date of execution, but convict Mukesh, through lawyer Vrinda Grover, moved an application to postpone the date, arguing that death warrants were unexecutable in light of him filing a mercy petition with the President.

to file, while the others are silent. These are delay tactics. How far can it be stretched, I do not know". However, A P Singh, appearing for Akshay and Pawan, claimed that he has been asking for documents to file mercy pleas, but the same has not be handed over to him by Tihar Jail authorities.

They were convicted and sentenced to death in September 2013. This was upheld by the High Court in March 2014 and by the Supreme Court in May 2017.
