The Cabinet recently approved promulgation of Mineral Laws (Amendment) Ordinance 2020 to amend Mines and Minerals (Development and Regulation) Act 1957 and Coal Mines (Special Provisions) Act 2015.

### NCLAT asks DLF to register transfer of shares to investor's legal heirs

THE NATIONAL COMPANY LawAppellateTribunal(NCLAT) has directed leading real estate playerDLFtoregistertransferof 60,000 shares to the legal heirs of one of its deceased shareholders and has imposed a cost of ₹5 lakh for "harassing the poor investors".

A three-member bench observed that DLF insisted again and again for affidavit and indemnity bond in spite of having a Letter of Administration for succession, and the action by the real estate firm deserved penal action. "We note that the appellant (DLF) is a listed company in real estate and is very well aware of legal formalities.
