GoAir suspends flights, cites shortage of aircraft

GoAir has announced the suspension of several flights owing to non-availability of aircraft. The shortage is due to grounding of planes for lack of engines and nondelivery by the aircraft manufacturer. The airline, however, did not specify the number of flights cancelled or the number in shortage. The demand-supply gap in aircraft will last till March.

Jail officials not handing over documents to file mercy plea'

Nirbhaya case convicts' lawyer moves Delhi court

An advocate appearing for three of the four death row convicts in the 2012 Nirbhaya gang rape and murder case moved a Delhi court on Friday alleging that the Tihar iail authorities are not handing over certain documents and this is causing delay in filing their mercy and curative petitions.

A.P. Singh moved an application alleging that the jail authorities are yet to give the documents which are required to file the mercy petition for Vinay Kumar Sharma, 26, and curative petitions for Akshay Kumar Singh, 31, and Pawan Singh,

The plea is likely to be taken up for hearing on Saturday.

The Supreme court recently dismissed the curative petitions of other two con-

Mukesh's mercy petition was rejected by the President earlier this month. The hanging of all four is to take place on February 1 at 6 a.m. according to the court order.

In his petition, the lawyer said he had expressed "an urgent will to file a mercy petition before the relevant authorities and undertook several steps to obtain relevant information to file it".

Indian scientists must try to work on interesting subjects'

Potential to do crucial work in the country: Nobel laureate

Young scientists in India should work on doing "important and interesting" science and it was possible to be based in India and do groundbreaking work without "lowering the level" of the science attempted, Nobel Laureate and President of the Royal Society Venkatraman 'Venki' Ramakrishnan, said at a lecture here.

His talk, 'My Adventures in the Ribosome' was delivered as part of the 10th edition of the TNQ Distinguished Lectures in the Life Sciences 2020. "There are a wealth of problems considering the biodiversity of India that need investigation,"

His address focussed on his contribution to the role of deciphering the structure of the ribosome. This is the biological machinery necessary to transform the genetic code, which is stored as DNA, into proteins that go

on to make up our bodies and sustain its processes.

Dr. Ramakrishnan referenced heavily from his memoir, The Gene Machine, to narrate personal anecdotes: about switching from physics to biology as a graduate student because he intuited that he'd likely be able to make a significant contribution, as well as reflect on the practice of science saying, 'Scientists are neither Spocks nor saints". He added that the "Nobel is mistaken for greatness."

The Nobel laureate dwelt

on the rivalry among scientists around the world to decipher the structure of the ribosome. Groups in Israel and at Yale University, at various points, appeared to have a lead on his group. So he took the "risky" step of moving to a new country the United Kingdom - and taking a 40% pay cut. However, the decision paid off as he was able to solve the structure of the ribosome and was instrumental in bringing to a wider audience the significance, Dr. Ramakrishnan said.

Urban areas are likely to receive a renewed focus under the government's ICDS programme, which provides for anganwadis or day-care centres across the country for delivery of nutrition and pre-school education.

The government's think tank, the NITI Aayog, has prepared a draft working paper, which once approved would be circulated to different ministries for consultations. These include the Ministry of Health and Family Welfare, the Ministry of Women and Child Development, the Ministry of Urban Housing and Affairs and the

Ministry of Drinking Water and Sanitation.

'Health and ICDS models that work in rural areas may not work in urban areas because of higher population density, transportation challenges and migration," a government official familiar with the deliberations, who spoke on condition of anonymity, told The Hindu.

'Other models'

"Because of these issues it may not be possible for a community worker to keep in contact with the beneficiaries, which she is able to achieve in rural settings. We have seen some models in India, and in other countries

and we are trying to synthesize learnings from those," the official added.

According to government data from 2018, of the 14 lakh anganwadis across the coun-

try there are only 1.38 lakh anganwadis in urban areas. The Integrated Child Development Services (ICDS) provide for anganwadis or daycare centres which deliver a package of six services including supplementary nutrition, pre-school non-formal education, nutrition and health education, immunisation, health check-up and referral services to hospitals.

Urban challenges

The first-ever pan-India survey on the nutrition status of children, highlighted that malnutrition among children in urban India is characterised by relatively poor levels of breastfeeding as mothers have to travel long distances for work. It also found a higher prevalence of obesity because of relative prosperity and lifestyle patterns, along with iron and Vitamin D deficiency.

Avani Kapur, a policy researcher, said improving infrastructure in urban areas would be key as the government embarks on improving service delivery under the ICDS programme.

"One thing which will be crucial for anganwadi services in urban areas is strengthening safety and infrastructure," said Ms. Kapur, Director at Accountability Initiative of the Centre for Policy Research.

CJI wants speedy resolution of cases

Bobde lays emphasis on tax disputes

Lower pendency of cases inspires public faith in the judiciary, and the use of technology, including Artificial Intelligence (AI), in the judicial work can help in speedy justice, but it can never replace human discretion in just decision-making, Chief Justice of India S.A. Bobde said on Friday.

Speaking at the 79th foundation day of the Income Tax Appellate Tribunal, he said that while tax evasion was injustice to fellow Indian citizens, arbitrary or excessive taxation resulted in social injustice by a government.

He said speedy resolution of tax disputes would act as an incentive to taxpayers



Plea for judicial probe in custodial death cases

SC seeks government's response

The Supreme Court on Friday asked the government to respond to a petition seeking implementation of Section 176(1A) of the Code Criminal Procedure, which provides for mandatory judicial inquiry in cases of death, disappearance or rape in police and judicial custody.

A Bench led by Justice Rohinton Nariman issued notice to the government on the petition made by activist Suhas Chakma, who pointed out that since the enactment of Section 176(1A) in 2005, the National Human Rights Commission has recorded 24,043 custodial deaths/rapes between 20052006 and 2018-2019.

Mr. Chakma said the National Crimes Records Bureau's annual reports from 2005 to 2017 state that judicial inquiry was not conducted in about 80% of the cases recorded by it. The reports further state

that with respect to 476 cases of "death or disappearance of persons remanded in police custody by court," 266 cases were registered and 54 policemen were chargesheeted, but not a single policeman was convicted. Out of the 827 cases of death or disappearance of persons in police custody without court remand, judicial inquiry was ordered only in 166 cases – 20% of the total cases.

Raids at hotels uncover assets worth ₹1,000 cr.

The Income Tax department's searches of the Bharat Hotels group, which runs the Lalit Hotels chain, has uncovered more than ₹1,000 crore in undisclosed foreign assets, according to government

sources. An official statement from the Finance Ministry said that the search operation was conducted on January 19. Organised against a leading hospitality group, the operation also found domestic tax evasion to the tune of ₹35 crore. While the statement did not name the group, government sources confirmed that it was the Bharat Hotels group, under the leadership of Chairperson and

Assets abroad

The search operation has so far resulted in the seizure of unaccounted assets valued at ₹24.93 crore, including ₹71.5 lakh in cash, jewellery worth ₹23 crore and expensive watches valued at ₹1.2 crore, said the statement. Foreign assets include investment in a U.K. hotel, immovable properties in the U.K. and the UAE, and deposits with foreign banks.

"Evidence seized during the search reveals that a large amount of black money was stashed abroad by the group, through the mechanism of Trusts, formed in early 1990s in tax havens," it said.
