### 4 Nirbhaya case convicts to be hanged on Jan. 22

Court issues death warrants on a plea by victim's parents

All four convicts in the December 16, 2012, Nirbhaya gang-rape and murder case will be hanged on January 22 at 7 a.m. inside Tihar jail, a Delhi court ordered on

Tuesday. Additional sessions judge Satish Kumar Arora issued the death warrants for convicts Mukesh, Vinay Sharma, Akshay Kumar Singh and Pawan Gupta on a plea by the victim's parents to expedite their execution.

Before passing the order, the judge conducted a video conference call with the convicts, who are lodged in Tihar, to hear their side of the argument.

The victim's mother, who was present in the court when the verdict was pronounced, said the decision would restore faith of women in the judiciary.

On December 18 last, the Supreme Court dismissed a review petition filed by conupholding his death penalty. In July 2018, the top court


#### **Options** running out

All four convicts in the Nirbhaya case will be hanged in Tihar jail on January 22, with a judge issuing their death warrants

- The convicts can still move the Supreme Court through a curative petition before the date of hanging
- They can also seek pardon from the President
- The Delhi Prison Rules specify a minimum of 14 days between the receipt of the communication of the rejection of the mercy petition and the scheduled date of execution. This is to enable the prisoner

sentenced to death to prepare himself, settle his affairs and meet his family members for one last time or to avail himself of any remaining judicial

The Supreme Court guidelines state that the iail administration has to also inform the family members of the convicts about the scheduled date of

## Charges against student leader, but none held for JNU attacks

Aishe Ghosh, 18 others charged with vandalising server room on campus

Forty-eight hours after masked goons attacked students and teachers on the campus of the Jawaharlal Nehru University (JNU), the Delhi police are yet to make any arrests in the case.

Instead, they have registered two FIRs against injured president of the JNU Students Union (INUSU) Aishe Ghosh and several others for allegedly attacking security guards and vandalising a server room on January

The two FIRs against Ms. Ghosh and the others were registered at 8.44 p.m. and at 8.49 p.m. on Sunday even as the masked intruders were going around the campus beating up students, entering hostel rooms and ransacking them.

#### Faculty plaint ignored

No FIR has been filed by the police so far on a written complaint filed on Monday by a JNU faculty member, Prof. Sucharita Sen, who suffered head injuries during the attack. In her complaint, which has a copy of her med-

ical report from the AIIMS, Prof. Sen has demanded that the police register an FIR that includes attempt to murder among other sections of the law.

The FIRs say a large number of student agitators, including Ms. Ghosh, Saket Moon and 18 others, allegedly entered the Communication and Information Services (CIS) office located in the administration block by "breaking" a glass door. They trespassed and damaged the fibre optic cables, servers and biometric devices and "attacked" security guards, the FIRs say.

In a video posted online on Monday, a fringe rightwing group, Hindu Raksha Dal, claimed responsibility for the attack.

The video shows a man, identifying himself as Pinki Chaudhary, saying that those who resort to "anti-national activities" will be treated in the same way that JNU students and faculty were.

### Government projects slower GDP growth

5% estimate in line with RBI forecast

The government expects the country's gross domestic product (GDP) to grow at a slower pace of 5% for the full year 2019-20, as compared to 6.8% in the previous year, according to the first advance estimates released by the Statistics Ministry on Tuesday.

This estimate is in line with projections made by the Reserve Bank of India, which had revised GDP growth downwards to 5% for 2019-20 from 6.1% during its October policy.

As per the data, the manufacturing sector is estimated to grow by 2% as compared to a robust growth of 6.9% in 2018-19. Likewise, the growth in the construction sector for the fiscal is expected to see a sharp decline to 3.2% as against a growth of 8.7% in the previous year. Economic growth slowed

# Kicked, abused in police custody, says Sadaf Jafar

Darapuri claimed he was denied a blanket in the cold and was also not provided food for 24 hours

Congress worker and social activist Sadaf Jafar on Tuesday alleged that not only did male police officers assault her in custody but they also subjected her to communal slurs and humiliation and asked her to "go to Pakistan".

"They said 'you are a Pakistani'," Ms. Jafar told The Hindu after being released from jail, more than two weeks after her arrest following the violence during the protests against the Citizenship (Amendment) Act in Lucknow

"They said 'you eat here but sing songs of Pakistan. What have we not provided to you people? You are doing jobs here, getting to eat and also produce kids'," she

Ms. Jafar, a single mother with two minor children, said the police accused her of re-



ceiving funds from Pakistan. She claimed that when she begged the police to allow her to inform her family of her detention on December 19, a male police officer beat her up while women constables slapped her multiple

"I didn't have any [warm] clothes. They [police] refused to give me a blanket and food," the septuagenarian said. The police also did not record his statement at the police station and fabricated it, he alleged.

Mr. Darapuri, who is also an Ambedkarite activist, said the arrests were an attempt by the government to suppress the voice of activists.

'The government was rattled by the manner in which the entire country opposed the law and adopted a tactic of suppression. They sent political and social activists to jail with the strategy that it would leave protesters outside without anyone to guide them. But the government has failed in it," he said.

Mr. Darapuri was under house arrest on December 19 but was arrested the following day. During his house detention, he had posted on Facebook a photo of him holding a placard, which read "Save citizenship", to express solidarity with the protesters.

He said he would continue to exercise his "democratic right to protest till the law [CAA] is withdrawn".

### With what confidence will students go to universities?'

AAP national convener and Delhi Chief Minister Arvind Kejriwal, while addressing the seventh town hall meeting on Tuesday, asked with what confidence will students go to universities.

He also accused the Central government of giving orders to Delhi Police to not take any action.

The seventh town hall meeting, part of AAP's election campaign, was anchored by Aaj Tak, a Hindi TV news channel.

Talking about the violence in JNU and Jamia Millia Islamia, he said: "I am too worried. The way violence is happening in universities, that is not good. Children go to university to study... The way students were attacked inside Jamia and the violence that happened in JNU, I am very worried."

#### 'L-G assured to inquire'

"With what confidence will the children go to universities? Soon after the incident, I had spoken to the L-G and he assured to inquire into it. There should not be violence in universities and colleges. Whatever must be done on this, everyone should do it together," he said.

Accusing the Central government, the Delhi CM said: "Delhi Police is capable, constables are capable. But order is given from above "just stand there don't take any action"."

The three-member committee includes, senior party leader Atishi as the chairperson, Vice Chairperson of Dialogue & Development Commission (DDC), Jasmine Shah and party spokesperson Ajoy Kumar as the members.

"All the three members will incorporate suggestions of people and the vision of our party while preparing the manifesto. The manifesto will be released between

January 15 and 20," said senior party leader Gopal Rai while addressing a press conference.

Mr. Rai said that issues highlighted by AAP chief Arvind Kejriwal during his town hall meetings such as cleaning the city and finding a solution to traffic congestion would be part of the manifesto.

The party also said that

they have reached out to 30 lakh households with the 'AAP ka report card' and also distributed it to about 13 lakh people during 650 mohalla

sabhas since December 26.

On December 24, the party had launched 'AAP ka report card', which describes the top 10 achievements of the government in the last five years and had set a target to take it to 35 lakh households. From December 26, the party has been taking it to households and mohalla sabhas held in all Assembly constituencies.

'We have reached out to 30 lakh households with the the report card. Will complete it by January 10," Mr. Rai said

Over two weeks before the Election Commission of India on Monday announced that the Delhi Assembly elections would be held on February 8, Delhi BJP president Manoj Tiwari told a television channel on December 18 that Chief Minister Arvind Kejriwal and the Aam Aadmi Party's fate would be known on February 8. After the Congress on Monday questioned whether Mr. Tiwari decided the election date, the ECI on Tuesday termed the allegation incorrect.

Sharing a video clip of Mr. Tiwari speaking at the News 18 Chaupal event, Congress spokesperson Randeep Surjewala said in a tweet on Monday night:

"The nation knows CBI, ED, DRI, CBDT and Income Tax are permanent allies of Modi-Shah duo! Has ECI joined the bandwagon with Manoj Tiwari? Delhi wants to know - Delhi polling dates were decided by ECI or in advance by Manoj Ti-

wari? Tiwari decides, ECI

When asked whether any complaint had been received in the matter and for comment on Mr. Surjewala's allegation, an ECI spokesperson said: "No complaint received by ECI. Such averments are factually incorrect."

Tiwari's response On his part, Mr. Tiwari rejected the allegation.

"This is an attempt to spread misconception among the people. What I said was that the result would be out on February 8 - but I have clearly been proved wrong since the results will be out on February 11. What was said was based on the dates of the previous elections. Everyone has a right to speculate," said Mr. Tiwari.

### Model code in place, civic bodies told to enforce provisions

Two complaints related to violation of code received so far over certain TV programmes, says CEO

With the announcement of the dates for the Delhi Assembly elections on Monday, the Model Code of Conduct (MCC) has come into place, Chief Electoral Officer (CEO) Ranbir Singh said on Tuesday.

All government depart ments have been instructed to take down political posters and images of political leaders from their websites and social media accounts within 24 hours, the CEO said.

All five urban local bodies of the city have also been instructed to enforce these provisions which primarily deal with enforcement of the anti-defacement law, the CEO said. This includes ensuring all such defacement is removed from private property as well within 72 hours. The MCC also provides that

Commenting on the impact of violent clashes during the election process, Mr. Singh said that there was no reason to believe that the law and order situation in Delhi was not conducive to carry out elections. He added that the police would keep a check on the same and would make provisions to ensure safety. With regard to whether there was any provision to call off the elections if the law and order situation deteriorated, Mr. Singh said that it would be the prerogative of the ECI.

### No need for binoculars, just look up to find CCTVs: AAP

## 'It breaks my heart to see JNU go down this way'

Professor Sucharita Sen recalls how masked attackers barged into campus and unleashed violence on a 'peace meeting'

Nursing her head injury while sitting at her friend's house in south Delhi on Tuesday, Professor Sucharita Sen, who has become one of the faces of the violent attack that took place inside Jawaharlal Nehru University (JNU) on January 5, said that the "regime (JNU administration) had completely disconnected with the students and

teachers". "For the first time, there is a regime (JNU administration and Vice-Chancellor) which has no relationship with the students and teachers. I do not think that the V-C, today, can turn around and say that these are my students and my teachers. It breaks my heart to see JNU going down this way," she said, adding that there have been V-Cs with whom teachers and students have disagreed and dissented, but there was never a lack of communication.

#### No security

Recalling the day of the attack, Ms. Sen said she noticed something unusual the absence of security from the peace meeting on Sunday. The professor said that whenever there has been a call for any gathering, there are security officials around. but on Sunday "I did not see any, which was strange".

Due to scuffles on campus over the past few days, the JNU Teachers' Association (INUTA) had called for a peace meeting on Sunday evening where they advised students to not indulge in violence. While the meeting was under way, a student came and informed Ms. Sen that a large group of people wearing masks and carrying sticks had entered the campus from the main gate and was coming towards Sabar-



mati T-Point where the meet-

ing was taking place. Ms. Sen's colleague Amit Thorat then took his bicycle and went to check. A while later, he came back running and told them that he had been thrashed by the mob and had to leave his bicycle behind. "We decided to form a human chain... the women came forward thinking that the group would not attack women. We had thought that group would show some respect for teachers. But I now realise that this thought process does not apply to them because they did not want to scare anyone... the attack was murderous".

As the violence ensued, Ms. Sen was attacked with a stone that she said was about half the size of a brick.

A student on a two-wheeler and a colleague came to her assistance and tried to get her to a hospital but they were stopped at the university's main gate.

"There were police on one side and a very aggressive group on the other. I was unable to register much but the student I was with kept arguing with the aggressive group to let us leave but we were not allowed to do so. The police did not intervene and kept watching. This is not the kind of police I want my country to have. They didn't even facilitate the movement," she said.

Ms. Sen was then taken to the health centre on campus and was later shifted to a hospital in her blood-soaked clothes.

The professor came to the university as a Master's student in 1984 and started teaching in 1997.

"JNU taught me what it means to be an Indian as the university is a microcosm of India with people from varying backgrounds. It teaches me and I am sure others too that there is no one way of living, there are 100 valid ways," she said.

She admitted that the university has been changing in significant ways and that the democratic structure of the institution was crumbling.

The kind of violence seen on Sunday was unthinkable, she said, adding: "Three years ago, we didn't even know 'V' of violence. There were strikes, dissent and protests but no violence. I'll forgive them for thrashing me but I'll never forgive them for turning my university - a safe space - into a space of terror".

### Police appeal for information



Commenting on the university's statements after the incident, which suggested that the people behind the violent attack were students who were protesting against the fee hike, Mr Kumar said that on January 3, students with masks had attacked JNU's server rooms to derail the registration process.

"These masked students damaged the data centre to prevent hundreds of students from registering and had a clear intent to stop the academic functioning of the university," he said, adding that the investigation would tell whether the same students were behind the January 5 violence.

He added that since registration for the new semester reopened on Tuesday, over 2,800 students had paid their hostel fee, "which shows that students want to resume their academic life".

Reacting to allegations that he had not reached out personally to injured students and faculty members, the V-C said that several administration officials had contacted students and staff.



### BJP wants to make JNU an election issue: Kanhaiya

'The party has no work to show or a chief ministerial face to project ahead of the Delhi Assembly polls'

Former Jawaharlal Nehru University Students' Union (JNUSU) president Kanhaiya Kumar alleged that the January 5 attack on the university was an attempt to create an election issue for the BJP as it did not have much work to show or a chiet ministerial face to project ahead of the Delhi Assembly elections.

"It has been four years since the February 9 incident in JNU and they did not manage to prove anything. Now, just ahead of the Assembly elections, Home Minister Amit Shah brought up the issue on Monday at a public event as he wants to make JNU an election issue by defaming it and divert attention from the real issues," Mr. Kumar said. A sedition case has been filed against Mr. Kumar and others for slogans raised on the campus during an event on February 9, 2016, against the hanging of Parliament attack convict Afzal Guru.

Mr. Kumar was speaking

at a meeting organised by the JNUSU and the JNU Teachers' Association (JNU-TA) that took place on campus after a solidarity march taken out by JNU alumni.

Several other alumni of the university spoke at the public meeting. Former JNU-SU chief and CPI (M) leader Sitaram Yetchury said that he headed the union during the Emergency and at that time also the fight was in defence of democracy and the Constitution. He alleged that on the night of the attack, he visited AIIMS where BIP MP Meenakshi Lekhi and other

senior BJP leaders were en-

suring that some members of the ABVP were admitted to the hospital so that they could say that the violence happened on both sides.

"I salute the doctors at AI-IMS who did not succumb to such pressure and treated those who really needed medical care," Mr. Yechury said, while encouraging the students to keep their struggle alive. "It is an extreme form of patriotism to defend the Constitution... if there is anybody who is anti-national, it is the government."

'Modi-Shah duo, please remember that JNU students sent back Indira Gandhi during the Emergency and did not let her enter campus and ensured that she was defeated in the elections soon after due to the students' movement. We can do it to you as well," Mr. Yechury said.

AIPWA secretary Kavita Krishnan said that the Delhi Police is quick to lathi charge JNU and Jamia Millia Islamia students but provide safe passage to masked attackers.

D. Raja, Yogendra Yadav, Bezwada Wilson and Sharmishta Mukherjee also spoke at the event and said that the attack on JNU students was an attack on the minds of reason and critical thinking.

Several INU alumni were not allowed on campus after their march as the university shut the gates.

### Doctors back students

### Haryana teachers ask President to visit JNU

Demand inquiry by independent panel

'Reign of terror'



#### Give information on air quality management, NGT tells States

The National Green Tribunal on Tuesday directed the Central Pollution Control Board (CPCB) to obtain information from Chief Secretaries of all States and Union Territories pertaining to compliance of solid waste management rules, air quality management and restoration of polluted river across

While persuing a report furnished by the apex pollution monitoring body, a Bench headed by NGT chairperson observed that the data was insufficient and that information pertaining to sewage generation and treatment reflected a gap. "Grading made by the CPCB into "good", "average", "poor" and "no information" is not based on any qualitative analysis but the extent of information furnished," it said. With regard to the restoration of 351 polluted river stretches, the NGT directed the State governments to provide information on the in-situ and ex-situ remediation.

The Tribunal added: "Chief Secretaries need to monitor and compile information on the subject of execution of action plans for containment of air pollution in 122 cities where air quality is not within permissible limits." The NGT also sought information on the quantity of municipal solid waste generated, segregated and treated along with data on the quantity of lega-

# 'Nirbhaya convict broke down after hearing execution date'

3 other convicts in 2012 gang rape-murder case remained impassive, says officer

After a Delhi court on Tuesday issued death warrants against all four convicts in the 2012 Nirbhaya case, one of them broke down while the rest remained impassive when the Judge announced the execution date, said a senior officer with Tihar jail.

#### January 22 at 7 a.m.

The convicts, who were produced before the court via videoconferencing, will be hanged on January 22 at 7

On hearing the verdict, Pawan (25) who was in a separate cell broke down while Mukesh (32), Vinay Sharma (26), and Akshay Singh (31), who were together at the time, remained expressionless, the officer said.

Three of the convicts are lodged in Jail No 2 while Pa-

wan is in Jail No 4.

"As per procedure, the convicts have to be moved to a separate condemned cell. They will be put under round-the-clock surveillance and their health will be monitored daily," said the officer.

DG (Tihar) Sandeep Goyal said they have received the judgment copy and the death warrants. On Tuesday, the court was hearing the applications moved by Nirbhaya's parents and the prosecution (Delhi government), seeking issuance of death warrant against the convicts.

A relief: hangman Hangman Pawan, who is like-

ly to execute the task, said he will get relief after hanging the rape convicts. "It will give a message to all those who disrespect women," Pawan from Meerut said. He will be approached by the Tihar jail authorities on Wednesday as another hangman in Lucknow's jail is said to be unwell.

"We had earlier written to the prison authority of Uttar Pradesh seeking service of hangman. Now that the death warrants have been issued, we will be writing to the prison authority again for the same," said the officer.

Jail Superintendent of Meerut prison, V.P. Pandey, said he has not received any letter for sending Pawan for the execution. "We will inform the family

members of the convicts and their last meeting will be arranged in Tihar. Four gallows are ready and the rope ordered from Buxar jail has already reached Tihar," said an officer.

All convicts will be hanged together, the officer added.

### Chief Minister welcomes verdict

Award death penalty to rape convicts within 6 months: Maliwal

The Aam Aadmi Party on Tuesday welcomed the Delhi court's verdict on the 2012 Nirbhaya gang rape and murder case.

"Today, a long term wish of the people of Delhi has been fulfilled. I think, the others will also learn that people who misbehave with women will not be spared," said AAP national convener Arvind Kejriwal while addressing the seventh town hall meeting, a part of the party's election campaign.

The meeting was organised by AAP and anchored by Aaj Tak. During the meeting, senior AAP leader Manish Sisodia said: "I am happy that the efforts of their lawyers, family, friends and activists have paid off. The court took a decision, for which people of the country have been waiting for a long

Mr. Kejriwal tweeted: "There is some sense of satisfaction after the issuance

of death warrants against the convicts in the Nirbhaya case. It took seven years. This system will have to change. Such a system must be put in place, which ensures that the rapist is hanged within six months."

Terming the verdict "justice to all Nirbhayas", Delhi Commission for Women chief Swati Maliwal on Tuesday said: "Even though it has taken a long time, the verdict is a win for all the Nirbhayas of the country."

When asked whether the death penalty handed will

act as a deterrent, she told The Hindu, "It will of course act as a deterrent in future as the hanging of the convicts will send out a strong message. Up until now, perpetrators were under the impression that there is no grave consequences to such heinous crimes. However, now with this judgment, it will be proved that justice will be brought in each case henceforth.'

Ms. Maliwal, who had gone on an indefinite hunger strike last December as well, demanding the death penalty for rape convicts maintained that such verdicts should be meted out within six months of the crime and "not wait for seven years".

"I appeal to the Centre to ensure that in the future, the death penalty should be awarded within six months so that justice is provided swiftly. It has to be guaranteed that perpetrators will be punished at the earliest," she added.

### Green tribunal seeks report on sewage overflowing on NH-19

Haryana pollution board, Faridabad DM given one month

The National Green Tribunal on Tuesday directed the Haryana State Pollution Control Board and Faridabad District Magistrate to furnish a factual and action taken report on sewage overflowing on the Delhi-Agra Highway.

Taking cognisance of a report published by The Hin*du* on safety concerns being raised due to the overflowing sewage on National Highway-19, a Bench headed by NGT Chairperson Justice Adarsh Kumar Goel directed authorities to furnish the report within one month.

The Bench said: "The news report gives rise to a substantial question of the environment which may call for the intervention of this Tribunal. The situation may

need to be remedied forthwith in the interest of the environment and public

The Hindu on January 6 had highlighted how sewage from the Seekri village was overflowing onto a service road for the last six months and had become a major cause of hindrance to locals and motorists.

The locals had complained of foul smell and water-borne diseases resulting from the sewage.

They had also raised concerns about accidents being caused due to the water logging in the area. The green panel noted:

The flooded road hampers the movement of vehicles, emits a foul smell, causes water-borne diseases and accidents on the highway. Pipeline and drains get frequently choked due to dumping of garbage in the open drain, leading to overflowing of sewage to the service road." An egg-stall owner, Prah-

lad, had said: "A portion of the road is damaged due to waterlogging and a truck overturned a month ago. The highway authorities then closed the right turn to the road passing through Seekri and connecting a dozen villages.'

# Delhi Development Authority plots begin

Exercise to be carried out from January 28 to 31, say officials

Registrations for an e-auction of vacant residential, commercial, industrial and institutional plots among others, under the Delhi Development Authority (DDA) began on Tuesday, said officials.

Last date

The e-auction will take place between January 28 and January 31 while the last date of registrations is Ianuary 24, said a senior DDA official.

Under the scheme, 51 institutional, 164 residential, 50 industrial and 90 commercial vacant plots will be put on offer, they said.

Around 129 plots meant for expandable housing scheme, seven group housing plots, 67 spaces for offices and shops will also be put on offer.

Additionally, 55 vacant plots meant for installing mobile towers and 12 spaces meant for kiosks will also be put on offer for interested stakeholders.

First phase

The land-owning agency, had in January last, launched the first phase of the scheme where around 645 vacant plots in the Capital were put under

In the first phase, the land-owning agency had collected around ₹925 crore by putting the vacant plots under the hammer with residential plots worth ₹198 crore being sold for a total of ₹298 crore.

Sold at for ₹90 crore

The industrial plots worth ₹38 crore being sold for ₹90 crore, officials said.

The officials added that interested stakeholders can register on the online portal till 6 p.m on January 24. and that a help desk was also available at the Delhi Development Auth-

### HC junks PIL for probe into IGIA duty-free shops

Fine of ₹10.000 imposed on petitioner

The Delhi High Court dismissed a PIL seeking a highlevel inquiry into the affairs of duty-free shops at the Indira Gandhi International Airport here and imposed a cost of ₹10,000 on the petitioner.

'Private interest'

An HC Bench refused to entertain the PIL, saying it was "absolutely a private interest litigation".

The Bench noted that the PIL was filed after a dutyfree shop at the airport had given chocolates worth ₹360 to the petitioner instead of change when he

purchased a bottle of wine priced ₹9,740. "We see no reason to entertain this writ petition because it is not a Public Interest Litigation at all. This is absolutely a private interest litigation," it said. The counsel for the petitioner, who claimed to be a book publisher, submitted that on June 17, 2019, when he landed at the IGIAfrom abroad, he had gone to the duty-free shop to purchase

wine, which cost ₹9,740. The plea alleged that such shops are selling small products like biscuits, chocolates to customers without their permission and demand and in this way they are disposing of old stock.

### Kherki Daula toll plaza traffic shifts to alternative route due to congestion

Heavy traffic diversion is causing revenue loss to company, which will be claimed from agency responsible for construction of new road, says toll operation manager

In the wake of the Ministry of Road Transport and Highways order for dedicated FASTag lanes at all National Highways Authority of India (NHAI) tolls from December 15 last year, a sizeable chunk of traffic at Kherki Daula toll plaza here has shifted to an alternative road connecting the Southern Peripheral Expressway to the Delhi-Jaipur Highway, opposite Hyatt Re-

Though the 5-km road passing through Sector 77 has been in use for the past six months, the traffic has suddenly increased on this stretch over the past few weeks due to congestion and long waiting time at the toll plaza. The commuters also save the toll fees into the

Millennium City Expressway Private Limited (MCEPL) toll operation assistant manager Mohammad Sohrab Khan told *The Hindu* that the traffic at the toll has gone drastically down from 80,000 vehicles per day earlier to around 65,000. He said the heavy traffic mostly had diverted to the new route, causing revenue loss to the company.

Delhi carriageway of the highway - mostly private vehicles from group housing societies along the Dwarka Expressway – take right from the U-turn cut, about 400 m before the toll plaza, blocking the traffic on the adjoining carriageway to reach the service road on the opposite side. The motorists then drive another 200 m on the service road to turn left on the road connecting to the SPR

Though the statistics for December indicate an increase of around 20% in FAS-Tag users in a month's time, Mr. Khan said, still 50% of the users paid through cash and there was not much improvement in the traffic situation at the toll. "The real picture would emerge in the second week of January after the automotive companies open again after the routine shutdown and the regular commuters to IMT Manesar return to work," said Mr. Khan.

He said there was also a possibility of FASTag users going back to the cash payment mode and it was, thus, at a meeting with the NHAI officials, a decision to begin charging penalty from the cash users entering the FAS-Tag lanes was taken. "Since the tag users may find it inconvenient to frequently recharge their tags and most are not comfortable using technology, they might go back to cash payment mode if we do not penalise the cash users," said Mr. Khan.

Though eight lanes on Jaipur-Delhi carriageway and 11 lanes on Delhi-Jaipur carriageway were declared as dedi-

cated FASTag lanes on December 15, all the toll lanes, except one on each side, would be operated as FASTag lanes from January 15. The trial for one only-cash lane on each side, i.e. Lane No.22 (heading to Delhi) and Lane no.28 (heading to Jaipur), will start on January 8. "All the users under the ex-

emption category will be allowed free passage on the production of a valid document to authenticate their exemption. However, they are also advised to get the exempted tag fitted on their vehicle as per the standard operation procedure of MoRTH," said NHAI Project Director (Gurugram) Ashok Sharma.

A doctor at a private nursing home in Baghpat district allegedly held parents to ransom by holding on their baby, as the couple could not pay the hospital bills of ₹40 000

Anil Kumar Singh, Additional Superintendent of Police, said a couple of days ago the police got a complaint from a Scheduled Caste couple from Bijrol village of Baghpat. According to the complaint, Shikha, wife of Mohar Singh, gave birth to a child in Usha Nursing Home of Baraut in September 2018. They were not in a condition to pay ₹40,000, the bill for Csection. When they paid ₹10,000 only, they were asked to give thumb impressions on blank papers and were told that the infant would remain with the hospital till they pay the rest of the amount. "When they returned to pay the amount, they were allegedly driven

out," said Mr. Singh.

He said after the police started investigating the case, the couple started changing the statement.

"They alleged that the doctor sold the child in Muzaffarnagar. We are looking into that angle."

Mr. Mohar also told local reporters that some people tried to kidnap him.

Teshu Hooda, the doctor at the Usha Nursing Home, said they were not in the wrong. "When the police approached us, we submitted all the documents. Shikha delivered a male child by C-section and the couple had made the required payment."

# U.P. police rescue minor girl from traffickers

The Uttar Pradesh police have busted a human trafficking ring in Bulandshahr and rescued a minor girl who was allegedly being sold for marriage in Ahmedgarh area. Seven persons, including two women, have been arrested, police said.

According to the FIR, the 16-year-old, who hailed from a village near Ranchi in Jharkhand, was being sold by her step-aunt at Naurangabad village for ₹75,000. "The police team raided the house of Savitri after a tipoff. We found the girl locked in a room," said Harendra Kumar, SP (Rural) Bulandshahr.

Suresh Kumar, CO, Shikarpur said the girl's stepaunt Kalawati brought her to the village to sell her to a family looking for a bride. "People usually consider Haryana as the hub of such marriages but we do get such cases in western Uttar Pradesh as well. Here the sex ratio is poor as well and rural unemployment is widespread but gets covered because districts of eastern U.P. fare better," he said.

The FIR said wedding ma-

The FIR said wedding material, such as sari and a vanity kit, was recovered from the spot. "Prima facie, Kalawati, from Ranchi, made use of the girl's poor financial condition. The girl was allegedly sold by her stepmother," said Mr. Kumar.

Besides teaching Hindi, Shaheen Khan, removed recently as a guest faculty member at a college in Katni district, for 15 years mentored students with their career goals, even lent them emotional support. But never did she imagine that despite having a PhD and qualifying the National Eligibility Test and the State Eligibility Test, her own future could look this bleak.

"Should we focus on our own future or our children's?" wonders Ms. Khan, a single mother of a daughter, a BSc student, and a son in Class XII. Not paid salary for six months, she is left grappling to pay ₹8,000 as house rent every month, and has even accrued a ₹2-lakh debt.

### Genome of Indian cobra sequenced

More potent anti-venom can be produced, but may be ineffective against other species

A consortium of scientists, including some from India, have mapped the genome of the Indian Cobra, among the most poisonous snakes in the country. Knowing the sequence of genes could aid in understanding the chemical constituents of the venom and contribute to development of new antivenom therapies, which have remained practically unchanged for over a century.

Every year, approximately five million people worldwide are bitten by venomous snakes resulting in about 400,000 amputations and more than 100,000 deaths. Each year, about 46,000 people die and 140,000 people are disabled in India from snakebites by the 'Big 4' – the Indian cobra, the common krait, Russell's viper, and the



the most poisonous snakes.

saw-scaled viper.

"High-quality genomes of venomous snakes... will enable generation of a comprehensive catalogue of venom-gland-specific toxin genes that can be used for the development of synthetic anti-venom of defined composition," the scientists said in the paper published

in the peer-reviewed journal Nature Genetics this week. Somasekar Seshagiri, of the SciGenome Research Foundation, Bengaluru, and among the authors of the study, used the genome and gene expression data from 14 different cobra tissues. They annotated venom-gland-relevant genes and analysed the genomic organisation of gene families encoding toxin proteins involved in venom-gland function.

The authors found that 19 toxin genes are expressed exclusively in the venom gland and verified the presence of protein for 16 of these genes.

"Targeting these 19 specific toxins using synthetic human antibodies should lead to a safe and effective anti-venom for treating Indian cobra bites," Mr. Seshagiri said in a

statement.
Sequencing a genome is an important step to making anti-venom but wouldn't on its own solve the problem of

enough of the product to address the huge volume – and variety – of snakebites in India, according to independent scientists.

"India is the snakebite capital of the world," says Kartik Sunagar, Assistant Professor at the Centre for Ecological Sciences, IISc.


Prof Sunagar and his colleagues reported last month that though bites from 60 of 270 species of Indian snakes are known to kill or maim, anti-venom now available is only effective against the 'Big 4.'

"These 4 species are not found in northeastern India but the region reports a significant number of snake bites. That implies we need new kinds of anti-venom against species here. The krait in Punjab produces a venom chemically different from the krait in South India," he explained to *The Hindu*.

### Left trade unions confident of total strike in Bengal

Supporting issues, not bandh, says TMC

The Left trade unions, which have called a 24-hour general strike on Wednesday in protest against the economic policies of the Centre, are confident of a total shutdown in West Bengal.

Representatives of the trade unions said on Tuesday that not only the working class but also the students, youth and middle class, who are opposed to the Citizenship (Amendment) Act and the National Register of Citizens, would join the strike and make it a huge success.

The strike called by 10 trade unions, including that of the Congress, has a long charter of demands, including universalisation of the public distribution system, containing unemployment through concrete measures, increase of minimum wages, trade union rights among other issues. "A number of issues have been added since we called the strike and people are keen to protest against the fascist tendencies of the Centre. Not only the working class, but tomorrow [Wednesday] we will see the support of students, youth and the middle class," said State president of the Centre of Indian Trade Unions and

former Labour Minister Anadi Sahu.

Mr. Sahu said rallies in Kolkata would start in different parts of the city at 6 a.m. "The central rally from the CITU headquarters in central Kolkata will start at 10 a.m.," he said.

#### TMC's stand

A day after Chief Minister Mamata Banerjee said though she supported the issues related to the strike, she would not allow a bandh, Trinamool leader Partha Chaterjee said strike was the last weapon and by using it often the Left parties were making it blunt. "For 34 years in the Left Front rule bandhs had become holidays," he said. Asked whether they were opposed to the strike, Mr. Chatterjee reiterated what Ms. Banerjee had said, "We are not in support of the bandh, we are supporting the issues."

The representatives of the trade unions however, expressed confidence that unlike the aggression shown in the past, the ruling TMC would not foil the bandh this time. "If they show any aggression to foil the strike, they will do at their own peril because people want to show resistance through the bandh," Mr. Sahu said.

#### Bengal to get 2 new districts

### Abode of peace turns venue of protests against JNU violence

Visva-Bharati students, teachers condemn attack on campus

The new citizenship law and the mob attack in Jawaharlal Nehru University have ignited protests in Santiniketan the abode of peace - which generally remains insulated from political unrest.

A place that has seen only candlelight marches in the past and where emotions are expressed mainly through art and poetry has, of late, been simmering with anger quite uncharacteristic of it, with students as well as teachers of Visva-Bharati University openly protesting against the Citizenship (Amendment) Act and the violence in JNU.

Many walls on the campus, usually adorned with artwork, now bear anti-CAA slogans and Upasana Griha, the famous glass-walled prayer hall, has become the venue of angry demonstrations.

On Monday, more than 500 students and teachers gathered outside the prayer hall to express solidarity with

the JNU students. Rabindranath Tagore's songs were sung, slogans chanted and speeches made. Visva-Bharati is a central university and its chancellor happens to be the Prime Minister.

"We are a part of India, and whatever is on India's agenda is on our agenda as well. Right now, our aim is to make the [Wednesday's] nationwide strike a big success," said Sudipta Bhattacharyya, professor of economics and president of the Visva-Bharati University Faculty Association, who was at the forefront

of Monday's protests. "[On Wednesday] students

are going to hold a demonstration outside the central office and we teachers are going to support them. I have already applied for leave so that I can participate in the strike," Mr. Bhattacharyya, himself a former student of JNU, told The Hindu.

Ironically, the university is holding a lecture by BJP ideologue Swapan Dasgupta on Wednesday; he is going to speak in favour of the CAA. The protesting groups have given a call for its boycott.

### IIT-Kharagpur scholars express solidarity with students, teachers

## CM urges India Inc. to revive business environment, create jobs

Industrialists commend Uddhav for speaking 'with passion, from the heart'

Minister Uddhav Thackeray has assured industrialists that the new three-party government under his leadership will not work with a vendetta against business deals signed by the previous regime.

Mr. Thackeray promised top CEOs and industrialists a basket of incentives for businesses agreeing to promote employment for local youth, while assuring a businessfriendly environment in the State over the next five years. In his first interaction with top corporate honchos, the Shiv Sena leader urged the corporates to help Mumbai become a global tourism hub and transform cities like Pune, often called the Oxford of the East, into global educational centres on the lines of Oxford.

The interaction at State guest house Sahyadri was attended by industry captains, including Tata Sons chairman emeritus Ratan Tata, Reliance Industries chairman Mukesh Ambani, Anand Mahindra, Adi Godrei, Sajian Jindal, Uday Kotak, Deepak Parekh, Gautam Singhania and Baba Kalyani. **Environment** Minister

Aaditya Thackeray said the government will develop 66 urban forests in Mumbai, and at the same time work to promote night life in the financial capital.

Industrialists told The Hindu they left the meeting impressed with the CM's honest appeal to revive the State's business environment and attempts at fostering a personal bond with each of them.

"It was a fabulous talk, he was unprepared and spoke from the heart, as he was not supposed to speak. Everyone went and congratulated Udd-

"A lot of manufacturing is running away from China, and Vietnam is taking away 50% of those investments. Why cannot Maharashtra [focus on] getting those investments and becoming a manufacturing hub driven by electronics?" he asked.

Industrialist Venugopal Dhoot told *The Hindu*, "For the industrial growth of Maharashtra, [the CM] is ready to help the corporates at any level. If any corporate comes to him at midnight ready to create jobs, he will go to any extent to help him. Further, he was more interested in dispersal of industry in backward areas. He also emphasised that his government will give maximum benefits to those who give employment to locals.'

### Raj meets Fadnavis, sets tongues wagging

'MNS to declare future plans on Jan. 23'

Fuelling speculation of what could be yet another strange political alliance in the State, Maharashtra Navnirman Sena (MNS) chief Raj Thackeray on Tuesday met former chief minister and Bharatiya Janata Party (BJP) leader Devendra Fadnavis.

The meeting held in Prabhadevi lasted for more than an hour, but neither of the two leaders was available for comment after it ended. However, sources said the meeting could be the beginning of the two parties coming together.

**Driving force** 

The BJP's long term ally, the Shiv Sena, quit the partnership to form a government with the Congress and Nationalist Congress Party (NCP). The MNS, which managed to win only one seat in the Assembly polls, neither has any power left in the ruling alliance, nor the Opposition. This seems to be compelling the two parties to join hands, despite the animosity between them in the last five years.

"Mr. Thackeray is set to address a public meeting on January 23, where he will announce the future course of action. There have been talks within the party fold to turn to the Hindutva ideology as the Sena has deserted it by joining hands with the Congress and the NCP," an MNS leader said on the condition of anonymity.

According to sources, the party is also likely to change its flag to add more saffron colour to it.

Strained past

The relations between both parties were strained last year after Mr. Thackeray campaigned against the BJP and Prime Minister Narendra Modi, though his party did not contest the Lok Sabha polls. Mr. Thackeray was later served a notice by the Enforcement Directorate in the Kohinoor mill case, which further worsened the relations.

The MNS chief had met NCP chief Sharad Pawar and party leader Aiit Pawar prior to the polls, giving rise to speculation that he might reach a tacit understanding with the NCP.

For the BJP, the loss of the Sena as an ally in Mumbai and Pune creates difficulty in civic polls, and an alliance with the MNS would mean the party can break into the Sena's Marathi vote bank.

With the NCP getting the lion's share in the Cabinet and key portfolios like Home, Finance, Rural Development and Cooperation, the party leadership sees this as an opportunity to expand its base in areas other than western Maharashtra and Marathwada.

The NCP has not been able to make inroads in Vidarbha, north Maharashtra and urban areas such as Mumbai. The three-party Maha Vikas Aghadi alliance has now given it an opportunity to cement its organisation in these areas.

Mumbai NCP chief and Minority Development Minister Nawab Malik told The *Hindu* that Mr. Pawar would interact with the party's mi-

nisters earlier too. "This is his method of working taking feedback and guiding the junior ministers. He will be talking to us about priorities of the government and how priorities of the work +need to be fixed," he said.

Housing Minister Jitendra Awhad said the meeting is to provide guidance to the ministers. "This is the first meeting and Pawar saheb is likely to take such review meetings at regular intervals," he said.

Mr. Pawar has already called three senior ministers - Home Minister Anil Deshmukh, Labour and State Excise Minister Dilip Walse-Patil and Mr. Malik – to Pune after the portfolio distribution and discussed the functioning of their respective departments.

### Ajit allays fears of transgender community about NRC, CAA

Delegation meets Deputy CM after 'others' excluded in Assam

The State government has assured the transgender community that the National Register of Citizens (NRC) and Citizenship Amendment Act (CAA) will be inclusive for all in Maharashtra.

After reports of transgender people being excluded from the NRC in Assam, a delegation representing the community met Deputy Chief Minister Ajit Pawar on Tuesday. Mr. Pawar assured them that the NRC/ CAA, if implemented in the State at all, will be made inclusive for the third gender.

An estimated 2,000 'others' were left out of the NRC process in Assam.

The delegation also demanded inclusion of the third gender in the police force, an age restriction on sex change, and a chapter on the community in text books, officials present in the meeting said. "The Deputy CM has assured them all help possible, while promising a gender-inclusive Budget," said an official.

The government also agreed to constitute a welfare board to ensure the third gender is mainstreamed in Maharashtra.

The welfare board will have a helpline to ensure community members are able to ask for help by just making a call. "The board will ensure speedy social, political and financial growth of the community," Mr. Pawar said.

# What happened in JNU is appalling, says Amartya Sen

Nobel laureate says CAA 'violates the demand of the Constitution'

Economist and Nobel laureate Amartya Sen termed the violence at Jawaharlal Nehru University (JNU) as "appalling", and condemned the delay by the university administration and the police in bringing the situation under control.

Interacting with reporters on the sidelines of the award function of the Infosys Prize 2019 here on Tuesday, where he was the chief guest, Prof. Sen said: "I'm appalled by what's going on...that the establishment of the university can't prevent outsiders from coming in and creating such bloody violence within the campus. I'm also appalled that communication between the administration and the police would be so de-

layed that ill-treatment of students could go on for quite some time without being prevented by forces of law and order."

Responding to questions about the massive protests across the country against the Citizenship (Amendment) Act, which are also seeing huge participation from students, Prof. Sen said, "The student community has great many issues to think about. But the CAA in my judgment should really

be turned down by the SC on the grounds of being unconstitutional. You cannot have certain types of fundamental rights of human beings – in this case connected with citizenship - be related with religious differences rather than the things that really matter such as where you were born, and what the citizenship laws require you to

He further went on to say that the Act "violates the demand of the Constitution," arguing instead for a more equitable process of granting citizenship.

"If you read large volumes of the Constituent Assembly records, you will see that using religion for discrimination of this kind will be regarded as not acceptable,"

### Pay up for rice, Centre tells Kerala

Close on the heels of the Centre denying Kerala the additional flood relief granted to seven States, it has demanded that the State government pay the cost of the rice allotted during the floods.

According to a letter written by the General Manager of the Food Corporation of India to the Kerala State Disaster Management Authority, the State government should immediately remit ₹205.81 crore as cost for the 89,540 tonnes of rice lifted by the Kerala State Civil Supplies Corporation from its warehouses during the floods in 2018-19.

The letter has been written as a reminder to the previous ones sent on December 5 and December 30 last year for clearing the cost of the rice.

### Supreme Court has reservations over land-grabbing case

Case tied to Yediyurappa, Shiyakumar

The Supreme Court on Tuesday expressed reservations about an NGO, Samaj Parivartana Samudava, intervening to fight a landgrabbing case allegedly involving Karnataka Chief Minister B.S. Yediyurappa and Congress leader D.K. Shivakumar when the original complainant had himself withdrawn from the litigation.

A Bench led by Chief Justice of India Sharad A. Bobde asked advocate Prashant Bhushan, appearing for the NGO, to make good its claim that it did not parachute into the case at the level of the Supreme Court but had been doggedly fighting for justice right from the level of the Karnataka Lokayukta.

The court gave the NGO two weeks to provide proof of its long-standing involvement in the case and that it too had filed a separate complaint with Lokayukta.

The original complainant and petitioner in the case, Kabbale Gowda, had suddenly withdrawn his case from the Supreme Court on February 21, 2019.

It was then that the NGO had intervened to get the top court to recall its order disposing of the petition. Mr. Bhushan, who had earlier appeared for Mr. Gowda and is now representing the NGO, said the case had seen many such complainants become "compromised" and bow out.

In the previous hearing in March 2019, Mr. Bhushan had urged the court to list the case again for hearing

on merits, saying it con-

cerned "corruption and crime" across party lines in the State. He had alleged how neither the Lokayukta nor the State government challenged the Karnataka High Court's decision in December 2015 to quash charges. On Tuesday, Chief Justice Bobde orally observed that the NGO cannot "ride piggyback" on Mr. Gowda's petition, especially after the latter has withdrawn from the case. "You are riding on someone else's shoulders. You cannot do that.. This person [Gowda] has withdrawn. Now, you can separately pursue your own case... And if you claim that you had filed a complaint with the Lokayukta, show us what happened to that complaint... Was it dismissed or allowed?" Chief Justice Bobde addressed Bhushan in court.

Mr. Gowda's petition was originally filed in the Supreme Court against a Karnataka High Court decision in December 2015 to set aside a trial court order of February 2012 to prosecute the politicians and other accused. The High Court had quashed the entire criminal proceedings. Mr. Gowda was the de-facto complainant in the case.

### Politics should be kept out of campuses, says Venkaiah

Some universities are in news for wrong reasons, he notes

Vice-President of India M. Venkiah Naidu said that he was disturbed over "one or two universities that have been in the news recently for the wrong reasons."

He was speaking at the silver jubilee celebrations of the National Assessment and Accreditation Council in Bengaluru on Tuesday.

Politics should be kept out of the campuses of educational institutions, said Mr. Naidu, adding that while there are over 900 universities in the country only a few

universities were in the news for the wrong reasons, without directly referring to the incidents at the JNU. "One should not disturb the peace on the campus. There is nothing wrong in discussing ideologies, but that should be done outside the campus. Universities are places of learning," he said. He argued that academic

endeavours and co-curricular initiatives must attain primacy in universities and not factionalism or divisive tendencies. "Our children, when they leave the portals of educational institutions, must be enlightened citizens who will take an abiding interest in protecting our democracy and preserving the fundamental values that are enshrined in our constitution," he said.

### Sabarimala case: dissenting judges are not part of Constitution Bench

It will hear 60 petitions against entry of women into temple

None of the three Supreme Court judges who dissented at various points in the Sabarimala litigation is part of the Constitution Bench, which will hear, from January 13, over 60 petitions challenging the entry of women of menstruating age into the temple in Kerala.

The court on Tuesday pu blished the names of the judges who would be part of the Bench, led by Chief Justice of India Sharad A. Bobde. The other judges are Justices R. Banumathi, Ashok Bhushan, L. Nageswara

Rao, Mohan M. Shantanagoudar, S. Abdul Nazeer, R. Subhash Reddy, B.R. Gavai and Surya Kant.

Justices Indu Malhotra, A.M. Khanwilkar, Rohinton Nariman and D.Y. Chandrachud are not part of the Bench. Justice Indu Malhotra was the lone dissenter on September 28, 2018, when the court, in a 4:1 decision, quashed the rule that barred women aged 10-50 from entering the temple.

Justices Nariman and Chandrachud, part of the Review Bench, had jointly dissented from the majority decision on November 14, 2019, to refer the issue to a larger Bench. Justice Nariman, in a minority opinion for himself and Justice Chandrachud, ordered Kerala to grant women pilgrims protection.

Incidentally, Justice Khanwilkar, who is also not a part of the nine-judge Bench, had agreed with the majority decision on September 28, 2018, and on November 14,

The nine-judge Bench will set the parameters for a judicial review in cases touching on customs and practices believed to be essential to a religion.

### 'It is up to States to provide 10% quota'

Centre responds to charge that law is not implemented in T.N. and Karnataka

The Centre on Tuesday informed the Supreme Court that it would be the States' prerogative to provide 10% economic reservation in government jobs and admiseducation to institutions.

'Whether or not to provide reservation to the economically weaker section in appointment to State government jobs and admission to State government educational institutions, as per provisions of the newly inserted Articles 15(6) and 16(6) of the Constitution, is to be decided by the State government concerned," the Centre said in an affidavit.

The Centre was responding to a writ petition from Supreme Court advocate G.S. Mani complaining that the economic reservation law was not being implemented in Tamil Nadu and Karnata-

However, the Centre said its Department of Social Justice and Empowerment "has no role in deciding the reservation policy of any State government".

### **IOB** officials booked for illegal transaction

The CBI has booked a regional resource manager, two assistant managers and a clerk of the Indian Overseas Bank (IOB) for allegedly helping a company and its proprietor get ₹90 crore illegally transferred to their accounts.

Timely action by other bank officials resulted in preventing the withdrawal of money from the accounts

of accused persons. Among those named as accused in the FIR are Green Valley Ministries Welfare Association (Visakhapatnam), a company named Bhaktinidhi and its proprietor Bellamkonda Murali Krishna Sharma, IOB regional resource manager Heli Veepuri, assistant managers Kandrathi Sreesha and Vuyyala Suresh and clerk Mothukuri Adinarayana. It is alleged that in Sep-

tember last year, Mr. Veepuri got opened a current account in the name of Green Valley Ministries Welfare Association in another branch. He then allegedly got a cheque for ₹90 crore, dated October 24, 2019, in the organisation's name.

The FIR alleges that Mr. Veepuri personally took the cheque to the bank's Mangalagiri branch the same day and without waiting for its clearance, got the amount debited and parked in the NEFT sundry creditors account.

Through eight transactions, ₹89 crore was transferred to the account of Bhaktinidhi with HDFC Bank and ₹1 crore was diverted to that of Mr. Sharma's account with a different IOB branch.

### A battle over welfare

The AAP will hope that the Assembly polls are a referendum on its government's work

elhi, the Union Territory (UT) that hosts India's capital city, might lag behind several States in total population and in area, but it enjoys outsize significance in terms of media and political attention. With 1.47 crore electors spread across the largely metropolitan national capital region and its pockets of rural voters in some suburbs, Delhi is expected, in polls scheduled on February 8, to reprise the three-cornered electoral fight which has been the norm in recent elections. The Aam Aadmi Party, which graduated from a social movement to a political party less than a decade ago, will now seek to stand on its governance record, five years after nearly sweeping the Assembly results in 2015. The Bharatiya Janata Party will hope that unlike in Maharashtra, Jharkhand and Haryana, the legions of voters who supported it in the Lok Sabha election will not transfer their votes to its competitors, while the Congress will seek to regain the support of the UT's poorer and marginalised sections, most of whom shifted allegiance to the AAP in 2015. The AAP, if multiple opinion polls are to be believed, is on a strong wicket despite its setback in the Lok Sabha election where it won only 18% of the votes for the third place behind the BJP's 56.6% and the Congress's 22.5%. A Centre for the Study of Developing Societies-Lokniti survey of May 2019 found that most of Delhi's voters who voted against the AAP for other parties in the national elections wanted the party to return to power in the Assembly election. This dichotomy in support could be explained by the reasonable satisfaction among voters with the welfare and development work done by the Arvind Kejriwal led-government.

A PRS Legislative Research report has shown that Delhi spends the most - nearly 40% of its overall Budget allocation compared to an average of 23% elsewhere in India - on education, health, water supply and sanitation between 2011 and 2019. The AAP's focus on improving government-run primary education, health care (the Mohalla clinic scheme in particular), lowering electricity and water supply costs besides easing public transport woes (through schemes such as free ridership for women in government-run buses) has earned the party strong campaign points. This could not yield it dividends in May, as the party still does not have a coherent ideological position or a national presence, while voters were concerned with other issues such as national security that favoured the BJP. The AAP's incoherence on questions related to ideology was a drawback then, and that is the reason why it will seek to turn the polls into a referendum on its tenure. The BJP hopes to challenge the AAP on this turf after passing a Bill in December 2019 that came up with a legal framework to provide ownership rights to those living in Delhi's unauthorised colonies. Whether this recent gesture, that is of importance to the roughly five million people in such areas, will sway voters remains to be seen.

A four-day Test will make all cricket seem like limited over internationals

revity and quicksilver processes constitute a raging trend be it Twitter or two-minute noodles. It is in sync with the current era notorious for its shrinking attention spans and paucity of time. Organised sport too isn't immune from this need to shorten formats. In this universe of instant gratification, Test cricket with its five-day schedule and breaks for lunch and tea, might seem an anachronism. It may boggle the mind that there were timeless Tests in the past during which a contest stretched beyond five days till a result was arrived at. That phase ended in 1939 as visiting squads were constrained by the urgency to catch a ship back home. Since those days of the slow life, cricket evolved and Tests now have two raucous siblings in One Day Internationals and Twenty20s, where a result is inevitable and the thrills, however transitory, seem limitless in these abridged formats. ODIs and T20s draw in the crowds and sponsors while Tests are now seen as an ageing matriarch lost to nostalgia and the prospect of ever-dwindling revenues. In a bid to bolster cricket's original form, the International Cricket Council (ICC), is mulling over four-day Tests from 2023. Cold logic has trumped relevance and it is a move that will destroy the sanctity of Tests and all that it stood for.

The tussle spread over five days is considered as the ultimate benchmark for judging cricketing greatness. Batsmen have to cope with fast bowlers on a fresh first day pitch and also counter wily spinners on a wearing surface on the fifth day. The action gathers steam over four days before a spectacular combustion on the concluding day. Yes, in recent times many Tests have finished within three or four days and broadcasting companies that spend top-dollar for telecast rights, have to craft studio-analysis to justify their ad-inventory. Another factor is that the ICC is keen to create more space for various T20 leagues ranging from the Indian Premier League to the Big Bash in Australia besides supporting the World Cup for Twenty20s. However, a fourday Test will lack character. Imagine what would have happened during that epochal March in the summer of 2001 at Kolkata's Eden Gardens where V.V.S. Laxman, Rahul Dravid and Harbhajan Singh inspired India to stun Steve Waugh's Australians. If that Test had ended as a mere draw in four days, Indian cricket may not have progressed over the last decade-and-a-half. A fiveday Test is the acme, a four-day one will slowly blur the distinction with limited overs cricket and it is a clear and present danger that players such as Sachin Tendulkar, Ricky Ponting and Virat Kohli have recognised. It is time the ICC woke up to this reality.

# Retrieving ideas of democracy and nation

The substantive versions of these ideas have been evoked in the popular upsurge across the country today

ithin much of modern Indian thought, the idea of India as a nation implied the assumption that it would invariably be a democracy - i.e., India realising itself or constituting itself as a nation will necessarily do so as a democracy. The relationship between the two was not problematised.

There were some exceptions though: the Gandhians laid stress on Swaraj but this idea, while not being not opposed to democracy, did not directly connote self-rule of the citizen-community. The socialists and communists who were interested in the idea of democracy, and uncoupling it from the idea of nation, tended to lay stress on the economic prerequisites and redistribution of power to realise the former. There were some thinkers such as V.D. Savarkar who argued that the idea of nation took shape in India in the epochal past, but they dwelt little on democracy. Some Islamic scholars such as Maulana Maududi introduced concepts such as "theo-democracy", i.e., the mode of self-rule where believers ordain their common affairs; but apart from the hierarchisation and exclusion such a conception threw up, it was hardly linked to the idea of nation as a bond or fellowship that marks it off from every other kindred entity. There were those who thought through the lens of caste, examples being E.V. Ramaswami Naicker, K.M. Panikkar and B.R. Ambedkar and also Adivasi leaders such as Jaipal Singh, who argued that the idea of nation has to be pro-

that such rethinking was needed to foreground democracy in an anticipatory mode.

While posing the relation between the ideas of the nation and democracy before the emerging public in India in this fashion is a gross simplification, and the arguments that people made and the positions they took were far more complex, this debate came to an abrupt end, or merely became the ideological fixtures of political parties, once India embraced constitutional democracy and held periodic elections under universal adult franchise. Interestingly, certain measures that the current government has embraced in the name of constitutional rectitude have reopened new fissures within the Indian body polity. It has made it imperative that we reopen the relation between the nation and democracy in India afresh even to sustain meaningful versions of constitutional democracy and periodic elections.

#### Trajectory of democracy

There were complex questions that had to be explored in the wake of Independence, and particularly following Partition. One was if India is a nation, what kind of a nation is it? If democracy is the mode of political association of this nation, what kind of democracy is conducive to it? However, giving short shrift to these questions, an amazing constitutional architecture came to be put in place. Amid a setting of bewildering social diversity and inequalities, India stepped into holding periodic elections on the basis of universal adult franchise.

The elite who were at the helm of operationalising constitutional democracy and periodic franchise made some place for diversity and preferential considerations to the disadvantaged in the Indian public. Some were aware of the course such a complex constitu-

tional and institutional ship was to set sail in and were apprehensive of its future course. Others wished it bon voyage for a variety of reasons including utility calculations. Whichever way one looked at it through a phalanx of institutions dovetailed to constitutional democracy and periodic elections, the elite thought the future of India lay in operationalising a set course of action rather than rethinking its foundations.

The course of action that India took came to be theorised by the likes of the late Rajni Kothari who argued that democracy is alive and kicking by accommodating diversity within the policy-making process through a distinct type of party system, that he termed one-party dominance. There was much claptrap that came from elsewhere too.

Comparativists such as Atul Kohli argued that India demonstrated "a delicate balance" between "forces of centralization and decentralization" and "the interests of the powerful" have been pursued "without fully excluding the weaker groups". Consociationalists such as Arend Lijphart thought that the Indian case demonstrated that democracy is viable - in spite of diversity and inequality - if it accommodates them in the governing institutions of a polity. These arguments came to be profoundly qualified by their proponents later, in the context of the failure or inadequacy of these institutions, and the rise of powerful dissent movements from below. However, their emphasis remained on rectification of the course and the institutions and policy measures arising therefrom, rather than envisaging the future of India beyond these con-

#### A notion of the nation

The rise of the ruling party has placed a particular notion of the nation on the political agenda, and it has sought to refract constitutional democracy and elections through it. It has confined constitutional democracy to the bare letter of the law and periodic elections to merely subserve a majority in the House. In the process it has shorn them off from even residual considerations of democracy as the self-rule of the citizen community and the nation as the outcome of this process.

One of the most ominous expressions of the Bharatiya Janata Party's version of the nation is found in the Citizenship (Amendment) Act, 2019, or the CAA, 2019 and the National Register of Citizens, allegedly on the anvil but officially denied in the face of widesresistance. commentators have already pointed out that the CAA calls into question the foundations of citizenship in India, the role and place of the majority in a political democracy and minority rights and reorders them to suit the notion of the nation the current ruling dispensa-

tion cherishes. How do we go about retrieving ideas of democracy and nation authentic to our context? One route leading to the same is subjecting the demands that the popular upsurge has voiced after the dilution of Article 370 of the Indian Constitution, and particularly following the enactment of the CAA, to reflective consideration. There are many angularities to the popular upsurge of the scale that we are witnessing in India today. But certain issues stand out if we

read the kind of slogans that have been voiced, the songs that reverberate, paintings and plays that hold the crowds in rapt attention, and the extent and intensity of participation, and connect them to the popular demands that have been voiced by the very same people overtime.

In the Northeast, there is a widespread feeling that the CAA has watered down the autonomy that they sought for their culture, language, and land rights and very forcefully voiced before the Bordoloi Committee of the Constituent Assembly. The large-scale participation of Muslims in this upsurge demonstrates that they do not want to be kept out but be treated as equal citizens. There is universal outrage about the communication blockade in the Kashmir Val-

But what is more is the participation of the rest, especially students in this movement. They seem to be saying: We do not want you to shove down our throat your pet notions of the nation and rules. Stop befuddling us with your doubletalk. There are matters of much more profound concern and urgency that we need to put upfront, and since they can be pursued only together, we need to reopen a conversation across our divides. The nation can only be that big and small that such a conversation affords.

While this popular upsurge does not give us a full-blown ideal of democracy that we wish to be and the image of the nation it recasts, the indicators are all there to see. There is a surplus in the ideas of nation and democracy that formal rules of law and modes of representation can never exhaust, and you cannot trump the former by invoking the latter.

The scale of the First World War underscored the command and control dilemmas of concurrent conflicts playing out multiple simultaneously in theatres of conflict.

#### War and the West

During the locust years of Great Britain, an issue that received consideration was the British higher command and control structures. With the declaration of the Second World War, the onus for the higher direction of war fell to the remit of the War Cabinet serviced by the Chiefs of Staff Committee. The British legislative system functioned through the Second World War. Winston Churchill, as Prime Minister, was given supreme powers but staved accountable to Parliament through the War Cabinet. He assumed the portfolio of Minister for Defence, with the resultant duty of overseeing the British War effort. This allowed him, as Chairperson of Chiefs of Staff Committee, to exercise both tactical and strategic options.

After the United States entered the war, following the Pearl Harbor attack, an integrated command became the norm during the Second World War as diverse allies including the Soviet Union had to work in unison. A unified command required a single commander liable to the joint chiefs of staff supported by a joint staff and


After the war ended and the world split into two ideological blocs, General Dwight D. Eisenhower became the First North Atlantic Treaty Organization (NATO) supreme commander while political power was vested in the NATO mander of the Warsaw Pact Forces was Marshal Ivan Konev, while defacto political authority resided with the General Secretary of the Soviet Union in Moscow. The United States, vide the National Security Act 1947, established the Joint Chiefs of Staff. They were jointly tasked to be Military Advisers to the President and the Secretary of Defence. Despite the experience of the Second World War, they chose not to appoint a Chief of Defence Staff (CDS). The U.S. amended this structure vide the Goldwater-Nichols Act in 1986 by having a chairperson and vice-chairperson of the Joint Chiefs of Staff. The Joint Chiefs in unison are again the principal military advisers to the government. There is no CDS. The military chain of command runs directly from the theatre commanders through a civilian Defence Secretary to the President. However, Britain, conversely in 1959, created a Chief of the Defence Staff. Air Chief Marshal Sir William Dickson became the first CDS after serving as the rotational chairperson of the Chiefs of Staff Committee. The chair of the committee was rotational, with the Service Chief longest in the committee becoming the chairperson'. This procedure operated into 'the middle of the 1950s despite the Commander-in-Chief only being an invitee to the Defence Committee of Cabinet. The designation of the Commander in-Chief of the three services was consciously altered to Chiefs of Staff in 1955. After the 1962 Sino-Indian war, the Defence Committee of the Cabinet first morphed into the Emergency Committee of Cabinet and then la-

well over the years. On December 24, 2019, a Press Information Bureau release on the Cabinet clearing the appointment of a Chief of Defence Staff (CDS) said: "The following areas will be Chief of Staff to Lord Mountbatten, dealt by the Department of Mili-

tary Affairs headed by CDS: The Armed Forces of the Union, namely, the Army, the Navy and the Air Force. Integrated Headquarters of the Ministry of Defence comprising Army Headquarters, Naval Headquarters, Air Headquarters and Defence Staff Headquarters. The Territorial Army. Works relating to the Army, the Navy and the Air Force. Procurement exclusive to the Services except capital acquisitions, as per prevalent rules and procedures."

It added, "The Chief of Defence Staff, apart from being the head of the Department of Military Affairs, will also be the Permanent Chairman of the Chiefs of Staff Committee. He will act as the Principal Military Adviser to the Raksha Mantri [RM] on all tri-Services matters. The three Chiefs will continue to advise RM on matters exclusively concerning their respective Services. CDS will not exercise any military command, including over the three Service Chiefs, so as to be able to provide impartial advice to the political leadership."

A subordination Herein lies the contradiction and the design flaw. As Secretary in charge of the Department of Military Affairs (DMA) and having superintendence over the Indian Army, Indian Navy and Indian Air Force, there would be an implied subordination of the three service chiefs to the CDS notwithstanding any declaration to the contrary. As Secretary of the DMA, the CDS is tasked with facilitating the restructuring of military commands, bringing about jointness in operations including through the establishment of joint/theatre com-

This will invariably encroach upon the domain of the service chiefs.

The CDS, as Permanent Chairperson of Joint Chiefs of Staff Committee, would outrank the three service chiefs even though theoretically all are four star. Moreover the advice of the CDS could override the advice of the respective Service Chiefs on critical tactical and perhaps even strategic issues.

With the creation of the DMA on most issues, the reporting structure of the three services to the Defence Minister would now be through the CDS: if not immediately it would become the norm over time. Even today while in theory the service chiefs report directly to the Defence Minister, in practice all files and decisions are routed through the Defence Secretary.

However most problematic is the erosion of civilian supremacy over the defence establishment in the Ministry of Defence itself. This impacts on the first principles of constitutionalism and has implications for our democratic polity also. Sophistry is being employed to suggest that the Secretary DMA would be in charge of military affairs and the Defence Secretary would look after the 'defence of the realm'. The fact is that the defence of India is managed by the three services who would now report to the DMA.

Since the DMA would exercise control over the three services, it virtually makes the CDS the 'Supreme Commander of the Indian Armed Forces'. A new czar has
