## **DELHI VOTES AMID TIGHT** SECURITY

**New Delhi, Feb. 8:** The polling for the 70-member Delhi Assembly got underway on Saturday morning, an election that saw the ruling AAP, opposition BJP and the Congress engaged in a bitterly fought high-octane campaign.

Over 1.47 crore people are eli-gible to exercise their franchise in the polls that will decide the fate of 672 candidates. The polling began at 8

am, an official said. Security forces kept a tight watch across the 70 constituencies, with police and paramilitary personnel keep ing an "extra vigil" in sensi tive areas like Shaheen Bagh Jamia Nagar and Seelampuri There were over 81 lakh male

voters, 66.80 lakh female voters, and 869 third-gender voters, Delhi CEO Ranbir Singh has said. Around 2.33 lakh voters are in the age group of 18-19, 2.04 lakh voters are senior citizens aged 80, while there are 11,608 service voters, according to officials.










# **Exquisite dance of narratives,** continents, identities





### **EXQUISITE CADAVERS** By Meena Kandasamy

o write one story and make it readable is hard enough. But to write two in the same book? To have the two run parallel to each other, disconnected by storyline but con-nected by themes and ideas and happenings, not just by having a common writer, is not just craft it is art.

Other than Italo Calvino I cannot recall such a device delivered with such masterful ease as Meena Kandasamy's *Exquisite Cadavers*. The first thing that strikes you with Kandasamy, if you have not read her before, is that she a feather-light touch and yet complete control of her words. This novella, or two-stories-in-one or reflections on our times or history of recent horrors, is not long but it is complete, and it is packed with the most, to borrow her word, exquisite writing.

The story of Maya and Karim, of Karim and Maya is a story of marriage, a dissection of the married state, the examination of the inner workings of a relationship, the dance of longing and hostility, of likeness and disparity when any two beings

#### try to become one.

Maya and Karim are a young couple in London. He is a film student from Tunisia struggling to find a subject for a film project which his university and today's British society find acceptable. She is British, dealing with demons of insecurity from her past and the judgment of others about her present.

But what draws you in, immediately, is the parallel narrative. Of the writer telling you how and why she is writing this particular story, what the charac-ters represent to her and what impact her writing has on her own life. And so you are held in By tĥe lives of thrall.

Kandasamy and Cedric and their baby, and the young love turmoil of Maya and Karim.

The skill is not just in the words or the device, it is also in the telling. You are drawn in lightly, maybe this is just anoth-er love story or two or the story of human foolishness and should you have succumbed to reading fiction instead of sticking to your non-fiction guns. But as you turn the pages, the big print and small both lead you into a larger world. The writer talks of her past, her violent abusive marriage, the plight of Sri Lankan Tamils, of Dalits as Karim struggles with his teachers who want to box and label him as Tunisian, Muslim, ethnic in a "nice" way but box him into their own convenient pigeonholes nonetheless

Eventually, the small print story, the writer's story becomes the story of today's India as she lives in London. Of the attacks on Muslims and Dalits, on everyone who does not fit in with the fascist vision of the BJP. She talks of attacks on women, of Brahmanism, of her friends jailed and mur-

dered, of the India she left behind and the India piling on atrocities as she is far away. Maya and Karim struggle with their identities, with how others identify them. Of the prejudices and questions that a mixed marriage raises, even in this day and age.

Do not imagine for a second that the reins on the story are slack or that the two horses run apart from each other. You are so engrossed with both that sometimes you find your eyes fighting with each other as they switch from column to column, font size to font size. You might imagine that this is annoying. But instead, it is doubly engaging. Indeed, as one story ends a few pages before the other, you feel a bit bereft. Like you have been denied, an additional insight, some precious nugget that was owed to you.

If any book leaves you feeling like that at the end, what more could any reader ask for?

s soon as the book reached my hands, I dived into the index looking for Madhavsinh Solanki, the former CM of Gujarat, who, as Narasimha Rao's foreign minister, had been widely reported as receiving an envelope from the British-Indian lawyer, Sarosh Zaiwalla, to be passed on to the Swiss foreign minister.

It was soon evident why for Zaiwalla categorically asserts that he was not the "eminent lawyer" who passed on the letter. Indeed, he denies he ever met Solanki. And then hurls his own bombshell. Sourcing his information to journalist Vir Sanghvi, he claims that the only "eminent lawyer" who could have got on to the aeroplane ferrying Solanki to Geneva without being a co-passenger was high com-missioner L.M. Singhvi availing of his diplomatic priv-ilege that Zaiwalla, a mere lawyer, could never have secured for himself.

Solanki, now in retirement and nearing his birth cen-tenary, has chosen to keep the details to himself and Singhvi has passed away. So, what the two pages reveal are that Zaiwalla had nothing to do with the farce that turned into high political drama when the Swiss foreign minister revealed to the press the contents of the letter which sought the Swiss government's assistance to close their investigation into the payments allegedly made by Bofors into five different Świss bank accounts. If the 1992 incident earned Zaiwalla undesired and

possibly undeserved notoriety, it was his association

with the Bachchan brothers that earned him his Perry Mason-esque repu-tation as the top Indian lawyer practicing in the English courts. The story is recounted by the author with both verve and clarity. The Swedish newspaper, Dagens Nyheter, had claimed on information leaked by the Swedish investigating authorities that there was, in fact, a sixth account connected to the Bachchan brothers acting on behalf of (by then) former PM, Rajiv Gandhi.

The Bachchans, says Zaiwalla, approached him to get their defamation suit against the Swedish journal heard in an English court. Zaiwalla spotted that jurisdiction in an English court could be claimed only if it could be proved that the newspaper was sold in England. He set his scouts

## 'You want to, but you cannot live in the past'

FORREST GANDER, poet, translator, essayist and novelist, won the Pulitzer Prize for poetry in 2019 for *Be With*, a collection of poetry written in remembrance of his wife, C.D. Wright, also a poet. Wright suddenly passed away in 2016 During an interaction with SUCHETA DASGUPTA on the sidelines of the 13th Jaipur Literature Festival, Forrest shared that he has found a new patch of creativity following his friendship with Ashwini Bhat, sculptor, who has helped him move forward.

As a pioneer of ecopoetics, how would you describe your knowledge as a geologist

informing your writings? Geology taught me how to look. When you look at a landscape as a geologist you have to see the large-scale features, the uplifting and the subduction, all the major things that will account for a mountain or a valley, but you also have to be able to see the crystalline properties in the shear zone and what's going on there,



in translation and try and because there is such good women's writing in Latin America — Coral Bracho in Veronica Volkow in Mexico. where we live affect our speech and our thinking. She notes, for example, that if you read Abraham Lincoln's Gettysburg Address, you hear the rhythms of a man who spent a lot of time (in cold Illinois, where he lived) chopping wood. In the south in the United States, houses are built with porches. People sit on porches and talk to their neighbours walking by, and the porch is a place where people meet up. It's commonplace in the US South that people will acknowledge each other when they walk past — unlike in many places in the North, New York for example, where people pass within inches of you without ever making eye contact. I think there are subtle ways that where we live affects who we are. Jaime Saenz, a Bolivian poet whom I translated, lived in La Paz and so, all his life, was conscious of the imposing mountain, Illimani, that presides over the town like some enormous toad over a scattering of ants. That kind of presence surely affects us in ways we can't easily decipher.

and so the constant going back and forth between the large scale and the very particular has become an aspect of my own poetry. It's how I tend to look at things, moving back and forth across scales.

Your poems are said to be highly stylised with their syntax, shape and line breaks expressing their message. How did you come to shape this form of poetry? What were vour influences?

I don't have a single shape. Every poem calls forth a different form. It's by listening to the poem that you begin to feel the form take place. I'm interested in the line of a poem being connected to percep-tion. A line gives you a moment of vision, and you can isolate things or you can run things together, and I am interested in the emotional energy of the line. Depending upon the emotional energy of the poem, the line will change.

How many languages do you speak and read? Which has been your most intensely enjoyable translation project? I translate mostly from Spanish. I have translated a lot of Latin American writers. I focussed on women because they tend to be underrepresented in every counman with a certain knack for vulnerability that provokes similar self-examination from the people with whom he interacts. Did you have any person or incident in mind when you wrote Les?

I did. There was an amazing American poet who died at the age of 30, who wrote one of the longest poems in English, called The Battlefield Where the Moon Says I Love You, and he has a huge cult following in the United States. His reputation has expanded long after his death. The skeleton of the idea that I had for this book is based on his life. His name is Frank Stanford.

Do you think vulnerability and originality are qualities that are becoming increasingly rare in today's pat, accessible, all-knowing, globalised world?

Don't you? It seems it is so easy to protect ourselves with the armaments of technology, and we are less exposed to different points of view now. The media we can choose to attend to can be very narrow online. It can be very hard to remember that only by being vulnerable that we can be surprised, that we can learn things when we drop our defences things that are very important in terms of how to live with other

people and with other species.

You have lost someone very dear to you. Does grief, in its need to preserve memory, spell the end of new experiences and vulnerability? What is the connection between landscapes and grief?

You want to but can't live in the past, so you live with a pain that eats at you constantly. In some ways, the light in my life is less substantial than it was before. But in our deep relationships with others, our substantialness increases. In their absence, we can feel like a much smaller thing because it is relationships that make us what we are. So that grief has been and continues to be very powerful for me, and at the same time I have

continued to live, and I have met someone now whom you just met - Ashwini Bhat with whom I have a new relationship. She is full of

life and I was full of death and sad ness, and that's opened me up and made me vulnerable again to feeling things which I didn't really even want to feel. I didn't want to get over my grief.

This question is to do with your philosophy of international regionalism. As a geologist, how do you think geography affects the personality of a people, especially in relation to the works that you have translated?

A wonderful American writer who wrote a lot about Native American culture, Mary Hunter Austin, suggested that the places

You have been spending a lot of time in India lately. Who is your favourite Indian writer in any language?

've been reading some ancient books, *The Life of Harishchandra* translated by Vanamala Viswanatha, the poetry of Andal translated by Ravi Shankar and Priya Sarukkai, and the Sangam poetry translated by A.K. Ramanujan. But among contemporary poets, I'm drawn to Arvind Krishna Mehrotra, Ranjit Hoskote and Biswamit Dwibedy. Incidentally, there has been a flourishing ofterrific Indian-American poetsand I follow a number of them hungrily, book by book.

#### Can poetry reverse climate change?

(Laughs heartily) I think the things that poets want poetry to do are important. But poetry doesn't probably fulfil the intentions of many poets. But I think it does do something, sometimes on a small scale — making people aware of language that allows them to articulate emotions that are more subtle, offering a way of seeing the world that's perhaps in the case of ecology more integrated with human life. So in ways it does change the small world but it certainly won't save the world.

to scour the news-stands in England and was able to procure a single copy on sale. Triumphantly dis-

playing it in court, he was able to establish that the Bachchan defamation suit could be pressed in an English court.

But, in fact, the case never really came before an English court for on the opening day of the hearing, the Swedish newspaper and the representative of the Swedish investigating agency, publicly stated that they had been mislead as there was no sixth account; the Bachchans, had nothing to do with this non-existent account; and hence, by extension, the innuendo against Rajiv Gandhi was entirely misplaced. Complex manoeuverings follow in consequence of which Zaiwalla says he never saw a penny of the Bachchans' rich offerings while Ajitabh successfully plotted to take control of the whole venture. Initially, claims Zaiwalla, Ajitabh had said that this humongous sum of money was from Amitabh's cinematic earnings, but later hinted that the money came from "New Delhi" which Zaiwalla took to mean the Congress Party. The only proof of this wild allegation that Zaiwalla offers is that when he told Sonia Gandhi of these Bachchan shenanigans she looked somber and two weeks later it was reported in the gossip columns that she had broken off all relations with the Bachchans. To set the record straight, relations had been fraught for nearly a decade

When this matter came up at the formal launch of the book at the India International Centre, New Delhi, Zaiwalla said that, as a lawyer of long experience, he could determine by looking into the eyes of his interlocutor whether the interlocutor was or was not telling the truth, and when he had talked to Rajiv about Bofors, he came away convinced that Rajiv was telling the truth when he emphatically denied having anything to do with the alleged Bofors' payoffs. In fact, despite the persistent efforts of nine years of non-Congress governments from V.P. Singh to Vajpayee III, no court has accepted that there was any wrongdoing on Rajiv's part. Zaiwalla should have included this crucial conclusion in his book instead of leaving it as a casual comment at the book release.


For the rest, the book is an easy read and a stirring account of an Indian-origin lawyer correctly diagnosing that the only way for an immigrant of talent in the United Kingdom is to work his way to the top by remaining himself and asserting his identity as an India-born instead of becoming a "WOG" (for Westernised Oriental Gentleman). Other immigrant aspirants should heed this sound advice.

any of our favourite folk tales have lost much of their original Gothic horror in later versions. By contrast, Daniel Kehlmann's retelling of the legend of Ulenspiegel, moved to the 17th century, is full of nightmares. Worse than imaginary fears awaiting travellers in the forest are real ones: hunger, cold, war, plague, torture "more refined and dreadful than anything the great painters of the inferno had dreamed". These

1867 novel; but if in the latter the hero fights for freedom, here he juggles many things, sometimes literally. Tyll the folklore character becomes an itinerant entertainer and court jester able to provoke and amuse, using his fool's licence to the full. Historical events — the Reformation and its consethe

quences, the Gunpowder Plot, the Fhirty Years' War — underpin the narrative, which includes the story of Elizabeth Stuart, Queen of Bohemia, with flashbacks to her girlhood in England. Meanwhile, life in Europe is taking its course: soldiers killing, rulers bargaining, marauders raping children, scholars looking for dragons.

From a young age, life doesn't treat Tyll kindly: a night he spends alone in the forest ends in a blood-curdling scene. Soon his father Claus, eager to "snatch knowledge wherever it can be found", is accused of witchcraft for his love of books, pentagrams, incantations; he keeps looking for answers to universal questions even as he eats the hangman's meal, feeling sated for the first time. Men in the novel rarely make good fighters, whereas – Tyll's mother, his soulwomen mate Nele, Elizabeth — are stronger, always hitting back.

German of that era is a language not yet suitable for poetry, still "awkward, a boiling brew" Proving what a powerful potion it has since become, the narrative moves from myth to historical

novel to ballad and back, and Ross Benjamin's translation follows it faithfully. While Shakespearean England theatre


flourishes, in Germany it's merely some "pitiful players" roaming the land. Yet Tyll is able to capture the imagination of his audience: "And all of us, looking up, suddenly understood what lightness was... what life could be like for someone who really did whatever he wanted, who believed in nothing and obeyed no one." Who is Tyll: a devil personified, a slick prankster or a great artist? These personas emerge when you read the story, as taut as the rope on which Tyll walks, "wondrously high up, over peaks and clouds".



Kashmiri Pandits, with a saffron spin

Vidhu Vinod C h o p r a 's Shikara, that tells the deeply sad and tragic story

of Kashmiri pandits' forced exodus from their homeland in January 1990, is dedicated to his mother who could never return home. It's personal. And a labour of

both, love and exhalation. The tragedy of four lakh Hindus

being driven from their homes, jobs, schools, lives and rendered homeless, refugees in their own country by a handful of militants while the state and Centre watched is unfathomable, unpardonable. In more ways than one, it was like the second Partition.

was like the second Partition. Shikara declares, at the very onset, that it has mostly used real refugees and not actors for an authentic look and feel.

There's little artifice here, it seems to suggest. *Shikara* should have also declared that it has simplified the

declared that it has simplified the story to let nothing interfere in the narrative of the tragedy of a people. No complexity, no politics, no crimp are allowed in, not even suggestion about where the blame may lie. According to *Shikara*, it doesn't really lie with Delhi, neither with Srinagar, nor with the Delhi-appointed governor, Jagmohan. It lies with Islam, Pakistan-trained militants, but above all with Kashmiri Muslims who either turned foe or rapacious.

There is, of course, no deadline on telling a story. But the timing of when one decides to tell a story often carries a story of its own. It's almost as if *Shikara* was timed to appear after the abrogation of Article 370. As if to justify yet in another tragedy perpetuated by I the state. le

There is a tinge of obscenity in accusing a people of complicity in a crime when they are under lockdown, muzzled, turned prisoners in their own homes.

In *Shikara*, Vidhu Vinod Chopra is often at pains to say that he is against hate, any shade of hate. And even adds, for good measure, that "*leader ka kaam jorna hota hai, todna nahin*".

But his film fits a certain narrative that's in currency, one that tries to justify state-sponsored atrocities in the name of righting past wrongs.

In 1987, young Shiv Kumar Dhar (Aadil Khan) meets sweet Shanti Sapru (Sadia) at the shoot of a Bollywood film in the haseen vaadiyan of Kashimir.

She is training to be a nurse and he is a writer, poet and soon-to-be professor.

When they meet, she is clutching a book of his poems and he, on the insistence of a director's assistance, grabs her hand. They have a cute, short courtship

after which they marry, in the course of which it is established that Shiv's bestfriend, Latif miyan, is soft on the heroine's

solv on the herofile's bestie. Shiv and Shanti want to build a house for which his bestie's dad, Khurshid saab, sends stones after stopping the construction of his own house, thus establishing a utopia where all was well and Kashmir indeed a paradise. But Khurshid saab, a Muslim leader, is killed, and Shiv, who now teaches at Srinagar's Amar Singh College, is whisked away to meet his friend who is being guarded by boys carrying automatic assault rifles.

"Go to India, sell your house and go to India," he is told. "Pindi Pindi, Rawalpindi," the

conductors of busses scream. J&K Commander Force puts out

hit-lists of Hindus who must leave or face consequences. Some prominent pandits are killed, including Shiv's Naveen bhaiyya and, on the night of January 18-19, 1990, Shiv and Shanti leave for Jammu with other

Shanti leave for Jammu with other Kashmiri Pandits, abandoning on the way a calf. In the refugee camps, there's government apathy, inefficiency and insults heaped by trucks carrying

insults heaped by trucks carrying tomatoes while an old man can't stop wailing about returning home, to Kashmir. And then, many years later, a

man comes to Shiv, asking him to sell his house. That's the day Shiv writes his first letter to the President of America.

Shikara, in fact, opens when Shiv is writing his 1,664th letter to the US President on his 28th year in the Muthi Refugee Camp. Though this is a recurring theme in the film, it's not quite clear to me what he says

in those letters apart from telling George Bush and subsequent US Presidents that the guns they sent to Afghanistan are being used to kill Kashmiris. In these letter-writing scenes,

Sharti often suggests to Shiv to share stuff from their personal lives, some happy news as well with the US President, as if he was their friend, reading Shiv's letters, interested in their lives, waiting for the next one even if he's unable to respond or help.

There is a particularly troubling melancholy to the dogged discipline of letter writing, posting and repeating the exercise without a response or riposte from someone you think has the power to change things, better your life.

It carries a hint of being driven to quiet madness by a tragedy, apathy and yet an attempt to clutch onto some dignity in the relentless, scholarly appeal. *Shikara* has a few such tiny but

brilliant vignettes that are cinematically quite clever, powerful. The film, written by Abhijat Joshi, Rahul Pandita and Vidhu

Joshi, Ranui Pandita and Vidnu Vinod Chopra, uses these to layer the story, and make the unbearable, bearable. But the film's real power comes

from the love story of Shiv and Shanti who hug and clutch at each other every time something bad happens. They are not just shielding and protecting each other, but there's almost a belief in that action that the sheer power and tenacity of their grip around each other will dissuade the storm coming their way. As Shiv and Shanti move from

the tent to an 8x8 *pucca* apartment,

we see how she quietly deals with her own trauma, or shares his. And when they move around the presidential suite of a hotel in awe and finally sit in the bathroom, next to a bathtub decorated with rose petals, it's their bond, their love which makes their yearning for their home very touching.

Sharma, is inspired. Apart from people from the Jagti refugee camp, many of whom have a blank, forlorn wait in their eyes, it's Kashmir-born Aadil Khan and Sadia as the leads who really bring a breeze of the Valley to *Shikara*. Both are good and the rough, amateur edges they have, obvious in between scenes where they don't have dialogue, is actually

very fresh, very charming. Sadia has a bit of Leela Naidu and Swaroop Sampat in her, and Aadil has an old world charm born out of not just good looks, but decency. Together, they add a moral sting to this tragic tale.

O ften, writers and directors who want to tell big, sweeping, epic tales of historic proportions, turn that into a backdrop, placing front and centre a love story. It's the easiest way to humanise a story, to give a face to a tragedy. But in those choices, in who those characters are, what they say and do, they also sell a worldview and make a statement.

The problem with *Shikara* is not that it wants to tell the story of a people forced out of their homes. But that it paints the common Kashmiri Muslim as a colluder, an active one at that

active one at that. The film shows two types of Kashmiri Muslims — one who turned to militancy and killed Hindus, and the other who, at least on the surface, tried to save their homes, but did so only so he could take them over.

There is no third type of Kashmiri Muslim in *Shikara*. But there is a cow. Calf, actually, lost, sad and abandoned. The film weeps for the calf, but not for the thousands of Kashmiri families who have, since 1990, lost a son, a husband, a father, a relative, friend or neighbour to bullets that sometimes come from militants and sometimes from the Indian Army.



## Samantha and Sharwanand recreate magic

**J a***anu* is the remake of the Tamil hit 96 and is helmed by C. Premkumar, who directed the original film. The presence of Samantha and the backing of top producer Dil Raju has created a buzz for the film. The film stars Sharwanand in the lead role. But there, in a nutshell, is the whole point of *Malang* which is set in Goa which, as per Bollywood, is a land of drugs, rave parties, hippies who are wannabe Sufis, and corrupt cops.

So much so that they are either loitering around getting laid at random, or just going around killing people.

A cat and mouse game begins where cops chase killer to save cops, but the killer is always a step ahead.

As he keeps offing cops, the cinematographer (Vikas Sivaraman) keeps taking aerial shots of Goa beaches and the director and writer (Aseem Arrora) keep up the pretence that they are keeping us engaged with some deep secret and suspense.

That's really silly because, a) we were not born yesterday and have seen enough movies, from *Ghajini* to whatever, to know that when angry young men, who once had girlfriends who are no longer by their side, go around killing cops, it's because

the cops did some bad things. b) The building of suspense in at least the first part of Malang is of the stupid kind. It's created not by the writing or the plot so much as by cutting scenes at the crucial moment — like those silly ads that come just before the last ball in a match. It's not called building suspense. It's called irritating the audience.

After the interval the movie picks up a bit, and there is actually a mild twist. It's not bad, but then it is

stretched in such bizarre, kinky birections that I lost interest.

A ditya Roy Kapur is quite cute and in the film he is not allowed to keep his shirts on for very long. Which makes sense because he is insanely dull when he has to do anything other than express this one emotion —"I need you so bad I am going to burst".

Ms Patani is shapely and it's quite obvious that she lives quite far away from any acting school. Someone should gift her a friendship band with a knot that must be untied after attending at least a hundred acting classes.

Anil Kapoor's character has been given a gun and a loud guffaw, the sort that throws little spit beads on unsuspecting faces. Despite that, he begins the film with a drug-induced conversation where his stare is dead and unflinching. For a second, I thought he had actually snorted something.

Kunal Khemu makes good of a very badly written character and adds some zing to this dreary, pointless film.

Mohit Suri's film is set in Goa for a reason. It allows him to show smoking, drinking, drugs, rave parties, lots of skin and random sex without having to bother about a story. So, he didn't bother.

### **Overnight brawl** leaves 8 dead

Nursultan/Almaty: A brawl and a series of clashes in several villages in Kazakhstan's southern Zhambyl province have left eight people dead and scores wounded, Interior Minister Yerlan Turgumbayev said Saturday. About 70 people were involved in the initial brawl on the outskirts of the Masanchi village, close to the Kazakh-Kyrgyz border, he told a briefing, after which 300 more people arrived from nearby villages. The crowd clashed with police, wounding two officers with gunshots, and torched dozens of buildings and cars. Police have detained 47 people and confiscated two hunting shotguns, Turgumbayev said. Police and the National Guard now have the situation under control, President Kassym-Jomart Tokayev said in a statement, ordering the government to take steps to maintain calm in the villages.

### **Russian FM slams** Venezuela curbs

Caracas: Russian Foreign Minister Sergei Lavrov on Friday slammed US sanctions against Venezuela as "illegal" during an official visit to Caracas. "These sanctions are illegal and are the main cause of the crisis in the Venezuelan economy," said Lavrov after meeting his Venezuelan counterpart Jorge Arreaza. Russia is one of the main backers of Venezuela's President Nicolas Maduro, along with China and Cuba. US President Donald Trump has launched a new wave of sanctions against Venezuela's economy, which has been in crisis for years, as well as against Maduro and his ministers. Among those measures, Washington imposed sanctions on Venezuela's oil industry last year, targeting the country's main source of hard currency, and on Friday it hit its flag airline. Conviasa. The US administration has said the sanctions are aimed at forcing Maduro to step down.

"I was advised today that the president intends to recall me effective immediately as (the) United States Ambassador to the European Union," Sondland said in a statement

on Friday. Hours before Vindman was escorted out of the White House security officials, his attorney said: "LTC Vindman was asked to leave for telling the truth.

"There is no question in the mind of any American why this man's job is over, why this country now has one less soldier serving it at the White House," Vindman's attorney, David Pressman, said in a statement. "His honour, his commitment to right, frightened the powerful," Pressman added.

"And, if Donald Trump could help us in any way..." "We need help. We are in a desperate, desperate state," his wife Milena Basso pleaded. "We're American citizens and we just want to get home." "It's not going to be a luxury cruise; it's going to be like a floating prison," wrote passenger David Abel on Facebook.

The Starliner's December 20 mission, an uncrewed test flight, ended early when it failed to engage its thrusters on time, due to a previously reported faulty timer. NASA said Friday that the problem arose because it incorrectly pulled time from its Atlas V launch rocket, creating an 11-hour mismatch.

The second problem was intermittent space-to-ground communications, impeding the flight control team's ability to command and control the vehicle. A third issue was confirmed by NASA and Boeing for the first time: A coding error in the programme that governs Starliner's preparation for reentry into Earth's atmosphere. This could have resulted in impact, destabilising the ship or damaging its heat shield, said Jim Chilton, senior V-P of Boeing's Space and Launch division.

"He would have got UK nation-ality and played county cricket, and he threw his chance away. I hope all cricketers look at his example as a deterrent against corruption." - PT

The victory also completed a hat-trick of ODI wins for the Black Caps starting from their World Cup semi-final win in Manchester last year. The win was more creditable as regular skipper Kane Williamson along with top bowlers Trent Boult, Lockie Ferguson were unavailable.

New Zealand's 6 foot 8 Jamieson (2/42 and 25 off 24 balls) got the 'Player of the Match' award for his all-round show. "I'm impressed with how we finished. Bhubaneswar, Feb. 8: Indian men hockey team's sensational run of form continued as they stunned world champions Belgium 2-1 to seal their third win on the trot in the FIH Pro League here on Saturday.

After defeating world number three the Netherlands in their opening two matches of the FIH Pro League, India beat world number one Belgium in a thrilling match at the Kalinga Stadium here to continue their unbeaten run.

Mandeep Singh scored a field goal in the second minute of the match before Gauthier Boccard equalised for European champions Belgium in the 33rd minute with a powerful drag flick from a penalty corner.

Ramandeep Singh scored the decisive goal in the 47th minute via a penalty corner to give world number four India a victory in front of a frenzied crowd at the same venue where the home side beat the Dutch twice.

With this sensational victory, India consolidated their ranking from No.5 to No.4 for the first time since the world ranking system was introduced in 2003. The two sides meet again on

Sunday at the same venue. After getting off to a rollicking start in their maiden FIH Hockey Pro League with a 5-2 and 3-1 shoot-out (3-3 in regulation time) win against the Netherlands,

With scores reading 1-1, it was a tense final quarter but India pushed back Belgium by scoring another goal.

It was Ramandeep, who after injecting the ball during a penalty corner battery, picked up a rebound off Belgium's first rush er to score the goal.

Though Belgium created penalty corners in the dying minutes of the match, India held their nerves and experienced goal keeper Sreejesh ensured India sealed the game to stay at second position in the points table.

Belgium are still on top with 11 points from five games. The victory was also India's 50th win against Belgium. — PTI

## Federer plays for Africa

Cape Town (South Africa), Feb. 8: Roger Federer and Rafael Nadal attracted what organisers said was a world record crowd for a tennis match when they played an exhibition event in the Cape Town Stadium on Friday.

The organisers said an audited attendance of 51,954 beat the 42,517 who watched Federer play Alexander Zverev of Germany in Mexico City last November.

They also announced that the 'Match in Africa' raised \$3.5million for the Roger Federer Foundation, which supports educational and athletic pro-grammes for children in Africa.

"To have 51,954 people in attendance at a tennis match, I never thought I'd be apart of something like that. It's not something you dream about," said Federer.

Federer, who was accompa-nied by his South African mother, Lynette, said his first appearance in South Africa was a special occasion. "The first time here in Cape Town, in South Africa, means so much more than just tennis," he said.

Federer won 6-4, 3-6, 6-3 in a match in which the players had to contend with cool, windy conditions in the stadium that

The arena was packed with eager fans who sang, clapped and did the wave throughout the match. "It's an amazing crowd, an amazing stadium,' said Nadal, who was making his first appearance in South Africa since playing in the country as a junior.

"I can't thank enough the people here in Cape Town. They came here and created an unforgettable atmosphere, he added

Earlier in the day, Federer and his doubles partner billionaire Bill Gates beat Nadal and South-African born come dian Trevor Noah in a match with more flexible rules.

The ceremonial coin toss was performed by World Cup-winning Springbok rugby captain

Siya Kolisi, who presented Federer with a Springbok jersey. The coin used was a commemorative 20 Swiss Francs piece minted with Federer's face. He gave it to Kolisi. Other high-profile South African sports stars in atten-

dance included former Springbok captains John Smit and Jean de Villiers as well as Olympic swimmer Ryk Neethling. The match is the sixth edi-

tion of the event organised by the Roger Federer Foundation and is the first to take place in Africa. Federer said he spent childhood holidays in South Africa

Thousands of fans showed up early and were ecstatic when Nadal and Federer hit practice balls into the stands. Earlier, Federer and Nadal played tennis with children from townships in Hout Bay. -AFP


