Travel from EU, U.K. banned as India tightens preventive steps

All from UAE, Qatar, Oman, Kuwait to be quarantined; COVID-19 cases touch 114

In a series of temporary preventive measures, the Group of Ministers (GoM) on CO-VID-19 on Monday banned the entry of travellers from European Union nations, the European Free Trade Association, Turkey and the United Kingdom to India from March 18.

After its seventh meeting on the COVID-19 outbreak. the GoM also called for expanding the compulsory quarantine for a minimum period of 14 days for passengers coming from/transiting through UAE, Qatar, Oman, and Kuwait.

national, testing positive, State Health Department officials said. With one more confirmation, Karnataka now has eight cases.

The national capital, which has so far reported seven COVID-19 cases and one death, announced that all gyms, night clubs and spas will remain shut till March 31 and that a gathering with more than 50 persons, excluding weddings, will not be allowed.

A senior Health Ministry official said if an Indian from Europe or U.K. or Turkey travels to another country from which there is no ban, such as the U.S. or Australia, he or she will be "allowed entry and quarantined or advised home quarantine depending on his condition." He added that this was already being allowed for Indians returning from France or Germany via Dubai in UAE.

Speaking at a press meet, Joint Secretary in the Health Ministry Lav Agarwal, assured that "adequate number of tests are being done to get information about any community transmission".

"We don't want to create panic and conduct unnecessary mass testing of people as of now. There is no requirement for it," he added.

Nath rules out floor test after meeting Governor

M.P. CM defies Tandon's directive. claims majority

Capping a day of hectic political activity, Madhya Pradesh Chief Minister Kamal Nath called on Governor Lalji Tandon at the Raj Bhavan late on Monday night. He later ruled out holding a floor test in the Assembly, claiming that his government enjoyed a majority.

The late night meeting followed a letter from the Governor directing the Nathled Congress government to hold a floor test on Tuesday after Speaker N.P. Prajapati earlier adjourned the House till March 26 in view of the COVID-19 threat.

The Speaker's decision, soon after the Governor's address on the first day of the Budget session, scuttled an expected floor test on Monday. "During the Vidhan Sabha session, honourable members and people can't be stopped from being in groups or meeting anyone," said Mr. Prajapati.

"Considering the health of the honourable members, historic steps taken by other Vidhan Sabhas, advisory issued by the Government of India and in larger public interest, the proceedings of the Vidhan Sabha have been adjourned until March 26."

Dares Opposition

Speaking to reporters after meeting Mr. Tandon, Mr. Nath said, "I met the Governor and thanked him for his address on the opening day of the Budget session. We are in a majority today so no question of a floor test... Those who claim that we don't have a majority should move a no-confidence motion against my government day, while "respecting con-

The Supreme Court will on Tuesday urgently hear a petition filed by former Madhya Pradesh Chief Minister Shivraj Singh Chouhan and nine other BJP MLAs seeking the holding of a vote of confidence on the floor of the Legislative Assembly against the Kamal Nath-led Congress government.

Mr. Chouhan and his fellow BJP legislators, who approached the court on Monday, wanted the floor test to be held immediately, possibly within the next 12 hours. They challenged the decision of the Speaker to

adjourn the floor test to March 26. Mr. Chouhan informed the court that "horse-trading is at its peak" in the State.

The petition is listed for hearing before a Bench of Justices D.Y. Chandrachud and Hemant Gupta.

"Any deferment of the floor test will further encourage horse-trading and would be in utter violation of the directions issued by the Governor and the law laid down by this Court and the spirit and Basic Structure of the Constitution," the BJP leaders contended.

At an unscheduled press conference to assuage market participants, RBI Gover nor Shaktikanta Das also assured depositors of the beleagured Yes Bank that the reconstruction was aimed at ensuring the safety of depositors' money.

Mr. Das assured that the central bank would provide liquidity to Yes Bank if needed, after the moratorium on withdrawals is lifted on March 18.

Investors' wealth eroded by ₹7.62 lakh crore on Monday as markets witnessed yet another sharp fall, with the Sensex plunging 2,713.41 points over the COVID-19

Global equity markets also continued to be in turmoil on account of the paneven as Indian benchmarks registered their second-biggest, single-day fall in absolute points, plunging to their lowest level since September 2017.

Nearly five months after winning its legal battle in the Supreme Court against telecom majors, including Vodafone and Bharti Airtel, for payment of Adjusted Gross Revenue (AGR) dues worth several lakhs of crores of rupees, the Centre did a virtual U-turn on Monday by urging the court to give the companies a 20-year window to pay the money back.

The SC had asked the firms to pay up within three months.

In an application mentioned for urgent hearing in the top court, the government said it has, after "detailed and long-drawn deliberations", devised a "formula" to soften the blow of the October 24, 2019 judgment directing the companies to cough up the AGR in three months.

Staggered instalments

"All the licensees impacted by the judgment be allowed to pay the unpaid or remaining amount of past DoT assessed/calculated dues in annual instalments over 20 years (or less if they so opt), duly protecting the net present value of the said dues using a discount rate of 8% (based on one year marginal cost of lending rate of SBI which is currently 7.75%)," the application said.

For many victims, Idgah relief camp feels safer than home

They fear being arrested for no reason; others await relief

Abubakar, a 24-year-old resident of Shiv Vihar currently staying at the Idgah relief camp in Mustafabad, was allegedly picked up by the Crime Branch last week, interrogated and thrashed for over five hours before being released.

Three weeks since the communal violence in northeast Delhi, for Mr. Abubakar and other youths his age, the relief camp has become their "safe place".

On March 10, Mr. Abubakar had gone to Shiv Vihar to take stock of his house when Crime Branch officers came looking for him. "They asked the neighbours for my name and then held me. They took me to their office and kept me there for six-seven hours. They slapped and punched me and showed me videos. They asked me to identify at least five people or they won't let me go," he alleged, adding that he wasn't there in any of the videos the officers showed him.

"They beat me up especially after reading a chat with my girlfriend on the night of February 24 wherein I had written that I was standing with 40-50 people as a precautionary measure," he said.

The Crime Branch officers told him they will release him after inquiring with the local police, Mr. Abubakar said. Senior Crime Branch of-

ficers remained unavailable for comment on the matter.

Standing a little ahead was a 20-year-old youth who said he had been told by his neighbours that policemen had come looking for him, his brother and father at their house. "They are picking up people from anywhere. We are scared and this camp is safe for us," he said.

Wait for compensation

For many at the relief camp, fear is not the only reason for not returning home. They haven't received any compensation to rebuild their houses and are unable to arrange funds on their own.

Nawab Khan, 45, said he fled his Shiv Vihar residence on February 24. His house was looted and set ablaze the next day. He still hasn't received the emergency relief fund, let alone the final compensation. "The primary reason we are not going back is because we don't have money and I haven't received
