A walk-in-Interview for appointment of Six posts of **Junior Resident** is to be held on **14/05/2020** at **11.AM** on **ADHOC** basis against the vacant post of **Junior Resident** as per details given below:-

ELIGIBILITY

For **JR**: **MBBS** from recognized university, internship completion certificate, registered with Delhi Medical Council. The candidate having completed compulsory rotary internship before 31/01/2019 need not apply if applied will not be considered.

EMOLUMENTS:

For JR Rs. 56,100/- plus usual allowance as admissible under the rules.

AGE LIMIT:

Age below 30 year as on 28/02/2020. Relax able for SC/ST by 05 years and for OBC by 03 years (OBC candidates are required to submit their caste certificate issued by the Competent Authority of Govt. of NCT of Delhi).

TENURE:

Appointment will be initially for a period of 89 days extendable on the basis of satisfactory work and conduct report from the concerned in charge and written request from the Doctor concerned.

RECRUITMENT CONDITIONS:

1. Other service conditions as prescribed from time to time by the Hospital will be applicable.
2. Bring all Original Documents along with self attested Photocopies on the schedule date of Interview.
3. No Correspondence or personal enquiries shall be entertained.
4. Candidates must have a valid updated DMC Registration Certificate (Delhi Medical Council Act, 1997 dated 11.02.1997).
5. Candidates who are already in Govt. service should submit NOC from the employer.
6. No TA/DA will be paid for attending the interview.
7. Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing in interview.

8. The decision of the Selection Board regarding selection will be final and binding and no representation will be entertained in this regard.
9. The services of JRs will be governed by the residency scheme of Govt. of India/ Civil Services (Temporary Rules).
10. All candidates are exempted from payment of fee.
11. In case of Non-availability of reserved candidate the post will be filled on adhoc basis from other categories.
12. Number of vacancies for appointment may be increased/decreased with the permission of the chair.
13. Seven days of salary of J/R Doctors shall be kept as security.
14. The Private Practice:- The private practice of any kind what so ever is strictly prohibited. Beside the candidates will not work simultaneously as Junior Resident in any other hospital. Breach of this condition will result in termination of certificate of appointment & necessary proceedings may also be initiated in consultation with DMC for cancellation of certificate of Registration...
15. Resignation/Termination: The appointment for the above mentioned post(s) on tenure basis, you are required to give 07 days prior notice for resignation otherwise required to deposit 07 days salary in lieu of the prior notice. In case the appointee is not interested in further extension, he/she required to intimate before 01 month of completion of tenure otherwise required to deposit 07 days salary in lieu of the prior notice. In case of the unsatisfactory work and conduct report from the concerned department, the contract appointment shall be terminated and no correspondence shall be entertained in this regard. If termination of service is made on disciplinary grounds due to continuous absence of the appointee, the last day of working may be treated as starting day of continuous absence & salary will be deducted from last dues for the notice period.
16. All the selected candidates shall have to attend a compulsory training on BIO-MEDICAL WASTE MANAGEMENT. For venue and schedule of the programme, must contact Dr. Ujwal Bhakta, I/c BIO-MEDICAL WASTE
17. The JR working in any specialty/Department may be required to perform to duties in Emergency Department as per requirements of patient care.

JURISDICTION OF DISPUTE:
